The Board wishes to inform the Shareholders of the Company that having consulted and agreed with its current auditors and other professions has basically resolved the major Alleged Non-compliance 2010, and including but not limited the clarification of appropriate accounting treatment of the Group's convertible bonds, evaluation a number of valuation models, reviewing the accounting allocation of the purchase price for the acquisition of Kang Yuan Universal Investment Limited together with its subsidiaries, which involved reviewing circumstances and evidence back to year 2010. Further additional time is required for the Company to compile the Group's consolidated financial statements, schedules, notes to accounts, agree the Annual Results with the current auditors, and finalize the audited consolidated financial statements and the Annual Results Announcement of the Group for the year ended 31 March 2013.

The release of the Annual Results and the dispatch of the Annual Report were previously expected to be taken place in mid of September 2013. However, due to the technical complexity and in-depth scope of work involved in the audit and related procedures as stated in the Announcements. At present, the Company expects to publish the Annual Results and dispatch the audited Annual Report for the year ended 31 March 2013 in October 2013.
