The Board has appointed ZHONGHUI ANDA CPA Limited as the new auditor of the Group with effect from 23 July 2014 to fill the vacancy following the resignation of HLB and to hold office until the conclusion of the coming annual general meeting of the Company.

The Board and the Audit Committee of the Company have also confirmed that there are no circumstances in respect of the change of auditors which need to be brought to the attention of the shareholders of the Company.

The Board would like to take this opportunity to express its sincere gratitude to HLB for its professional services rendered to the Group during the past years.
