2. the page reference to the consolidated financial statements of the Company and its subsidiaries for the year ended 31 December 2016 appeared on page 44 of the Annual Report should be “pages 49 to 93” instead of “pages 44 to 93”.

The Board confirms that the above clarification does not affect other information contained in the Annual Report.
