HIGH CONCENTRATION OF SHAREHOLDING

This announcement is made at the request of the Stock Exchange in respect of the high concentration of shareholding of the Company in the hands of a limited number of Shareholders as at 24 August 2017.

In view of the high concentration of shareholding in a small number of Shareholders, Shareholders and prospective investors should be aware that the price of the Shares could fluctuate substantially even with a small number of Shares traded, and therefore should exercise extreme caution when dealing in the Shares.

This announcement is made at the request of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) in respect of the high concentration of shareholding of Haitian Energy International Limited (the “**Company**”) in the hands of a limited number of shareholders of the Company (the “**Shareholders**”) as at 24 August 2017.

HIGH CONCENTRATION OF SHAREHOLDING

The Company noted that an announcement was published by the Securities and Futures Commission (the “**SFC**”) on 4 September 2017 (the “**SFC Announcement**”).

As disclosed in the SFC Announcement, the SFC has recently completed an enquiry into the shareholding of the Company. The SFC's findings indicated that as at 24 August 2017, 19 Shareholders held an aggregate of 2,555,584,000 Shares of the Company (the "Shares"), representing approximately 27.97% of the issued Shares. Such shareholding, together with 6,000,000,000 Shares (representing approximately 65.67% of the issued Shares) held by the controlling Shareholder of the Company, represented approximately 93.64% of the issued Shares. Therefore, only 580,416,000 Shares (representing approximately 6.36% of the issued Shares) were held by other Shareholders as at 24 August 2017.
