The Board announces that HLB Hodgson Impey Cheng Limited has resigned as the auditors of the Group with effect from 28 December 2018, and with the recommendation of the audit committee of the Board, Elite Partners CPA Limited was appointed as the new auditors of the Group with effect from 28 December 2018 to fill the casual vacancy following the resignation of HLB Hodgson Impey Cheng Limited and to hold office until the conclusion of the next annual general meeting of the Company.

The board of directors (the “**Board**”) of National Arts Entertainment and Culture Group Limited (the “**Company**”) announces that HLB Hodgson Impey Cheng Limited (“**HLB**”) has resigned as the auditors of the Company and its subsidiaries (collectively referred to as the “**Group**”) with effect from 28 December 2018, and with the recommendation of the audit committee of the Board, Elite Partners CPA Limited was appointed as the auditors of the Group with effect from 28 December 2018 to fill the casual vacancy following the resignation of HLB and to hold office until the conclusion of the next annual general meeting of the Company.

HLB tendered its resignation as the auditors of the Group due to the failure between it and the Company to agree on the audit fees for the financial year ending 31 December 2018.

HLB has confirmed that from its perspective there are no matters in addition to those stated above that need to be brought to the attention of the holders of securities of the Company. The Board confirms that there is no disagreement between the Company and HLB and there are no matters in relation to the resignation of HLB as the auditors of the Group that need to be brought to the attention of the shareholders or creditors of the Company.
