This announcement is made by China Yu Tian Holdings Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rules 17.10, 18.03, 18.48A and 18.49 of the Rules Governing the Listing of Securities on GEM (the “**GEM Listing Rules**”) of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

References are made to the announcements of the Company dated 29 March 2019, 15 May 2019, 14 August 2019, and 14 November 2019 (the “**Announcements**”) respectively in relation to, among other things, (i) the delay in publication of the 2018 Annual Results and the delay in despatch of the 2018 Annual Report; (ii) the postponement of Board meeting in relation to the 2018 Annual Results; (iii) the delay in publication of the 2019 First Quarterly Results and the delay in despatch of the 2019 First Quarterly Report; (iv) the postponement of Board meeting in relation to the 2019 First Quarterly Results; (v) the delay in publication of the 2019 Interim Results and the delay in despatch of the 2019 Interim Report; (vi) the postponement of Board meeting in relation to the 2019 Interim Results; (vii) the delay in publication of the 2019 Third Quarterly Results and the delay in despatch of the 2019 Third Quarterly Report; and (viii) the postponement of Board meeting in relation to the 2019 Third Quarterly Results. ## **DELAY IN PUBLICATION OF THE 2019 ANNUAL RESULTS AND DELAY IN DESPATCH OF ANNUAL REPORT**

Pursuant to Rules 18.03, 18.48A and 18.49 of the GEM Listing Rules, the Company must publish its annual results announcement (the “**2019 Annual Results Announcement**”) and despatch its annual report (the “**2019 Annual Report**”), in respect of the year ended 31 December 2019, not later than three months after the date upon which the financial year ended, i.e., 31 March 2020. As the publication of the 2018 Annual Results, 2019 First Quarterly Results, 2019 Interim Results and 2019 Third Quarterly Results is still pending, the Company is unable to publish the 2019 Annual Results Announcement and despatch its 2019 Annual Report to the Shareholders within the prescribed time in accordance with the GEM Listing Rules.

At the request of the Company, trading in the shares of the Company on the Stock Exchange has been suspended with effect from 9:00 a.m. on Friday, 29 March 2019 and will continue to be suspended until further notice.
