References are made to the announcements of the Company dated 31 March 2020, 13 May 2020, 17 June 2020 and 31 August 2020 (collectively the “**Announcements**”) in relation to, among other things, delay in publication of its annual results and annual report in respect of the year ended 31 December 2019 (the “**2019 Annual Results**”), delay in publication of its quarterly results and quarterly report in respect of the three months ended 31 March 2020 (the “**2020 First Quarterly Results**”), delay in publication of its interim results and interim report in respect of the six months ended 30 June 2020 (the “**2020 Interim Results**”) and the resumption guidance, respectively. The Company will publish further announcements in due course to inform its shareholders the progress in relation to the publication/despatch of the 2019 Annual Results, 2020 First Quarterly Results, 2020 Interim Results and 2020 Third Quarterly Results.
