On behalf of the board of Directors (the "**Board**"), I hereby present the annual results of the Company and its subsidiaries (collectively the "**Group**") for the year ended 31 December 2020. During the year under review, the Group recorded revenue of approximately HK\$1,050,847,000 (2019: HK\$641,261,000), representing an increase of 63.9% as compared with that in last year. The loss attributable to the shareholders (the "**Shareholders**") of the Company was approximately HK\$72,697,000 (2019: HK\$127,582,000).

OVERVIEW

During the year under review, the Group continued to adopt a diversified business development strategy. The Coronavirus Disease 2019 ("COVID-19") has resulted in a significant pressure on the cashflow of the Group's business of mobile internet cultural business and provision of IT services as its operation efficiency has been adversely affected due to the guarantine policies arising from the pandemic. After considering different means to raise funds for maintaining the operation of this business segment and with debt financing being the only option viable at the time, (i) Concord-Linked Limited ("CL Borrower"), a company which is owned as to 51% by the Company and 49% by Mr. Wong Jing Shong (the "CL Lender"), a director of the CL Borrower and a number of its subsidiaries, hence a connected person of the Company at the subsidiary level; and (ii) the CL Lender entered into a loan agreement (the "CL Loan Agreement") on 4 September 2020, pursuant to which the CL Lender should advance a one-year loan in the principal amount of HK\$30,000,000 to the CL Borrower.

The revenue generated by the Group from its provision of hospitality and related services in Australia through its three venues located in Victoria, namely the Balgownie Estate Vineyard Resort & Spa Yarra Valley, the Bellinzona Resort Cellar Door & Dining and the Cleveland Winery Resort & Events, declined compared to last year due to the drop in average occupancy rate of the resorts. The decline in average occupancy rate of the resorts was mainly attributable to the decrease in the number of domestic visitations to regional Australia due to the global outbreak of COVID-19 and the demand for domestic travel has been adversely affected by the declining economic growth in Australia.

概覽

於回顧年度內,本集團繼續採用多元化業務發 展策略。受新型冠狀病毒疫情影響,本集團的 移動互聯網文化業務及資訊科技服務業務的 現金流量面臨巨大壓力,原因為本集團經營效 益因抗擊疫情所實施的隔離政策而受到不利 影響。為維持此業務分部運營,本集團考慮過 多種籌集資金的方式,債務融資為當時唯一可 行的選擇。因此,於二零二零年九月四日,(i) Concord-Linked Limited(協盟有限公司)(「協 **盟借款人**」),一間由本公司擁有51% 權益及 由黃靖淳先生(「協盟貸款人」,為協盟借款人 及其若干附屬公司的董事,因此屬本公司於附 屬公司層面之關連人士)擁有49%權益之公 司;與(ii)協盟貸款人訂立貸款協議(「協盟貨 **款協議」**),據此協盟貸款人應向協盟借款人 發放本金額為30,000,000港元之一年期貸款。

本集團在澳洲透過位於維多利亞的三處物業 (即博爾基尼酒莊水療度假村、貝林佐納度假 村及克里夫蘭酒莊度假村)提供酒店及相關服 務產生的收入較去年有所下降,乃由於度假村 的平均入住率下降。度假村的平均入住率下降 主要是由於全球爆發新型冠狀病毒疫情導致 到澳洲地區的國內遊客數量下降及國內旅遊 需求因澳洲經濟增長下降而受到不利影響所 致。

CHAIRMAN'S STATEMENT 主席報告書

In light of the declining economic growth in Australia and the global outbreak of COVID-19, the demand for the services of the resorts of the Group in Australia has substantially decreased and such decrease is expected to continue until the first guarter of 2021. The government of the state of Victoria announced on 16 September 2020 some easing of the restrictions to combat COVID-19 previously imposed on cafes and restaurants. With effect from 11:59 p.m. on 27 October 2020, the government of the state of Victoria introduced Stage 3 easing of restrictions for Melbourne, under which restaurants and cafes are allowed to open for outdoor and indoor seated service of food or drink, subject to limits on the number of customers and distance between tables. The operation of the Balgownie Estate Vineyard Resort & Spa Yarra Valley partially resumed in November 2020, and the resumption of its operation would take place in stages in line with the progress of the lifting of the restrictions by the government and as and when it is economically viable for the Group to do so.

In August 2020, the Group completed the disposal of (i) the business of the Bellinzona Resort Cellar Door & Dining; (ii) the assets for operating the business; and (iii) the site at which the business operated (collectively, the "Bellizona Disposals"), in which the property and the business of the Bellinzona Resort Cellar Door Dining, being the worst performing resort of the Group over the past two years, and the assets for operating such business were disposed of by the Group. In February 2021, the Group entered into two agreements to dispose of (i) the business of the Cleveland Winery Resort & Events; (ii) assets used in the business (except for the stocks of wine); and (iii) the site at which the business operated (collectively, the "Cleveland Disposals", together with the Bellizona Disposals, the "Disposals"). The Group will dedicate the resources freed up from the Bellinzona Resort Cellar Door of Dining and the Cleveland Winery Resorts & Events to the development of the Balgownie Estate Vineyard Resort & Spa Yarra Valley, which is likely to achieve a more rapid recovery due to its competitive advantages, including its geographical location, which is in an area popular among tourists.

The Group's assets investment business turned from a loss into a profit for the year under review and the change was primarily attributable to the reversal of provision for the litigations which amounted to approximately HK\$2,777,000 (2019: provision for the litigations amounting to approximately HK\$32,796,000) for the year under review. 由於澳洲經濟增長下滑及全球爆發新型冠狀 病毒疫情,市場對本集團澳洲度假村的服務需 求大幅下降,且下降趨勢預期將持續至二零 二一年第一季度。維多利亞州政府於二零二零 年九月十六日宣佈放寬之前對咖啡店及餐廳 施加的抗擊新型冠狀病毒的限制措施。自二零 二零年十月二十七日午夜十一時五十九分起, 維多利亞州政府對墨爾本放寬第三階段限制, 允許餐廳及咖啡店提供室外及室內餐飲服務, 但須限制顧客人數及餐桌間距離。博爾基尼酒 莊水療度假村於二零二零年十一月恢復部分 營運,後續本集團將在經濟上可行的情況下, 根據政府解除限制的進度分階段恢復營運。

於二零二零年八月,本集團完成出售(i)貝林佐 納度假村之業務;(ii)經營業務之資產;及(iii) 業務經營場地(統稱「貝林佐納出售事項」), 至此,貝林佐納度假村(為過去兩年本集團旗 下表現最差的度假村)之物業及業務以及經營 業務所用之資產已全部出售。於二零二一年二 月,本集團訂立兩份協議,以出售(i)克里夫蘭 酒莊度假村之業務;(ii)用於業務之資產(葡萄 酒庫存除外);及(iii)業務經營場地(統稱「克 **里夫蘭出售事項」**, 連同貝林佐納出售事項統 稱「出售事項」)。本集團計劃將出售貝林佐納 度假村及克里夫蘭酒莊度假村而釋放的資源 用於發展博爾基尼酒莊水療度假村,因博爾基 尼酒莊水療度假村具有競爭優勢(包括位於 遊客熱門地區的地理位置優勢),更有望快速 實現復甦。

本集團之資產投資業務於本年度轉虧為盈, 主要是由於於回顧年度撥回訴訟撥備約 2,777,000港元(二零一九年:計提訴訟撥備約 32,796,000港元。

PROSPECTS

The negative impacts of the outbreak of COVID-19 on the global economy are enormous. The operation and financial performance of the Group's businesses of mobile internet cultural business and provision of information technology ("**IT**") services and provision of hospitality and related services in Australia during the year under review have been adversely affected by COVID-19.

Going forward, the Group will continue to closely monitor the development of the COVID-19 pandemic and its impacts on the Group's businesses, and the Group will proactively take measures to mitigate the adverse impacts of COVID-19 on its businesses. In particular, the Group has been identifying investment opportunities to diversify its businesses. In March 2021, the Group subscribed for 10,200 ordinary shares of TNG Indonesia Holdings Limited ("Target Company"), representing 51% of the issued share capital of the Target Company upon completion as enlarged by the allotment and issue of such shares, at the subscription price of US\$1,000,000 (equivalent to HK\$7,800,000). The Target Company holds 79% of the issued shares of a company incorporated in Singapore, which holds 99% of the issued shares of PT TNG Wallet Indonesia ("TNG Indonesia"), which is a company incorporated in Indonesia with limited liability and an investment holding company and 1% of the issued shares of TNG Indonesia is held by the Target Company. TNG Indonesia holds 49% of the issued shares of PT Walletku Indompet Indonesia ("TNG Indompet"), which is a company incorporated in Indonesia with limited liability. 51% of the issued shares of TNG Indompet is held by an individual who has pledged such interest in favour of TNG Indonesia pursuant to the contractual arrangements, details of which are set out in the Company's announcement dated 9 March 2021. TNG Indompet is principally engaged in (1) Indosat mobile top-up distribution business and (2) the cobranding "W-Cash" electronic wallet with a licensed e-money issuer in Indonesia pursuant to the cooperation between TNG Indompet and such e-Money issuer. The Group believes that its investment in the Target Company provides it an opportunity to develop its business in Indonesia as well as the bordering areas, and will also strongly complement the Group's mobile internet cultural business and provision of IT services and money lending business as well as providing overall synergistic benefits to its principal activities. Following the investment in the Target Company, the Group is also exploring the business opportunities in the development and operation of FinTech platform for microlending in Hong Kong and Southeast Asia such as Indonesia.

To further diversify its businesses, the Group also intends to engage in provision of medical services in Hong Kong and is currently identifying potential clinic(s) and medical centre(s) in Hong Kong.

前景

新型冠狀病毒疫情爆發對全球經濟造成巨大 負面影響。於回顧年度,本集團的移動互聯網 文化業務及提供資訊科技(「資訊科技」)服務 業務以及於澳洲提供酒店及相關服務業務的 經營及財務表現均因新型冠狀病毒疫情受到 不利影響。

未來,本集團將持續密切關注新型冠狀病毒疫 情的發展及其對本集團業務的影響。本集團 將積極採取措施以緩解新型冠狀病毒疫情對 其業務的不利影響。尤其是,本集團一直在物 色投資良機,以實現業務多元化。於二零二一 年三月,本集團認購TNG Indonesia Holdings Limited (「目標公司」)之10,200股普通股, 相當於目標公司於完成後經配發及發行相 關股份擴大之已發行股本之51%,認購價為 1,000,000美元(相當於7,800,000港元)。目 標公司持有一間於新加坡註冊成立之公司已 發行股份的79%,該公司持有PT TNG Wallet Indonesia (「**TNG Indonesia**」)之99%已發行 股份。TNG Indonesia 為一間於印尼 註冊成 立之有限公司,屬投資控股公司,其餘下之1% 已發行股份由目標公司持有。TNG Indonesia 持有 PT Walletku Indompet Indonesia (「TNG Indompet」,一間於印尼註冊成立之有限公 司)之49%已發行股份, TNG Indompet 之51% 已發行股份由一名個人持有,而該人士已根 據合約安排以TNG Indonesia 為受益人質押相 關股權,有關詳情載列於本公司日期為二零 二一年三月九日之公佈。TNG Indompet主要(1) 從事Indosat移動充值卡分銷業務;及(2)根據 TNG Indompet 與一名持牌電子貨幣發行人協 定的合作事項,與該電子貨幣發行人於印尼推 出聯合品牌 [W-Cash] 電子錢包。本集團認為 於目標公司之投資為本集團提供機會發展其 於印尼及周邊地區之業務·亦將與本集團之移 動互聯網文化業務及提供資訊科技服務以及 放債業務形成強大互補,並為其主要業務提供 整體協同效益。繼投資目標公司後,本集團亦 在香港及東南亞地區 (如印尼等)尋求發展及 經營FinTech 平台小額貸款業務的機會。

為使其業務更加多元化,本集團亦有意於香港 提供醫療服務,目前正在香港物色具有潛在合 作可能之診所及醫療中心。

BUSINESS AND FINANCIAL REVIEW

During the year ended 31 December 2020, the principal activities of the Group were (i) mobile internet cultural business and provision of IT services; (ii) provision of hospitality and related services in Australia; (iii) money lending business; and (iv) assets investments business.

The loss attributable to the Shareholders was approximately HK\$72,697,000 during the year under review (2019: HK\$127,582,000), and such decrease in loss was mainly attributable to (i) the reversal of provision for the litigations which amounted to approximately HK\$2,777,000 (2019: provision for litigations amounting to approximately HK\$32,796,000) for the year under review; (ii) the government subsidies and other related subsidies from the governments of Australia, Hong Kong and the People's Republic of China ("**PRC**") of approximately HK\$13,972,000 (2019: 4,474,000) for the year ended 31 December 2020; and (iii) the decrease of impairment loss on property, plant and equipment from approximately HK\$23,616,000 for the year ended 31 December 2019 to approximately HK\$8,512,000 for the year ended 31 December 2020.

Mobile internet cultural business and provision of IT services

During the year under review, the Group's mobile internet cultural business and provision of IT services recorded a revenue of approximately HK\$1,014,554,000 (2019: HK\$544,544,000), representing a growth of approximately 86%. The core IT businesses of the Group include enterprise software applications, mobile internet applications, mainframe downsizing, application localisation and systems integration. The Group has experienced a significant growth in its provision of IT services business during the year ended 31 December 2020 as a result of the increase in the demand for the Group's IT services. However, in light of the outbreak of COVID-19 in the PRC from the first two months of 2020, the operation efficiency of the Group's provision of IT services business had been adversely affected given that some of its staff had been put under guarantine in their hometowns in the PRC and could not return to the office to work or needed to work from home which adversely affected the ability of the Group to deliver its services to meet with its customers' orders during the three months ended 31 March 2020. Notwithstanding the operation efficiency of the Group's provision of IT services business had resumed to normal in April 2020, which led to an increase in the revenue generated by the Group under this business segment in the second to fourth quarters of 2020, such growth in revenue was outpaced by the increase in the aggregate salaries and benefits of the technical staff of the Group due to the increase in the number of staff employed to cope with the expansion of the Group's IT business.

業務及財務回顧

截至二零二零年十二月三十一日止年度,本集團之主要業務為:(i)移動互聯網文化業務及提 供資訊科技服務:(ii)於澳洲提供酒店及相關 服務:(iii)借貸業務:及(iv)資產投資業務。

於回顧年度,股東應佔虧損約為72,697,000港 元(二零一九年:127,582,000港元),虧損減 少主要歸因於(i)於回顧年度撥回訴訟撥備約 2,777,000港元(二零一九年:計提訴訟撥備 約32,796,000港元);(ii)截至二零二零年十二 月三十一日止年度,收到澳洲、香港及中華人 民共和國(「中國」)政府發放的政府補貼及其 他相關補貼約13,972,000港元(二零一九年: 4,474,000港元);及(iii)物業、廠房及設備之減 值虧損由截至二零一九年十二月三十一日止 年度的約23,616,000港元減少至截至二零二 零年十二月三十一日止年度的約8,512,000港 元。

移動互聯網文化業務及提供資訊科技服務

於回顧年度,本集團自其移動互聯網文化業務 及提供資訊科技服務錄得收入約1,014,554,000 港元(二零一九年:544,544,000港元),增幅 為約86%。本集團的核心資訊科技業務包括 企業級應用軟件、移動互聯網應用軟件、大型 機小型化、應用本地化及系統集成。截至二零 二零年十二月三十一日止年度,由於市場對本 集團資訊科技服務的需求增加,本集團資訊科 技服務業務錄得大幅增長。然而,於二零二零 年首兩個月,中國爆發新型冠狀病毒疫情,本 集團部分國內員工須接受居家隔離,無法返回 辦公室辦公或需在家辦公,對本集團於截至二 零二零年三月三十一日止三個月提供資訊科 技服務以滿足客戶訂單的能力造成不利影響, 本集團科技資訊科技服務業務的經營效益因 而受到不利影響。本集資訊科技業務經營效益 於二零二零年四月恢復正常,因此該業務分部 於二零二零年第二至第四季度產生的收入有 所增長,惟增幅不及本集團為應對資訊科技業 務擴張而增聘人員導致之本集團技術員工薪 金及福利總額之增幅。

COVID-19 has resulted in a significant pressure on the cashflow of the Group's business of mobile internet cultural business and provision of IT services as its operation efficiency has been adversely affected due to the quarantine policies arising from the pandemic. After considering different means to raise funds for maintaining the operation of this business segment and with debt financing being the only option viable at the time.

On 4 September 2020, the CL Borrower and the CL Lender, entered into the CL Loan Agreement, pursuant to which the CL Lender should advance to the CL Borrower a one-year loan (the "**CL Loan**") in the principal amount of HK\$30,000,000 bearing interest at a rate of 5% per annum, to be secured by a share mortgage (the "**CL Share Mortgage**") granted by the Company in favour of the CL Lender over 51% interest in the CL Borrower held by the Company, for securing the repayment obligations of the CL Borrower under the CL Loan Agreement. The CL Lender shall not be obliged to advance the CL Loan or any part thereof to the CL Borrower unless the following conditions precedent have all been fulfilled: (a) the Board has approved the CL Loan Agreement, the CL Share Mortgage and the transactions contemplated thereunder respectively; (b) the Shareholder(s) have approved the CL Loan Agreement, the CL Share Mortgage and the transactions contemplated thereunder pursuant to Rule 20.34 or Rule 20.35 of the GEM Listing Rules; and (c) the CL Lender has received the executed CL Loan Agreement and the CL Share Mortgage. As at the date of this report, all of the above conditions precedent were fulfilled and the CL Loan has been fully drawn down.

The CL Borrower and its subsidiaries are principally involved in the provision of IT services. As a result of the fierce industry competition, the CL Borrower has been recording a net loss since its financial year ended 31 December 2017. Due to the dire financial situation of the CL Borrower, the Company had been exploring various financing possibilities. Given that debt financing was the only viable option at the time, the CL Borrower entered into the CL Loan Agreement with the CL Lender on 4 September 2020.

Details of the CL Loan are set out in the announcement of the Company dated 4 September 2020 and the circular of the Company dated 24 September 2020. 受新型冠狀病毒疫情影響,本集團的移動互聯 網文化業務及資訊科技服務業務的現金流量 面臨巨大壓力,原因為本集團經營效益因抗擊 疫情所實施的隔離政策而受到不利影響。為維 持此業務分部運營,本集團考慮過多種籌集資 金的方式,債務融資為當時唯一可行的選擇。

於二零二零年九月四日,協盟借款人與協盟 貸款人訂立協盟貸款協議,據此,協盟貸款人 應向協盟借款人發放本金額為30,000,000港 元之一年期貸款(「**協盟貸款**」),按年利率5% 計息,由本公司以協盟貸款人為受益人就本公 司所持協盟借款人51%權益作出之股份押記 (「協盟股份押記」)作抵押,用以擔保協盟借 款人於協盟貸款協議項下之還款責任。除非以 下各項先決條件均獲達成,否則協盟貸款人毋 須向協盟借款人發放協盟貸款或其任何部分: (a) 董事會已分別批准協盟貸款協議、協盟股 份押記及其項下擬進行之交易;(b)股東已根 據GEM上市規則第20.34或20.35條批准協盟 貸款協議、協盟股份押記及其項下擬進行之交 易;及(c)協盟貸款人收到已簽署的協盟貸款 協議及協盟股份押記。於本報告日期,上述所 有先決條件均已達成且協盟借款人已全數提 取協盟貸款。

協盟借款人及其附屬公司之主要業務為提供 資訊科技服務。由於行業競爭激烈,協盟借款 人自截至二零一七年十二月三十一日止財政 年度以來持續錄得淨虧損。由於協盟借款人所 面臨的財務困境,本公司一直在探索各種融資 可能性。鑒於債務融資為當時唯一可行的選 擇,協盟借款人與協盟貸款人於二零二零年九 月四日訂立協盟貸款協議。

有關協盟貸款的詳情載於本公司日期為二零 二零年九月四日的公佈及本公司日期為二零 二零年九月二十四日的通函。 In addition to the provision of IT services above, the Group has also invested in the mobile-online game business. As at the date of this report, the Group holds 28.8% of the issued share capital of Something Big Technology Holdings Limited ("Something **Big**", together with its subsidiaries and controlled companies, "Something Big Group"), which is principally engaged in the design, development, marketing, distribution and operation of mobile-online games. During the year under review, the Group's share of the loss from Something Big Group amounted to approximately HK\$1,306,000 (2019: HK\$6,745,000). Since the Group's share of such loss for the year ended ended 31 December 2020 is in excess of the carrying amount of the Group's investment in Something Big Group, the carrying amount of this investment has been reduced to zero as at 31 December 2020. During the year under review, Something Big Group has been making a loss due to the fierce competition in the mobile-online game market in the PRC and lack of new innovative games for launch by Something Big Group.

Hospitality and Related Services in Australia

The Group was engaged in the hospitality business mainly through its three venues located in Victoria, Australia, namely the Balgownie Estate Vineyard Resort & Spa Yarra Valley, Bellinzona Resort Cellar Door & Dining and Cleveland Winery Resort & Events (collectively, the "**Resorts**").

The Balgownie Estate Vineyard Resort & Spa Yarra Valley, which is located in the Yarra Valley, is a popular winery and tourism destination in Victoria, Australia. It is a 4.5-star rated resort and the winner of Tourism Accommodation Australia (TAA) for Best Resort Style Accommodation four years in a row from 2016 to 2019. It consists of a piece of freehold land of approximately 29 hectares with a 7-hectare vineyard growing Pinot and Chardonnay wine grapes, and offers 70 luxury accommodation rooms, day spa, health club facilities, cellar door, restaurant and conference facilities. The resort is one of the few in the Yarra Valley region offering such comprehensive services and facilities, which give it a strong competitive advantage.

The Bellinzona Resort Cellar Door & Dining is located in Hepburn Springs, Daylesford, the heart of the Victoria's spa region. The resort includes a piece of freehold land of approximately one hectare and comprises 43 elegant hotel rooms, including deluxe spa suites, an indoor swimming pool, a wine bar, a heritage restaurant and purposely built conference facilities catered for small to large conferences.

Cleveland Winery Resort & Events is located in Lancefield, Macedon Ranges. The resort includes a piece of freehold land of approximately 40 hectares comprising a 3-hectare vineyard growing cool climate Pinot, Chardonnay and a sparkling wine grape, 50 ensuite rooms, a restaurant and extensive conference facilities, including several lounges and breakout areas.

During the year under review, the Group recorded a revenue of approximately HK\$33,946,000 (2019: HK\$95,043,000) for its segment of provision of hospitality and related services in Australia.

除上述資訊科技服務外,本集團亦已投資移動網絡遊戲業務。於本報告日期,本集團持有大事科技控股有限公司(「大事科技」,連同其附屬公司及受控制公司統稱為「大事科技集團」) 28.8%的已發行股本,大事科技主要從事設計、開發、營銷、分銷及運營移動網絡遊戲。 於回顧年度,本集團分佔大事科技集團虧損約1,306,000港元(二零一九年:6,745,000港元)。由於本集團分佔的截至二零二零年十二 月三十一日止年度的虧損超過本集團於大事科技集團投資的賬面值,於二零二零年十二月 三十一日,此項投資的賬面值已撇減至零。於 回顧年度,大事科技集團錄得虧損,乃主要由 於中國移動網絡遊戲市場競爭激烈及大事科 技集團新的創新遊戲推出不足所致。

於澳洲提供酒店及相關服務

本集團先前主要通過其於澳洲維多利亞的三 處物業從事酒店業務,即博爾基尼酒莊水療度 假村、貝林佐納度假村及克里夫蘭酒莊度假村 (統稱為「**度假村**」)。

博爾基尼酒莊水療度假村位於亞拉河谷,該地區為澳洲維多利亞受人青睞之釀酒廠及旅遊勝地。博爾基尼酒莊水療度假村是4.5星級的度假村,於二零一六年至二零一九年連續四年獲澳洲旅遊住宿協會頒授「年度度假村住建」。其包括一幅面積約為29公頃之永久業權土地,擁有種植比諾及霞多麗葡萄酒葡萄的7公頃葡萄園,並提供70間豪華客房、水療、健身俱樂部設施、酒窖、餐廳及會議設施。該度假村是亞拉河谷地區少數幾個擁有如此全面的服務及設施的度假村之一,具有強大的競爭優勢。

貝林佐納度假村位於維多利亞水療區的中心 戴爾斯福德的赫本溫泉。此度假村包括一幅面 積約為1公頃之永久業權土地,擁有43間優雅 的酒店客房,包括豪華水療套房、室內游泳池、 酒吧、傳統餐廳以及適合小型至大型會議的功 能性會議設施。

克里夫蘭酒莊度假村位於馬其頓山脈的蘭斯 菲爾德,包括一幅面積約為40公頃之永久業權 土地,擁有種植涼爽氣候下的比諾、霞多麗和 起泡葡萄酒葡萄的3公頃葡萄園、50間套房、 餐廳及寬敞的會議設施(包括幾個休息室及 休息區)。

於回顧年度,本集團就於澳洲提供酒店及相 關服務分部錄得收入約33,946,000港元(二零 一九年:95,043,000港元)。

The decline in revenue generated from this segment of the Group was mainly due to the drop in the average occupancy rate of the Resorts from approximately 49% for the year ended 31 December 2019 to approximately 22% for the year ended 31 December 2020, which was mainly attributable to the declining economic growth in Australia and the global outbreak of COVID-19, resulting in a reduction in the demand for the services of the Resorts, which is expected to continue to decrease until the first guarter of 2021. In view of the restrictions put in place by the Australian government to combat COVID-19, the Group suspended the operation of the Resorts for the first time on 30 March 2020. On 8 May 2020, the Australian Prime Minister announced a three-step plan for reopening Australia, which would be implemented by the state and territory governments as they see fit. The government of the state of Victoria announced the gradual easing of the restrictions throughout Victoria with effect from 11:59 p.m. on 31 May 2020. In particular, tourist accommodation may be re-opened to guests provided there are no shared communal facilities, such as kitchens and bathrooms, and dine-in service for restaurants, cafes and other hospitality businesses may be resumed under certain restrictions and requirements, including those on the number of patrons per enclosed space and the spacing between the tables. The operation of the Resorts was partially resumed in June 2020, which took place in stages in line with the progress of the lifting of the restrictions by the government. However, the resurgence of new COVID-19 cases on 7 July 2020 prompted the government of the state of Victoria to reintroduce Stage 3 Stay at Home restrictions across the state of Victoria to help slow the spread of COVID-19. With effect from 6 p.m. on 2 August 2020, the government of the state of Victoria introduced Stage 4 restrictions for Melbourne, under which a curfew would be in place from 8 p.m. to 5 a.m. every evening. While curfews are in operation, people are only allowed to leave their house for work and essential health, care or safety reasons. Outside of these hours, people are only allowed to leave their houses for one of the following reasons: (i) to purchase food and necessary supplies; (ii) to exercise; (iii) to care and health care; (iv) to work; and (v) for personal reasons, such as visiting an intimate partner, parenting arrangements, etc. From midnight on 6 August 2020, residents were encouraged to stay at home unless for (a) shopping for food and supplies; (b) receiving care and caregiving; 本集團此分部產生的收益下降主要是由於度 假村的平均入住率由截至二零一九年十二月 三十一日止年度的約49%降至截至二零二零 年十二月三十一日止年度的約22%,此乃主 要由於澳洲經濟增長下滑及全球爆發新型冠 狀病毒疫情,導致對度假村服務的需求下降, 且下降趨勢預期將持續直至二零二一年第一 季度。鑒於澳洲政府為抗擊新型冠狀病毒疫情 而制定的限制措施,本集團自二零二零年三月 三十日起首次暫停度假村之營運。於二零二零 年五月八日,澳洲總理就重新開放澳洲宣佈一 項三階段計劃,由州政府和領地政府酌情實 施。維多利亞州政府宣佈逐步放寬維多利亞州 全境的限制措施,自二零二零年五月三十一 日午夜十一時五十九分起生效。其中,在無共 用廚房及浴室等公共設施的條件下,旅館可重 新向遊客開放,而餐廳、咖啡店及其他餐飲店 可在符合若干限制及規定(包括有關每個封 閉空間的顧客人數及餐桌之間的間隔的限制 及規定)的條件下恢復堂食服務。根據政府解 除限制措施的進度,本集團於二零二零年六月 分階段恢復部分度假村營運。然而,於二零二 零年七月七日,新增新型冠狀病毒病例再度飆 升,促使維多利亞州政府在維多利亞州全境重 新實施三級居家限制令,以減緩新型冠狀病毒 傳播。自二零二零年八月二日下午六時起,維 多利亞州政府對墨爾本實施四級封鎖措施,晚 上八時至清晨五時實施宵禁。在宵禁期間,除 非因工作及必要的醫療、護理或安全所需,居 民不可外出。於宵禁時段外,除非出於以下原 因,否則居民不得離開住所:(i)購買食物及必 需品;(ii)鍛鍊;(iii)獲得護理及醫療;(iv)工作; 及(v) 個人原因, 如拜訪親密伴侶、育兒安排 等。自二零二零年八月六日午夜起,鼓勵居民 居家隔離,盡量減少外出,除非是為了(a)購買 食物及日用品;(b)獲得護理及看護;(c)鍛鍊 及戶外運動;及(d)學習及工作。鑒於實施新限 制措施,本集團自二零二零年七月九日起再度 暫停度假村之營運直至另行通知為止,恢復營 運時間取決於澳洲境內新型冠狀病毒疫情進 展及澳洲政府的政策。維多利亞州政府宣佈, 自二零二零年九月十六日午夜十一時五十九 (c) exercising and outdoor recreation; and (d) studying and working. In view of these new restrictions, the Group temporarily suspended the operation of the Resorts again with effect from 9 July 2020 until further notice, subject to the development of COVID-19 in Australia and the policies of the Australian government. The government of the state of Victoria announced the gradual easing of the restrictions throughout Victoria with effect from 11:59 p.m. on 16 September 2020. Restrictions were eased to allow restaurants and some outdoor entertainment venues to open. Restaurants opened in a predominantly outdoor capacity, with a group limit of 10 people, and density limits. With effect from 11:59 p.m. on 27 October 2020, the government of the state of Victoria introduced stage 3 easing of restrictions for Melbourne, under which restaurants and cafes are allowed to open for outdoor and indoor seated service of food or drink. subject to limits on the number of customers and distance between tables. The operation of the Balgownie Estate Vinevard Resort & Spa Yarra Valley partially resumed in November 2020. and the resumption of its operation would take place in stages in line with the progress of the lifting of the restrictions by the government. All these restrictions have resulted in a significant decline in bookings in tourism accommodation across the state of Victoria.

Under the impact of the COVID-19 pandemic, the Group recorded a revenue for the Balgownie Estate Vineyard Resort & Spa Yarra Valley and the Cleveland Winery Resort & Events of approximately HK\$28,801,000 (2019: HK\$80,521,000), representing an decrease of 64% as compared with that in last year.

In addition, impairment loss on property, plant and equipment of approximately HK\$8,512,000 was recognised during the year under review (2019: HK\$23,616,000) as the recoverable amount of the buildings was lower than the carrying amount. 分起逐步放寬維多利亞州全境的限制措施,其 中包括允許餐廳及若干戶外娛樂場所開放。餐 廳主要以戶外經營為主,團體就餐人數限制為 10人,人員密度亦有限制。自二零二零年十月 二十七日午夜十一時五十九分起,維多利亞州 政府對墨爾本放寬第三階段限制,允許餐廳及 咖啡店提供室外及室內餐飲服務,但須限制顧 客人數及餐桌間距離。博爾基尼酒莊水療度假 村於二零二零年十一月恢復部分營運,後續將 根據政府解除限制的進度分階段逐步恢復營 運。前述限制措施導致維多利亞州境內旅館住 宿預訂大幅下降。

受新型冠狀病毒疫情影響,本集團就博爾基 尼酒莊水療度假村及克里夫蘭酒莊度假村 錄得收入約28,801,000港元(二零一九年: 80,521,000港元),較去年減少64%。

此外,於回顧年度內,由於樓宇之可收回金 額低於賬面值,故就物業、廠房及設備確認 減值虧損約8,512,000港元(二零一九年: 23,616,000港元)。

In June 2020, there was a fire at the Balgownie Estate Vineyard Resort & Spa Yarra Valley which had destroyed the restaurant and cellar door of the resort. The Group had insurance coverage for rebuilding the restaurant and the cellar door. During the year under review, the Group has started the reconstruction of the restaurant and the cellar door, the completion of which is expected to take place in the third quarter of 2021. The Group also set up a temporary restaurant and cellar door to provide dining and wine tasting facilities to the inhouse guests staying at the resort during the year.

On 12 June 2020, the Group entered into two sale and purchase agreements with certain independent third parties in respect of the Bellinzona Disposals, at an aggregate consideration of AUD3,575,000 (equivalent to approximately HK\$19,135,000). In light of the declining economic growth in Australia and the global outbreak of COVID-19, the demand for the services of the Bellinzona Resort Cellar Door & Dining substantially decreased in 2019 and the first quarter of 2020, and such decrease is expected to continue until the first guarter of 2021. In view of the above and taking into account that, among the three Resorts, the Bellinzona Resort Cellar Door & Dining had been the worst performing resort over the past two years, the Directors considered that the Bellinzona Disposals provided a good opportunity for the Group to re-allocate its resources to the development of the Balgownie Estate Vineyard Resort & Spa Yarra Valley, which was likely to achieve a more rapid recovery due to its competitive advantages, including its geographical location, which is in an area popular among tourists.

After the completion of the Bellinzona Disposals on 25 August 2020, the assets and the financial results of the Bellinzona Resort Cellar Door & Dining were no longer accounted for in the consolidated financial statements of the Group.

Details of the Bellinzona Disposals are set out in the announcements of the Company dated 12 June 2020 and 17 June 2020.

於二零二零年六月,博爾基尼酒莊水療度假村 發生火災,度假村的餐廳及酒窖遭到破壞。本 集團先前已投購保險,餐廳及酒窖重建成本將 由保險公司承擔。於回顧年度,本集團已開始 重建餐廳及酒窖,預計將於二零二一年第三季 度完工。本集團已開設一間臨時餐廳及酒窖, 為年內入住度假村的賓客提供餐飲及品酒場 所。

於二零二零年六月十二日,本集團與若干第三 方就貝林佐納出售事項訂立兩份買賣協議,總 代價為3,575,000澳元(相當於約19,135,000港 元)。由於澳洲經濟增長下滑及全球爆發新型 冠狀病毒疫情,二零一九年及二零二零年第一 季度貝林佐納度假村的服務需求大幅下降,且 下降趨勢預期將持續至二零二一年第一季度。 鑒於上述情況,並經考慮到於過去兩年三個度 假村中,貝林佐納度假村的表現最差,董事認 為,貝林佐納出售事項對本集團而言實屬良 機,本集團可藉此重新分配資源以發展博爾基 尼酒莊水療度假村。博爾基尼酒莊水療度假村 具有競爭優勢(包括位於遊客熱門地區的地 理位置優勢),更有望快速實現復甦。

於二零二零年八月二十五日貝林佐納出售事 項完成後,貝林佐納度假村之資產及業績不再 計入本集團之綜合財務報表。

貝林佐納出售事項之詳情載於本公司日期為 二零二零年六月十二日及二零二零年六月 十七日之公佈。 Although the operation of the provision of hospitality and related services in Australia segment was negatively affected by the COVID-19 pandemic, the liquidity and working capital sufficiency of such segment did not seriously worsen due to the receipt of consideration from the Bellinzona Disposals and the absence of further operating costs for Bellinzona Resort Cellar Door & Dinging since August 2020. Further, in the year under review, the Group has taken strict cost control measures with respect to such segment, for example, carefully adjusting labour and resources to be used in the segment in light of the lower demand for hospitality and related services in Australia.

On 8 February 2021, the Group entered into two sale and purchase agreements with certain independent third parties in respect of the Cleveland Disposals, at an aggregate consideration of AUD4,000,000 (equivalent to approximately HK\$23,803,000). In light of the declining economic growth in Australia and the global outbreak of COVID-19, the demand for the services of the Cleveland Winery Resort & Events has substantially decreased since the first guarter of 2020, and such decrease is expected to continue until the first guarter of 2021. In view of the above and taking into account that, the Cleveland Winery Resort & Events had not been performing well over the past two years, the Directors considered that the Cleveland Disposals would provide a good opportunity for the Group to re-allocate its resources to the development of the Balgownie Estate Vineyard Resort & Spa Yarra Valley, which was likely to achieve a more rapid recovery due to its competitive advantages, including its geographical location, which is in an area popular among tourists.

Upon completion of the Cleveland Disposals, the assets and the financial results of the Cleveland Winery Resort & Events will no longer accounted for in the consolidated financial statements of the Group.

Details of the Cleveland Disposals are set out in the announcement of the Company dated 8 February 2021.

儘管於澳洲提供酒店及相關服務分部之營運 受到新型冠狀病毒疫情之負面影響,但由於收 到貝林佐納出售事項之代價及貝林佐納度假 村自二零二零年八月起不再產生進一步營運 成本,故該分部之流動資金及營運資金充足性 並無嚴重惡化。此外,於回顧年度,本集團已 就該分部採取嚴格的成本控制措施,例如,鑒 於澳洲酒店及相關服務的需求低迷,本集團審 慎調整該分部使用的勞動力及資源。

於二零二一年二月八日,本集團與若干獨立第 三方就克里夫蘭出售事項訂立兩份買賣協議, 總代價為4,000,000澳元(相當於約23,803,000 港元)。由於澳洲經濟增長下滑及全球爆發新 型冠狀病毒疫情,克里夫蘭酒莊度假村的服務 需求自二零二零年第一季度以來大幅下降,且 下降趨勢預期將持續至二零二一年第一季度。 鑒於上文所述及考慮到克里夫蘭酒莊度假村 於過去兩年表現欠佳,董事認為,克里夫蘭 於量、上文所述及考慮到克里夫蘭酒莊度假村 於過去兩年表現欠佳,董事認為,克里夫蘭出 售事項對本集團而言實屬良機,本集團可藉此 重新分配資源以發展博爾基尼酒莊水療度假 村。博爾基尼酒莊水療度假村具有競爭優勢(包 括位於遊客熱門地區的地理位置優勢),更有 望快速實現復甦。

於克里夫蘭出售事項完成後,克里夫蘭酒莊度 假村之資產及財務業績將不再計入本集團之 綜合財務報表。

克里夫蘭出售事項之詳情載於本公司日期為 二零二一年二月八日之公佈。

Money Lending Business

The Group is engaged in the money lending business in Hong Kong through its wholly-owned subsidiary, Mark Profit Finance Limited, which is a holder of a money lender's licence under the Money Lenders Ordinance (Chapter 163 of the Laws of Hong Kong). During the year under review, the Group recorded interest income of approximately HK\$2,045,000 (2019: HK\$1,642,000) from its money lending business. The Group has been paying close attention to the market conditions and will continue to monitor its resources to strive for the development of its money lending business with prudent credit procedures in accepting customers.

On 13 July 2020, Mega Strength Limited ("MSL"), a wholly-owned subsidiary of the Company, entered into a memorandum of understanding (the "MOU") with the Target Company, in respect of the possible subscription (the "Possible **Subscription**") for 51% equity interest in the Target Company by the Group with an exclusivity period of up to 13 January 2021. The MOU may or may not lead to the entering into of the formal agreement for the Possible Subscription and the transactions contemplated thereunder may or may not be consummated. The Target Company, which has been granted a loan in the principal amount of US\$1,000,000 (equivalent to approximately HK\$7,800,000) maturing on 13 January 2021 (the "TNG Loan") by Mark Profit Finance Limited on 13 July 2020, is an investment holding company, the subsidiaries of which are principally engaged in mobile top-up distribution business, grocery mini-mart operations and co-branded digital wallet business in Indonesia.

On 13 January 2021, Mark Profit Finance Limited entered into a supplement agreement with, inter alia, the Target Company to extend the maturity date of the TNG Loan to 13 April 2021. MSL and the Target Company has entered into an addendum to the MOU to extend the expiry date of the exclusivity period to 13 April 2021. On 9 March 2021, the Group entered into a subscription agreement with, among others, the Target Company pursuant to which the Group subscribed for 51% of the enlarged issued share capital of the Target Company at the consideration of US\$1,000,000 (equivalent to HK\$7,800,000), which has been set off against the TNG Loan, details of which are set out in the paragraph headed "EVENTS AFTER THE REPORTING YEAR" below.

Details of the TNG Loan are set out in the announcements of the Company dated 13 July 2020. 13 January 2021 and 9 March 2021.

借貸業務

本集團透過其全資附屬公司百利財務有限公司在香港從事借貸業務。該公司乃根據放債 人條例(香港法例第163章)持有放債人牌照。 於回顧年度,本集團自借貸業務錄得利息收入 約2,045,000港元(二零一九年:1,642,000港 元)。本集團一直密切關注市場狀況及持續監 控其資源,致力發展借貸業務,同時會對客戶 採用審慎的信貸程序。

於二零二零年七月十三日,本公司之全資附屬 公司Mega Strength Limited (「MSL」)與目標 公司訂立諒解備忘錄(「諒解備忘錄」),內容 有關本集團擬認購目標公司51% 權益(「可能 認購事項」)並訂明獨家期至二零二一年一月 十三日。諒解備忘錄未必一定會導致訂立可能 認購事項之正式協議,而據此擬進行之交易未 必一定會完成。目標公司於二零二零年七月 十三日獲百利財務有限公司授出一筆本金額 為1,000,000美元(相當於約7,800,000港元)的 貸款,到期日為二零二一年一月十三日(「TNG 貸款」)。目標公司為一間投資控股公司,其附 屬公司主要於印尼從事移動充值卡分銷業務、 雜貨店營運及聯名電子錢包業務。

於二零二一年一月十三日,百利財務有限公 司與(其中包括)目標公司訂立補充協議, 將TNG貸款的到期日延長至二零二一年四月 十三日。MSL與目標公司已訂立諒解備忘錄之 補充文件,將獨家期之到期日延長至二零二一 年四月十三日。於二零二一年三月九日,本集 團與(其中包括)目標公司訂立認購協議,據 此,本集團認購目標公司經擴大已發行股本之 51%,代價為1,000,000美元(相當於7,800,000 港元),已與TNG貸款抵銷,詳情載於下文「報 告年度後事項」一段。

TNG貸款之詳情載於本公司日期為二零二零 年七月十三日、二零二一年一月十三日及二零 二一年三月九日之公佈。

Assets Investments Business

During the year under review, the Group recorded a segment profit from its assets investment business of approximately HK\$5,157,000 (2019: segment loss of approximately HK\$28,388,000), the change was primarily attributable to the combined effect of (i) the reversal of provision for the litigations which amounted to approximately HK\$2,777,000 (2019: provision for the litigations amounting to approximately HK\$32,796,000) for the year under review; and (ii) the increase in the fair value loss on financial assets at FVTPL from approximately HK\$579,000 during the year ended 31 December 2019 to approximately HK\$2,409,000 during the year ended 31 December 2020, which were mainly attributable to the Group's investments in Town Health International Medical Group Limited ("Town Health") (the shares of which are listed on the Main Board of the Stock Exchange (Stock Code: 3886) and approximately 1.25% of the total issued shares of which were held by the Group as at 31 December 2020) of approximately HK\$36,933,000 (2019: HK\$38,534,000). Given the trading of the shares of Town Health on the Stock Exchange was suspended as at 31 December 2020, the fair value of the Group's investment in Town Health as at 31 December 2020 was arrived at on the basis of a valuation carried out by an independent qualified professional valuer not connected to the Group, using the index return method, which is a generally accepted approach in the industry, where the last trading price of the shares of Town Health was adjusted by the return of a synthetic index. Assumptions used in the valuation include: (a) no material change in the existing conditions which might adversely affect the business of Town Health; (b) prospective earnings would provide a reasonable estimate on the fair market value of the assets held by Town Health; (c) reliance by the valuer on the assistance and information provided by the Company; and (d) information related to the valuation would be made available to and reviewed by the valuer. Inputs including (a) the return of other comparable publicly listed companies ranging from -68.32% to -34.29% from the last trading date to their year-end dates; (b) business nature and financial reports of Town Health; (c) publication and research reports of the related industry; and (d) reliable sources of market data were applied in the valuation. There was neither significant change in the value of the inputs and assumptions from those used in the valuation in the prior year nor subsequent change to the valuation method adopted.

資產投資業務

於回顧年度,本集團錄得其資產投資業務分 部溢利約5,157,000港元(二零一九年:分部 虧損約28,388,000港元),該變動主要是以下 兩者的綜合影響所致:(i)於回顧年度撥回訴 訟撥備約2,777,000港元(二零一九年:計提) 訴訟撥備約32,796,000港元);及(ii)按公平 值透過損益列賬之金融資產的公平值虧損由 截至二零一九年十二月三十一日止年度的約 579,000港元增加至截至二零二零年十二月 三十一日止年度的約2,409,000港元,主要歸 因於本集團於康健國際醫療集團有限公司(「康 健」)(其股份於聯交所主板上市(股份代號: 3886),於二零二零年十二月三十一日其已發 行股份總數約1.25%由本集團持有)的投資 約36,933,000港元(二零一九年:38,534,000 港元)。鑒於康健的股份於二零二零年十二月 三十一日於聯交所暫停買賣,於二零二零年 十二月三十一日,本集團於康健之投資的公平 值乃根據與本集團並無關連之獨立合資格專 業估值師所作估值達致。該估值使用指數回報 法,而該方法為業內公認方法,故康健股份最 後成交價經綜合指數的回報調整。估值中使 用的假設包括:(a)現狀並無出現或會對康健 業務造成不利影響的重大變動;(b)預期盈利 將就康健所持資產的公平市值作出合理的估 計;(c)估值師對本公司提供的協助及資料的 倚賴;及(d)與是次估值有關的資料將可供估 值師閱覽並由估值師審閱。應用於估值的輸入 數據包括(a)其他可省比較公眾上市公司於康 健之最後交易日至年度結算日介乎-68.32% 至-34.29%的回報;(b)康健的業務性質及財 務報告;(c)有關行業的公佈及研究報告;及(d) 可靠市場數據來源。過往年度估值所用之輸入 數據數值及假設及隨後已應用的估值方法均 無發生重大變動。

On 3 March 2021 and 10 March 2021, the Group disposed of 4,000 and 81,374,000 shares in Town Health for an aggregate cash consideration (excluding transaction costs) of approximately HK\$3,000 and HK\$22,886,000 respectively on the open market of the Stock Exchange via Southbound Trading of Shanghai-Hong Kong Stock Connect ("**TH Disposals**"). Details of the TH Disposals are set out in the announcement of the Company dated 10 March 2021.

In addition to financial assets at FVTPL, the Group recorded fair value gain on financial assets at fair value through other comprehensive income (**"FVTOCI**") of approximately HK\$1,660,000 during the year under review (2019: HK\$77,329,000).

As at 31 December 2020, the Group recorded financial assets at FVTPL of approximately HK\$55,519,000 (2019: HK\$41,289,000) and financial assets at FVTOCI of approximately HK\$177,728,000 (2019: HK\$169,309,000). The Directors consider securities investments with a carrying amount that accounts for more than 5% of the Group's total assets as at 31 December 2020 as significant securities investments of the Group. Details of the significant securities investments of the Group as at 31 December 2020 are as follows:

Prospects of the Group's significant securities investments

LEO is a company incorporated in the PRC with limited liability, the shares of which are listed on the Shenzhen Stock Exchange (Stock Code: 002131). LEO is principally engaged in the manufacturing and sale of industrial and domestic pumps and internet services including digital marketing business, marketing strategy and innovation, media delivery and execution, monitoring and optimisation of marketing results and precise marketing, etc. Since the listing of the shares of LEO on the Shenzhen Stock Exchange, the business scope of LEO has gradually expanded from a purely domestic pumps business in the PRC to an industrial pump business in the PRC, covering almost all the pump products in the entire pump industry in the country. Given that the growth of the traditional pump manufacturing business has stabilised, LEO has been actively seeking for a new breakthrough in its strategic development and striving to explore growth opportunities beyond the traditional pump industry, so as to improve its profitability and develop new profit growth. In 2014, LEO successfully expanded its principal business into the internet service business through a series of acquisitions. The internet services LEO provides include digital marketing services and digital media agency services. Based on LEO's announcement in relation to its predicted annual results for 2020, it has predicted a net profit attributable to its owners of approximately RMB4,730 million to RMB4,830 million (2019: RMB308 million) for the year ended 31 December 2020, representing an increase of approximately from 1,438% to 1,470% compared with that of the previous year. The increase was mainly attributable to the increase in the fair value on financial assets during the year ended 31 December 2020.

本集團重大證券投資之前景

利歐為一間於中國註冊成立之有限公司, 其股份於深圳證券交易所上市(股份代號: 002131)。利歐主要從事工業用及家用水泵生 產及銷售以及網絡服務(包括數字營銷業務、 營銷策略與創意、媒介投放及執行、營銷效果 監測及優化以及精準營銷等)。自利歐股份於 深圳證券交易所上市以來,利歐業務範圍已逐 漸由單純的中國家用水泵業務擴展至中國工 業用水泵業務,幾乎覆蓋國內整個水泵行業所 有水泵產品。鑒於中國傳統水泵生產業務增長 已穩定,利歐已積極為其策略發展尋求新突破 口, 並致力於發現傳統水泵行業以外的增長機 會,以改善其盈利能力以及開發新溢利增長。 於二零一四年,利歐透過一系列收購,成功將 其主要業務擴展至網絡服務業務。利歐提供之 網絡服務包括數字營銷服務以及數字媒體代 理服務。根據利歐發佈的二零二零年全年業績 預告,利歐於截至二零二零年十二月三十一 日止年度錄得其擁有人應佔溢利淨額約人民 幣4,730,000,000元至人民幣4,830,000,000元 (二零一九年:人民幣308,000,000元),較上 年增加約1.438%至1.470%,主要歸因於截至 二零二零年十二月三十一日止年度其金融資 產之公平值增加。

With regards to the prospects of LEO based on the published information, the Directors noted that LEO had been actively expanding its digital marketing services through both vertical and horizontal integrations in recent years to capture the business opportunities arising from the new internet-based interactive entertainment pattern, which resulted in a growth in its revenue. The Directors noted that LEO had received recognitions in the market in recent years, being a sign of the success of LEO in its business development.

In addition, as at 31 December 2020, the Group held 10,650 ordinary shares of Luck Key Investment Limited ("Luck Key"), representing 48.33% of the equity interest of Luck Key, the investment cost of which was approximately HK\$56,511,000. As at 31 December 2020, the carrying amount of this investment was approximately HK\$84,939,000, representing approximately 7.46% of the total assets of the Group as at 31 December 2020. During the year under review, the share of total comprehensive income of the investment attributable to the Group amounted to approximately HK\$6,495,000, no realised gain was recorded and no dividend income was received from this investment. Luck Key together with its subsidiaries are principally engaged in the provision of medical diagnostic and health check services and operated 8 health check centres and 1 testing laboratory as at the date of this Annual Report. During the year under review, revenue of Luck Key amounted to approximately HK\$196,294,000 (2019: HK\$210,155,000), representing a decrease of approximately 6.6%. The profit for the year attributable to the shareholders of Luck Key for the year under review amounted to approximately HK\$13,440,000 (2019: HK\$14,012,000). The management of Luck Key will strive to improve the operational efficiency of its health check business so as to enhance its competitiveness in the market and its profitability.

The Group will continue to hold the investments in its portfolio, unless there are changes in its investment strategy or potential opportunities in realising its existing investments in securities arise, taking into account the prospects of the issuers of the securities investments and the Group's objectives to optimise the returns from its investment portfolios and create value for the Shareholders. 就根據已刊發資料所示利歐之前景而言,董事 注意到利歐近年來一直透過縱向及橫向整合 積極擴大其數字營銷服務,以捕捉基於互聯網 的新互動娛樂模式帶來的商機,這使得其收益 增長。董事注意到,利歐近幾年獲得數字營銷 服務市場認可,表明利歐於其業務發展中取得 成功。

此外,於二零二零年十二月三十一日,本集 團持有10,650股Luck Key Investment Limited (「Luck Key」) 普通股,相當於Luck Key 48.33%的股權,投資成本約56,511,000港元。 於二零二零年十二月三十一日,該投資賬面值 約為84,939,000港元,相當於本集團於二零二 零年十二月三十一日的資產總值的約7.46%。 於回顧年度,本集團應佔投資全面收益總額 約6,495,000港元,且並無錄得已變現收益及 並無收到來自該投資的股息收入。Luck Key連 同其附屬公司主要從事提供醫學診斷及體檢 服務,於本年報日期運營著8個體檢中心及1間 測試實驗室。於回顧年度, Luck Key 收益為約 196,294,000港元(二零一九年:210,155,000 港元),相當於減少約6.6%。於回顧年度Luck Kev 股東應佔溢利約為13,440,000港元(二零 一九年:14,012,000港元)。Luck Key管理層致 力提升其體檢業務的營運效能,以此提升其於 市場的競爭力及其盈利能力。

經計及證券投資發行公司之前景以及本集團 優化其投資組合回報及為股東創造價值的目標,除非其投資策略有變或出現變現其現有證 券投資的潛在機會,否則本集團將繼續維持其 現有投資組合。

PROSPECTS

The negative impacts of the outbreak of COVID-19 on the global economy are enormous. The operation and financial performance of the Group's businesses of mobile internet cultural business and provision of IT services and provision of hospitality and related services in Australia during the year under review have been adversely affected by COVID-19.

Going forward, the Group will continue to closely monitor the development of the COVID-19 pandemic and its impacts on the Group's businesses, and the Group will proactively take measures to mitigate the adverse impacts of COVID-19 on its businesses. In particular, the Group has been identifying investment opportunities to diversify its businesses.

In March 2021, the Group subscribed for 10,200 ordinary shares of the Target Company, representing 51% of the issued share capital of the Target Company upon completion as enlarged by the allotment and issue of such shares, at the subscription price of US\$1,000,000 (equivalent to HK\$7,800,000). The Target Company holds 79% of the issued shares of a company incorporated in Singapore, which holds 99% of the issued shares of the TNG Indonesia, which is a company incorporated in Indonesia with limited liability and an investment holding company and 1% of the issued shares of TNG Indonesia is held by the Target Company. TNG Indonesia holds 49% of the issued shares of TNG Indompet, which is a company incorporated in Indonesia with limited liability. 51% of the issued shares of TNG Indompet is held by an individual who has pledged such interest in favour of TNG Indonesia pursuant to the contractual arrangements, details of which are set out in the Company's announcement dated 9 March 2021. TNG Indompet is principally engaged in (1) Indosat mobile top-up distribution business and (2) the cobranding "W-Cash" electronic wallet with a licensed e-money issuer in Indonesia pursuant to the cooperation between TNG Indompet and such e-Money issuer. The Group believes that its investment in the Target Company provides it an opportunity to develop its business in Indonesia as well as the bordering areas, and will also strongly complement the Group's mobile internet cultural business and provision of IT services and money lending business as well as providing overall synergistic benefits to its principal activities. Following the investment in the Target Company, the Group is also exploring the business opportunities in the development and operation of FinTech platform for microlending in Hong Kong and Southeast Asia such as Indonesia.

To further diversify its businesses, the Group also intends to engage in provision of medical services in Hong Kong and is currently identifying potential clinic(s) and medical centre(s) in Hong Kong.

前景

新型冠狀病毒疫情爆發對全球經濟造成巨大 負面影響。於回顧年度,本集團的移動互聯網 文化業務及資訊科技服務業務以及於澳洲提 供酒店及相關服務業務的經營及財務表現均 因新型冠狀病毒疫情受到不利影響。

未來,本集團將持續密切關注新型冠狀病毒疫 情的發展及其對本集團業務的影響。本集團將 積極採取措施以緩解新型冠狀病毒疫情對其 業務的不利影響。尤其是,本集團一直在物色 投資良機,以實現業務多元化。

於二零二一年三月,本集團認購目標公司 之10,200股普通股,相當於目標公司於完成 後經配發及發行相關股份擴大之已發行股 本之51%,認購價為1,000,000美元(相當於 7,800,000港元)。目標公司持有一間於新加坡 註冊成立之公司已發行股份的79%,該公司 持有TNG Indonesia 之99% 已發行股份。TNG Indonesia為一間於印尼註冊成立之有限公 司, 屬投資控股公司, 其餘下之1% 已發行股 份由目標公司持有。TNG Indonesia 持有TNG Indompet(一間於印尼註冊成立之有限公司) 之49% 已發行股份, TNG Indompet 之51% 已 發行股份由一名個人持有,而該人士已根據合 約安排以TNG Indonesia 為受益人質押相關股 權,有關詳情載列於本公司日期為二零二一年 三月九日之公佈。TNG Indompet 主要(1) 從事 Indosat移動充值卡分銷業務;及(2)根據TNG Indompet 與一名持牌電子貨幣發行人協定的 合作事項,與該電子貨幣發行人於印尼推出聯 合品牌 [W-Cash] 電子錢包。本集團認為於目 標公司之投資為本集團提供機會發展其於印 尼及周邊地區之業務,亦將與本集團之移動互 聯網文化業務及提供資訊科技服務以及放債 業務形成強大互補,並為其主要業務提供整體 協同效益。繼投資目標公司後,本集團亦在香 港及東南亞地區(如印尼等)尋求發展及經營 FinTech平台小額貸款業務的機會。

為使其業務更加多元化,本集團亦有意於香港 提供醫療服務,目前正在香港物色具有潛在合 作可能之診所及醫療中心。

Strategic Update

Entering into 2021, both regional and global markets will unquestionably remain sensitive to geopolitical and macroeconomic uncertainties, as well as the pandemic situation of the COVID-19. The Group's focus will be on (i) maintaining operational resilience in times of unpredictability and challenges; (ii) remaining competitive and forward-thinking, skillfully executing on its strategy; and (iii) exploring new opportunities, experimenting, and moving steadily and boldly towards greater success.

The Group's focus will remain on the successful execution of the strategic plan and working together with the regulators and other stakeholders to support the prosperity and sustainability of the markets and communities where the Group operates. Also, the Group's commitment to strengthen its competitiveness will remain a core focus in the years ahead. The Group is confident that the efforts it is making will position it strongly for the next phase of its journey and generate value over a longer term.

FINANCIAL RESOURCES AND LIQUIDITY

As at 31 December 2020, the total assets of the Group were approximately HK\$1,134,050,000 (2019: HK\$957,322,000) including cash and cash equivalents of approximately HK\$89,480,000 (2019: HK\$180,516,000), among which approximately 35% (2019: 78%) were denominated in Hong Kong dollars, 21% (2019: 8%) were denominated in United States dollars, 33% (2019: 12%) were denominated in Renminbi and 11% (2019: 2%) were denominated in Australian dollars. As at 31 December 2020, the Group had borrowings repayable within one year (or on demand) of approximately HK\$277,205,000 (2019: HK\$219,669,000). These borrowings bore interest at rates ranging from 2.9% to 6% per annum (2019: 3.7% to 6.0% per annum), among which approximately 77% (2019: 67%) were subject to fixed interest rates. Out of the total borrowings, approximately 22% (2019: 33%) were denominated in Australian dollars, the balance of approximately 67% (2019: 67%) were denominated in Renminbi and approximately 11% (2019: Nil) was denominated in Hong Kong dollars. As at 31 December 2020, the Group had borrowing facilities to the extent of approximately HK\$341,876,000 (2019: HK\$333,032,000). As at 31 December 2020, approximately HK\$279,987,000 (2019: HK\$221,830,000) of the facilities had been utilised by the Group. There is no seasonality in relation to the borrowing requirements of the Group.

策略更新

步入二零二一年,地區及全球市場毫無疑問地 均依然對地緣政治及宏觀經濟不確定性以及 新型冠狀病毒疫情狀況保持敏感。本集團將 聚焦於(i)在不可預測及充滿挑戰時期保持運 營彈性:(ii)保持競爭力及前瞻性,巧妙實施策 略;及(iii)探索新機會,勇敢嘗試,向更大的成 功穩步大膽邁進。

本集團的重點將依然是成功實施策略計劃,並 與監管機構及其他持份者共同努力,支持本集 團營運所在市場及社區的繁榮與可持續發展。 此外,本集團致力提高競爭力的承諾仍將是未 來幾年的核心重點。本集團有信心,現正付出 的努力將為下一征程的發展奠定堅實基礎及 創造長遠價值。

財務資源及流動資金

於二零二零年十二月三十一日,本集團資產 總值約為1,134,050,000港元(二零一九年: 957,322,000港元),包括現金及等同現金項目 約89,480,000港元(二零一九年:180,516,000 港元),其中約35%(二零一九年:78%)乃 以港元計值、21%(二零一九年:8%)乃以 美元計值、33%(二零一九年:12%)乃以人 民幣元計值及11%(二零一九年:2%)乃以 澳元計值。於二零二零年十二月三十一日, 本集團有於一年內(或按要求)償還的借貸約 277,205,000港元(二零一九年:219,669,000 港元)。該等借貸按年利率介乎2.9%至6%(二 零一九年:年利率介乎3.7%至6.0%)計息, 其中約77%(二零一九年:67%)按固定利 率計息。借貸總額中,約22%(二零一九年: 33%) 按澳元計值, 約67% (二零一九年: 67%)按人民幣計值,約11%(二零一九年: 無)按港元計值。於二零二零年十二月三十一 日,本集團的借款額度為約341,876,000港元 (二零一九年:333,032,000港元)。於二零二 零年十二月三十一日,本集團已動用額度中約 279,987,000港元(二零一九年:221,830,000 港元)。本集團並無季節性的借貸需求。

As at 31 December 2020, the Group's gearing ratio (calculated on the basis of total liabilities to total assets) was 0.77 times (2019: 0.62 times) and its net debt-to-equity capital ratio (calculated as the total trade and other payables, accruals and provision, interest-bearing bank and other borrowings and lease liabilities less pledge time deposit and cash and cash equivalents, over equity attributable to the Shareholders) was 2.36 times (2019: 0.89 times).

Despite the fact that the Group had net current liabilities of approximately HK\$36,135,000 as at 31 December 2020, the consolidated financial statements of the Company for the year ended 31 December 2020 have been prepared on the basis that the Group will continue to operate as a going concern. The Directors are of the opinion that the Group is able to continue as a going concern and to meet in full their financial obligations as; (i) the Group has been actively negotiating with its creditors to extend the repayment terms of its indebtedness; (ii) the Group is in the process of renewing a banking facility of approximately HK\$50,000,000 and bank borrowings of approximately HK\$42,752,000 (collectively, "Credit Facilities") and completed the process of renewing a banking facility of approximately HK\$36,410,000 as at 25 March 2021. Having considered the longstanding and good relationship established with the bank, the Directors are of the view that the Credit Facilities will be renewed upon their expiry. In light of all the measures adopted and arrangements implemented, the Directors are of the opinion that the Group will have sufficient cash resources to satisfy its future working capital and other financial requirements and it is reasonable to expect the Group to remain as a commercially viable concern. Accordingly, the Directors are satisfied that it is appropriate to prepare these consolidated financial statements on a going concern basis. It is noted that (i) the net current liabilities of the Group as at 31 December 2020 as mentioned above is mainly attributable to the net current liabilities of the CL Borrower and its subsidiaries ("CL Borrower Group"), which amounted to approximately HK\$138 million as at 31 December 2020; and (ii) as set out in the Company's announcement dated 4 September 2020, on 4 September 2020, the CL Lender advanced a one-year loan in the principal amount of HK\$30,000,000 to the CL Borrower, and such loan is secured by the share mortgage granted by the Company in favour of the CL Lender over the 51% interests in the CL Borrower held by the Company. If the CL Borrower defaults in repaying such loan, the CL Lender shall be entitled to enforce such share mortgage, upon which, the CL Borrower may cease to be a subsidiary of the Company (i.e. its consolidated assets and liabilities may no longer be consolidated to those of the Group), and the net current liabilities position of the Group mentioned above may be significantly improved.

儘管本集團於二零二零年十二月三十一日有 流動負債淨額約36.135.000港元,但本集團截 至二零二零年十二月三十一日止年度的綜合 財務報表已按本集團將持續經營的基準編製。 董事認為,本集團能夠持續經營並全面履行其 財務責任,原因為(i)本集團一直積極與其債權 人磋商,以延長債務的還款期限;及(ii)本集團 已在辦理重續金額約50,000,000港元的銀行 融資及金額約42,752,000港元的銀行借款(統 稱「信貸融資」),於二零二一年三月二十五日 已辦妥金額約36,410,000港元的銀行融資的 重續手續。經考慮與銀行建立的長期良好關 係,董事認為,信貸融資於到期時可獲得重續。 基於所有已採取的措施及已實施的安排,董事 認為本集團將具備充足的現金資源以滿足其 日後的營運資金及其他財務需求且合理預期 本集團能維持商業上可行之經營。因此,董事 信納按持續經營基準編製該等綜合財務報表 屬適當。需注意的是:(i)上述本集團於二零二 零年十二月三十一日之流動負債淨額主要歸 因於協盟借款人及其附屬公司(「協盟借款人 集團」)於二零二零年十二月三十一日之流動 負債淨額約138,000,000港元;及(ii) 誠如本公 司日期為二零二零年九月四日的公佈所載,於 二零二零年九月四日,協盟貸款人向協盟借款 人發放一筆本金額為30,000,000港元之一年 期貸款,該筆貸款由本公司以協盟貸款人為受 益人就本公司持有之協盟借款人51% 權益作 出的股份押記作擔保。倘協盟借款人未能如約 償還該筆貸款,協盟貸款人將有權強制執行股 份押記,於該情況下,協盟借款人可能不再為 本公司的附屬公司(即其綜合資產及負債可 能不再綜合計入本集團的綜合資產及負債), 從而上述本集團之流動負債淨額狀況可能得 到大幅改善。

CAPITAL STRUCTURE

As at 31 December 2020, the Group had shareholders' equity of approximately HK\$298,858,000 (2019: HK\$372,336,000).

As at 31 December 2020, the Group had borrowings of approximately HK\$279,987,000 (2019: HK\$221,830,000). Certain loans are subject to the fulfilment of covenants commonly found in lending arrangements with financial institutions. If the Group were to breach the covenants, the draw down facilities would become repayable on demand. In addition, the Group's certain loan agreements contain clauses which give the lenders the right at their sole discretion to demand immediate repayment at any time irrespective of whether the Group has complied with the covenants and met the scheduled repayment obligations.

FOREIGN EXCHANGE

During the year under review, the Group mainly generated revenue and incurred costs in Hong Kong dollars, Renminbi, Australian dollars and Euro. The Group did not invest in any derivative product for hedging during the year under review. Nevertheless, the Group will keep monitoring its foreign currency risk and when there are uncertainties or material fluctuations in the foreign exchange rates, the Group will consider using appropriate hedging instruments, including futures and forward contracts in managing the Group's exposure in relation to fluctuations in the foreign exchange rates.

CHARGE ON THE GROUP'S ASSETS

As at 31 December 2020, certain borrowing facilities of the Group were secured by freehold land and buildings of approximately HK\$114,859,000 (2019: HK\$143,624,000), financial assets at FVTOCI of approximately HK\$164,484,000 (2019: HK\$151,926,000), fixed deposit of approximately HK\$13,000,000 (2019: HK\$13,000,000) and financial assets at FVTPL of approximately HK\$31,900,000 (2019: HK\$33,284,000).

CAPITAL COMMITMENTS

As at 31 December 2020, the Group had capital commitments contracted but not provided for amounting to approximately HK\$3,590,000 (2019: Nil).

DISPOSAL OF ZHIQU

On 7 December 2015, the Group, Mr. Xu Jialiang, Mr. Xu Xiaofeng (collectively with the Group, the "Vendors"), 上海智 趣廣告有限公司 (in English, for identification purpose, Shanghai Zhiqu Advertisement Co., Ltd.) ("Zhiqu") and LEO entered into a sale and purchase agreement (as amended and supplemented by a supplemental agreement dated 11 January 2016) (the "Zhiqu SP Agreement"), pursuant to which LEO agreed to acquire, and the Vendors agreed to sell, the entire equity interest of Zhigu (the "Zhigu Disposal"). The Vendors and LEO also entered into the performance compensation agreement (the "Performance Compensation Agreement") in relation to the adjustments to the total consideration for the Zhigu Disposal. The total consideration shall be subject to adjustments (the "Adjustments", each an "Adjustment") in accordance with the Performance Compensation Agreement in the manner as stipulated below:

For the purpose of the Adjustments, the "Audited NOP" is Zhiqu's audited net operating profit after tax, after adjustments for, where applicable, any non-recurring and exceptional gains or losses, whichever is lower, that are not related to the ordinary business of Zhiqu, attributable to shareholders of the parent company of Zhiqu as deduced from the audited consolidated financial statements of Zhiqu for the relevant financial year ended 31 December 2016 ("FY2016"), financial year ended 31 December 2017 ("FY2017") and financial year ended 31 December 2018 ("FY2018") (each a "Guaranteed FY"). The Vendors severally (but among Mr. Xu Jialiang and Mr. Xu Xiaofeng, jointly and severally) undertook to LEO that:

- (i) the Audited NOP of Zhiqu for FY2016 shall be not less than RMB58,000,000 (the "2016 Target NOP");
- (ii) the Audited NOP of Zhiqu for FY2017 shall be not less than RMB75,400,000 (the "2017 Target NOP"); and
- (iii) the Audited NOP of Zhiqu for FY2018 shall be not less than RMB98,020,000 (the "2018 Target NOP").

出售智趣

於二零一五年十二月七日,本集團、徐佳亮先 生、徐曉峰先生(連同本集團統稱為「賣方」)、 上海智趣廣告有限公司(「智趣」)與利歐訂立 一份買賣協議(經二零一六年一月十一日之 補充協議修訂及補充)(「智趣買賣協議」), 據此,利歐同意收購及賣方同意出售智趣之全 部股權(「智趣出售事項))。賣方與利歐亦就 智趣出售事項總代價之調整訂立表現補償協 議(「表現補償協議」)。總代價須根據表現補 償協議按下文規定之方式予以調整(「調整」, 各項「調整」):

就調整而言,「經審核經營溢利淨額」指根據 智趣截至二零一六年十二月三十一日止財政 年度(「**二零一六財年**」)、截至二零一七年 十二月三十一日止財政年度(「**二零一七財年**」) 以及截至二零一八年十二月三十一日止財政 年度(「**二零一八財年**」)相關財政年度(「**擔保 財年**」)之經審核綜合財務報表,就(倘適用) 與智趣之日常業務並不相關之任何非經常性 及特別收益或虧損(以較低者為準)作出調整 後,智趣母公司股東應佔的智趣經審核除税後 經營溢利淨額。賣方個別(但徐佳亮先生及徐 曉峰先生共同及個別)向利歐承諾:

- (i) 智趣二零一六財年之經審核經營溢利淨額不少於人民幣58,000,000元(「二零一六年目標經營溢利淨額」);
- (ii) 智趣二零一七財年之經審核經營溢利淨額不少於人民幣75,400,000元(「二零一七年目標經營溢利淨額」);及
- (iii) 智趣二零一八財年之經審核經營溢利淨額 不少於人民幣98,020,000元(「二零一八年 目標經營溢利淨額」)。

The Vendors and LEO agreed that the amount of Adjustment (the "Adjustment Amount") for each Guaranteed FY shall be settled by the Vendors in the following order:

- (i) firstly, by the consideration shares allotted and issued to Mr. Xu Jialiang and Mr. Xu Xiaofeng, in proportion to the consideration shares allotted and issued to them ("Xu's Shares");
- (ii) if the Xu's Shares shall be insufficient to settle the relevant Adjustment Amount, secondly, in cash by Mr. Xu Jialiang and Mr. Xu Xiaofeng in proportion to the cash consideration received by them ("Xu's Cash");
- (iii) if Mr. Xu Jialiang and Mr. Xu Xiaofeng have not fully compensated LEO, thirdly, by the consideration shares allotted and issued to the Group ("Jixiang's Shares");
- (iv) if the Xu's Shares, the Xu's Cash and the Jixiang's Shares shall be insufficient to settle the relevant Adjustment Amount, fourthly, in cash by the Group, which is subject to a cap of RMB25,510,009 ("Jixiang's Cash"); and
- (v) if the Xu's Shares, the Xu's Cash, the Jixiang's Shares and the Jixiang's Cash shall be insufficient to settle the relevant Adjustment Amount, finally, in cash by Mr. Xu Jialiang and Mr. Xu Xiaofeng to settle the balance.

Upon the end of each Guaranteed FY and the issue of the special audit report of Zhiqu for FY2018, LEO shall engage qualified auditors to conduct asset impairment test and issue a report in respect of any asset impairment. Where the asset impairment of Zhiqu as reflected in such report shall be more than the total Adjustment Amount compensated by the Vendors to LEO, the Vendors shall compensate LEO a sum equal to the difference between such asset impairment and the Adjustment Amount then compensated by the Vendors to LEO, which shall be settled first by the consideration shares (the value of which shall be calculated by multiplying such number of consideration shares with the issue price), with payment of cash to settle the balance (if any). All liabilities of the Group under the Performance Compensation Agreement shall at all times be capped at the total consideration received by it.

Based on a special audit report of Zhiqu for FY2016 published by LEO on 30 August 2017, the Audited NOP of Zhiqu for FY2016 amounted to RMB32,239,594.87, which is less than the 2016 Target NOP. Accordingly, the Adjustment Amount for FY2016 shall be RMB83,931,144.53 and shall be settled by 18,166,915 Xu's Shares (the "**FY2016 Compensation**"). The Group is not required to pay any compensation to LEO in respect of the Audited NOP of Zhiqu for FY2016. 賣方與利歐協定,各擔保財年的調整金額(「調整金額」)將由賣方以下列次序償付:

於各擔保財年年結日及出具二零一八財年智 趣特別審核報告時,利歐將委聘合資格核數師 進行資產減值測試並就任何資產減值出具報 告。倘該等報告所反映之智趣資產減值超過賣 方向利歐補償之總調整金額,賣方將補償利歐 相當於有關資產減值與賣方當時向利歐補償 之調整金額之間的差額之金額,該金額將首先 以代價股份償付(其價值根據代價股份數目 乘以發行價計算得出),而餘額(如有)則以現 金支付。本集團於表現補償協議項下之所有負 債在任何時間均以其收取之總代價為限。

As disclosed in LEO's announcement dated 31 August 2017, Mr. Xu Jialiang and Mr. Xu Xiaofeng shall pay additional compensation which comprises (i) an aggregate of 21,993,909 LEO's shares to LEO; and (ii) cash in the aggregate amount of RMB80,000,000 to Zhiqu, on or before 31 December 2017 (the "Additional Compensation"). According to LEO's announcement dated 19 December 2017, such shares were returned to LEO for distribution to its shareholders in December 2017.

Based on a special audit report of Zhiqu for FY2017 published by LEO on 14 December 2018, the Audited NOP of Zhigu for FY2017 amounted to RMB36,689,479.02, which is less than the 2017 Target NOP. Accordingly, the Adjustment Amount for FY2017 shall be RMB126,124,504.45 and shall be settled by 3,821,856 Xu's Shares and Xu's Cash in the amount of RMB108,467,529.73 (the "FY2017 Compensation") taking into consideration the Additional Compensation. However, as disclosed in the Company's announcement dated 15 March 2019, according to LEO's announcement dated 15 March 2019, given that the 3,821,856 Xu's Shares were not sufficient to settle the FY2017 Compensation and Mr. Xu Jialiang and Mr. Xu Xiaofeng were unable to provide the Xu's Cash in the amount of approximately RMB108,468,000, in accordance with the settlement mechanism above, the FY2017 Compensation shall be settled by 23,477,822 Jixiang's Shares and the Group shall also return the cash dividend in the amount of approximately RMB506,000 received from LEO to an account designated by LEO.

As disclosed in the announcement of the Company dated 29 April 2019, on 29 April 2019, the Group received a letter from the Shanghai International Economic and Trade Arbitration Commission (Shanghai International Arbitration Center) ("SHIAC") that LEO had commenced arbitration proceedings against the Group to pursue the settlement of the portion of the FY2017 Compensation that Mr. Xu Jialiang and Mr. Xu Xiaofeng were unable to satisfy (the "Unsettled FY2017 Compensation"). As at 31 December 2018, the Company has been preliminarily advised by its legal advisers as to the laws of the PRC that the Group should have a good chance to argue in such arbitration proceeding that the demand from LEO for settlement of the Unsettled FY2017 Compensation should not be upheld. The hearing of the arbitration proceeding was held on 24 September 2019 before a panel of three arbitrators.

According to the announcement of LEO dated 8 November 2019, based on the special audit report in respect of the Audited NOP of Zhiqu for FY2018, the Audit NOP of Zhiqu for FY2018 amounted to RMB7,701,500, which is less than the 2018 Target NOP.

誠如利歐日期為二零一七年八月三十一日 的公佈所披露,徐佳亮先生及徐曉峰先生於 二零一七年十二月三十一日或之前(i)以共計 21,993,909股利歐股份向利歐作出額外補償; 及(ii)向智趣支付共計人民幣80,000,000元(「額 外補償」)。根據利歐日期為二零一七年十二 月十九日的公佈,有關股份於二零一七年十二 月歸還予利歐以供分派予其股東。

根據利歐於二零一八年十二月十四日刊發的 二零一七財年智趣特別審核報告,智趣二零 一七財年的經審核經營溢利淨額為人民幣 36,689,479.02元,低於二零一七年目標經營 溢利淨額。因此,二零一七財年的調整金額 為人民幣126,124,504.45元,經計及額外補 償,由3,821,856股徐之股份及金額為人民幣 108,467,529.73元徐之現金結算(「ニ零ー七 **財年補償**」)。然而, 誠如本公司於二零一九年 三月十五日之公佈所披露,根據利歐於二零 一九年三月十五日之公佈,鑒於3,821,856股 徐之股份不足以償付二零一七財年補償及徐 佳亮先生及徐曉峰先生未能提供金額約人民 幣108,468,000元之徐之現金,根據上述之償 付機制,二零一七財年補償將以23.477.822股 迹象之股份作償付及本集團亦將退還自利歐 收取之現金股息約人民幣506,000元至利歐指 定之賬戶。

如本公司日期為二零一九年四月二十九日的 公佈所披露,於二零一九年四月二十九日,本 集團收到上海國際經濟貿易仲裁委員會(上 海國際仲裁中心)(「上海國仲」)之函件,當 中稱利歐已就尋求償付徐佳亮先生及徐曉峰 先生未能償付的部分二零一七財年補償(「未 償付二零一七財年補償」)提起針對本集團的 仲裁程序。於二零一八年十二月三十一日,根 據本公司中國法律顧問初步意見,本集團很有 機會在相關仲裁程序中主張利歐要求清償未 償付二零一七財年補償的要求不應獲得支持。 於二零一九年九月二十四日,由三個仲裁員組 成的小組進行聆訊程序。

根據利歐日期為二零一九年十一月八日之公佈,根據有關二零一八財年智趣經審核經營溢利淨額之特別審核報告,二零一八財年智趣之經審核經營溢利淨額為人民幣7,701,500元,少於二零一八年目標經營溢利淨額。

According to the announcement of LEO dated 3 December 2019, in view of the Audited NOP of Zhigu for FY2018 being RMB7,701,500, the Adjustment Amount for FY2018 shall be RMB402,738,466.59 accordingly. The Adjustment Amount for FY2018 shall be settled by the Xu's Shares, and where such shares are insufficient, by the Xu's Cash received by Mr. Xu Jialiang and Mr. Xu Xiaofeng. Given that Mr. Xu Jialiang and Mr. Xu Xiaofeng no longer hold any consideration shares, they will be required to compensate LEO in cash. LEO will issue a demand notice for compensation to Mr. Xu Jialiang and Mr. Xu Xiaofeng after the compensation proposal in respect of the Adjustment Amount for FY2018 has been approved by the shareholders of LEO. If Mr. Xu Jialiang and Mr. Xu Xiaofeng do not settle the Adjustment Amount for FY2018 in full within 30 days after the issue of the demand notice, the Group will be required to settle the Adjustment Amount for FY2018 by 45,779,220 Jixiang's Shares that it holds and, if such shares are insufficient, by Jixiang's Cash. In addition, the Group will also be required to return the cash bonus in relation to the Jixiang's Shares that it has received from LEO, the amount of which as determined in accordance with the amount of compensation that the Group is required to pay. If there is still a shortfall in the settlement of the Adjustment Amount for FY2018, Mr. Xu Jialiang and Mr. Xu Xiaofeng, who are jointly liable for such settlement, will be required to compensate LEO in cash. LEO will seek approval from its shareholders in respect of the above compensation proposal.

As disclosed in the announcement of the Company dated 6 December 2019, on 6 December 2019, the Group received a letter from SHIAC indicating that it has approved LEO's application ("**Application**") to make the following amendments ("**Amendments**") to certain demands made by LEO against the Group in relation to the settlement of the Unsettled FY2017 Compensation:

- (i) the transfer of 45,779,220 Jixiang's Shares (instead of 23,477,822 Jixiang's Shares) held by the Group to LEO;
- (ii) if the Group is unable to transfer the entire 45,779,220 Jixiang's Shares (instead of 23,477,822 Jixiang's Shares) to LEO, the shortfall shall be compensated to LEO by way of cash; and
- (iii) the return of the cash bonus in the amount of approximately RMB989,000 (instead of approximately RMB506,000) in relation to the 45,779,220 Jixiang's Shares (instead of 23,477,822 Jixiang's Shares) by the Group to LEO.

根據利歐日期為二零一九年十二月三日之公 佈,鑒於智趣經審核經營溢利淨額於二零一八 財年為人民幣7,701,500元,據此,二零一八財 年調整金額應為人民幣402,738,466.59元。二 零一八財年調整金額應由徐之股份結算,而倘 相關股份不足,則透過徐佳亮先生及徐曉峰先 生已接獲徐之現金結算。鑒於徐佳亮先生及徐 曉峰先生不再持有任何代價股份,彼等將要求 以現金賠償利歐。於利歐就賠償二零一八財年 調整金額提交其股東審議後,利歐將向徐佳亮 先生及徐曉峰先生發出要求補償通知。倘徐佳 亮先生及徐曉峰先生並未於發出要求通知後 30日內全數償付二零一八財年調整金額,本 集團須以其持有之45,779,220股迹象股份及 (倘相關股份不足)迹象現金償付二零一八財 年調整金額。此外,本集團亦將須退還就迹象 股份而已收利歐的現金紅利,有關金額根據本 集團須支付的賠償金額釐定。倘仍未能足額償 付二零一八財年調整金額,徐佳亮先生及徐曉 峰先生(彼等就上述償付連帶責任)將須以現 金補償利歐。利歐將就上述賠償建議提交其股 東審議。

誠如本公司日期為二零一九年十二月六日之 公佈所披露,於二零一九年十二月六日,本集 團已接獲上海國仲之函件,當中表明已批准利 歐就清償未償付二零一七財年補償針對本集 團提出的若干要求而作出以下修訂(「修訂」) 的利歐申請(「申請」):

- (i) 向利歐轉讓本集團所持有之45,779,220
 股迹象之股份(而非23,477,822股迹象股份);
- (ii) 倘本集團無法向利歐轉讓全部45,779,220 股迹象之股份(而非23,477,822股迹之象 股份),則相關差額須以現金方式補償予 利歐;及
- (iii) 本集團向利歐退還有關45,779,220股迹象 股份(而非23,477,822股迹象股份)的現金 紅利約人民幣989,000元(而非約人民幣 506,000元)。

In the Application, further to the above amendments, LEO also demands the Group to pay LEO (i) cash compensation in the amount of approximately RMB25,510,000; and (ii) an amount which is calculated from the date of the Application, based on the amount of unsettled compensation due from the Group to LEO times the one-year loan prime rate published on 21 October 2019 as authorised by the People's Bank of China (i.e. 4.20% per annum), as compensation for the loss suffered by LEO.

It is stated in the Application that the Amendments are proposed taking into consideration that (i) the Audited NOP of Zhiqu for FY2018 as reported in the special audit report in respect of the Audited NOP of Zhiqu for FY2018 amounting to approximately RMB7,702,000, is less than the 2018 Target NOP (i.e. RMB98,020,000); and (ii) any party in breach of the Performance Compensation Agreement shall be liable for damages caused to the parties not in default. It is stated in the letter that the Group shall provide rebuttal opinion on evidence in respect of the supplemental information attached to the Application ("**Rebuttal**") within five working days after the receipt of the letter.

On 10 December 2019, the Group has instructed its PRC legal adviser to provide the Rebuttal and an objection to the Application ("Objection") to the SHIAC. In the Objection, the Group requested the SHIAC to reject the Application, taking into account that (i) the Application was made too late, which would severely affect the normal process of the arbitration; and (ii) the inclusion of the compensation for the Adjustment Amount for FY2018 into the amended demands under the Application would complicate the case and cause delay to the arbitration proceedings, and more importantly, the LEO's claims against the Group in relation to the Adjustment Amount for FY2018 are subject to (a) the LEO's claims against Mr. Xu Jialiang and Mr. Xu Xiaofeng after the shareholders of LEO have given their approval of the related compensation proposal; and (b) the failure of Mr. Xu Jialiang and Mr. Xu Xiaofeng to settle the 2018 Adjustment Amount in full within 30 days after the issue of the demand notice by LEO.

在申請中,除以上修訂外,利歐亦要求本集團 支付利歐(i)現金補償金額約人民幣25,510,000 元;及(ii)自申請日期起計,以本集團應付利歐 的未償付補償金額為基數按中國人民銀行授 權全國銀行間同業拆借中心於二零一九年十 月二十一日公佈的一年期貸款市場報價利率 (即每年4.20厘)計算的款項,以作為利歐遭受 的虧損補償。

申請載述建議修訂乃考慮(i)根據智趣二零 一八財年之經審核經營溢利淨額特別審核報 告所載,智趣二零一八財年之經審核經營溢利 淨額約為人民幣7,702,000元,低於二零一八 年目標經營溢利淨額(即人民幣98,020,000 元):及(ii)任何違反表現補償協議的訂約方須 承擔對未違反訂約方造成的損失。函件載述本 集團應於接獲函件後五個工作日內對申請所 附的補充資料發表質證意見(「**質證**」)。

於二零一九年十二月十日,本集團已指示其中 國法律顧問向上海國仲提供質證及有關申請 的異議(「異議」)。於異議中,本集團要求上 海國仲駁回申請,理由如下:(i)作出申請時間 過遲,將嚴重影響仲裁的正常程序;及(ii)將二 零一八財年調整金額之補償納入申請項下問 經修訂要求將使得案情複雜並導致仲裁程序 推遲,及更為重要的是,利歐就二零一八財年 調整金額針對本集團提出的索償受限於下列 情況:(a)利歐於其股東批准相關補償方案後 向徐佳亮先生及徐曉峰先生提出索償;及(b) 徐佳亮先生及徐曉峰先生於利歐發出要求通 知後30日內未能全數償付二零一八財年調整 金額。

On 19 December 2019, LEO issued a letter to Mr. Xu Jialiang and Mr. Xu Xiaofeng demanding the settlement of the Adjustment Amount for FY2018. In response to the demand letter issued by LEO on 19 December 2019 as mentioned above, Mr. Xu Jialing and Mr. Xu Xiaofeng informed LEO in writing on 20 December 2019 that they were unable to pay the Adjustment Amount for FY2018 due to their financial difficulties. If Mr. Xu Jialiang and Mr. Xu Xiaofeng do not settle the Adjustment Amount for FY2018 in full within 30 days after the issue of the demand letter, the Group will be required to settle the Adjustment Amount for FY2018 by way of the 45,779,220 Jixiang's Shares that it holds and, if such shares are insufficient, by way of cash. which is subject to a cap of approximately RMB25,510,000 (being the amount of cash consideration received by the Group in relation to the Zhigu Disposal). In addition, the Group will also be required to return the cash dividend in relation to the Jixiang's Shares that it has received from LEO, the amount of which as determined in accordance with the amount of compensation the Group is required to pay. If there is still a shortfall in the settlement of the Adjustment Amount for FY2018, Mr. Xu Jialiang and Mr. Xu Xiaofeng, who are jointly liable for such settlement, will be required to compensate LEO in cash. As set out in LEO's announcement dated 14 January 2020, LEO has sought approval from its shareholders in respect of the proposal to repurchase and cancel the 45,779,220 Jixiang's Shares held by the Group as partial settlement of the Adjustment Amount for FY2018.

As disclosed in the announcement of the Company dated 8 February 2021, the Group received the arbitral awards ("**Arbitral Awards**") issued by the SHIAC in respect of the demands made by LEO against the Group in relation to the settlement of the Unsettled FY2017 Compensation and the Adjustment Amount for FY2018, the details of which are as follows:

- the Group shall transfer 45,779,220 Jixiang's Shares it holds to LEO and assist LEO with matters relating to the acquisition and cancellation of such shares;
- (ii) if the Group is unable to transfer the entire 45,779,220 Jixiang's Shares to LEO within 45 days from 5 February 2021
 (i.e. the date on which the Arbitral Awards were issued by the SHIAC ("Award Date")), the shortfall shall be compensated by the Group to LEO by way of cash, the amount of which shall be calculated using the following formula: Amount of cash compensation to be paid to LEO = A x 16.17/3.5

A, being the number of Jixiang's shares in shortfall;

於二零一九年十二月十九日,利歐向徐佳亮先 生及徐曉峰先生發出函件要求償付二零一八 財年調整金額。因應上述利歐於二零一九年 十二月十九日發出之要求函件,徐佳亮先生及 徐曉峰先生於二零一九年十二月二十日書面 通知利歐,彼等因財務困難而未能支付二零 一八財年調整金額。倘徐佳亮先生及徐曉峰先 生並未於發出要求函件後30日內全數償付二 零一八財年調整金額,本集團將須以其持有 之45,779,220股迹象之股份及(倘有關股份不 足)以現金(上限為約人民幣25,510,000元, 即本集團就智趣出售事項收取之現金代價金 額) 償付二零一八財年調整金額。此外,本集 團亦將須退還就迹象之股份而已收利歐之現 金股息,有關金額乃根據本集團須支付之賠 償金額釐定。倘仍未能足額償付二零一八財 年調整金額,徐佳亮先生及徐曉峰先生(彼等 就上述償付承擔連帶責任)將須以現金補償利 歐。如利歐日期為二零二零年一月十四日之公 佈所載,利歐將就建議回購及註銷本集團所 持45,779,220股迹象之股份以償付部分二零 一八財年調整金額提交其股東審議。

誠如本公司日期為二零二一年二月八日的公佈所披露,本集團接獲上海國仲就利歐針對本 集團提出有關償付二零一七年未償付補償及 二零一八年調整金額之要求而作出之仲裁裁 決(「**仲裁裁決**」),詳情如下:

- (i) 本集團應向利歐轉讓其持有之45,779,220
 股迹象股份,並協助利歐處理有關取得及
 隨後註銷該等股份之事宜;
- (ii) 倘本集團未能於二零二一年二月五日 (即上海國仲發出仲裁裁決之日期(「裁 決日期」))起計45日內向利歐轉讓全部 45,779,220股迹象股份,則有關差額將由 本集團以現金向利歐作出補償,補償金額 按以下公式計算:向利歐支付之現金補償 金額=Ax16.17/3.5

A為迹象股份數目差額;

(iii) the Group shall pay to LEO (a) cash compensation in the amount of RMB9,626,612.92 ("Cash Compensation"); and (b) damages. The amount of which shall be calculated using the following formula: Amount of cash damages to be paid to LEO = 9,626,612.92 x 3.85%/365 x B

B, being the number of days from 4 December 2019 to the date on which the Cash Compensation is fully paid by the Group to LEO;

- (iv) the Group shall return the cash bonus in the amount of RMB987,523.17 to LEO;
- (v) the Group shall pay to LEO RMB500,000 of the legal fees incurred by LEO as a result of the disputes with the Group over the settlement of the Unsettled FY 2017 Compensation and the Adjustment Amount for FY 2018 ("Disputes"); and
- (vi) the Group and LEO shall bear 70% and 30% of the arbitration fees incurred to settle the Disputes, respectively. Given that LEO has fully settled the entire amount of the arbitration fees of RMB1,632,434, the Group shall pay 70% of such fees (i.e. RMB1,142,703.80) to LEO.

The Arbitral Awards set out above are final and they shall be performed by the Group within 45 days from the Award Date.

The Group is in the course of seeking legal advice on the above matter, in particular, the performance of the Arbitral Awards by the Group and the possibility of appealing to the Arbitral Awards. The Company will keep the Shareholders and potential investors informed of any further material developments in connection with the above matter by way of further announcement(s) as and when appropriate.

Details of the Zhiqu Disposal and the calculation of the Adjustment Amount for each Guaranteed FY are set out in (i) the announcements of the Company dated 8 December 2015, 11 January 2016, 29 February 2016, 20 May 2016, 5 July 2016, 5 September 2016, 7 September 2016, 31 August 2017, 14 December 2018, 15 March 2019, 9 April 2019, 29 April 2019, 8 November 2019, 3 December 2019, 6 December 2019, 10 December 2019, 27 December 2019 and 8 February 2021; and (ii) the circular of the Company dated 11 February 2016.

- (vi)本集團及利歐應分別承擔解決爭議而產生 之仲裁費用之70%及30%。鑒於利歐已全 數付清仲裁費用人民幣1,632,434元,本集 團應向利歐支付該等費用之70%(即人民 幣1,142,703.80元)。

上述仲裁裁決為終局裁決,本集團須於裁決日期起計45日內履行。

本公司正就上述事項(特別是有關本集團履 行仲裁裁決以及就仲裁裁決進行申訴的可能性) 尋求法律意見,並評估仲裁裁決對本集團之影 響。本公司將適時透過刊發進一步公佈及時知 會本公司股東及潛在投資者有關上述事項之 任何進一步重大進展。

LITIGATION AND CLAIMS

The Group was involved in the following legal proceedings and claims:

(a) On 19 December 2017, Ever Robust Holdings Limited ("Ever Robust"), an indirect wholly-owned subsidiary of the Company, received a writ of summons with a statement of claim (the "Writ") issued in the Court of First Instance of the High Court of Hong Kong (the "Court") by Convoy Global Holdings Limited ("Convoy"), Convoy Collateral Limited (the "Second Plaintiff") and CSL Securities Limited (the "Third Plaintiff", together with Convoy and the Second Plaintiff, collectively as the "Plaintiffs") against, among other defendants, Ever Robust (together with the other defendants, collectively as the "Defendants").

Based on the Writ, the orders sought by the Plaintiffs against Ever Robust are as follows: (i) Convoy sought an order as against, among others, Ever Robust, that the allotment of the shares in Convoy by Convoy to, among others, Ever Robust on 29 October 2015, be set aside; (ii) the Second Plaintiff and the Third Plaintiff sought an order that the financing facilities granted by them, including the loan (the "Convoy Loan") in the amount of HK\$129,000,000 granted to Ever Robust by the Second Plaintiff on 9 November 2015, and the margin loan (the "Margin Loan") granted to Ever Robust by the Third Plaintiff which amounted to HK\$67,574,473 as at 29 March 2016, be rescinded; and (iii) the Plaintiffs sought against, among others. Ever Robust for (a) general or special damages; (b) interests; (c) costs; and (d) further and/or other reliefs (the "Convoy Proceedings"). As at 19 December 2017, Ever Robust had fully repaid the Convoy Loan and the Margin Loan and did not hold any shares in Convoy.

訴訟及申索

本集團牽涉下列法律訴訟及申索:

(a) 於二零一七年十二月十九日,本公司之間 接全資附屬公司連捷控股有限公司(「連 捷」)接獲康宏環球控股有限公司(「 康 宏」)、康宏財務有限公司(「 第二原告人」) 及康證有限公司(「 第三原告人」,統稱「原 告人」)於香港高等法院(「法院」)原訟法 庭向包括連捷在內的其他被告人(連同其 他被告人統稱「被告人」)發出的傳訊令狀 連同申索書(「令狀」)。

根據令狀,原告人對連捷尋求的命令如 下:(i)康宏向連捷尋求命令(其中包括)康 宏於二零一五年十月二十九日向(其中包 括) 連捷配發的康宏股份予以撤銷; (ii) 第 二原告人及第三原告人尋求有關廢止彼等 授出的財務融資的命令,包括由第二原告 人於二零一五年十一月九日向連捷授出的 金額為129.000.000港元的貸款(「**康宏貸 款**」),及由第三原告人於二零一六年三月 二十九日向連捷授出的金額為67,574,473 港元的孖展貸款(「**孖展貸款」**);及(iii)原 告人向連捷尋求(其中包括)(a)一般或特 定損害賠償;(b)利息;(c)成本;及(d)進一 步及/或其他寬免(「康宏訴訟」)。於二零 一七年十二月十九日,連捷已悉數償還康 宏貸款及孖展貸款及並無持有任何康宏股 份。

On 6 March 2018, a Case Management Conference Hearing was held before the Honourable Mr. Justice Harris on the Convoy Proceedings. On 9 July 2018, Ever Robust has received an amended writ of summons and an amended statement of claim (the "Amended Statement of Claim"). Pursuant to the Amended Statement of Claim, the reliefs sought by the Plaintiffs against Ever Robust are amended as follows: (i) a declaration and order as against among others, Ever Robust, that the allotment of the shares in Convoy by Convoy to, among others, Ever Robust, on 29 October 2015, is null and void, or has been rescinded and set aside (as sought by Convoy); (ii) an account of profits and an order for payment of any sums found to be due, equitable compensation to be assessed, and/or damages to be assessed for breach of fiduciary, common law and/or statutory duties, dishonest assistance, unlawful means conspiracy and/or lawful means conspiracy, as against, among others, Ever Robust (as sought by Convoy): (iii) an order against. among others, Ever Robust, for an account of profits and an order for payment of any sums found to be due, equitable compensation to be assessed, and/or damages to be assessed for breach of fiduciary, common law and/or statutory duties, dishonest assistance, unlawful means conspiracy and/or lawful means conspiracy (as sought by the Second Plaintiff and the Third Plaintiff); and (iv) against, among others, Ever Robust, for (a) general or special damages; (b) interests; (c) costs; and (d) further and/or other reliefs (as sought by all the Plaintiffs).

On 27 July 2018, Ever Robust received a sealed order (the "**Order**") dated 28 June 2018 against, among other Defendants, Ever Robust, in which 11 parties are ordered to join the proceedings as additional defendants. Pursuant to the Order, it is further ordered, among other matters, as to between the Plaintiffs and Ever Robust (among certain other Defendants), that the Plaintiffs do have leave to file and serve the Amended Statement of Claim.

On 30 November 2018, Ever Robust received a copy sealed order dated 1 November 2018 against, among other defendants, Ever Robust, in which a party is ordered to join the proceedings as an additional defendant.

On 10 December 2018, Ever Robust filed its Defence (the "**Defence**") to the Plaintiff's claim in the Convoy Proceedings with the Court. Pursuant to the Defence, Ever Robust avers that the Plaintiffs are not entitled to any relief against Ever Robust in the Convoy Proceedings.

於二零一八年三月六日,法院夏利士法官 就康宏訴訟進行了案件管理會議。於二零 一八年七月九日,連捷已接獲經修訂傳訊 令狀及經修訂申索書(「經修訂申索書」)。 根據經修訂申索書,原告人尋求對連捷的 寬免修訂如下:(i)一項針對(其中包括)連 捷的關於康宏於二零一五年十月二十九日 向(其中包括)連捷配發康宏股份的聲明 及命令為無效或已撤回及撤銷(如康宏所 尋求);(ii)交出所得利潤令及一項就違反 授信責任、普诵法及/或法定責任、不誠 **窗協助、非法及/或合法手段串謀而針對** (其中包括)連捷作出的有關支付任何應 付款項、將予評定之衡平補償及/或將予 評定之損害賠償的命令(如康宏所尋求); (iii)對(其中包括)連捷頒令交出所得利潤 及頒令其因違反授信責任、普通法及/或 法定責任、不誠實協助、非法及/或合法 手段串謀而須支付任何應付款項、將予評 定之衡平補償及/或將予評定之損害賠償 (如第二原告人及第三原告人所尋求);及 (iv)針對(其中包括)連捷的(a)一般或特定 損害賠償;(b)利息;(c)成本;及(d)進一步 及/或其他寬免(如所有原告人所尋求)。

於二零一八年七月二十七日,連捷接獲一份針對包括連捷等被告人發出日期為二 零一八年六月二十八日之蓋印命令(「 命 令」),當中頒令11名涉事方作為新增被告 人加入有關法律程序。除有關原告人及連 捷(包括若干其他被告人)間的其他事項 外,該命令亦進一步頒令稱原告人已獲許 可存檔及送達經修訂申索書。

於二零一八年十一月三十日,連捷接獲一 份針對包括連捷等被告人發出日期為二零 一八年十一月一日之蓋印命令副本,當中 頒令一名涉事方作為新增被告人加入有關 法律程序。

於二零一八年十二月十日,連捷就康宏訴 訟向法院遞交回應原告人索償之抗辯書 (「**抗辯書**」)。根據抗辯書,連捷聲明原告 人無權於康宏訴訟中向連捷索取任何寬免。 On 30 August 2019, Ever Robust filed its Amended Defence pursuant to the Order of Hon Harris J dated 12 July 2019.

Further details of the Convoy Proceedings are set out in the Company's announcements dated 19 December 2017, 1 June 2018, 7 June 2018 and 25 July 2018.

After seeking the legal opinion, the Group considered that there was no assessed monetary claim by Plaintiffs and it is premature to give opinion on the probable outcome and estimate the ultimate liability.

(b) On 2 January 2018, Ever Robust received a petition (the "Petition") issued in the Court by Zhu Xiao Yan (the "Petitioner") against, among other respondents, Ever Robust. Based on the Petition, the Petitioner has held and continues to hold 3,234,000 shares in Convoy since around mid-2015, and the Petitioner sought the following orders against, among others, Ever Robust: (i) a declaration that the placement of 3,989,987,999 shares in Convoy by Convoy to, among other placees, Ever Robust, and/or such placed shares are void ab initio and of no legal effect or, alternatively, be set aside; (ii) damages for dilution of the Petitioner's shareholding; (iii) interest; (iv) such further or other relief and all necessary and consequential directions as the Court may think fit; and (v) costs (the "Zhu Proceedings"). As at 2 January 2018, Ever Robust did not hold any shares in Convoy.

On 6 March 2018, a Case Management Conference was held on the Zhu Proceedings, in which the Honourable Mr. Justice Harris made an order that the Zhu Proceedings be stayed with liberty to restore, pending the outcome of the Convoy Proceedings.

Further details of the Zhu Proceedings are set out in the Company's announcement dated 2 January 2018.

The Group has sought preliminary opinion on the above legal proceedings from its solicitors (or legal adviser) in Hong Kong, who, based on the information available as of the date of this Annual Report, is of the opinion that:

A provision for litigation of approximately RMB14,221,000 (equivalent to approximately HK\$16,863,000) (2019: provision of approximately RMB28,746,000 (equivalent to approximately HK\$32,118,000), was made in relation this litigation for the year under review.

(d) During the years ended 31 December 2018 and 2019, a subsidiary of the Company (the "Borrower") had breached the covenant of a loan (the "**Loan**") in the original principal amount of RMB79,868,600, which is secured by certain of the listed securities extended by Essence Securities Co., Limited (the "Lender"). Subsequent to the end of the reporting period on 17 January 2020, the Borrower received the summons (the "Summons") issued by the Lender, as plaintiff, in Shenzhen Intermediate People's Court (the "SZ Court") against the Borrower as defendant. Pursuant to the Summons, the Lender demands the SZ Court to order the Borrower to: (i) repay to the Lender the outstanding principal amount of the Loan in the sum of approximately RMB70,893,000 (equivalent to approximately HK\$79,216,000); (ii) pay to the Lender interest at the rate of 6% per annum accrued on the outstanding principal amount of the Loan in the sum of approximately RMB70,893,000 (equivalent to approximately HK\$79,216,000) from 20 June 2019 to the date of repayment; (iii) pay to the Lender liquidated damages at the daily rate of 0.03%, including liquidated damages on the outstanding interest in the sum of approximately RMB1,042,000 (equivalent to approximately HK\$1,164,000) from 16 September 2019 to the date of repayment and liquidated damages on the principal from 19 June 2018 to the date of repayment; (iv) pay to the Lender its legal costs in making the claims in the sum of RMB76,000 (equivalent to approximately HK\$85,000); (v) use the proceeds from the realisation of certain of the listed securities pledged by the Borrower ("Pledged Assets") through discounting, sale or auction firstly to repay to the Lender the outstanding amount of the Loan, the interest, the liquidated damages and the legal costs; and (vi) bear all the litigation costs such as case acceptance fees and security fee of this case. As per the Summons, the aggregate amount of the claims under (i) to (iv) up to 18 November 2019 amounted to approximately RMB85,186,000 (equivalent to approximately HK\$95,187,000).

- (1) the Borrower shall within ten days after the Judgement becoming effective, repay to the Lender (a) the outstanding principal amount of the Loan in the sum of approximately RMB71 million and interest on the outstanding principal amount of the Loan (consisting of (i) interest in the amount of approximately RMB1 million accrued from 20 June 2019 to 16 September 2019; and (ii) interest at the rate of 6% per annum accrued on the outstanding principal amount of the Loan in the sum of approximately RMB71 million from 16 September 2019 to the date of repayment); (b) liquidated damages at the daily rate of 3/10,000 on the outstanding interest in the sum of approximately RMB1 million payable from 16 September 2019 to the date of repayment; and (c) liquidated damages at the daily rate of 3/10,000 on the outstanding principal amount of the Loan (consisting of (i) liquidated damages in the amount of approximately RMB1 million payable from 19 June 2019 to 19 August 2019; and (ii) liquidated damages on the outstanding principal amount of the Loan in the sum of approximately RMB71 million payable from 19 August 2019 to the date of repayment);
- (2) the Lender shall have the right to the Pledged Assets as a chargee and the priority to be compensated with the proceeds from the realisation of the Pledged Assets through discounting, auction or sale; and
- (3) out of the litigation costs (consisting of case acceptance fees and security fee) in the aggregate amount of approximately RMB473,000, approximately RMB465,000 and approximately RMB8,000 shall be borne by the Borrower and the Lender, respectively.

Save for the above, the orders the Lender demanded the SZ Court to make against the Borrower in the Summons were rejected by the SZ Court.

Further details of the Summons and the Judgment are set out in the Company's announcements dated 18 January 2020 and 20 November 2020.

As set out on page 18 in this Annual Report, the Group completed the TH Disposals on 3 March 2021 and 10 March 2021 to partially repay the loan and the liabilities owed to the Lender under the Loan as required by the Judgment.

A provision for litigation of approximately RMB23,218,000 (equivalent to approximately HK\$27,532,000) (2019: provision of approximately RMB13,473,000 (equivalent to approximately HK\$15,054,000)), and such increase was mainly attributable to the liquidated damages at the daily rate of 3/10,000 on the outstanding principal amount of the Loan under the Judgment, together with a provision for interest accrual of approximately RMB6,618,000 (equivalent to approximately HK\$7,848,000) (2019: RMB2,294,000 (equivalent to approximately HK\$2,563,000)) were made by the Group in relation to this litigation for the year ended 31 December 2020.

The Group has made provisions for the above legal proceedings except for items (a) and (b) above as the Group is not able to reliably assess the amount of potential liabilities under the cases in items (a) and (b) above. The Company will, in accordance with the applicable laws, make every effort to protect the interests of the Company and the Shareholders, proactively respond to the case and defend its position vigorously. The Company will closely monitor the development of these matters and make further announcements if and when there are any significant developments in relation to each of these legal proceedings.

CONTINGENT LIABILITIES

Save as disclosed in the paragraph headed "LITIGATION AND CLAIMS" in the Management Discussion and Analysis in this Annual Report, as at 31 December 2020, the Group did not have any material contingent liabilities (2019: Nil).

As at 31 December 2020, the Group had approximately 6,200 employees (2019: approximately 3,700). Staff costs (including the Directors' salaries, allowances and bonuses totaled approximately HK\$965,257,000 for the year under review (2019: HK\$599,373,000), of which approximately HK\$852,871,000 (2019: HK\$485,976,000) was included in the cost of services. The Group continues to maintain and upgrade the capabilities of its workforce by providing them with adequate and regular training.

Mr. Mui has over 20 years of experience in education and education consultancy. Mr. Mui had taught at various primary and secondary schools in Hong Kong, including Ying Wa Primary School from September 2004 to February 2005, S.K.H. All Saints' Primary School from March 2005 to September 2006, Hong Kong Sea School from September 2006 to August 2008 and Yan Chai Hospital Chan Iu Seng Primary School from September 2008 to August 2009. From April 2013 to August 2016, Mr. Mui was the chief executive of Hong Kong Church Music Association ("**HKCMA**"), an organisation engaged in the promotion of church music in Hong Kong, during which he was responsible for the implementation of the strategies and policies of HKCMA and the promotion and development of the ministry of HKCMA. His responsibilities at HKCMA included the organisation of the personnel of HKCMA across all levels to advance the development of the ministry of HKCMA, the promotion of the services of HKCMA to other religious organisations in Hong Kong, the organisation of fundraising and other activities to support the expansion of the development of HKCMA and the promotion of the development of HKCMA's online education platform. Mr. Mui has been the managing director of True Light Consultant Services Limited since December 2017, a company which provides one-stop service to educational institutions from kindergartens to universities and social welfare organisations in Hong Kong (collectively, the "Institutions"), ranging from advice on the Institutions' organisation development, assessment on the Institutions, sourcing of regular and consumable supplies for the Institutions, training courses for the Institutions' middle management, teachers and parents, as well as training courses on the Hong Kong Diploma of Secondary Education Examination (DSE), music and sports for interschool competitions and Japanese for students.

He is a member of each of the audit committee, nomination committee and remuneration committee of the Board.

PRINCIPAL ACTIVITIES

The principal activity of the Company is investment holding. The activities of the Company's principal subsidiaries are set out in note 45 to the consolidated financial statements.

BUSINESS REVIEW

The Group's revenue for the year under review was derived from its business activities carried on in Hong Kong, Australia and the PRC. An analysis of the Group's performance for the year ended 31 December 2020 by operating segments is set out in note 6 to the consolidated financial statements.

The business review of the Group for the year ended 31 December 2020 is set out in the paragraph headed "BUSINESS AND FINANCIAL REVIEW" in the Management Discussion and Analysis on pages 9 to 20 in this Annual Report. 董事會謹此呈報其報告,連同截至二零二零年 十二月三十一日止年度之經審核綜合財務報 表。本年報之管理層討論及分析構成本董事會 報告書的一部分。

主要業務

本公司之主要業務為投資控股。本公司主要附 屬公司之業務載於綜合財務報表附註45。

業務回顧

於回顧年度,本集團之收入乃來自於香港、澳 洲及中國進行之業務活動。本集團於截至二零 二零年十二月三十一日止年度之按經營分部 劃分之表現分析載於綜合財務報表附註6。

本集團截至二零二零年十二月三十一日止年 度之業務回顧載於本年報第9至20頁管理層討 論及分析「業務及財務回顧」一段。



PRINCIPAL RISK AND UNCERTAINTIES

Risks which are relevant to the Group and its business

(i) Mobile internet cultural business and provision of IT services

The Group's mobile internet cultural business and provision of IT services is sensitive to the general economic conditions. A severe or prolonged downturn in the global economy or the Chinese economy could materially and adversely affect the Group's business, financial conditions, results of operations and prospects. Economic conditions in the PRC are sensitive to the global economic conditions. Since 96.5% of the Group's revenue for the year under review (2019: 84.9%) was derived from the mobile internet cultural business and provision of IT services in the PRC, the Group's business and prospects are substantially affected by the economic conditions in the PRC, especially following the recent outbreak of COVID-19 during the year under review, the negative impact on the economy is enormous and the operation and financial performance of the Group's mobile internet cultural business and provision of IT services business have been adversely affected by COVID-19. As a result of COVID-19, there is a significant pressure on the cashflow of the Group's business of mobile internet cultural business and provision of IT services owing to the operation of some of the customers of this business segment have been suspended, which led to a decrease in demand for the Group's IT services.

主要風險及不確定因素

與本集團及其業務相關的風險

(i) 移動互聯網文化業務及提供資訊科技服務

本集團的移動互聯網文化業務及提供資訊 科技服務對整體經濟狀況較為敏感。全球 經濟或中國經濟的嚴重或長期不振可能會 對本集團的業務、財務狀況、經營業績及 前景產生重大不利影響。中國的經濟狀況 對全球經濟狀況非常敏感。於回顧年度, 由於本集團96.5% (二零一九年:84.9%) 收入來自於中國移動互聯網文化業務及提 供資訊科技服務,因此本集團的業務及前 景將在很大程度上受中國的經濟狀況影響, 尤其是於回顧年度內隨著近期新型冠狀病 毒的爆發,對經濟產生巨大的負面影響, 本集團的移動互聯網文化業務及提供資訊 科技服務的營運及財務表現因而受到新型 冠狀病毒的不利影響。受新型冠狀病毒影 響,本集團的移動互聯網文化業務及提供 資訊科技服務業務的現金流量面臨巨大壓 力,原因為該業務分部之部分客戶的運營 已暫停,導致對本集團資訊科技服務的需 求減少。

The IT industry is characterised by rapid technological changes, changes in consumer preferences, quick development and enhancement of services and products and emerging industry standards. The introduction of services or products embodying new technologies and the emergence of new industry standards and practices can render existing services or products obsolete and unmarketable. The Group's future success will depend, in part, on its ability to: (i) develop new products and services that address the increasingly sophisticated and varied needs of prospective customers: and (ii) respond to technological advances and emerging industry standards and practices on a timely and cost-effective basis. If the Group is unable to develop and introduce new products in a timely manner in response to changing market conditions and/or customer requirements, or if its new products and services do not achieve market acceptance, the Group's business will be harmed. The Group's development of new products and services entail significant technological risks. The Group cannot assure that it will succeed in using new technologies effectively, adapting its services and products to emerging industry standards, developing, introducing and marketing enhancements of its services and products, or introducing its new products and services.

As the market for the IT business is highly competitive, when the Group develops new applications and software in the future, it may face further operating and marketing challenges. If the Group fails to successfully develop and launch new products in the competitive markets or if the products developed by the Group lack popularity, the Group may not be able to capture the growth opportunities associated with these new products or recover the costs associated with developing and marketing such products, which may materially and adversely affect the Group's business, financial conditions, results of operations and growth strategies. The Group manages its IT business through the adoption of cost controls, the establishment of an internal control system and the maintenance of a positive corporate culture that attracts and retains talents.

In addition, details of the concentration risk and credit risk associated with the major customers of the Group in relation to its provision of IT services business are discussed in the paragraph headed "RELATIONSHIPS WITH STAKEHOLDERS" in this Directors' Report. 資訊科技行業的技術革新迅速、消費者偏 好變動較快、服務及產品經常發展及升級 且行業標準不斷推陳出新。推出使用新技 術的服務或產品以及新興行業標準及慣例 的出現可能會令已經存在的服務或產品被 淘汰並失去市場。本集團未來的成就將部 分取決於以下能力:(i)開發新產品及服務, 以滿足潛在客戶日益複雜及多變的需求; 及(ii)以具有成本效益的方式及時應對技 術革新及行業準則與慣例的出現。若本集 **團無法及時開發及推出新產品**,以應對瞬 息萬變的市場狀況及/或客戶需求,或倘 其新產品及服務無法為市場所接納,則本 集團的業務將會受到不利影響。本集團開 發新產品及服務須承擔重大的技術風險。 本集團無法保證在有效應用新技術、令服 務及產品符合新出現的行業慣例、開發、 推出並升級其服務及產品或推出新產品及 服務方面將卓有成效。

由於資訊科技業務市場競爭激烈,本集團 於日後開發新應用及軟件時,可能面臨更 多的經營及市場推廣挑戰。若本集團無法 個競爭激烈的市場成功開發及推出新 產品,或本集團開發的產品不受青睞,則 產集團可能無法把握與上述新產品相關 的成本,這可能會對本集團的業務、則 關的成本,這可能會對本集團的業務、 對 影響。本集團透過採用成本控制、建立 內部控制系統以及維持可吸引及留住人才。

此外,在提供資訊科技服務業務過程中與 本集團主要客戶有關之集中風險及信貸風 險詳情於本董事會報告書「與持份者之關 係」一段論述。

(ii) Provision of hospitality and related services in Australia

The local business risks in Australia in relation to the Group's provision of hospitality and related services in Australia could have material impact on the businesses, financial conditions, results of operations and growth prospects of the Group's provision of hospitality and related services in Australia. The Group is, and may increasingly become, exposed to different and changing political, social, legal, tax, regulatory and environmental requirements at the local, national or international level in Australia. Also, new policies or measures introduced by the governments in Australia, whether fiscal, tax, regulatory or environmental, or other changes taking place which affect market competition, may lead to an increase in the Group's operating expenses and capital expenditures, an increase in market competition, a decrease in the overall investment return of the Group's businesses and may delay or disrupt the commercial operation of a business resulting in a loss of revenue and profit, which may adversely affect the Group's businesses, financial conditions, results of operations and growth prospects. Following the outbreak of COVID-19, the Group's provision of hospitality and related services in Australia business during the first guarter of 2021 has been adversely affected by COVID-19. In light of the declining economic growth in Australia and the global outbreak of COVID-19, the demand for the services of the Resorts has decreased and is expected to continue to decrease until the third guarter of 2021. In August 2020, the Group completed the Bellinzona Disposals. In February 2021, the Group entered into the agreements in relation to the Cleveland Disposals. Taking into consideration that the Bellinzona Resort Cellar Door & Dining and the Cleveland Winery Resorts & Events have not been performing well, the Group proceeded with the Disposals, so as to re-allocate its resources to the development of Balgownie Estate Vineyard Resort & Spa Yarra Valley, which is likely to achieve a more rapid recovery due to its competitive advantages, including its geographical location, which is in an area popular among tourists.

(ii) 於澳洲提供酒店及相關服務

有關本集團於澳洲提供酒店及相關服務面 臨的澳洲當地業務風險可能會對本集團於 澳洲提供之酒店及相關服務之業務、財務 狀況、經營業績及增長前景構成重大影響。 本集團受澳洲當地、國內或國際方面不斷 變化的各種政治、社會、法律、税務、監管 及環境規定所規限,且未來可能受到更多 上述約束。此外,澳洲政府引進新的政策 或措施(不論是財政、税務、監管或環境, 或其他影響市場競爭的變化)均可能會導 致本集團經營開支及資本開支增加及市場 競爭加劇,可能會減少本集團業務的整體 投資回報,並可能會令業務的商業化經營 推遲或中斷,從而導致收入及溢利有所損 失,這可能會對本集團的業務、財務狀況、 經營業績及增長前景帶來不利影響。新型 冠狀病毒爆發後,本集團於澳洲提供酒店 及相關服務的業務已於二零二一年第一季 度受到新型冠狀病毒的不利影響。鑒於澳 洲經濟增長下滑及全球爆發新型冠狀病 毒,對度假村服務的需求已下降並預計二 零二一年第三季度前繼續下降。於二零二 零年八月,本集團完成貝林佐納出售事項。 於二零二一年二月,本集團就克里夫蘭出 售事項訂立協議。經考慮貝林佐納度假村 及克里夫蘭酒莊度假村運營狀況欠佳,本 集團進行了出售事項,藉以重新分配資源 促進博爾基尼酒莊水療度假村發展。因地 處熱門景區,博爾基尼酒莊水療度假村憑 藉其地理位置及其他競爭性優勢有望更快 復甦。

The results of the Group are reported in Hong Kong dollars but its subsidiaries may receive revenue and incur expenses in other currencies. Any currency fluctuations arising from the translation of the accounts of these subsidiaries, and the repatriation of earnings, equity investments and loans may adversely affect the Group's businesses, financial conditions, results of operations and growth prospects. A depreciation or fluctuation in the currencies in which the Group conducts its operations relative to the Hong Kong dollar could adversely affect the Group's businesses, financial conditions, results of operations and growth prospects.

The Group is in the process of implementing its strategy of achieving a diversified business portfolio to reduce its reliance on revenue and income generated from one single segment or geographical location, so as to minimise the risks related to fluctuations in the foreign exchange rates. The Group may also consider to use appropriate hedging instruments, including futures and forward contracts in the management of exposure caused by fluctuations in the foreign exchange rates. 本集團的業績乃以港元列賬,但其附屬公 司可能會取得及產生以其他貨幣計值的收 入及開支。因此,任何上述附屬公司賬目 換算產生的貨幣匯率波動,及盈利匯回、 股權投資及貸款可能會對本集團的業務、 財務狀況、經營業績或增長前景產生不利 影響。本集團經營所在地貨幣兑港元的貶 值或波動可能會對本集團的業務、財務狀 況、經營業績及增長前景產生不利影響。

本集團正落實其多元化業務組合政策,以 減少其對單一分部或地理位置所產生收益 及收入的依賴,藉以減低外匯匯率波動之 風險。本集團亦會考慮使用適當之對沖工 具(包括期貨及遠期合約),管理外匯匯率 波動所產生之風險。

(iii) Money lending business

The money lending business of the Group is exposed to possible default from the customers, which involves the risk of loss due to the inability or unwillingness of customers to meet their contractual obligations. If the customers of the money lending business of the Group fail to meet their contractual obligations, the Company may need to incur additional costs to realise the collaterals for the relevant secured loans. The risks of losses will be higher for unsecured loans in the event of default. However, the Group has adopted prudent credit procedures in customers' acceptance so as to minimise the credit risk of the Group.

(iv) Assets investments business

For the Group's business of trading of securities in Hong Kong, the Group aims at maximising the profits of the Company for the Shareholders and will revamp its investment strategy and explore securities investment opportunities with due care and diligence. Due to the volatility and uncertainties of the securities market in Hong Kong, the Group may suffer losses on securities trading in the future if the investment strategy the Group has adopted does not fit the then market conditions. The Group will regularly review its investment portfolio and determine a suitable investment strategy to cater for the changes in the market conditions.

Risks which are relevant to the industry and market in which the Group operates

The Group's success will depend, in part, on its ability to respond to technological advances. The Group may not be successful in responding quickly, cost-effectively and sufficiently to these developments. If the Group is unable, for technical, financial or other reasons, to adapt in a timely manner in response to technological advances, it will not be able to compete effectively and the business of the Group will be adversely affected.

(ⅲ)借貸業務

本集團借貸業務存在客戶違約的潛在風險, 當中包括客戶無法或拒絕履行合約義務而 造成損失的風險。若本集團借貸業務的客 戶未履行彼等的合約義務,本公司可能需 於變現相關有抵押貸款的抵押品時產生額 外的成本。若無抵押貸款發生違約,將面 臨更大的損失風險。然而,本集團於吸納 客戶方面採納審慎信貸程序,以減低本集 團信貸風險。

(iv)資產投資業務

就本集團於香港進行證券交易的業務而言, 本集團擬為本公司股東創造更多溢利,並 將修訂其投資策略,同時審慎盡職地尋求 證券投資機會。由於香港證券市場波動及 前景不明朗,若本集團採取的投資策略不 符合當時市況,本集團日後可能會因證券 交易而蒙受損失。本集團將定期檢討其投 資組合,並釐定合適投資策略以應對市況 變動。

與本集團經營所在行業及市場相關的風險

本集團的成功將部分取決於其應對技術革新 的能力。本集團可能無法快速地以具有成本效 益的方式充分應對技術進步。若本集團由於技 術、財務或其他原因無法及時應對技術進步, 則將無法有效進行競爭,從而將令本集團的業 務受到不利影響。 The Group may face risks and uncertainties posed by local political, regulatory and religious environments and failure to comply with country-specific regulatory restrictions may expose the Group to fines, penalties and liabilities. There is no assurance that the current government policies, economic and social conditions in the regions where the Group's business operates will not undergo significant changes in the future. Any new rules and regulations introduced and implemented in the future which regulate the provision of IT services (including the mobile internet cultural business), hospitality business and related services in Australia, money lending business and assets investments business, may adversely affect the business. international expansion and growth prospects of the Group. The Group will from time to time obtain updates on relevant rules and regulations from external professionals to review and ensure the Group is in compliance with the applicable regulations and requirements.

Financial Instrument Risks

The Group is subject to market risks, such as those in relation to currency fluctuations and volatility of interest rates, price risk, credit risk, and liquidity risk in the normal course of the Group's business. Particulars of the nature and extent of financial instrument risks of the Company are set out in note 43 to the consolidated financial statements.

EVENTS AFTER THE REPORTING YEAR

- (i) As set out on page 16 in this Annual Report, on 13 January 2021, Mark Profit Finance Limited, a wholly-owned subsidiary of the Company entered into a supplement agreement with, inter alia, the Target Company to extend the maturity date of the TNG Loan to 13 April 2021. MSL and the Target Company has entered into an addendum to the MOU to extend the expiry date of the exclusivity period to 13 April 2021.
- (ii) As set out on pages 31 to 32 in this Annual Report, the Group has received the Arbitral Awards issued by SHIAC in respect of the demands made in respect of the demands made by LEO against the Group in relation to the settlement of the Unsettled FY2017 Compensation and the Adjustment Amount for FY2018.

- (iv) On 9 March 2021, Noble Tack International Limited (a whollyowned subsidiary of the Company) ("Noble Tack") entered into the subscription agreement with the Target Company and TNG FinTech Holdings Limited, pursuant to which Noble Tack subscribed for 10,200 ordinary shares of the Target Company, representing 51% of the issued share capital of the Target Company upon completion as enlarged by the allotment and issue of such shares, at the subscription price of US\$1,000,000 (equivalent to HK\$7,800,000). The Target Company is an exempted company incorporated in the Cayman Islands with limited liability. The Target Company is an investment holding company. The Target Company holds 79% of the issued shares of TNG Indonesia Pte Ltd ("TNG **Singapore**"), which is a company incorporated in Singapore with limited liability and an investment holding company. TNG Singapore holds 99% of the issued shares of the TNG Indonesia, which is a company incorporated in Indonesia with limited liability and an investment holding company and 1% of the issued shares of TNG Indonesia is held by the Target Company. TNG Indonesia holds 49% of the issued shares of the TNG Indompet, which is a company incorporated in Indonesia with limited liability. 51% of the issued shares of TNG Indompet is held by Mr. Tri Putra Permadi Wiyono ("Indonesian Shareholder") who has pledged such interest in favour of TNG Indonesia pursuant to the contractual arrangements, details of which are set out in the Company's announcement dated 9 March 2021. TNG Indompet is principally engaged in (1) Indosat mobile top-up distribution business of PT Dian Kencana Puri Prima for three (3) exclusive clusters, namely Balikpapan, Samarinda and Papua through traditional physical outlets; and (2) the co-branding "W-Cash" electronic wallet with a licensed e-money issuer ("E-Money **Issuer**") in Indonesia pursuant to the cooperation between TNG Indompet and the E-Money Issuer.
- (v) As set out on page 18 in this Annual Report, the Group completed the TH Disposals on 3 March 2021 and 10 March 2021 to partially repay the loan and the liabilities owed to the Lender under the Loan as required by the Judgment.

The purpose of the Scheme is to provide incentives or rewards for eligible participants' contribution to the Group and/or to enable the Group to recruit and retain high-calibre employees and attract human resources that are valuable to the Group and any invested entity.

The maximum entitlement of each participant under the Scheme would not exceed 1% of the aggregate number of shares for the time being issued and issuable in any 12-month period under the Scheme.

A nominal consideration of HK\$1 is payable on acceptance of the grant of an option.

The exercise price will be determined by the Directors, but may not be less than the highest of the closing price of the shares on the GEM on the date of the grant of the option or the average of the closing price of the shares on the GEM for the five trading days immediately preceding the date of the offer of grant of the option or the nominal value of the shares.

The Scheme shall remain in force for the period of 10 years commencing on the adoption date of the Scheme which was 9 June 2020.

The maximum number of shares of the Company which may be issued upon exercise of all options that may be granted under the existing Scheme limit is 533,623,510 shares of HK\$0.01 each (representing approximately 10% of the issued share capital of the Company as at the date of this Annual Report). During the year ended 31 December 2020, no options have been granted under the existing Scheme limit.

Creating a paperless working environment not only alleviates environmental damages but also fits the commercial goals of the Group, which saves physical space, facilitates information sharing via IT networks, and reduces complicated documentation procedures for the Group. Moreover, duplex printing and copying have become the norm within the Group, greatly reducing paper consumption and saving costs. Data on printing is regularly collected and assessed, in order to monitor the efficacy of the Group's paperless environment. Details of the Group's commitments and efforts are summarised in the section headed "ENVIRONMENTAL, SOCIAL AND GOVERNANCE REPORT" in this Annual Report.

RELATIONSHIPS WITH STAKEHOLDERS

The Group recognises that employees are valuable assets of the Group. The Group ensures all employees are reasonably remunerated, and continues to improve, regularly review and update its policies on remuneration and benefits, training, occupational health and safety. Employees are encouraged to devote their time to participate in local fund-raising activities.

The Group understands the importance of maintaining a good relationship with its suppliers, customers and business partners to meet its immediate and long-term goals. Based on the Group's business nature, most of the customers are occasional and non-routine, except for the major customer in relation to the Group's provision of IT services, which is a sizable corporate client which has over ten years of relationship with the Group. To minimise credit risk, the Group in general does not allow credit sales for individual customers. On the other hand, credit terms ranging from 30 days to 180 days are given to sizable corporate customers and major customers with long-term business relationships with the Group. The Group values the feedback from its customers and always tries to understand their needs through regular communication and business updates.

環境政策與表現

本集團鼓勵環保並推動其僱員提升環保意識。 本集團亦於人力資源及採購(倘適用)等日常 營運中,採用無紙化系統及措施。營造無紙化 之工作環境可為本集團節省空間、透過資訊科 技促進資訊互享及削減繁複文書程序,既能減 輕對環境造成破壞,亦合乎本集團商業考慮。 另外,雙面列印及複製已成為本集團之慣常做 法,大大減少紙張消耗及節省成本。本集團定 時收集及評估有關列印之數據,藉此監控本集 團無紙化環境之成效。本集團之承擔及投入之 詳情概述於本年報所載之「環境、社會及管治 報告」一節。

與持份者之關係

本集團認識到員工是本集團之寶貴財富。本集 團確保給予全體僱員合理待遇,不斷完善及定 期檢討和更新其薪酬福利、培訓、職業健康與 安全政策。本集團鼓勵僱員投放時間參與地方 籌款活動。

本集團了解與其供應商、客戶及業務夥伴保持 良好關係對達到其短期及長期目標之重要性。 根據本集團業務性質,除本集團提供資訊科技 服務之主要客戶為與本集團有著逾十年客戶 關係之大型企業客戶之外,其餘大部分客戶乃 非經常性及非固定客戶。為減低信貸風險,本 集團一般不會允許個別客戶進行賒銷。另一方 面,本集團會向與本集團有著長期業務關係之 大型企業客戶及主要客戶授予30日至180日之 信貸期。本集團重視客戶之反饋意見,務求透 過定期溝通及更新業務資訊了解客戶之需求。

In particular, the largest customer in relation to the Group's IT services business has accounted for approximately 94.5% (2019: 94.4%) of the total revenue of the Group from the corresponding business and 91.3% (2019: 80.1%) of the total revenue of the Group during the year ended 31 December 2020. Such customer is a leading Chinese multinational networking and telecommunications equipment and services company. As at 31 December 2020, accounts receivable (comprising trade receivables and contract assets) due from such customer amounted to approximately HK\$291,368,000. As at the date of this Directors' Report, more than half of these accounts receivable have been settled. The contractual credit period agreed with such customer was generally 90 days, whereas the maximum extension of credit period was 6 months. During the year ended 31 December 2018, the Group changed its accounting policies in relation to the assessment of the recoverability of accounts receivable following the initial adoption of Hong Kong Financial Reporting Standard ("HKFRS") 9 "Financial instruments". The expected credit loss model requires an ongoing measurement of credit risk associated with a financial asset. Under this model, the Group has made a reversal of impairment of contract assets of approximately HK\$536,000 (2019: HK\$8,000); and an impairment loss of approximately HK\$1,790,000 (2019: HK\$383,000) on accounts receivables, loan and interest receivables for the year ended 31 December 2020. In consideration of the size and reputation of the major customer as well as its sound payment history, the Board considers that there is a low risk in accounts receivables, loan and interest receivables recoverability. The Board is satisfied with the subsequent settlement of this major customer and is of the view that its credit quality has not deteriorated.

The Group anticipates that it will continue to derive a significant portion of its revenue from this major customer in the near future. Nevertheless, there can be no assurance that the Group will be able to retain this major customer or secure purchase orders on favorable terms to the Group, to maintain the current level of business with this major customer, or to renew the co-operation framework agreement with this major customer in the long run on terms that are favourable to the Group. Any significant reduction in the volume of business with this major customer, any significant restriction in pricing terms with this customer, or any cancellation, delay or reduction in the scope of sales from this major customer, could have a material adverse effect on the operating results and profitability of the Group. The Directors considered that the Group's reliance on its major customer will be reduced as the Group's customer base has been diversified through the Group's provision of hospitality and related services business in Australia with the Group's revenue being less concentrated during the year under review.

尤其是,本集團資訊科技服務業務之最大客 戶佔本集團相應業務總收益約94.5%(二零 一九年:94.4%), 並佔本集團截至二零二零 年十二月三十一日止年度總收益91.3%(二 零一九年:80.1%)。該客戶為中國一家領先 的跨國網絡工程及電信設備及服務公司。於 二零二零年十二月三十一日,應收該名客戶 之賬款(包括應收貿易賬款及合約資產)約為 291.368.000港元。於本董事會報告書日期, 該等應收賬款中超過一半已結算。與該名客戶 協定之合約信貸期一般為90天,而信貸期最 高可延長至6個月。於截至二零一八年十二月 三十一日止年度,本集團於首次應用香港財務 報告準則(「香港財務報告準則」)第9號「金融 工具」後,就應收賬款可回收性評估更改其會 計政策。預期信貸虧損模式要求對金融資產的 相關信貸風險持續計量。在此模式下,於截至 二零二零年十二月三十一日止年度,本集團 已作出合約資產減值撥回約536,000港元(二 零一九年:8,000港元);及應收賬款、應收貸 款及利息之減值虧損約1,790,000港元(二零 一九年:383,000港元)。經考慮主要客戶之規 模、聲譽及良好付款記錄,董事會認為應收賬 款、應收貸款及利息存在較低的可收回性風 險。董事會信納主要客戶後續結算,並認為其 信貸質素並未惡化。

本集團預料,短期內其大部分收益將繼續來自 該主要客戶。然而,概不保證本集團將能夠留 住該主要客戶或按對本集團有利的條款獲得 任何採購訂單,以維持與該主要客戶現時的業 務水平,或與該主要客戶按較長期間對本集團 有利的條款重續合作框架協議。倘與該主要客 戶的業務遭受任何重大限制,或與該客客戶 定價條款遭覺任何取消、延誤或結減, 重 動業。董事認為,本集團對其主要客 的現有集團之經營業績及盈利能力差破 之經營業將逐漸降低,因為本集團的戶基礎 透過本集團於澳洲提供酒店及相關服務業中 程度亦有所下降。

COMPLIANCE WITH LAWS AND REGULATIONS

During the year under review, there was no material breach of or non-compliance with the applicable laws and regulations such as the Companies Ordinance (Chapter 622 of the Laws of Hong Kong) (the "**Companies Ordinance**"), the GEM Listing Rules, and other applicable local laws and regulations in various jurisdictions that has a significant impact on the business and operations of the Group.

In addition, the Group is subject to the requirements under various laws in relation to its different business segments. The laws and regulations that have significant impacts on the business and operations of the Group are as follows.

PERMITTED INDEMNITY PROVISION

A permitted indemnity provision that meets the requirements specified in section 469(2) of the Companies Ordinance for the benefit of the Directors is currently in force and was in force throughout the year under review. The Company has taken out and maintained directors' liability insurance during the year under review, which provides appropriate cover for the directors of the Group.

SUFFICIENCY OF PUBLIC FLOAT

Based on information that is publicly available to the Company and within the knowledge of the Directors as at the latest practicable date prior to the date of this Annual Report, the Company has maintained sufficient public float under the GEM Listing Rules as at the date of this Annual Report.

PRE-EMPTIVE RIGHTS

There are no provisions for pre-emptive rights under the Bye-Laws, or the laws of Bermuda, which would oblige the Company to offer new shares of the Company on a pro-rata basis to existing Shareholders.

AUDITOR

PKF Hong Kong Limited resigned as the auditor of the Company with effect from 27 November 2019 as the Company was unable to reach an agreement with PKF Hong Kong Limited on the auditor's remuneration for the year ended 31 December 2019. The Board has resolved that, with the recommendation of the audit committee of the Board, to appoint Ascenda Cachet CPA Limited as the new auditor of the Company with effect from 27 November 2019 to fill the causal vacancy left by the resignation of PKF Hong Kong Limited.

核數師

由於本公司與大信梁學濂(香港)會計師事 務所有限公司未能就截至二零一九年十二月 三十一日止年度的核數師酬金達成協議,大信 梁學濂(香港)會計師事務所有限公司已辭任 本公司核數師,自二零一九年十一月二十七日 起生效。經董事會審核委員會推薦,董事會議 決委任天健德揚會計師事務所有限公司為本 公司新任核數師,自二零一九年十一月二十七 日起生效,以填補大信梁學濂(香港)會計師 事務所有限公司辭任後之臨時退任空缺。 Ascenda Cachet CPA Limited resigned as the auditor of the Company with effect from 7 January 2021 because, as part of their normal procedures including an annual consideration of whether they would wish to continue to act for their audit clients, having taken into account the level of audit fees and their available internal resources in light of their current work flows in respect of the professional risk associated with the audit, they decided to tender their resignation as the auditor of the Company. The Board has resolved that, with the recommendation of the audit committee of the Board, to appoint McMillan Woods (Hong Kong) CPA Limited as the new auditor of the Company with effect from 7 January 2021 to fill the causal vacancy left by the resignation of Ascenda Cachet CPA Limited.

McMillan Woods (Hong Kong) CPA Limited will retire and being eligible, offer itself for re-appointment. A resolution for the re-appointment of McMillan Woods (Hong Kong) CPA Limited as the auditor of the Company is to be proposed at the forthcoming annual general meeting of the Company.

INTRODUCTION

Hang Tai Yue Group Holdings Limited (the "**Company**", together with its subsidiaries, "**the Group**") adopts a diversified business development strategy and has established its firm footing in four business segments, namely (i) mobile internet cultural business and provision of information technology ("**IT**") services; (ii) provision of hospitality and related services in Australia; (iii) money lending business; and (iv) assets investments business during the financial year ended 31 December 2020 ("**FY2020**").

This Environmental, Social and Governance Report (the "**ESG Report**") summarises the environmental, social and governance ("**ESG**") initiatives, plans and performances of the Group and demonstrates its commitment to sustainable development.

The ESG Governance Structure

The Group conducts a top-down management approach regarding its ESG issues. The board of Directors (the "**Board**") oversees the Group's ESG performance, sets out ESG strategies and periodically reviews the progress of the identified material ESG issues. The Board is also responsible for ensuring the effectiveness of the Group's risk management and internal controls.

The Group has designated personnel to systematically identify and cater to ESG issues. The said personnel are responsible for collecting and analysing relevant ESG data and identifying the Group's ESG issues. In addition, these designated personnel will periodically report to the Board for the evaluation and subsequent implementation or revision of the Group's ESG strategies.

環境·社會及管治結構

本集團對其環境、社會及管治問題採取自上而 下的管理方法。董事會(「**董事會**」)監督本集 團的環境、社會及管治表現、制定環境、社會 及管治策略並定期檢討已識別重大環境、社會 及管治事宜的進展。董事會亦負責確保本集團 的風險管理及內部監控成效。

本集團已指定人員系統性地識別及應對環境、 社會及管治問題。該等人員負責收集及分析相 關環境、社會及管治數據,及識別本集團的環 境、社會及管治問題。此外,該等指定人員將 定期向董事會匯報,以便對本集團環境、社會 及管治策略作出評價及後續實施或修訂。

SCOPE OF REPORTING

The ESG Report only covers the Group's businesses in relation to the provision of hospitality and related services in Australia, money lending business and assets investments business in Hong Kong. Three sites in Australia, namely i) the Balgownie Estate Vineyard Resort & Spa Yarra Valley ("**Balgownie**"), ii) the Bellinzona Resort Cellar Door & Dining ("**Bellinzona**") and iii) the Cleveland Winery Resort & Events ("**Cleveland**") (collectively, the "**Resorts**") and a general administrative office in Hong Kong will therefore be included in the ESG Report. As at 25 August 2020, the disposal of Bellinzona was completed. The ESG Report will therefore include the environmental key performance indicators ("**KPIs**") of Bellinzona up to the date of disposal, whereas its related social KPIs will be excluded.

The KPIs gathered are shown in the ESG Report and are supplemented by explanatory notes to establish benchmarks. The Group will extend the scope of disclosure when and where possible.

REPORTING FRAMEWORK

The ESG Report has been prepared in accordance with the Environmental, Social and Governance Reporting Guide (the "**ESG Reporting Guide**") except for the amendments thereto which are applicable to financial year commencing on or after 1 July 2020 as set out in Appendix 20 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited ("**Stock Exchange**").

Information relating to the Group's corporate governance practices can be found in the Corporate Governance Report on pages 99 to 115 of this Annual Report.

REPORTING PERIOD

The ESG Report specifies the ESG activities, challenges, measures taken by, compliance and results of the Group during FY2020.

報告範圍

Environmental protection and sustainable development rely on concerted and continuous efforts from all industries and society. Therefore, the Group has continued to refine and improve upon its mitigation policies to reduce both its direct and indirect negative environmental impacts arising from its business operations.

The Group was not aware of any material noncompliance with laws and regulations relating to air and GHG emissions, discharges into water and land, and the generation of hazardous and non-hazardous waste that would have a significant impact on the Group during FY2020. The said laws and regulations include but are not limited to the Road Traffic Ordinance, the Waste Disposal Ordinance, the Water Pollution Ordinance of Hong Kong, the State Environment Protection Policy (Ambient Air Quality) and the Environment Protection Act 2017 of Victoria, Australia.

Air Emissions

Due to the Group's business nature, only an immaterial amount of air emissions was generated from the use of company vehicles. Description of mitigation measures of emissions will be provided in the following section – GHG Emissions.

GHG Emissions

The principal GHG emissions of the Group were generated from the combustion of petrol and diesel from the use of vehicles and yachts (Scope 1), purchased electricity (Scope 2) and paper waste disposal at landfills (Scope 3).

Scope 1 – Direct GHG Emissions

To reduce fuel usage and thus air emission, the Group has provided the following guideline to its business operations:

- Switch off the engine when the vehicle is idling;
- Plan routes ahead of time to optimise fuel consumption and reduce air emissions; and
- Provide regular maintenance service for the vehicles to ensure optimal engine performance and fuel use.

Scope 2 – Indirect GHG Emissions

Electricity consumption accounts for the largest indirect GHG emissions within the Group. The Group has implemented a series of measures to reduce energy consumption, said measures will be mentioned in "Aspect A2 – Use of Resources".

Scope 3 – Other Indirect GHG Emissions

Due to the travel restrictions caused by the COVID-19 pandemic, all business travel was temporarily suspended and was replaced by web conferences or teleconferences. Measures on reducing the disposal of paper waste will be mentioned in the section headed "Non-hazardous Waste Handling Method".

Total GHG emissions decreased by approximately 63.51% from approximately 3,059.64 tCO₂e in FY2019 to approximately 1,116.50 tCO₂e in FY2020. This was mainly due to the reduced patronage of hotel guests of the Resorts following the COVID-19 restrictions placed by the Australian government. Also, employees' awareness of reducing indirect GHG emissions has been increased through the implementation of the above-mentioned measures.

Waste Management

Hazardous Waste Handling Method

Due to the Group's business nature, no material hazardous waste, according to the list of waste considered as being hazardous under the Hazardous Waste (Regulation of Exports and Imports) Act 1989 of Australia and Waste Disposal Ordinance of Hong Kong, has been generated during FY2020.

Non-hazardous Waste Handling Method

The majority of the non-hazardous waste generated by the Group was office paper. A policy on reducing wastage can also be found in the respective Employee Handbook for both the Group's head office in Hong Kong and the Resorts in Australia, it reminds employees to take extra care during normal duties when handling tools, equipment, supplies and food so that the Group can minimise its non-hazardous waste production.

In the office, a number of green measures are encouraged:

- Use double-sided printing or photocopying;
- Print electronic correspondences only when necessary; and
- Reuse one-sided printed paper.

At the Resorts, the Group has incorporated sustainability measures into its daily operations by introducing a robust recycling system. The Group engaged one of Australia's largest recyclers to recycle the plastic bottles and paper generated by the Group's operations. The Group is also planning on transitioning away from single-use plastic items and replacing them with more sustainable alternatives in the future.

From the implementation of the above-mentioned efforts, employees' awareness of adopting good waste management practices has increased. This is shown by a decrease of approximately 42.58% of the office paper usage from FY2019 to FY2020. This was mainly due to the reduced operation of the Resorts following the Australian government's restrictions on combating the COVID-19 pandemic. The comparison was made only on office paper waste instead of the total non-hazardous waste since the data in general waste was not available in FY2019.

Water Consumption

The Group is committed to reducing water usage by promoting and nurturing employees' awareness of water conservation. A number of green measures have been adopted in the Group's business operations:

- Water collected from the roofs of the Resorts will be reused for various purposes to reduce reliance on external water supply;
- Effluent treatment systems are installed at the Resorts to capture and treat all waste on-site, water is then reused on all irrigation to the vines and landscaping;
- Water-saving slogans and posters are displayed as reminders; and
- Dual flush water cisterns in toilets and faucet aerators in sinks are installed in washrooms.

Water usage in FY2020 amounted to approximately 7,366.02m³, a decrease of approximately 60.22% from approximately 18,517.00m³ in FY2019. This was mainly due to the reduced patronage of hotel guests of the Resorts following the COVID-19 restrictions placed by the Australian government. Also, employees' awareness of reducing water consumption has been increased through the implementation of the above-mentioned measures.

Due to the business nature, the Group did not encounter any problem in sourcing water that is fit for purpose during FY2020.

Energy Consumption

The Group has established relevant policies and initiatives on energy conservation to monitor and maximise its energy efficiency. All employees are duly notified of the implementation of such policies and measures. Regular review is conducted on the Group's energy objectives for continuous improvement in the Group's energy consumption performance. Should the energy usage in any of the Group's operations increase unreasonably, the Group will send reminders via email to remind relevant departments of energy conservation.

In the office, a number of green measures have been encouraged:

- Purchase energy-efficient equipment on replacement of retired equipment;
- Switch off unnecessary lightings and electrical appliances when not in use; and
- Set all computer screens and printers to standby mode after a certain period of idling.

At the Resorts, the Group stresses the importance of environmental sustainability; sustainable designs can be observed throughout the Resorts. A number of elements have been incorporated to reduce energy usage, as shown below:

- Power-saving devices have been installed to all units which automatically de-activate all air-conditioning and lighting when the units are left unattended;
- Appropriate insulation and shading to the building have been added to optimise temperature control;
- Skylights and glazing are installed to bring more natural light into the facilities;
- Solar heating systems are installed to complement gas heating systems and electric efficient heat pumps; and
- Natural flow through ventilation to all units reduces the reliance on air-conditioning usage.

Energy consumption has decreased by approximately 57.46% from approximately 3,104,756.06kWh in FY2019 to approximately 1,320,628.09kWh in FY2020. This was mainly due to the reduced patronage of hotel guests of the Resorts following the COVID-19 restrictions placed by the Australian government. Also, employees' awareness of reducing energy consumption has been increased through the implementation of the abovementioned measures.

During the procurement process for furniture and amenities, the Group takes sustainability into consideration and prefers procuring from organisations that offer responsibly sourced goods. For the provision of hospitality and related services in Australia, the Group intends to further minimise the use of single-use disposable items, consider the environmental impacts and life cycle of the products to be purchased and explore more environmentally friendly alternatives.

Climate Change Mitigation and Adaptation

The Group is aware of the threat posed by climate change and is adamant in doing its part by offsetting its carbon footprint. The Group has plans to engage a leading Australian commercial energy efficiency company to implement solar photovoltaic ("**PV**") systems in its Resorts to aid the transition towards renewable energy. GHG emissions are forecasted to reduce in the subsequent financial years following the successful implementation.

Noise Control

The Group recognises that entertainment venue noise may be generated at some of the Resorts. The Group abides by the State Environment Protection Policy (Control of Music Noise from Public Premises) No. N-2 which is incorporated in the venues' current liquor licences. The Resorts actively control the music level and limit loud music at the prescribed hours to ensure that other guests and neighbours will not be severely disrupted.

減緩及適應氣候變化

本集團了解氣候變化所帶來的威脅, 並堅決通過抵消其碳足跡來履行自己 的責任。本集團計劃委聘一間澳洲領 先的商業能源效率公司於其度假村安 裝太陽能光伏(「**光伏**」)系統,從而協 助本集團向可再生能源過渡。於系統 成功安裝後,預期在隨後的財政年度 溫室氣體排放將會減少。

Human resources are the cornerstone of the Group. The Group recognises that its continued success is dependent on employees' talents and their dedication.

Employment policies for each of the Group's operations have been established in detail with regard to recruitment and remuneration, compensations, working hours and rest periods, diversity and equal opportunities, etc. These policies and employment practices are put under review periodically for revision to ensure the Group continues to improve its employment standards and competitiveness against companies in a similar industry.

During FY2020, the Group was not aware of any material non-compliance with employment-related laws and regulations that would have a significant impact on the Group, including but not limited to the Fair Work Act 2009 and the Workplace Gender Act 2012 of Australia, the Equal Opportunity Act 2010 of Victoria, Australia and the Employment Ordinance, the Minimum Wage Ordinance, the Employees' Compensation Ordinance, the Sex Discrimination Ordinance and the Disability Discrimination Ordinance of Hong Kong. As at 31 December 2020, the Group had 143 employees working in the reported segments.

Talent Attraction and Retention

The Group's employees are recruited via a robust, transparent and fair recruitment process based solely on their experience and expertise and without regard to their age, ethnicity, origin, gender identity, marital status, sexual orientation and religion.

Employees are assessed by their ability and potential to fulfil the Group's current and future needs. All employees responsible for the recruitment process will periodically review the selection criteria to ensure that existing policies remain relevant and that the policies do not unlawfully discriminate. Recruitment interviews will also be carried out by more than one person where possible.

Promotion and advancement will be made based on merits and in line with the Recruitment and Selection Policy that is formally documented in the Employee Handbook. The Group will conduct an annual performance and salary review to determine any salary adjustments and/or promotion opportunities. Written and verbal performance evaluations will be given to all employees at least once a year, such evaluations are intended to give recognition to the hard work of the employees and provide any comments for improvement.

Employees' Rights and Welfare

The Group's basis for remuneration is job-related skills, qualifications and performances. Remuneration packages include annual leave, maternity leave, compassionate leave and community service leave, etc. Also, the Group has formulated policies in determining the working hours and rest periods for employees according to local employment laws. All compensation made by the Group is given based on the provision of Workmen's Injury Compensation Insurance Policy under the Workplace Injury Rehabilitation and Compensation Act 2013 of Victoria, Australia and Employees' Compensation Ordinance of Hong Kong which cover the rehabilitation of injured workers and compensation in relation to injuries or deaths arising out of accidents and diseases in the workplace.

Unreasonable dismissal under any circumstances is prohibited. A detailed list of major offences regarded as just reasons for immediate dismissal can be found in the Employee Handbook.

Equal Opportunities, Diversity and Anti-discrimination

The Group recognises the value of diversity in its talent pool and is committed to creating and maintaining an inclusive and collaborative workplace culture in which all employees can thrive. The Group prohibits any discrimination, physical or verbal harassment based on race, religion, colour, gender, physical or mental disability, age, place of origin, marital status and sexual orientation in the workplace. Deliberate acts of unlawful discrimination or harassment are also considered serious misconducts which may result in the termination of contract without notice. The Group does not tolerate sexual harassment or abuse in the workplace of any form. B. 社會(續)

A comprehensive policy on occupational health and safety is in place to safeguard the interest of the employees. During induction training, relevant policies and procedures will be explained and/or provided to the employees to mitigate the occurrence of accidents. Relevant policies are reviewed annually, or soon after an incident arises, to make sure that the said policies continue to be of relevance.

During FY2020, the Group was not aware of any material non-compliance with health and safety-related laws and regulations that would have a significant impact on the Group including but not limited to the Occupational Health and Safety Act 2004 and the Occupational Health and Safety Regulations 2007 of Victoria, Australia and the Occupational Safety and Health Ordinance of Hong Kong. During FY2020, there were no reported cases of work-related fatalities and no lost days due to work injury.

Occupational Health and Safety

The Group recognises that employees are its most valuable assets, therefore the Group is keen on providing a safe and pleasant working environment to retain talents and ensure that their well-being is taken care of. Relevant health and the safety policies are indicated in the Employee Handbook, said policies are regularly reviewed and/or reviewed upon trigger events to ensure that the provisions continue to provide protection to its employees. At the Resorts, a front office training session has been held to familiarise its employees with various emergency scenarios such as gas leaks, wildlife or bomb threats. Uniform and/or personal protective equipment are provided for relevant employees.

Safety Training and Inspections

The Group makes use of safety training and inspections to ensure employees are aware of the importance of complying with safety requirements. An induction training on relevant health and safety policies with regard to their particular position is provided to every employee at the beginning of the employment to minimise the likelihood of accidents or workplace injuries. Personnel, whether employed directly or indirectly by the Group, is required to abide by all applicable laws, regulations and safety requirements imposed by relevant government authorities.

Occupational health and safety meetings are held regularly to address concerns and identify possible alternatives or solutions in an expedited manner. Regular meetings were held in FY2020 and minutes have been taken during all these meetings. Meetings are considered crucial to the improvement of the health and safety of guests and employees as issues are directly dealt with and persons-in-charge are designated to ensure that the actions or plans are followed through.

Preventative Measures on COVID-19

In response to the outbreak of the COVID-19 pandemic, the Group has implemented a series of measures to ensure the health and safety of its employees and guests of the hospitality business. To reduce infection risk the Group has complied with the public health and safety policies set out by the HKSAR government and the Australian Government Department of Health during the year under review. For example, guests and employees are required to check their temperature and wear a surgical mask before entering any of the Group's premises.

As the Group is also responsible for the health and safety of its guests, the Group has enhanced its health and safety protocols and carried out additional measures in the Resorts. Internal training regarding COVID-19 was held in the Resorts during the year under review to ensure compliance with the state and federal health directions regarding COVID-19 and train its employees with essential hygiene practices to reduce crosscontamination. Employees of the Resorts are asked to remind guests to maintain social distancing at all times and to advise guests not to share rooms with others not from the same household. Back-to-back usage of rooms is avoided, all surfaces whether in rooms or public areas of the Resorts are subject to rigorous disinfection and sanitation practices.

Training and continuous development are indispensable to the Group's employees to keep abreast of the everchanging trend of the industry. To incentivise employees to acquire new skills and to increase their professional knowledge, the Group has policies in place to encourage its employees to pursue training for the advancement of their careers that will benefit the Group and the employees. The training cost may be borne by the Group subject to the approval of the Group.

In FY2020, the Group arranged its employees in Hong Kong to participate in seminars organised by ListcoPRO, a leading services provider for listed companies in Hong Kong in the area of continuing professional development. In FY2020, seminars participated by the employees in Hong Kong cover topics such as anti-money laundering, effective internal control and corporate governance.

Training contents are regularly updated to be in line with the industrial standards and provide maximum benefit to the employees.

The Group prohibits the recruitment of child and forced labour as prescribed by laws and regulations. The Group strictly complies with local laws and shall not provide job opportunities to those who are under the legal working age of respective jurisdictions.

To avoid illegal employment of child labour and underage workers, the Human Resources department of the Group is responsible for verifying personal data such as the identification card during the recruitment process. If violation is involved, it will be dealt with according to circumstances. No employee shall be compelled to work against his or her will through force or intimidation of any form or subjected to corporal punishment or coercion of any type related to work.

During the supplier selection process, the Group takes into account the supplier's job references, prevailing market price, delivery time and reputation. In addition, the Group also considers suppliers who incorporate ESG issues into their policies and general business development strategies. Preferential consideration will be given to suppliers who utilise recycled or reused material in their production process. Furthermore, the Group is keen on supporting the local economies, where possible, the procurement is sourced locally in Australia and Hong Kong.

Procurement policy is present within the Group. Where possible, competitive quotes should be obtained from at least two suppliers. For procurement of a higher value, an additional analysis should be run through beforehand, such as its cost and benefit, presence of other alternatives and implications if the said purchase is not made. The Group strives not to over-rely on a specific supplier in order to ensure the stability of the supply chain.

To monitor the continuous efforts from the suppliers in minimising their environmental and social impacts, a regular assessment will be conducted on existing suppliers to ensure compliance with the Group's expectations. Contracts with suppliers may be terminated if the expectation of the Group is not met.

During FY2020, the Group was not aware of any material non-compliance with laws and regulations that would have a significant impact on the Group, including but not limited to the Privacy and Data Protection Act 2014, the Liquor Control Reform Act 1998 of Victoria, Australia and the Personal Data (Privacy) Ordinance of Hong Kong, concerning health and safety, advertising, labelling and privacy matters relating to products and services and methods of redress. During FY2020, the Group did not receive any cases of product or service-related complaints, nor was it subjected to any product recalls.

Business Ethics

The Group advocates ethical practices and is determined to mitigate any potential misconduct or poor services in all its business segments. Therefore, the Group has established different policies, as shown below, to better guide its employees and nurture them the importance of upholding ethical practices from the beginning of their professional careers.

In maintaining and ensuring the quality of products produced in the Group's vineyards, strict requirements have been imposed on the storage environment and the production facilities. Since wine production is outsourced, the Group conducts quality control inspections upon receiving wine from its subcontractor. The winery in Cleveland has obtained a Liquor Licence pursuant to the Liquor Control Reform Act 1998 of Victoria, Australia and strictly complied with the requirements prescribed in the said Licence.

Customer Health and Safety

The Group places great emphasis on ensuring customers' health and safety. Detailed policies and guidelines have been in place to ensure employees provide the highest quality and safe services to the Group's customers and guests. In doing so, the occurrence of unfortunate accidents or illnesses can be avoided. Disciplinary actions will be taken against employees who participate in activities that would threaten the health and safety of concerned parties, his/her colleagues or others.

Marketing and Labelling

The Group conforms with wine labelling guidelines pursuant to the Wine Australia Act 2013. As for alcohol marketing, the Group abides by the requirements set out in the ABAC Responsible Alcohol Marketing Code. Relevant guidelines have been provided to the relevant employees. B. 社會(續)

Guidelines on the special requirements in money lending business advertisements are formally documented. In addition, the Group abides by the stipulated legal requirements that pertain to the Money Lending Licence under the Money Lenders Ordinance.

Customer Services and Complaint Management

The Group maintains an open and welcoming attitude to feedback and complaints from the Group's customers and guests, as the Group views it as an opportunity to improve its service. Procedures for handling complaints are detailed in the Service Handbook for the reference of relevant employees. Should the Group receive any complaints, the Group will strive to act immediately to resolve the issue with effective corrective actions.

Customer Data Protection and Privacy

The Code of Conduct states that the Group's employees have an obligation to maintain the confidentiality of information acquired during the course of employment. Access to sensitive data and the Group's network is granted on an 'as needed' basis. Employees are also required not to transmit highly confidential data through the use of electronic communications as it is not completely private. During FY2020, the Group was not aware of any material non-compliance with the relevant laws and regulations of bribery, extortion, fraud and money laundering, including but not limited to the Criminal Code Act 1995 of Australia and the Prevention of Bribery Ordinance of Hong Kong that would have a significant impact on the Group. During FY2020, there were no concluded legal cases regarding any forms of fraud brought against the Group or its employees.

Anti-money Laundering and Counter-financing of Terrorism

As the Group provides money lending business, the Group may be subjected to the risk of unintentionally engaging in money laundering and financial crimes. Therefore, in addition to the compliance with laws and guidelines set up by regulatory authorities, the Group has set out guidelines to safeguard the interests of the Group, such as conducting background investigation, due diligence and loan approvals for loan financing applications.

BOARD OF DIRECTORS

Board composition

As at the date of this Annual Report, the Board comprises six members, three of which are executive Directors, namely Mr. Hui Chun Sum, Ms. Lam Ching Yee, and Ms. Pauline Lam. Three other members of the Board are independent non-executive Directors, namely Mr. Wong Siu Keung, Joe, Mr. Mui Wai Lun, who has been appointed as an independent non-executive Director with effect from 8 December 2020, and Professor Tsui Ka Kin Kevin, who has been appointed as an independent non-executive Director with effect from 14 December 2020. Mr. Lee King Fui resigned as an independent non-executive Director with effect from 8 December 2020 and Mr. Ho Kin Wai resigned as an independent non-executive Director with effect from 15 December 2020.

The members of the Board, who come from different backgrounds, provide a diverse range of business and professional expertise to the Company. The biographical details of the Directors are set out in the section headed "DIRECTORS PROFILE" on pages 40 to 42 in this Annual Report. All Directors are subject to retirement by rotation and re-election at the annual general meeting of the Company at least once every three years in accordance with the Bye-Laws. The Company has arranged appropriate insurance cover for the Directors. As at the date of this Annual Report, none of the Directors has any relationship (including financial, business, family or other material/relevant relationship) with each other.

Roles and responsibilities of the Board and delegation to the management

The Board is responsible for the leadership and control of the Company and oversees the Group's business, strategic decisions and performance, and is responsible for promoting the success of the Company by directing and supervising its affairs. In practice, the Board takes responsibilities for decision making in all major matters of the Company which include approving and monitoring all policy matters, overall strategies, material transactions, appointment of directors and other significant financial and operational matters. The day-to-day management, administration and operation of the Company are delegated to the senior executives who are responsible for implementing the decisions of the Board, the coordination and direction of day-today operation and management of the Company in accordance with the management strategies and plans approved by the Board. Approval has to be obtained from the Board prior to the entering by the Group into any significant transactions. These senior executives provide full support to the Board in order for the Board members to discharge their responsibilities.

Practices and conduct of board meetings

The company secretary (the "**Company Secretary**") of the Company is responsible to the Board for providing Board papers and related materials, for ensuring that all Board procedures and all applicable laws, rules and regulations are followed, and for reporting to the Chairman on governance matters. All Directors have unrestricted access to the advice and services of the Company Secretary. The Company Secretary also keeps minutes of all meetings of the Board which are available for inspection at any reasonable time on reasonable notice given by any Director.

The Board meets regularly and held 18 board meetings during the year ended 31 December 2020. The Directors attended the meetings in person or through other means of electronic communication in accordance with the Bye-Laws. During the regular Board meetings, the Directors discussed and formulated the overall strategies of the Group, reviewed and approved the annual, interim and quarterly results, as well as discussed and decided on other significant matters of the Group. All Directors have full and timely access to all relevant information as well as the advice and services of the Company Secretary, with a view to ensuring that Board procedures and all applicable laws and regulations are followed. Each Director is normally able to seek independent professional advice in appropriate circumstances at the Company's expense, upon making request to the Board. If considered to be necessary and appropriate by the Directors, they may retain independent professional advisors at the Group's expense.

Individual attendance records of each Director at the respective Board and committee meetings are set out in the table on page 108 of this Annual Report.

Directors' continuing professional development

All Directors have been updated from time to time on the latest developments and changes in the GEM Listing Rules and other applicable regulatory requirements to ensure the Company's compliance and to enhance the Directors' awareness of good corporate governance practices. The Directors understand the importance of continuous professional development and are committed to participating in any suitable training or to studying relevant materials in order to develop and refresh their knowledge and skills.

Mr. Hui Chun Sum, Ms. Lam Ching Yee, Ms. Pauline Lam, Mr. Wong Siu Keung, Joe, Mr. Mui Wai Lun and Professor Tsui Ka Kin Kevin have confirmed that they had complied with Code Provision A.6.5 during the year ended 31 December 2020 by participating in continuous professional development to develop and refresh their knowledge and skills. According to Code Provision A.2.1, the roles of the chairman and the chief executive officer should be separate and should not be performed by the same individual. With effect from 1 December 2018, Mr. Hui Chun Sum became the Chairman. With effect from 5 June 2019, Ms. Lam Ching Yee became the Chief Executive Officer.

INDEPENDENT NON-EXECUTIVE DIRECTORS

The Company has been in compliance with Rules 5.05(1) and (2), and 5.05A of the GEM Listing Rules during the year under review, with the appointment of the three independent non-executive Directors representing at least one-third of the Board and at least one of whom having appropriate professional qualifications, or accounting or related financial management expertise. The Company has received from each of the independent nonexecutive Directors an annual confirmation of his independence, and the Company considers such Directors to be independent in accordance with each and the various guidelines set out in Rule 5.09 of the GEM Listing Rules.

Each of Mr. Wong Siu Keung, Joe, Mr. Lee King Fui (who resigned with effect from 8 December 2020) and Mr. Ho Kin Wai (who resigned with effect from 15 December 2020) was appointed for a term of 12 months commencing from 1 January 2020 to 31 December 2020 (both days inclusive). Mr. Mui Wai Lun was appointed for a term commencing from 8 December 2020 to 31 December 2021 (both days inclusive) and Professor Tsui Ka Kin Kevin was appointed for a term commencing from 14 December 2020 to 31 December 2021. Mr. Wong Siu Keung, Joe was re-appointed for a term of 12 months commencing from 1 January 2021 to 31 December 2021 (both days inclusive).

From 1 January 2020 to 7 December 2020, the Audit Committee comprised three independent non-executive Directors, namely Mr. Wong Siu Keung, Joe, Mr. Lee King Fui and Mr. Ho Kin Wai. From 8 December 2020 to 13 December 2020, the Audit Committee comprised three independent non-executive Directors, namely Mr. Wong Siu Keung, Joe, Mr. Mui Wai Lun and Mr. Ho Kin Wai. On 14 December 2020, the Audit Committee comprised four independent non-executive Directors, namely Mr. Wong Siu Keung, Joe, Mr. Mui Wai Lun, Professor Tsui Ka Kin Kevin and Mr. Ho Kin Wai. High emphasis is placed on ensuring a balanced composition of skills and experience at the Board level in order to provide a range of perspectives, insights and challenge that enables the Board to discharge its duties and responsibilities effectively, support good decision making in view of the core businesses and strategy of the Company and support succession planning and development of the Board. For achieving an optimal Board, additional measurable objectives/specific diversity targets may be set and reviewed from time to time to ensure their appropriateness.

Selection of candidates will be based on the Policy and will take into account this Policy. The ultimate decision will be based on merit and contribution that the selected candidates will bring to the Board, having due regard to the benefits of diversity on the Board and also the needs of the Board without focusing on a single diversity aspect. On 8 December 2020 and 14 December 2020, each of Mr. Mui Wai Lun and Professor Tsui Ka Kin Kevin was appointed as an independent non-executive Director respectively, whereby the background of the Directors has been diversified.

The Board will take opportunities to increase the proportion of female members over time when selecting and making recommendation on suitable candidates for Board appointments. The Board would ensure that appropriate balance of gender diversity is achieved with reference to stakeholders' expectation and international and local recommended best practices, with the ultimate goal of bringing the Board to gender parity.

The Nomination Committee reviews this Policy at least once annually to ensure its effectiveness. The Nomination Committee will discuss any revisions to the Policy that may be required and make recommendation to the Board for approval. The Nomination Committee also monitors the implementation of this Policy by conducting review of the Board's composition at least once annually taking into account the benefits of all relevant diversity aspects and adhering to the Policy when making recommendation on any Board appointments. The Nomination Committee also ensures that Board diversity is considered as part of the evaluation of the Board's effectiveness. During the year ended 31 December 2020, relevant trainings were provided to the Directors from time to time to equip themselves with the attributes and competencies required for the Board in light of the strategic needs of the Group and the environment in which it operates.

The total amount of fees paid/payable to other audit firm for providing audit and non-audit services for the year ended 31 December 2020 amounted to approximately HK\$298,000 and approximately HK\$422,000 respectively. The non-audit service fees incurred consist of fees of approximately HK\$422,000 for taxation review.

The Directors acknowledge that it is their responsibility to prepare the accounts of the Group and other disclosures required under the GEM Listing Rules, and management will provide information and explanations to the Board to enable it to make an informed assessment of the financial and other Board decisions.

A statement by the Company's external auditor, McMillan Woods (Hong Kong) CPA Limited, about their reporting responsibilities is included in the Independent Auditor's Report in this Annual Report.

Despite the fact that the Group had net current liabilities of approximately HK\$36,135,000 as at 31 December 2020, the consolidated financial statements of the Company for the year ended 31 December 2020 have been prepared on the basis that the Group will continue to operate as a going concern. The Directors are of the opinion that the Group is able to continue as a going concern and to meet in full their financial obligations as; (i) the Group has been actively negotiating with its creditors to extend the repayment terms of its indebtedness; (ii) the Group is in the process of renewing the Credit Facilities and completed the process of renewing a banking facility of approximately HK\$36,410,000 as at 25 March 2021. Having considered the longstanding and good relationship established with the bank, the Directors are of the view that the Credit Facilities will be renewed upon their expiry. In light of all the measures adopted and arrangements implemented, the Directors are of the opinion that the Group will have sufficient cash resources to satisfy its future working capital and other financial requirements and it is reasonable to expect the Group to remain as a commercially viable concern. Accordingly, the Directors are satisfied that it is appropriate to prepare the consolidated financial statements of the Company for the year ended 31 December 2020 on a going concern basis. It is noted that (i) the net current liabilities of the Group as at 31 December 2020 as mentioned above is mainly attributable to the net current liabilities of the CL Borrower Group, which amounted to approximately HK\$138 million as at 31 December 2020; and (ii) as set out in the Company's announcement dated 4 September 2020, on 4 September 2020, the CL Lender advanced a one-year loan in the principal amount of HK\$30,000,000 to the CL Borrower, and such loan is secured by the share mortgage granted by the Company in favour of the CL Lender over the 51% interests in the CL Borrower held by the Company. If the CL Borrower defaults in repaying such loan, the CL Lender shall be entitled to enforce such share mortgage, upon which, the CL Borrower may cease to be a subsidiary of the Company (i.e. its consolidated assets and liabilities may no longer be consolidated to those of the Group), and the net current liabilities position of the Group mentioned above may be significantly improved.

COMPANY SECRETARY

The Company Secretary is an employee of the Group and has day-to-day knowledge of the Group's affairs. The Company Secretary is responsible to the Board for ensuring the Board procedures are followed and that the Board is briefed on legislative, regulatory and corporate governance developments. During the year under review, the Company Secretary has taken not less than 15 hours of relevant professional training as required by the GEM Listing Rules. 儘管本集團於二零二零年十二月三十一日有 流動負債淨額約36.135.000港元,但本集團 截至二零二零年十二月三十一日止年度的綜 合財務報表已按本集團將持續經營的基準編 製。董事認為,本集團能夠持續經營並全面履 行其財務責任,原因為(i)本集團一直積極與其 債權人磋商,以延長債務的還款期限;及(ii)本 集團已在辦理重續信貸融資,於二零二一年 三月二十五日已辦妥金額約36,410,000港元 的銀行融資的重續手續。經考慮與銀行建立 的長期良好關係,董事認為,信貸融資於到期 時可獲得重續。基於所有已採取的措施及已 **實施的安排**,董事認為本集團將具備充足的 現金資源以滿足其日後的營運資金及其他財 務需求且合理預期本集團能維持商業上可行 之經營。因此,董事信納按持續經營基準編製 本集團截至二零二零年十二月三十一日止年 度的綜合財務報表屬適當。需注意的是:(i)上 述本集團於二零二零年十二月三十一日之流 動負債淨額主要歸因於協盟借款人集團於二 零二零年十二月三十一日之流動負債淨額約 138,000,000港元;及(ii) 誠如本公司日期為二 零二零年九月四日的公佈所載,於二零二零年 九月四日,協盟貸款人向協盟借款人發放一筆 本金額為30,000,000港元之一年期貸款,該筆 貸款由本公司以協盟貸款人為受益人就本公 司持有之協盟借款人51%權益作出的股份押 記作擔保。倘協盟借款人未能如約償還該筆貸 款,協盟貸款人將有權強制執行股份押記,於 該情況下,協盟借款人可能不再為本公司的附 屬公司(即其綜合資產及負債可能不再綜合 計入本集團的綜合資產及負債),從而上述本 集團之流動負債淨額狀況可能得到大幅改善。

公司秘書

公司秘書為本集團僱員,彼對本集團日常事務 有深入認識。公司秘書向董事會負責確保已遵 從董事會程序且董事會已了解法例、規例及企 業管治發展。於回顧年度,公司秘書已接受不 少於GEM上市規則所規定之十五小時之有關 專業培訓。

INTERNAL CONTROL

The Board is responsible for establishing and maintaining the Group's systems of risk management and internal control and for reviewing the effectiveness of these systems. The risk management and internal control systems are designed to meet the particular needs of the Group and to mitigate the risks which it is exposed to. By their nature, however, such risk management and internal control systems are designed to manage rather than eliminate the risk of failure to achieve business objectives. and can provide only reasonable but not absolute assurance against material misstatement or loss. The Board has engaged an independent advisor to review the effectiveness of the risk management and internal control systems of the Group, covering all material financial, operating and compliance controls for the year ended 31 December 2020. Such review is conducted annually. The scope of the review has been previously determined and approved by the Board and the Audit Committee. The independent advisor has reported major findings and areas of improvement to the Board. All the recommendations have been properly followed up by the Group to ensure that they will be implemented within a reasonable period of time. The Board is of the view that the Group's current risk management and internal control systems are adequate and effective.

As might be expected of a Group of its size, a key control procedure is the day-to-day supervision of the business by the executive Directors, supported by managers responsible for operations and the key central and divisional support provided by the Group's financial information systems and human resources. Key elements of the risk management and internal control systems of the Group as described below have all been in place throughout the year under review and up to the date of this Annual Report and are reviewed regularly by the Board:

- clearly defined management structure, lines of responsibilities and delegation of authority;
- high recruitment standards and formal career development and training to ensure the integrity and competence of the staff;
- regular and comprehensive information provided to management, covering financial performance and nonfinancial measures;

誠如與本集團規模相近之集團所預期,一項重 點監管程序乃由執行董事監察日常業務,並由 本集團負責營運及中央及分部之財務資訊系 統及人力資源等各支援部門之經理給予支援。 下文所載本集團風險管理及內部監管系統之 主要元素於整個回顧年度及直至本年報日期 已全面到位,並由董事會進行定期審查:

- procedures for the approval of capital expenditure, investments and acquisitions;
- detailed budgeting process in which top management is involved in budget setting, constant monitoring of key statistics and review of management accounts on a monthly basis, noting and investigating major variances; and
- consideration of progress made against significant business risks at monthly management review meetings, with quarterly briefings to the Board.

The processes used to identify, evaluate and manage significant risks by the Group are summarised as follows:

Risk Identification

• Identifies risks that may potentially affect the Group's business and operations.

Risk Assessment

- Assesses the risks identified by using the assessment criteria developed by the management; and
- Considers the impacts of the risks on the business caused by the adverse events associated with the risks and the likelihood of occurrence of these adverse events.

Response to Risks

- Prioritises the risks by comparing the results of the risk assessments; and
- Determines the risk management strategies and internal control processes to prevent, avoid and mitigate the risks.

Risk Monitoring and Reporting

- Performs ongoing and periodic monitoring of the risks and ensures that appropriate internal control processes are in place and resolve material internal control defects (if any);
- Revises the risk management strategies and internal control processes in case of any significant change of situation; and
- Reports the results of risk monitoring to management and the Board regularly.

Inside Information

The Group has in place, as an element of its risk management and internal control systems, a policy on disclosure of inside information, to ensure that inside information is handled and disseminated properly and in accordance with the applicable laws and regulations. The finance manager of the Company and the department heads within the Group are responsible for monitoring the changes and developments in their respective areas of operation and report any potential or suspected inside information events to the Board. Based on the information obtained through internal reporting, the Board assesses whether any of the information constitutes inside information which needs to be released to the public. Should public disclosure be required, the Board will determine the scope of information to be disclosed and the timing of disclosure. If and when appropriate, the Board may seek independent professional advice to ensure that the Company complies with the disclosure requirements.

The Board has considered the need for an internal audit function, and concluded that, given the size of the Group and its risk management and internal control systems in place, it is not necessary at present. The Board will review this issue on an annual basis.

DIVIDEND POLICY

The Company has adopted a dividend policy with effect from 1 January 2019. Dividends may be paid out by means of cash or by other means that the Directors consider appropriate. Declaration and payment of any dividends would require the recommendation of the Board and will be at its discretion. In addition, any dividends for a financial year will be subject to the approval of the Shareholders. A decision to declare or to pay any dividends in the future, and the amount of any dividends, depends on a number of factors, including the financial performance and future funding needs of the Company and other factors the Board may deem relevant.

Declaration and payment of dividends by the Company is subject to compliance with the Bye-laws and the laws of Bermuda.

The Board will review the dividend policy from time to time and may exercise its sole and absolute discretion to update, amend and/or modify the dividend policy at any time as it deems fit and necessary.

There is no assurance that dividends will be declared or paid in any particular amount for any given period.

概不保證將在任何指定期間宣派或支付任何 特定金額的股息。

COMMUNICATION WITH SHAREHOLDERS

Communication with the Shareholders is given a high priority by the Company. The Company aims to provide the Shareholders with high standards of disclosure and financial transparency through the publication of annual, interim and quarterly reports, announcements and circulars made through the websites of the Company and of the Stock Exchange.

The Board also maintains an on-going dialogue with the Shareholders and use general meetings to communicate with the Shareholders. The Company encourages all the Shareholders to attend general meetings of the Company which provide a useful forum for the Shareholders to exchange their views with the Board. The Chairman and members of the relevant Board committees and senior management of the Company are also available to answer the Shareholders' questions in the general meetings.

To safeguard the Shareholders' interests and rights, a separate resolution is proposed for each substantially independent issue at general meetings of the Company, including the election of individual Directors. The Company keeps on promoting investor relations and enhancing communication with the existing Shareholders and potential investors. It welcomes suggestions from investors, stakeholders and the public. Enquiries to the Board or the Company may be sent by post to the Company's principal place of business in Hong Kong.

During the year ended 31 December 2020, there was no significant change in the Company's memorandum of association and the Bye-Laws.

SHAREHOLDERS' RIGHT

Procedures for Shareholders to convene a general meeting

Pursuant to Bye-Law 58 of the Bye-Laws, any one or more Shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the Company Secretary, to require a special general meeting to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two (2) months after the deposit of such requisition. If within twenty-one (21) days of such deposit the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in accordance with the provisions of Section 74(3) of the Companies Act 1981 of Bermuda.

Such written requisition (i) must state the object of business to be transacted at the meeting; and (ii) must be signed by the requisitionists; and (iii) must be deposited at the Company's principal place of business in Hong Kong in hard copy form for the attention of the Board or the Company Secretary. The requisition may consist of several documents in like form, each signed by one or more of the requisitionist(s).

Putting forward proposals at general meetings

Save for the procedures for the Shareholders to convene a general meeting as set out above and for the Shareholders to nominate a person for election as a Director pursuant to Bye-Law 85 of the Bye-Laws, there are no other provisions allowing the Shareholders to put forward proposals at a general meeting of the Company under the Bye-Laws or under the laws of Bermuda. Shareholders may follow the procedures set out above to convene a special general meeting of the Company for any business specified in such written requisition.

Shareholders' enquiries

Shareholders may send their enquiries requiring the Board's attention to the Company Secretary at the Company's principal place of business in Hong Kong. Questions about the procedures for convening or putting forward proposals at an annual general meeting or a special general meeting of the Company may also be put to the Company Secretary by the same means.

OPINION

We have audited the consolidated financial statements of Hang Tai Yue Group Holdings Limited (the "**Company**") and its subsidiaries (collectively referred to as the "**Group**") set out on pages 116 to 284, which comprise the consolidated statement of financial position as at 31 December 2020, consolidated statement of profit or loss and other comprehensive income, consolidated statement of changes in equity and consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2020, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards ("**HKFRSs**") issued by the Hong Kong Institute of Certified Public Accountants ("**HKICPA**") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

意見

BASIS FOR OPINION

We conducted our audit in accordance with Hong Kong Standards on Auditing ("**HKSAs**") issued by HKICPA. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Consolidated Financial Statements section of our report. We are independent of the Group in accordance with the HKICPA's Code of Ethics for Professional Accountants (the "**Code**"), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

MATERIAL UNCERTAINTY RELATED TO GOING CONCERN

We draw attention to note 2 to the consolidated financial statements which reveals that during the year ended 31 December 2020, the Group incurred a loss of approximately HK\$104,436,000 and as at 31 December 2020, the Group had net current liabilities of approximately HK\$36,135,000. These conditions indicate the existence of a material uncertainty which may cast significant doubt on the Group's ability to continue as a going concern. Notwithstanding the above, these consolidated financial statements have been prepared on the basis that the Group will continue to operate as a going concern. Our opinion is not modified in respect of this matter.

KEY AUDIT MATTERS

1. GENERAL INFORMATION

Hang Tai Yue Group Holdings Limited (the "**Company**") was incorporated in the Cayman Islands and was redomiciled and continued on 1 December 2015 in Bermuda with limited liability. The registered office of the Company is located at Clarendon House, 2 Church Street, Hamilton HM11, Bermuda. The principal place of business is Unit B, 19/F, Centre Mark II, 305-313 Queen's Road Central, Sheung Wan, Hong Kong. The Company's shares are listed on GEM of The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**").

The Company is an investment holding company. The principal activities of its subsidiaries are set out in note 45 to the consolidated financial statements.

2. BASIS OF PREPARATION

These consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("**HKFRSs**") issued by the Hong Kong Institute of Certified Public Accountants (the "**HKICPA**"). HKFRSs comprise Hong Kong Financial Reporting Standards ("**HKFRS**"); Hong Kong Accounting Standards ("**HKAS**"); and Interpretations. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on GEM of the Stock Exchange (the "**GEM Listing Rules**") and with the disclosure requirements of the Hong Kong Companies Ordinance (Cap. 622). Significant accounting policies adopted by the Group are discussed below.

The HKICPA has issued certain new and revised HKFRSs that are first effective or available for early adoption for the current accounting period of the Group. Note 3 provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current and prior accounting periods reflected in these consolidated financial statements.

1. 一般資料

2. 編製基準

本綜合財務報表乃根據香港會計師公會 (「**香港會計師公會**」)頒佈之香港財務報 告準則(「**香港財務報告準則**])編製。香港 財務報告準則包括《香港財務報告準則》、 《香港會計準則》(「**香港會計準則**」)及 《詮釋》。本綜合財務報表亦符合聯交所 GEM證券上市規則(「**GEM上市規則**」)之 適用披露條文及香港公司條例(第622章) 之披露規定。本集團採納的主要會計政策 於下文討論。

Material uncertainty related to going concern

For the year ended 31 December 2020, the Group incurred a loss of approximately HK\$104,436,000 and as at 31 December 2020, the Group had net current liabilities of approximately HK\$36,135,000. These conditions indicate the existence of a material uncertainty which may cast significant doubt on the Group's ability to continue as a going concern. Notwithstanding the above, these consolidated financial statements have been prepared on the basis that the Group will continue to operate as a going concern.

In preparing these consolidated financial statements, the Directors have given careful consideration to the impact of the current and anticipated future liquidity of the Group after taken into account the following plans and measures to strengthen the Group's capital base and working capital requirements in the foreseeable future including but limited to:

- (i) the Group has been actively negotiating with its creditors to extend the repayment terms of its indebtedness; and
- (ii) the Group is in the process of renewing a banking facility of approximately HK\$50,000,000 and bank borrowings of approximately HK\$42,752,000 (collectively, the "Credit Facilities") and completed the process of renewing a banking facility of approximately HK\$36,410,000 at 25 March 2021. Having considered the longstanding and good relationship established with the bank, the Directors are of the view that the Credit Facilities will be renewed upon their expiry.

Based on the cash flow projections of the Group and having taken into account the available financial resources of the Group with the above measures, the Directors have concluded that the Group is able to continue as going concern and to meet their financial obligations as and when they fall due for the next twelve months.

Should the Group be unable to continue as a going concern, adjustments would have to be made to the consolidated financial statements to adjust the value of the Group's assets to their recoverable amounts, to provide for any further liabilities which might arise and to reclassify non-current assets and liabilities as current assets and current liabilities respectively. The effects of these potential adjustments have not been reflected in these consolidated financial statements. *For the year ended 31 December 2020* 截至二零二零年十二月三十一日止年度

截至二零二零年十二月三十一日止年度, 本集團產生虧損約104,436,000港元,而於 二零二零年十二月三十一日,本集團的流 動負債淨額約為36,135,000港元。該等情 況顯示存在重大不明朗因素,可能對本集 團持續經營之能力構成重大疑問。儘管存 在上述情況,此等綜合財務報表乃按本集 團將繼續持續經營之基準編製。

根據本集團的現金流量預測及經考慮本集 團可動用的財務資源及上述措施後,董事 認為本集團有能力持續經營及履行其於未 來十二個月到期的財務責任。

4. SIGNIFICANT ACCOUNTING POLICIES

These consolidated financial statements have been prepared under the historical cost convention, unless mentioned otherwise in the accounting policies below (e.g. certain financial instruments that are measured at fair value).

The preparation of financial statements in conformity with HKFRS requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Group's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in note 5.

The significant accounting policies applied in the preparation of these consolidated financial statements are set out below.

(a) Consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 31 December. Subsidiaries are entities over which the Group has control. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group has power over an entity when the Group has existing rights that give it the current ability to direct the relevant activities, i.e. activities that significantly affect the entity's returns.

When assessing control, the Group considers its potential voting rights as well as potential voting rights held by other parties. A potential voting right is considered only if the holder has the practical ability to exercise that right.

Subsidiaries are consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date the control ceases.

The gain or loss on the disposal of a subsidiary that results in a loss of control represents the difference between (i) the fair value of the consideration of the sale plus the fair value of any investment retained in that subsidiary and (ii) the Company's share of the net assets of that subsidiary plus any remaining goodwill and any accumulated foreign currency translation reserve relating to that subsidiary.

Intragroup transactions, balances and unrealised profits are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests represent the equity in subsidiaries not attributable, directly or indirectly, to the Company. Non-controlling interests are presented in the consolidated statement of financial position and consolidated statement of changes in equity within equity. Non-controlling interests are presented in the consolidated statement of profit or loss and consolidated statement of profit or loss and other comprehensive income as an allocation of profit or loss and total comprehensive income for the year between the noncontrolling shareholders and owners of the Company.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling shareholders even if this results in the non-controlling interests having a deficit balance. 4. 主要會計政策(續)

Changes in the Company's ownership interest in a subsidiary that do not result in a loss of control are accounted for as equity transactions (i.e. transactions with owners in their capacity as owners). The carrying amounts of the controlling and non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiary. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to the owners of the Company.

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment loss, unless the investment is classified as held for sale (or included in a disposal group that is classified as held for sale).

(b) Associates

Associates are entities over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of an entity but is not control or joint control over those policies. The existence and effect of potential voting rights that are currently exercisable or convertible, including potential voting rights held by other entities, are considered when assessing whether the Group has significant influence. In assessing whether a potential voting right contributes to significant influence, the holder's intention and financial ability to exercise or convert that right are not considered.

Investment in an associate is accounted for in the consolidated financial statements by the equity method and is initially recognised at cost. Identifiable assets and liabilities of the associate in an acquisition are measured at their fair values as at the acquisition date. The excess of the cost of the investment over the Group's share of the net fair value of the associate's identifiable assets and liabilities is recorded as goodwill which is included in the carrying amount of the investment. Any excess of the Group's share of the net fair value of the net fair value of the investment of the identifiable assets and liabilities over the cost of acquisition is recognised in consolidated profit or loss.

The Group assesses whether there is an objective evidence that the interest in an associate may be impaired. When any objective evidence exists, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised is not allocated to any asset, including goodwill, that forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

The Group's share of an associate's post-acquisition profits or losses and other comprehensive income is recognised in consolidated statement of profit or loss and other comprehensive income. When the Group's share of losses in an associate equals or exceeds its interest in the associate (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate), the Group does not recognise further losses, unless it has incurred obligations or made payments on behalf of the associate. If the associate subsequently reports profits, the Group resumes recognising its share of those profits only after its share of the profits equals the share of losses not recognised.

The gain or loss on the disposal of an associate that results in a loss of significant influence represents the difference between (i) the fair value of the consideration of the sale plus the fair value of any investment retained in that associate and (ii) the Group's entire carrying amount of that associate (including goodwill) and any related accumulated foreign currency translation reserve. If an investment in an associate becomes an investment in a joint venture, the Group continues to apply the equity method and does not remeasure the retained interest.

Unrealised profits on transactions between the Group and its associates are eliminated to the extent of the Group's interests in the associates. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of associates have been changed where necessary to ensure consistency with the policies adopted by the Group.

(i) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is the Company's functional and presentation currency.

(ii) Transactions and balances in each entity's financial statements

Transactions in foreign currencies are translated into the functional currency on initial recognition using the exchange rates prevailing on the transaction dates. Monetary assets and liabilities in foreign currencies are translated at the exchange rates at the end of each reporting period. Gains and losses resulting from this translation policy are recognised in profit or loss.

Non-monetary items that are measured at fair value in foreign currencies are translated using the exchange rates at the dates when the fair values are determined.

When a gain or loss on a non-monetary item is recognised in other comprehensive income, any exchange component of that gain or loss is recognised in other comprehensive income. When a gain or loss on a non-monetary item is recognised in profit or loss, any exchange component of that gain or loss is recognised in profit or loss.

- Assets and liabilities for each statement of financial position presented are translated at the closing rate at the date of that statement of financial position;
- Income and expenses are translated at average exchange rates for the period (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the exchange rates on the transaction dates); and
- All resulting exchange differences are recognised in other comprehensive income and accumulated in the foreign currency translation reserve.

On consolidation, exchange differences arising from the translation of monetary items that form part of the net investment in foreign entities are recognised in other comprehensive income and accumulated in the foreign currency translation reserve. When a foreign operation is sold, such exchange differences are reclassified to consolidated profit or loss as part of the gain or loss on disposal.

Goodwill and fair value adjustments arising on the acquisition of a foreign entity are treated as assets and liabilities of the foreign entity and translated at the closing rate.

Property, plant and equipment are held for use in the production or supply of goods or services, or for administrative purposes. Property, plant and equipment are stated in the consolidated statement of financial position at cost, less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance are recognised in profit or loss during the period in which they are incurred.

Depreciation of property, plant and equipment is calculated at rates sufficient to write off their cost less their residual value over its estimated useful life on a straight-line basis. The principal annual rates are as follows:

The residual values, useful lives and depreciation method are reviewed and adjusted, if appropriate, at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

The gain or loss on disposal of property, plant and equipment is the difference between the net sales proceeds and the carrying amount of the relevant asset, and is recognised in profit or loss.

(e) Leases

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

(i) The Group as a lessee

Where the contract contains lease component(s) and non-lease component(s), the Group has elected not to separate non-lease components and accounts for each lease component and any associated nonlease components as a single lease component for all leases.

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. Where applicable, the cost of the rightof-use assets also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received. The right-of-use asset is subsequently stated at cost less accumulated depreciation and impairment losses.

The lease liability is remeasured when there is a change in future lease payments arising from a change in an index or rate, or there is a change in the Group's estimate of the amount expected to be payable under a residual value guarantee, or there is a change arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

The lease liability is also remeasured when there is a change in the scope of a lease or the consideration for a lease that is not originally provided for in the lease contract ("lease modification") that is not accounted for as a separate lease. In this case the lease liability is remeasured based on the revised lease payments and lease term using a revised discount rate at the effective date of the modification. The only exceptions are any rent concessions which arose as a direct consequence of the COVID-19 pandemic and which satisfied the conditions set out in paragraph 46B of HKFRS 16. In such cases, the group took advantage of the practical expedient set out in paragraph 46A of HKFRS 16 and recognised the change in consideration as if it were not a lease modification.

If this is not the case, the lease is classified as an operating lease.

(f) Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end. The following intangible assets with finite useful lives are amortised from the date they are available for use and their useful lives are as follows:

(g) Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the first-in, firstout basis. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

(h) Contract assets and contract liabilities

Contract asset is recognised when the Group recognises revenue before being unconditionally entitled to the consideration under the payment terms set out in the contract. Contract assets are assessed for expected credit losses ("**ECL**") in accordance with the policy set out in note 4(x) and are reclassified to receivables when the right to the consideration has become unconditional.

A contract liability is recognised when the customer pays consideration before the Group recognises the related revenue. A contract liability would also be recognised if the group has an unconditional right to receive consideration before the Group recognizes the related revenue. In such cases, a corresponding receivable would also be recognised.

For a single contract with the customer, either a net contract asset or a net contract liability is presented. For multiple contracts, contract assets and contract liabilities of unrelated contracts are not presented on a net basis.

When the contract includes a significant financing component, the contract balance includes interest accrued under the effective interest method.

Financial assets and financial liabilities are recognised in the consolidated statement of financial position when the Group entity becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit and loss ("**FVTPL**")) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in profit or loss.

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group recognises its retained interest in the asset and an associated liability for amounts it may have to pay. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

(j) Financial assets

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace. All recognised financial assets are measured subsequently in their entirety at either amortised cost or fair value, depending on the classification of the financial assets.

A receivable is recognised when the Group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due. If revenue has been recognised before the group has an unconditional right to receive consideration, the amount is presented as a contract asset.

Receivables are stated at amortised cost using the effective interest method less allowance for credit losses.

(I) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated statement of cash flow. Cash and cash equivalents are assessed for ECL.

(m) Financial liabilities and equity instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument under HKFRSs. An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. The accounting policies adopted for specific financial liabilities and equity instruments are set out below.

(n) Borrowings

Borrowings are recognised initially at fair value, net of transaction costs incurred, and subsequently measured at amortised cost using the effective interest method.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the reporting period.

Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the promised consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. When the contract contains a financing component which provides the Group a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

Provision of IT contract services

Revenue from rendering of IT contract services is recognised over time using an input method to measure progress towards complete performance of the services, measured by reference to the proportion of work completed to date to the estimated total work of the relevant contract.

Maintenance services

Revenue from provision of maintenance services is recognised over the maintenance period on a straight-line basis because the customer simultaneously receives and consumes the benefits provided by the Group. Advances are normally required before rendering the services.

Revenue from hotel accommodation and other ancillary services is recognised over time in the accounting period in which the control of the products or the services are transferred to the customer because the customer simultaneously receives and consumes the benefits provided by the Group's performance as it performs.

Revenue from sales of hotel supplies and food and beverage in hotel business and food and restaurants operation is recognised at a point in time when the control of the products or the services is transferred to the customers, being when the products are delivered to the customers, there is no unfulfilled obligation that could affect the customers' acceptance of the products and the customer has obtained the physical possession or the legal title of the products and the Group has present right to payment and the collection of the consideration is probable. The Group controls the products in these transactions and, therefore, the Group is the principal and revenue is recognised on a gross basis.

Revenue from other sources

Dividend income

Dividend income is recognised at the time when the shareholders' right to receive the dividend have been established.

Interest income

Interest income is recognised as it accrues using the effective interest method. For credit-impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount less loss allowance) of the financial asset.

Employee leave entitlements

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the end of the reporting period.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

Pension scheme

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "**MPF Scheme**") under the Mandatory Provident Fund Schemes Ordinance (Chapter 485 of the Laws of Hong Kong) for all of its employees in Hong Kong. Contributions are made based on a percentage of the employees' basic salaries and are charged to the statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when it made contribution to the MPF Scheme. No forfeited contribution is available to reduce the contribution payable in future years.

The employees of the Company's subsidiaries which operate in the People's Republic of China (the "**PRC**") are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute a certain percentage of their payroll costs to the central pension scheme. The contributions are charged to profit or loss as they become payable in accordance with the rules of the central pension scheme. No forfeited contribution is available to reduce the contribution payable in future years.

The subsidiaries' legal or constructive obligation is limited to these contributions, which are recognised as an expense as they become payable. No forfeited contribution is available to reduce the contribution payable in future years.

(s) Share-based payments

The Group issues equity-settled share-based payments to certain employees. Equity-settled share-based payments are measured at the fair value (excluding the effect of non-market based vesting conditions) of the equity instruments at the date of grant. The fair value determined at the grant date of the equity-settled sharebased payments is expensed on a straight-line basis over the vesting period, based on the Group's estimate of shares that will eventually vest and adjusted for the effect of non-market based vesting conditions.

The Group issues equity-settled share-based payments to certain directors, employees and consultants.

Equity-settled share-based payments to directors and employees are measured at the fair value (excluding the effect of non-market based vesting conditions) of the equity instruments at the date of grant. The fair value determined at the grant date of the equity-settled sharebased payments is expensed on a straight-line basis over the vesting period, based on the Group's estimate of shares that will eventually vest and adjusted for the effect of non-market based vesting conditions.

(t) Government grants

A government grant is recognised when there is reasonable assurance that the Group will comply with the conditions attaching to it and that the grant will be received.

Government grants relating to income are deferred and recognised in profit or loss over the period to match them with the costs they are intended to compensate.

Government grants that become receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

(u) Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets, until such time as the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

The capitalisation rate is the weighted average of the borrowing costs applicable to the borrowings of the Group that are outstanding during the period, other than borrowings made specifically for the purpose of obtaining a qualifying asses. Any specific borrowing that remain outstanding after the related asset is ready for its intended use or sale is included in the general borrowing pool for calculation of capitalisation rate on general borrowings.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

(v) Taxation

Income tax represents the sum of the current tax and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit recognised in profit or loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences, unused tax losses or unused tax credits can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries and associates, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised, based on tax rates that have been enacted or substantively enacted by the end of the reporting period. Deferred tax is recognised in profit or loss, except when it relates to items recognised in other comprehensive income or directly in equity, in which case the deferred tax is also recognised in other comprehensive income or directly in equity.

The measurement of deferred tax assets and liabilities reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for leasing transactions in which the Group recognises the right-ofuse assets and the related lease liabilities, the Group first determines whether the tax deductions are attributable to the right-of-use assets or the lease liabilities.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 requirements to the leasing transaction as a whole. Temporary differences relating to right-of-use assets and lease liabilities are assessed on a net basis. Excess of depreciation on right-of-use assets over the lease payments for the principal portion of lease liabilities resulting in net deductible temporary differences.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis.

Intangible assets that have an indefinite useful life or that are not yet available for use are reviewed for impairment annually and whenever events or changes in circumstances indicate the carrying amount may not be recoverable.

The carrying amounts of non-financial assets are reviewed at each reporting date for indications of impairment and where an asset is impaired, it is written down as an expense through the consolidated statement of profit or loss to its estimated recoverable amount. The recoverable amount is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. If this is the case, recoverable amount is determined for the cash-generating unit to which the asset belongs. Recoverable amount is the higher of value in use and the fair value less costs of disposal of the individual asset or the cash-generating unit.

Value in use is the present value of the estimated future cash flows of the asset/cash-generating unit. Present values are computed using pre-tax discount rates that reflect the time value of money and the risks specific to the asset/cash-generating unit whose impairment is being measured.

Impairment losses for cash-generating units are allocated first against the goodwill of the unit and then pro rata amongst the other assets of the cash-generating unit. Subsequent increases in the recoverable amount caused by changes in estimates are credited to profit or loss to the extent that they reverse the impairment.

(x) Impairment of financial assets and contracts assets

The Group recognises a loss allowance for expected credit losses on investments in debt instruments that are measured at amortised cost or at FVTOCI, lease receivables, trade receivables and contract assets. The amount of expected credit losses is updated at each reporting date to reflect changes in credit risk since initial recognition of the respective financial instrument.

The Group always recognises lifetime ECL for trade receivables, contract assets and lease receivables. The expected credit losses on these financial assets are estimated using a provision matrix based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current as well as the forecast direction of conditions at the reporting date, including time value of money where appropriate.

For all other financial instruments, the Group recognises lifetime ECL when there has been a significant increase in credit risk since initial recognition. However, if the credit risk on the financial instrument has not increased significantly since initial recognition, the Group measures the loss allowance for that financial instrument at an amount equal to 12-month ECL.

Lifetime ECL represents the expected credit losses that will result from all possible default events over the expected life of a financial instrument. In contrast, 12-month ECL represents the portion of lifetime ECL that is expected to result from default events on a financial instrument that are possible within 12 months after the reporting date.

Significant increase in credit risk

In assessing whether the credit risk on a financial instrument has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument at the reporting date with the risk of a default occurring on the financial instrument at the date of initial recognition. In making this assessment, the Group considers both quantitative and gualitative information that is reasonable and supportable, including historical experience and forwardlooking information that is available without undue cost or effort. Forward-looking information considered includes the future prospects of the industries in which the Group's debtors operate, obtained from economic expert reports, financial analysts, governmental bodies, relevant think-tanks and other similar organisations, as well as consideration of various external sources of actual and forecast economic information that relate to the Group's core operations.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk for a particular financial instrument;
- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk on a financial asset has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the foregoing, the Group assumes that the credit risk on a financial instrument has not increased significantly since initial recognition if the financial instrument is determined to have low credit risk at the reporting date. A financial instrument is determined to have low credit risk if:

- (i) the financial instrument has a low risk of default,
- (ii) the debtor has a strong capacity to meet its contractual cash flow obligations in the near term, and
- (iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations.

Significant increase in credit risk (Cont'd)

The Group considers a financial asset to have low credit risk when the asset has external credit rating of "investment grade" in accordance with the globally understood definition or if an external rating is not available, the asset has an internal rating of "performing". Performing means that the counterparty has a strong financial position and there is no past due amounts.

For financial guarantee contracts, the date that the Group becomes a party to the irrevocable commitment is considered to be the date of initial recognition for the purposes of assessing the financial instrument for impairment. In assessing whether there has been a significant increase in the credit risk since initial recognition of a financial guarantee contracts, the Group considers the changes in the risk that the specified debtor will default on the contract.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

Definition of default

The Group considers the following as constituting an event of default for internal credit risk management purposes as historical experience indicates that receivables that meet either of the following criteria are generally not recoverable:

- when there is a breach of financial covenants by the counterparty; or
- information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above analysis, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

Credit-impaired financial assets

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- significant financial difficulty of the issuer or the counterparty;
- a breach of contract, such as a default or past due event;
- the lender(s) of the counterparty, for economic or contractual reasons relating to the counterparty's financial difficulty, having granted to the counterparty a concession(s) that the lender(s) would not otherwise consider; or

Write-off policy

The Group writes off a financial asset when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, including when the debtor has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of trade receivables, when the amounts are over two years past due, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. Any recoveries made are recognised in profit or loss.

Measurement and recognition of ECL

The measurement of expected credit losses is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward looking information as described above. As for the exposure at default, for financial assets, this is represented by the assets' gross carrying amount at the reporting date; for financial guarantee contracts, the exposure includes the amount drawn down as at the reporting date, together with any additional amounts expected to be drawn down in the future by default date determined based on historical trend, the Group's understanding of the specific future financing needs of the debtors, and other relevant forward-looking information.

For financial assets, the expected credit loss is estimated as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the original effective interest rate. For a lease receivable, the cash flows used for determining the expected credit losses is consistent with the cash flows used in measuring the lease receivable in accordance with HKFRS 16.

For a financial guarantee contract, as the Group is required to make payments only in the event of a default by the debtor in accordance with the terms of the instrument that is guaranteed, the expected loss allowance is the expected payments to reimburse the holder for a credit loss that it incurs less any amounts that the Group expects to receive from the holder, the debtor or any other party.

If the Group has measured the loss allowance for a financial instrument at an amount equal to lifetime ECL in the previous reporting period, but determines at the current reporting date that the conditions for lifetime ECL are no longer met, the Group measures the loss allowance at an amount equal to 12-month ECL at the current reporting date, except for assets for which simplified approach was used.

The Group recognises an impairment gain or loss in profit or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account, except for investments in debt instruments that are measured at FVTOCI, for which the loss allowance is recognised in other comprehensive income and accumulated in the investment revaluation reserve, and does not reduce the carrying amount of the financial asset in the statement of financial position.

(y) Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a present legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow is remote.

(z) Events after the reporting period

Events after the reporting period that provide additional information about the Group's position at the end of the reporting period are adjusting events and are reflected in the consolidated financial statements. Events after the reporting period that are not adjusting events are disclosed in the notes to the consolidated financial statements when material.

Critical judgements in applying accounting policies

In the process of applying the accounting policies, the directors have made the following judgements that have the most significant effect on the amounts recognised in the consolidated financial statements (apart from those involving estimations, which are dealt with below).

(a) Going concern

These consolidated financial statements have been prepared on a going concern basis, the validity of which depends upon the successful outcomes of the Group's plans and measures to strengthen its capital base and liquidity. Details are explained in note 2 to the consolidated financial statements.

(b) Significant increase in credit risk

As explained in note 43, ECL are measured as an allowance equal to 12-month ECL for stage 1 assets, or lifetime ECL for stage 2 or stage 3 assets. An asset moves to stage 2 when its credit risk has increased significantly since initial recognition. HKFRS 9 does not define what constitutes a significant increase in credit risk. In assessing whether the credit risk of an asset has significantly increased the Group takes into account qualitative and quantitative reasonable and supportable forward looking information.

(b) 信貸風險顯著增加

如附註43所述,預期信貸虧損就第1階 段資產按相等於12個月預期信貸虧損 的撥備計量,就第2階段或第3階段資 產,則按相等於全期預期信貸虧損的 撥備計量。資產在其信貸風險自初始 確認後顯著增加時轉入第2階段。香港 財務報告準則第9號並無界定構成信 貸風險顯著增加的因素。於評估資產 的信貸風險是否顯著增加時,本集團 會考慮合理且可靠的定性及定量前瞻 性資料。

Key sources of estimation uncertainty

The key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are discussed below.

(a) Impairment of property plant and equipment, goodwill, other non-financial assets and rights-ofuse assets

Determining whether property, plant and equipment, goodwill and other non-current assets are impaired requires an estimation of the value in use of the cashgenerating units to which the property, plant and equipment, goodwill and other non-current assets have been allocated. The calculation of value in use requires the Group to estimate the future cash flows expected to arise from the cash-generating units and a suitable discount rate in order to calculate the present value.

The carrying amount of property plant and equipment, rights-of-use assets, goodwill, and other non-financial assets as at 31 December 2020 were approximately HK\$182,368,000 (2019: HK\$196,899,000), HK\$66,688,000 (2019: HK\$40,238,000), HK\$Nil (2019: HK\$Nil) and HK\$86,731,000 (2019: HK\$83,055,000) respectively.

(b) Useful lives of other intangible assets (other than goodwill)

The Group determines the estimated useful lives for its property, plant and equipment and intangible assets. This estimate is based on the historical experience of the actual useful lives of property, plant and equipment and intangible assets of similar nature and functions. It could change significantly as a result of technical innovations and management's long-term strategic development. Management will increase the amortisation charge where useful lives are less than previously estimated lives, or it will write off or write down technically obsolete or nonstrategic assets that have been abandoned or sold.

The carrying amount of intangible assets as at 31 December 2020 was approximately HK\$272,000 (2019: HK\$745,000).

(b) 物業、廠房及設備以及其他無形資產 (商譽除外)之可使用年期

本集團釐定其物業、廠房及設備以及 無形資產的估計可使用年期。該估計 乃依據性質與功能類似的物業、廠房 及設備以及無形資產的實際可使用年 期的過往經驗,可能由於技術創新及 管理層的長期策略發展而出現重大變 化。倘可使用年期較之前的估計為短, 則管理層會增加攤銷費用,或撇銷或 撇減已報廢或出售的技術過時或非策 略性資產。

於二零二零年十二月三十一日,無形 資產的賬面值約為272,000港元(二零 一九年:745,000港元)。

(c) Impairment of accounts and other receivables and contract assets

The Group estimates the loss allowances for debtors and contract assets by assessing the ECLs. This requires the use of estimates and judgements. ECLs are based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, and an assessment of both the current and forecast general economic conditions at the end of the reporting period. Where the estimation is different from the original estimate, such difference will affect the carrying amounts of debtors and contract assets and thus the impairment loss in the period in which such estimate will be changed. The Group keeps assessing the ECLs of trade debtors and contract assets during their expected lives.

As at 31 December 2020, the carrying amount of accounts and other receivables and contract assets are HK\$192,273,000 and HK\$133,530,000 (2019: HK\$67,225,000 and HK\$130,561,000) respectively.

(d) Impairment of loan and interest receivables

The Group reviews its loan portfolio to assess whether there is any objective evidence that the loan receivable is impaired at least on a yearly basis. In determining whether an impairment loss should be recorded in the consolidated statement of profit or loss, the Group makes judgements as to whether there is any observable data indicating that there is a measurable decrease in the estimated future cash flows from a portfolio of loan receivables before the decrease can be identified with an individual loan in that portfolio. This evidence may include observable data indicating that there has been an adverse change in the payment status of borrowers in the group, or national or local economic conditions that correlate with defaults on assets in the group. Management estimates based on historical loss experience for assets with credit risk characteristics and objective evidence of impairment similar to those in the portfolio when scheduling its future cash flows. The methods and assumptions used for estimating both the amount and timing of future cash flows are reviewed regularly to reduce any differences between loss estimates and actual loss experience.

As at 31 December 2020, the carrying amount of loan and interest receivables is HK\$110,205,000 (2019: HK\$11,301,000).

(e) Fair value of the financial assets designated at FVTOCI or financial assets at FVTPL

The fair value of financial assets designated at FVTOCI or financial assets at FVTPL that are not traded in active markets or suspended trading are determined by using valuation techniques. Where valuation techniques are used to determine fair values, they are periodically reviewed. To the extent practical, models use only observable data, however, areas such as estimated profit, volatilities and correlations require management to make estimation. Changes in assumptions about these factors could affect the FVTOCI and the FVTPL.

As at 31 December 2020, the carrying amounts of the Group's financial assets at FVTOCI and FVTPL are HK\$177,728,000 (2019: HK\$169,309,000) and HK\$55,519,000 (2019: HK\$41,289,000) respectively.

(f) Net realisable value of inventories

Net realisable value of inventories is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale. These estimates are based on the current market conditions and the historical experience of selling products with similar nature. Any change in the assumptions would increase or decrease the amount of inventories write-down or the related reversals of writedown made in prior years and affect the Group's net assets value. The Group reassesses these estimates at the end of each reporting period.

At the end of reporting period, the Group's inventories of HK\$7,974,000 (2019: HK\$8,581,000) stated at cost.

(g) Provision for litigations

The Group has been involved in a number of litigations during the year. Provision for litigations have been assessed by management with reference to legal advices. Provision on possible obligations, if any, are made based on management's best estimates and judgements. Further details are stated in note 38 to the consolidated financial statements.

(h) Revenue from contracts with customers – determining the timing of satisfaction of provision of IT contract services

The Group concluded that revenue from provision of IT contract services is to be recognised over time because the customer simultaneously receives and consumes the benefits provided by the Group.

The Group determined that the input method is the best method in measuring the progress of the IT contract services because there is a direct relationship between the Group's effort (i.e. labour hours incurred) and the transfer of services to the customer. The Group recognises revenue on the basis of the labour hours expended relative to the total expected labour hours to complete the services. 5. 重大判斷及主要估計(續)

(g) 訴訟撥備

本集團確定投入法是衡量資訊科技合約服務進度的最佳方法,因為本集團的努力(即產生的工時)與向客戶轉讓服務間存在直接關係。本集團按已耗用工時佔完成服務的預期總工時比例確認收入。

The recoverable amount of the remaining Estates Resorts assessed by an independent professional valuer by using depreciated replacement cost approach, amounted to approximately AUD19,450,000 (equivalent to approximately HK\$116,189,000).

As at 31 December 2019, the recoverable amount of the Estate Resorts, assessed by an independent professional valuer using depreciated replacement cost basis approach, amounted to approximately AUD28,440,000 (equivalent to approximately HK\$124,332,000).

Accordingly, an impairment loss on property, plant and equipment related to the segment of provision of hospitality and related services in Australia of approximately HK\$8,512,000 (2019: approximately HK\$23,616,000) was recognised in the consolidated statement of profit or loss and other comprehensive income during the year.

- (b) As at 31 December 2020, the Estate Resorts of aggregate carrying amount of approximately HK\$114,859,000 (2019: approximately HK\$143,624,000) were freehold land and buildings which were pledged for interest-bearing bank borrowings (note 27(a)).
- (c) On 19 September 2019, the Group entered into a sale and purchase agreement with an independent third party (the "Vendor"), pursuant to which, the Group acquired (i) 100% equity interest in Ascent Key Limited ("Ascent Key"); and (ii) the outstanding balances of the amount due to the Vendor by Ascent Key of approximately HK\$16,630,000, at an aggregate consideration of HK\$6,940,000. The acquisition was completed on 19 September 2019 (the "Acquisition Date"). The Directors were of the opinion that Ascent Key did not have any operation and its principal assets as at the Acquisition Date were yachts and therefore, the acquisition of Ascent Key was not accounted for as a business combination but an acquisition of assets. Accordingly, the difference between the consideration over the carrying value of the individual identifiable assets and liabilities of Ascent Key as at the Acquisition Date has been recognised as the deemed cost of the vachts acquired.

Loan and interest receivables

Loan and interest receivables are mainly arising from the money lending business, which are entered with contractual maturity within 6 months. The Group seeks to maintain strict control over its loan and interest receivables in order to minimise credit risk by reviewing the borrowers' financial positions. The loan receivables are interest-bearing at rates mutually agreed between the contracting parties, at a fixed rate of 1%-9% (2019: 10%) per annum. It is also provided in the Agreement that (i) to ensure the settlement of the Compensation by EPRO, EPRO shall agree that the amount of the outstanding Accounts Receivable shall exceed the amount of the remaining Compensation from time to time and HW shall have the right to set off the Compensation against the Accounts Receivable; and (ii) EPRO shall provide its preceding year's annual audited financial report to HW every year. Capital management

The primary objectives of the Group's capital management are to safeguard the Group's ability to continue as a going concern and to maintain healthy capital ratios in order to support its business and maximise shareholders' value.

The Group manages its capital structure and makes adjustments to it, in light of changes in economic conditions. To maintain or adjust the capital structure, the Group may adjust the dividends payment to shareholders, return capital to shareholders of issue new shares.

30.SHARE OPTION SCHEME

The Company's share option scheme (the "**Share Option Scheme**") was adopted on 9 June 2020. The purpose of the Scheme is to provide incentives or rewards for eligible participants' contribution to the Group and/or to enable the Group to recruit and retain high-calibre employees and attract human resources that are valuable to the Group and any invested entity.

There were no share options outstanding, granted, exercised, cancelled or lapsed during the years ended 31 December 2020 and 2019.

Convoy Case

(a) On 19 December 2017, Ever Robust Holdings Limited ("Ever Robust"), an indirect wholly-owned subsidiary of the Company, received a writ of summons with a statement of claim (the "Writ") issued in the Court of First Instance of the High Court of Hong Kong (the "Court") by Convoy Global Holdings Limited ("Convoy"), Convoy Collateral Limited (the "Second Plaintiff") and CSL Securities Limited (the "Third Plaintiff", together with Convoy and the Second Plaintiff, collectively as the "Plaintiffs") against, among other defendants, Ever Robust (together with the other defendants, collectively as the "Defendants").

Based on the Writ, the orders sought by the Plaintiffs against Ever Robust were as follows: (i) Convoy sought an order as against, among others, Ever Robust, that the allotment of the shares in Convoy by Convoy to, among others, Ever Robust on 29 October 2015, be set aside; (ii) the Second Plaintiff and the Third Plaintiff sought an order that the financing facilities granted by them, including the loan (the "Convoy Loan") in the amount of HK\$129,000,000 granted to Ever Robust by the Second Plaintiff on 9 November 2015, and the margin loan (the "Margin Loan") granted to Ever Robust by the Third Plaintiff which amounted to HK\$67,574,473 as at 29 March 2016, be rescinded; and (iii) the Plaintiffs sought against, among others, Ever Robust for (a) general or special damages; (b) interests; (c) costs; and (d) further and/or other reliefs (the "Convoy Proceedings"). On 30 November 2018, Ever Robust received a copy sealed order dated 1 November 2018 against, among other defendants, Ever Robust, in which a party was ordered to join the proceedings as an additional defendant.

On 10 December 2018, Ever Robust filed its Defence ("**Defence**") to the Plaintiff's claim in the Convoy Proceedings with the Court. Pursuant to the Defence, Ever Robust averred that the Plaintiffs were not entitled to any relief against Ever Robust in the Convoy Proceedings.

On 30 August 2019, Ever Robust filed its Amended Defence pursuant to the Order of Hon Harris J dated 12 July 2019.

Further details of the Convoy Proceedings were set out in the Company's announcements dated 19 December 2017, 1 June 2018, 7 June 2018 and 25 July 2018.

After seeking the legal opinion, the Group considered that there was no assessed monetary claim by the Plaintiffs and it is premature to give opinion on the probable outcome and estimate the ultimate liability.

Based on the Petition, the Petitioner has held and continues to hold 3,234,000 shares in Convoy since around mid-2015, and the Petitioner sought the following orders against, among others, Ever Robust: (i) a declaration that the placement of 3,989,987,999 shares in Convoy by Convoy to, among other placees, Ever Robust, and/or such placed shares were void ab initio and of no legal effect or, alternatively, be set aside; (ii) damages for dilution of the Petitioner's shareholding; (iii) interest; (iv) such further or other relief and all necessary and consequential directions as the Court may think fit; and (v) costs (the "**Zhu Proceedings**"). As at 2 January 2018, Ever Robust did not hold any shares in Convoy.

On 6 March 2018, a Case Management Conference was held on the Zhu Proceedings, in which the Honourable Mr. Justice Harris made an order that the Zhu Proceedings be stayed with liberty to restore, pending the outcome of the Convoy Proceedings.

Further details of the Zhu Proceedings were set out in the Company's announcement dated 2 January 2018.

The Group has sought preliminary opinion on the above legal proceedings from its solicitors (or legal adviser) in Hong Kong, who, based on the information available as of the approved date on these consolidated financial statements, was of the opinion that:

- there is no assessed monetary claim except the Plaintiffs' claim and the Petitioner's claims against Ever Robust for damages to be assessed;
- it is premature to give opinion on the probable outcome; and

Subsequent to the end of the reporting period on 17 January 2020, the Borrower received the summons (the "Summons") issued by the Lender, as plaintiff, in Shenzhen Intermediate People's Court (the "SZ **Court**") against the Borrower as defendant. Pursuant to the Summons, the Lender demanded the SZ Court to order the Borrower to: (i) repay to the Lender the outstanding principal amount of the Essence Loan in the sum of approximately RMB70,893,000 (equivalent to approximately HK\$79,216,000); (ii) pay to the Lender interest at the rate of 6% per annum accrued on the outstanding principal amount of the Essence Loan in the sum of approximately RMB70,893,000 (equivalent to approximately HK\$79,216,000) from 20 June 2019 to the date of repayment; (iii) pay to the Lender liquidated damages at the daily rate of 0.03%, including liquidated damages on the outstanding interest in the sum of approximately RMB1,042,000 (equivalent to approximately HK\$1,164,000) from 16 September 2019 to the date of repayment and liquidated damages on the principal from 19 June 2018 to the date of repayment; (iv) pay to the Lender its legal costs in making the claims in the sum of RMB76,000 (equivalent to approximately HK\$85,000); (v) use the proceeds from the realisation of 45,779,220 shares in LEO (i.e. the Jixiang's Shares) (note 19) pledged by the Borrower through discounting, sale or auction firstly to repay to the Lender the outstanding amount of the Essence Loan, the interest, the liquidated damages and the legal costs; and (vi) bear all the litigation costs such as case acceptance fees and security fee of this case. On 10 December 2019, Jixiang has instructed its PRC legal adviser to provide the Rebuttal and an objection to the Application ("Objection") to SHIAC. The Group's principal financial instruments, comprise interest-bearing bank and other borrowings, cash and bank balances and pledged time deposit. The main purpose of these financial instruments is to raise finance for the Group's operations. The Group has various other financial assets and liabilities such as contract assets, accounts receivable, loan and interest receivables and trade and other payables, accruals and provision, which arise directly from its operations.

The main risks arising from the Group's financial instruments are foreign currency risk, credit risk, liquidity risk, interest rate risk and market price risk. The Directors review and agree on policies for managing each of these risks as summarised below.

(a) Foreign currency risk

Foreign currency risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in foreign exchange rates.

The Group currently does not have a foreign currency hedging policy. However, the management will monitor the foreign exchange exposure should the need arise.

(b) Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in a financial loss to the Group. The Group's credit risk is primarily attributable to contract assets, accounts receivable, loan and interest receivable, other receivables, pledged time deposit, cash and bank balances. Management has a credit policy in place and the exposures to these credit risks are monitored on an ongoing basis. As at 31 December 2020, the Group did not provide any guarantee which would expose the Group to credit risk.

Credit evaluations are performed on customers requiring credit terms. These evaluations focus on the customer's history of making payments and current abilities to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. Normally, the Group does not obtain collateral from customers.

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer and therefore significant concentrations of credit risk primarily arise when the Group has significant exposure to individual customers. As at 31 December 2020, approximately 94.7% (2019: 85.4%) of the total accounts receivable and contract assets were concentrated in one customer, and approximately 96.7% (2019: 96.8%) of the total accounts receivable and contract assets were concentrated in five customers of the Group.

Maximum exposure and year-end staging

The tables below shows the credit quality and the maximum exposure to credit risk based on the Group's credit policy, which is mainly based on past due information unless other information is available without undue cost or effort, and year-end staging classification as at 31 December.

(c) Liquidity risk

Liquidity risk is the risk that the Group cannot meet its current obligations as they fall due.

The Group had net current liabilities of approximately HK\$36,135,000 as at 31 December 2020 (2019: HK\$73,164,000). In view of the liquidity situation faced by the Group, the Directors have adopted various measures with a view to improving the Group's overall financial and cash flow position and to maintaining the Group's existence on a going concern basis, details of which have been set out in note 2 to the consolidated financial statements. In light of all the measures adopted and arrangements implemented, the Directors are of the opinion that the Group will have sufficient cash resources to satisfy its future working capital and other financial requirements and it is reasonable to expect the Group to remain as a commercially viable concern.

The following table shows the remaining contractual maturities at the end of the reporting period of the Group's non-derivative financial liabilities, which are based on contractual undiscounted cash flows (including interest payments computed using contractual rates or, if floating, based on rates current at the end of the reporting period) and the earliest date on which the Group can be required to pay.

(d) Interest rate risk

Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Group's fair value and cash flow interest rate risks mainly relate to fixed and variable rates borrowings respectively. In order to exercise prudent management against interest rate risk, the Group continues to review the market trend, as well as its business operations needs and its financial position, so as to arrange the most effective interest rate risk management tools.

The Group's cash flow interest rate risk is mainly concentrated on the fluctuation of the business lending rates in Australia (2019: the business lending rates in Australia). The Group manages its fair value interest rate risk, when it is considered significant, by entering into appropriate swap contracts.

The sensitivity analysis below has been determined based on the exposure to interest rates for variable-rate interest-bearing bank and other borrowings at the end of the reporting period. The analysis is prepared assuming the amount of liability outstanding at the end of the reporting period has been outstanding for the whole year. A 50 basis point increase or decrease is used which represents management's assessment of the reasonably possible change in interest rates. If interest rates had been 50 basis points higher/lower and all other variables were held constant, the Group's loss for the year ended 31 December 2020 would have increased/decreased by approximately HK\$317,000 (2019: HK\$363,000).

(e) Market price risk

Market price risk is the risk that the fair value or future cash flows of a financial instrument traded in the market will fluctuate because of changes in market prices. The Group manages market prices risk, when it is considered significant, by entering into appropriate derivatives contracts.

The Group is exposed to equity price risk arising from equity investments classified as financial assets at FVTOCI and financial assets at FVTPL.
