References are made to the announcement of GSN Corporations Limited (the “**Company**”) dated 14 May 2021, in relation to, among other matters, delay in the publication of the 2021 First Quarterly Results Announcement and despatch its 2021 First Quarterly Report, and the announcement of the Company dated 21 July 2021 in relation to, among other matters, its audited consolidated annual results for the year ended 31 December 2020 (collectively, the “**Announcements**”). Unless otherwise defined herein, capitalised terms used in this announcement shall have the same meanings as those defined in the Announcements.

This announcement is made by the Board pursuant to Rule 17.10 of the GEM Listing Rules and the Inside Information Provisions (as defined in the GEM Listing Rules) of Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

#### **DELAY IN PUBLICATION OF 2021 INTERIM RESULTS ANNOUNCEMENT AND 2021 INTERIM REPORT**

Pursuant to Rules 18.53 and 18.78 of the GEM Listing Rules, the Company must publish its interim results announcement (the “**2021 Interim Results Announcement**”) and despatch its interim report (the “**2021 Interim Report**”), in respect of the first six months ended 30 June 2021, not later than 45 days after the end of the such period. As the publication of the 2021 First Quarterly Results Announcement is still pending and more time is required to finalise the interim result for the six months ended 30 June 2021, the Company is unable to make the 2021 Interim Results Announcement and despatch its 2021 Interim Report to its Shareholders within the prescribed time in accordance with the GEM Listing Rules.

As disclosed in the Announcements and based on the latest available information, the 2021 First Quarterly Results Announcement is expected to be published by end of August 2021, and the 2021 Interim Results Announcement is expected to be published by the end of September 2021.

The Company will publish further announcement(s) in due course to inform the Shareholders and potential investors in relation to the date of Board meeting and the release and the despatch of its 2021 First Quarterly Results Announcement, 2021 First Quarterly Report, 2021 Interim Results Announcement and 2021 Interim Report.

At the request of the Company, trading in the Shares on the Stock Exchange has been suspended with effect from 9:00 a.m. on 1 April 2021 and will remain suspended until further notice.
