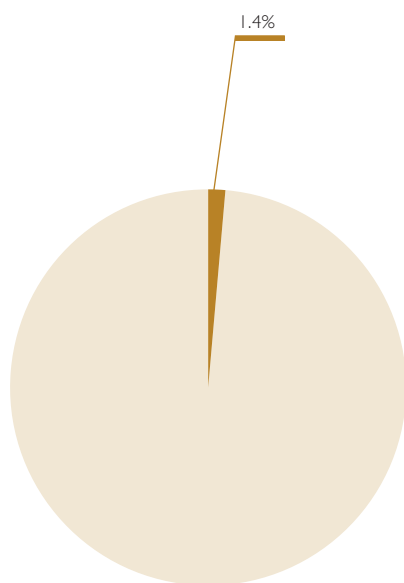

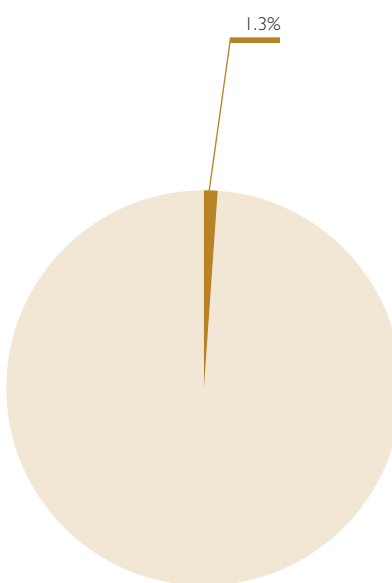

## Management Discussion and Analysis 管理層討論及分析

### BUSINESS REVIEW AND OUTLOOK

The Group is a contractor principally engaged in undertaking slope works, foundation works and other general building works in Hong Kong. Slope works generally refer to landslip preventive and remedial works for improving or maintaining the stability of slopes and/or retaining walls. Foundation works are generally concerned with the construction of foundations. General building works mainly include the general construction of buildings. Fraser Construction Company Limited, our principal operating subsidiary, is an approved specialist contractor included in the List of Approved Specialist Contractors for Public Works maintained by the Development Bureau of the Government of the Hong Kong Special Administrative Region (the "Hong Kong Government") under the categories of "Landslip Preventive/Remedial Works to Slopes/Retaining Walls" with a confirmed status and "Land Piling (Group II)". Being on such list is a prerequisite for tendering for public sector projects in the relevant works categories. In addition, Fraser Construction Company Limited is registered under the Buildings Ordinance (Chapter 123 of the Laws of Hong Kong) as a (i) Registered Specialist Contractor under the sub-register of "Site Formation Works" and "Foundation Works" categories; and (ii) Registered General Building Contractor.

The Group experienced an increase in revenue and slightly increase in gross profit margin, recorded a decrease in net loss for the year ended 30 April 2022 compared to the net loss for the year ended 30 April 2021. Hong Kong construction companies are facing tougher competitive condition, as well as the slower progress of scrutinising the funding proposals for public works projects by the Finance Committee and the Public Works Subcommittee due to political and social chaos in Hong Kong. The Group has also been facing challenging operating environment resulting from increasing costs of operation including, in particular, higher subcontracting rate and higher general operation costs. As such, the Directors consider that competition in the market has become more intense recently.

### 業務回顧及展望

本集團為一名主要在香港承建斜坡工程、地基工程及其他一般建築工程的承建商。斜坡工程一般指改善或保持斜坡及／或擋土牆穩定性的防止山泥傾瀉及修補工程。地基工程一般指地基建造。一般建築工程主要包括一般建築施工。我們的主要營運附屬公司科正建築有限公司為一名香港特別行政區政府（「香港政府」）發展局備存的「斜坡／擋土牆的防止山泥傾瀉／修補工程」（已取得核准資格）及「土地打樁」（第II組）類別下的認可公共工程專門承建商名冊上的認可專門承建商。名列該名冊是投標有關工程類別中的公營項目的必備條件。此外，科正建築有限公司已根據建築物條例（香港法例第123章）登記註冊為(i)「地盤平整工程」及「地基工程」類別分冊下的註冊專門承建商；及(ii)註冊一般建築承建商。

與截至二零二一年四月三十日止年度錄得淨損相比，本集團於截至二零二二年四月三十日止年度的收益增長及毛利率小幅上升，錄得淨損減少。香港的建築公司正面臨更嚴峻的競爭環境，財務委員會及工務小組委員會因香港政治及社會亂局而放慢公共工程項目的撥款建議的審議進度。本集團亦面臨更具挑戰性的經營環境，此乃由於經營成本不斷上升，包括（尤其是）分包費用及整體經營成本升高。因此董事認為，市場競爭近期日趨激烈。

## Management Discussion and Analysis

The Directors are also cautiously monitoring the overall construction costs with respect to the works undertaken by the Group which are affected by factors including the overall market conditions and costs in the construction industry as well as overall economy in Hong Kong.

Going forward, in developing the Group's business, the Directors will continue to carefully evaluate the potential costs and to control the Group's overall costs to an acceptable and satisfactory level.

Nevertheless, we believe that the Hong Kong Government's continuing increase in major construction and infrastructure projects in Hong Kong will increase the demand for slope works because of the public safety. The Hong Kong Government still maintain its stand to launch a rolling Landslip Prevention and Mitigation Programme to systematically deal with the landslide risk associated with both man-made slopes and natural hillsides. The stand enable steady flow of slopes construction works load to the construction industry. All in all, the Directors remain cautiously optimistic about the slope works industry in Hong Kong.

Up to the date of this report, the Group has obtained public projects from each of Civil Engineering and Development Department ("CEDD") and Lands Department of the Hong Kong Government respectively, which are expected to be completed in the coming years.

#### FINANCIAL REVIEW

##### Revenue

The Group's overall revenue increased by approximately HK\$23.2 million or 21.1% from approximately HK\$110.1 million for the year ended 30 April 2021 to approximately HK\$133.3 million for the year ended 30 April 2022. The increase in revenue is mainly due to the increase in revenue derived from undertaking slope works and foundation works as further discussed below.

董事亦審慎監控本集團所承建的工程的整體建築成本，該建築成本受不同因素影響，包括香港整體市況、建築行業成本以及整體經濟。

今後，在發展本集團業務的過程中，董事將繼續審慎地評估潛在成本以及控制本集團的整體成本至一個可接受及令人滿意的水平。

然而，我們相信，香港政府於香港持續增加主要建設及基建項目將因公共安全而增加斜坡工程之需求。香港政府仍持續展開長遠防治山泥傾瀉計劃，以有系統處理人造斜坡和天然山坡涉及的山泥傾瀉風險，為建造業帶來穩定斜坡建造工程。總而言之，董事對香港斜坡工程行業仍持審慎樂觀態度。

直至本報告日期，本集團已分別自香港政府土木工程拓展署（「土木工程拓展署」）及地政總署獲得公營項目，預計將於未來年度完工。

#### 財務回顧

##### 收益

本集團總體收益由截至二零二一年四月三十日止年度之約110.1百萬港元增加約23.2百萬港元至截至二零二二年四月三十日止年度之約133.3百萬港元，增幅為21.1%。收益增加乃主要來自承接斜坡工程及地基工程之收益增加所致（於下文作進一步論述）。

The Board regards the Group's business of construction as a single operating segment and reviews the overall results of the Group as a whole to make decision about resources allocation. Accordingly, no segment analysis information is presented. No separate analysis of segment information by geographical segment is presented as the Group's revenue and non-current assets are principally attributable to a single geographical region, which is in Hong Kong. The Group's principal operating activities for the year ended 30 April 2022 are as follows:

**Slope works:** Undertaking landslip preventive and remedial works for improving or maintaining the stability of slopes and/or retaining walls. Revenue from undertaking slope works increased from approximately HK\$110.0 million for the year ended 30 April 2021 to approximately HK\$133.0 million for the year ended 30 April 2022, representing an increase of approximately 21.0%. The increase in revenue was primarily attributable due to the increase of slope work projects.

**Foundation works:** Undertaking works in relation to the construction of foundations for general building construction. Revenue from undertaking foundation works increased from approximately HK\$0.1 million for the year ended 30 April 2021 to approximately HK\$0.3 million for the year ended 30 April 2022, representing an increase of approximately 200%, as a result of the increase in the number of foundation work projects undertaken by our Group during the year ended 30 April 2022.

The Group's direct costs increased by approximately HK\$22.8 million or 21.0% from approximately HK\$108.7 million for the year ended 30 April 2021 to approximately HK\$131.5 million for the year ended 30 April 2022. Such increment was mainly attributable to the increase in amount of works performed resulting in the increase in our subcontracting charges.

The Group's gross profit slightly increased by approximately HK\$0.4 million or 26.7% from approximately HK\$1.5 million for the year ended 30 April 2021 to approximately HK\$1.9 million for the year ended 30 April 2022 and the Group's gross profit margin increased from approximately 1.3% for the year ended 30 April 2021 to approximately 1.4% for the year ended 30 April 2022. The slightly increase in gross profit margin were mainly due to (i) increase in projects and (ii) tight control in subcontracting rate and overall construction costs for existing projects under the tougher competitive condition and challenging operating environment in Hong Kong construction market.

董事會將本集團的建築業務視為單一經營分部，並審閱本集團整體之業績，以就資源分配作出決策。因此，並無呈報部分分析資料。由於本集團的收益及非流動資產主要來自單一地理區域（香港），故並無呈報按地理分部劃分的分部資料獨立分析。本集團於截至二零二二年四月三十日止年度的主要經營活動如下：

**斜坡工程：**承建改善或保持斜坡及／或擋土牆穩定性的防止山泥傾瀉及修補工程。來自承建斜坡工程的收益由截至二零二一年四月三十日止年度之約110.0百萬港元增加至截至二零二二年四月三十日止年度之約133.0百萬港元，增幅約為21.0%。收益的增加主要由於斜坡工程項目增加所致。

**地基工程：**承建與一般樓宇建設的地基建造有關的工程。來自承建地基工程的收益由截至二零二一年四月三十日止年度之約0.1百萬港元增加至截至二零二二年四月三十日止年度之約0.3百萬港元，增幅約為200%，此乃由於本集團於截至二零二二年四月三十日止年度承建地基工程的數目增加所致。

本集團的直接成本由截至二零二一年四月三十日止年度的約108.7百萬港元增加約22.8百萬港元至截至二零二二年四月三十日止年度約131.5百萬港元，增幅為21.0%。有關增加乃主要由於開展的工程數量增加，從而導致我們的分包費用增加。

本集團的毛利由截至二零二一年四月三十日止年度的約1.5百萬港元小幅增加約0.4百萬港元至截至二零二二年四月三十日止年度的約1.9百萬港元，增幅為26.7%，而本集團的毛利率由截至二零二一年四月三十日止年度的約1.3%增加至截至二零二二年四月三十日止年度的約1.4%。毛利率小幅增加乃主要由於(i)項目增加及(ii)香港建築市場更嚴峻的競爭環境及具挑戰性的經營環境導致對現有項目的分包費用及整體建築成本進行嚴格控制。

#### Other Income and Other Net Loss

The Group's other income and other net loss amounted to approximately HK\$1.3 million and HK\$0.9 million for the years ended 30 April 2021 and 2022 respectively. The decrease was mainly due to the decrease of government grant of approximately HK\$1.3 million for the year ended 30 April 2022.

#### Administrative Expenses

The Group's administrative expenses decreased by approximately HK\$5.5 million or approximately 36.7% from approximately HK\$15.0 million for the year ended 30 April 2021 to approximately HK\$9.5 million for the year ended 30 April 2022. The decrease in the Group's administrative expenses was mainly due of the decrease in total staff costs and short-term leases expenses.

#### Loss on deconsolidation of subsidiaries

During the year ended 30 April 2021, the Group has incurred a loss of approximately HK\$23.6 million due to the Special Event mentioned below under the heading of Deconsolidated Subsidiaries in PRC. More information is set out in note 2.4 and note 23(b) to the consolidated financial statements.

#### Loss on disposal of subsidiaries

During the year ended 30 April 2022, the Group has incurred a loss of approximately HK\$0.2 million. More information is set out in note 24 to the consolidated financial statements.

#### Impairment loss on financial assets

Impairment loss on financial assets amounted to approximately HK\$0.1 million and 57.5 million for the year ended 30 April 2022 and 2021 respectively, details of which are as follows:

- (i) During the year ended 30 April 2022, the Group has incurred an impairment loss of approximately HK\$0.1 million. More information is set out in notes 8(b) to the consolidated financial statements.
- (ii) During the year ended 30 April 2021, the Group has incurred an impairment loss of approximately HK\$43.9 million due to an amount due from a deconsolidated subsidiary. More information is set out in note 2.4 and note 23(c) to the consolidated financial statements.

#### 其他收入及其他虧損淨額

本集團截至二零二一年及二零二二年四月三十日止年度的其他收入及其他虧損淨額分別約為1.3百萬港元及0.9百萬港元。下降乃主要由於截至二零二二年四月三十日止年度，政府補貼減少約1.3百萬港元。

#### 行政開支

本集團的行政開支由截至二零二一年四月三十日止年度的約15.0百萬港元減少約5.5百萬港元至截至二零二二年四月三十日止年度的約9.5百萬港元，減幅約為36.7%。本集團的行政開支減少乃主要由於員工成本及短期租賃開支總額減少。

#### 終止綜合入賬附屬公司的虧損

於截至二零二一年四月三十日止年度，本集團因下文終止綜合入賬中國附屬公司中所述的特別事件而產生虧損約23.6百萬港元。更多資料載於綜合財務報表附註24及附註23(b)。

#### 出售附屬公司虧損

截至二零二二年四月三十日止年度，本集團產生虧損約0.2百萬港元。更多資料載於綜合財務報表附註24。

#### 金融資產減值虧損

截至二零二二年及二零二一年四月三十日止年度分別錄得金融資產減值虧損約0.1百萬港元及57.5百萬港元，有關詳情如下：

- (i) 截至二零二二年四月三十日止年度，本集團產生減值虧損約0.1百萬港元。更多資料載於綜合財務報表附註8(b)。

### Finance Costs

During the year ended 30 April 2022, the Group has incurred financial costs of approximately HK\$0.3 million due to interest on borrowings.

### Net Loss

Loss attributable to owners of the Company for the year ended 30 April 2022 was approximately HK\$7.4 million as compared to loss attributable to owners of the Company of approximately HK\$93.4 million for the year ended 30 April 2021. The decrease in net loss for the year was mainly due to decrease in loss on deconsolidation of subsidiaries and impairment loss on financial assets as a result of the Special Event for the year ended 30 April 2021 as discussed above.

### Final Dividend

The Board did not recommend a payment of a final dividend for the year ended 30 April 2022 (2021: Nil).

## LIQUIDITY AND FINANCIAL RESOURCES

As at 30 April 2022, current assets amounted to HK\$71.1 million (2021: HK\$49.4 million) of which HK\$44.8 million (2021: HK\$25.2 million) was cash and cash equivalents, HK\$16.5 million (2021: HK\$14.3 million) was trade and other receivables. The Group's current liabilities amounted to HK\$90.6 million (2021: HK\$62.0 million), including trade and other payables in the amount of HK\$85.6 million (2021: HK\$62.0 million). Calculated based on current assets of HK\$71.1 million (2021: HK\$49.4 million) divided by current liabilities of HK\$90.6 million (2021: HK\$62.0 million), current ratio was 0.8 (2021: 0.8).

截至二零二二年四月三十日止年度的本公司擁有人應佔虧損約為7.4百萬港元，而截至二零二一年四月三十日止年度的本公司擁有人應佔虧損則約為93.4百萬港元。年內虧損淨額減少乃主要由於上述截至二零二一年四月三十日止年度的特別事件導致附屬公司終止綜合入賬的虧損及金融資產減值虧損減少。

### 末期股息

董事會不建議派付截至二零二二年四月三十日止年度之末期股息（二零二一年：無）。

As at 30 April 2022, the cash at banks and other financial institution and cash in hand of the Group amounted to approximately HK\$44.8 million (2021: approximately HK\$25.2 million), representing an increase of approximately HK\$19.6 million as compared to 30 April 2021.

#### CHARGES OVER ASSETS OF THE GROUP

There is no charge over assets of the Group as at 30 April 2022 (2021: Nil).

#### GEARING RATIO

As at 30 April 2022, the gearing ratio of the Group was approximately negative 317.7% (2021: approximately negative 286.5%).

The gearing ratio is calculated as total debts HK\$61.1 million (2021: HK\$34.0 million) divided by equity attributable to owners of the Company HK\$19.2 million deficit (2021: HK\$11.9 million deficit) as the respective reporting date. For this purpose total debts is defined as amounts due to former directors, amount due to director of a subsidiary, and borrowings as shown in the consolidated statement of financial position. The Group's gearing ratio was negative as the Group's equity was deficit position as at 30 April 2022.

#### FOREIGN EXCHANGE EXPOSURE

The majority of the Group's transactions, assets and liabilities are denominated in Hong Kong dollar. The Group has no material exposed to exchange rate risk for the year ended 30 April 2022.

#### CAPITAL COMMITMENTS

The Group had no material capital commitment as at 30 April 2022 (2021: Nil).

As at 30 April 2022, the Group had 46 (2021: 36) employees, including the Directors. Staff costs (including directors' emoluments) were approximately HK\$5.5 million for the year ended 30 April 2022 as compared to approximately HK\$7.3 million for the year ended 30 April 2021. The remuneration policy and package of the Group's employees were annually reviewed. The salaries increment and discretionary bonuses may be awarded to employees according to the assessment of individual performance.

The emoluments of the Directors were reviewed by the remuneration committee of the Company, having regard to the Company's operating results, market competitiveness, individual performance, and approved by the Board.

### SIGNIFICANT INVESTMENTS HELD, MATERIAL ACQUISITIONS OR DISPOSALS OF SUBSIDIARIES AND AFFILIATED COMPANIES, AND PLANS FOR MATERIAL INVESTMENTS OR CAPITAL ASSETS

Save as disclosed in this annual report, the Group did not have other plans for material investments or capital assets as of 30 April 2022.

### CONTINGENT LIABILITIES

As at 30 April 2022, the Group had no material contingent liabilities (2021: Nil).

### CAPITAL STRUCTURE

The change in the capital structure of the Company for the year ended 30 April 2022 is set out in note 21 to the consolidated financial statements. The share capital of the Group only comprises of ordinary shares.

As at 30 April 2022, the Company's issued capital was approximately HK\$15.8 million and the number of its issued ordinary shares was 1,577,200,000 of HK\$0.01 each.

#### SEGMENT INFORMATION

#### PRINCIPAL RISKS AND UNCERTAINTIES

The Group's key risk exposures are summarized as follows:

- i. A significant portion of the Group's past revenue was generated from contracts granted by the Hong Kong Government and statutory bodies, which are non-recurrent in nature, and if the level of Hong Kong Government's spending on construction projects particularly for slope works is reduced, the Group's financial performance may be materially affected;
- ii. The Group is dependent on its senior management and in-house engineers, inability to retain its staff may adversely affect the Group's business operations; and
- iii. Any delays in the Group's projects may affect the Group's cash flows and may have adverse impact on the Group's business and reputation.

For other risks and uncertainties facing the Group, please refer to the section headed "Risks Factors" in the Company's prospectus dated 23 October 2015.

#### COMPLIANCE WITH LAWS AND REGULATIONS

The Group's operations are mainly carried out by the Company's subsidiaries in Hong Kong while the Company itself is listed on the Stock Exchange. Our establishment and operations shall therefore comply with the relevant laws and regulations in Hong Kong. External compliance and legal advisers are engaged to ensure transactions and businesses performed by the Group are within the applicable law framework. Updates on applicable laws, rules and regulations are brought to the attention of relevant employees and operation units from time to time. During the year ended 30 April 2022 and up to the date of this annual report, there is no material non-compliance with the relevant prevailing laws and regulations in Hong Kong by the Group.

- ii. 本集團依賴其高級管理層及內部工程師，未能挽留其員工或會對本集團的業務營運造成不利影響；及

#### 遵守法律及法規

本集團的業務主要由本公司於香港的附屬公司進行，而本公司本身於聯交所上市。因此，我們的成立及經營須遵守香港相關法律及法規。我們已聘用外部合規及法律顧問，確保本集團的交易及業務乃於適用的法律框架內進行。會不時通知相關僱員及經營單位適用法律、規則及法規的更新。於截至二零二二年四月三十日止年度及截至本年報日期，本集團並無重大違反香港的相關現行法律及法規。

### RELATIONSHIP WITH CUSTOMERS, SUPPLIERS, SUBCONTRACTORS AND EMPLOYEES

#### Customers

The Group's customers mainly include (a) for public sector projects, Hong Kong Government departments such as CEDD, Lands Department and Architectural Services Department, as well as other statutory bodies including the Hong Kong Housing Authority; and (b) for private sector projects, private corporations and other entities in the private sector.

During the year ended 30 April 2022, the Group served customers from both of public and private sector in Hong Kong. The Group has business relationship with most of the top customers ranging from one year to over 10 years.

#### Suppliers and Subcontractors

During the year ended 30 April 2022, the suppliers of goods and services which were specific to the business of the Group and were required on a regular basis to enable the Group to continue to carry on its business included (i) subcontractors engaged by the Group to perform the slope works; (ii) suppliers of construction materials and consumables as such high-tensile steel, structural steel, cement and aggregates.

The Group maintains an internal list of approved subcontractors. While engaging subcontractors, the Group generally selects the most suitable subcontractor from the approved list based on their relevant experience as well as their availability and fee quotations.

The Group did not experience any material difficulties in sourcing materials from suppliers or assigning subcontractors during the year ended 30 April 2022. Also, there is no significant dispute with our top five suppliers and subcontractors during the year ended 30 April 2022.

#### Employees

The Group believes that employees are important assets and their contribution and support are valued at all times. The Group provides competitive remuneration packages to attract and retain employees with the aim to form a professional staff and management team that can bring the Group to new levels of success. The Group regularly reviews compensation according to industry benchmark, financial results as well as the individual performance of employees. Furthermore, the Group places great emphasis on the training and development of employees and regards excellent employees as a key factor in its competitiveness.

### 與客戶、供應商、分包商及僱員的關係

#### 客戶

本集團的客戶主要包括(a)就公營項目而言，土木工程拓展署、地政總署及建築署等香港政府部門以及其他法定機構（包括香港房屋委員會）；及(b)就私營項目而言，私人公司及私營項目其他實體。

於截至二零二二年四月三十日止年度，本集團服務香港公營及私營項目的客戶。本集團已與大部分主要客戶維持介乎一年至十年以上的業務關係。

#### 供應商及分包商

於截至二零二二年四月三十日止年度，供應本集團業務所特有及本集團為繼續開展業務而定期所需的商品及服務的供應商包括(i)本集團委聘進行斜坡工程的分包商；(ii)供應高強度鋼、鋼架、水泥及集料等建材及耗材的供應商。

本集團存置認可分包商的內部名單。本集團委聘分包商時，一般根據彼等的相關經驗以及時間安排及費用報價，從認可名單中挑選最適合的分包商。

於截至二零二二年四月三十日止年度，本集團並未於向供應商採購物料或委派分包商遭遇任何重大困難。另外，我們於截至二零二二年四月三十日止年度並無與我們五大供應商及分包商產生任何重大糾紛。

#### 僱員

本集團相信僱員乃寶貴資產，而且任何時候都重視他們的貢獻及支持。本集團提供具競爭力的薪酬待遇以吸引及挽留僱員，務求構建專業的員工及管理團隊，推動本集團續創佳績。本集團根據業內指標、財務業績及個別僱員的表現定期檢討僱員的薪酬。此外，本集團十分重視僱員的培訓及發展，並視優秀僱員為其競爭力的關鍵要素。

#### Deconsolidated Subsidiaries in PRC

Pursuants to the Company's announcement dated 15 October 2021, the Company appointed a legal adviser (the "PRC Legal Adviser") and the Company has been reported by the PRC Legal Advisers as below:

- 1) The PRC Legal Adviser has made enquiry to the branch office of the Hangzhou Public Security Bureau\* (杭州市公安局拱墅區分局) and it indicated that Mr. Zhou and Ms. Meng were suspected of illegal absorption of public deposits under the operation of Zhejiang United Small-and Medium-sized Enterprises Holdings Group Company Limited\* (浙江聯合中小企業控股集團有限公司), a company incorporated and operated in the PRC of which Mr. Zhou and Ms. Meng are the ultimate shareholders and not a subsidiary within the Group, which were under formal investigation. On 21 July 2021, Mr. Zhou and Ms. Meng were held in custody by the Bureau. On 26 August 2021, Mr. Zhou and Ms. Meng were officially arrested by People's Procuratorate of Gongshu District, Hangzhou. The Bureau has published a press release in relation to their arrest on 27 August 2021
- 2) The PRC Legal Adviser conducted on-site visit to the registered offices and principal places of business of the PRC subsidiaries, namely Zhejiang Zhong Chun Wenhua Keji Limited\* (浙江中淳文化科技有限公司) ("Zhejiang Zhong Chun"), Zhejiang Fu Lian Zichan Guanli Limited\* (浙江富連資產管理有限公司) ("Zhejiang Fulian") and Zhejiang Xin Lian Hengi Tongxun Jishu Limited\* (浙江新聯恒基通訊技術有限公司) ("Zhejiang Xinlian") and found that, the respective premises of the registered offices and principal places of business of the above mentioned PRC subsidiaries were either empty or occupied by other parties instead of the above mentioned PRC subsidiaries. The PRC Legal Adviser made enquiry to the relevant government authorities and found that no other business addresses were registered by the above mentioned PRC subsidiaries.
- 3) The PRC Legal Adviser also made enquiry to the offices of the principal banks of the PRC subsidiaries which responded that the details and status of the bank accounts of the PRC subsidiaries could only be accessed by their legal representatives or their delegate. All the legal representatives of the PRC subsidiaries were unable to be contacted during the investigation.

#### 終止綜合入賬中國附屬公司

根據本公司日期為二零二一年十月十五日的公佈，本公司委任一名法律顧問（「中國法律顧問」）且已獲中國法律顧問告知如下：

- 1) 中國法律顧問已諮詢杭州市公安局拱墅區分局，其表明，已對周先生及孟女士在經營浙江聯合中小企業控股集團有限公司（一間於中國註冊成立及營運且周先生及孟女士為其最終股東的公司，並非本集團內附屬公司）期間涉嫌非法吸收公眾存款一案立案偵查。於二零二一年七月二十一日，公安局對周先生及孟女士進行拘留。於二零二一年八月二十六日，周先生及孟女士被杭州市拱墅區人民檢察院正式逮捕。公安局已於二零二一年八月二十七日發佈有關該逮捕案情通報。
- 2) 中國法律顧問已實地訪問中國附屬公司（即浙江中淳文化科技有限公司（「浙江中淳」）、浙江富連資產管理有限公司（「浙江富連」）及浙江新聯恒基通訊技術有限公司（「浙江新聯」））的註冊辦事處及主要營業地點，且發現上述中國附屬公司註冊辦事處及主要營業地點的相關處所已空置或被其他方而非上述中國附屬公司所佔據。中國法律顧問已詢問相關政府機構，未發現上述中國附屬公司有其他登記的經營地址。
- 3) 中國法律顧問亦詢問中國附屬公司的主要往來銀行辦公室，獲告知中國附屬公司的銀行賬戶詳情及狀態僅可由其法人代表或其代表訪問。所有中國附屬公司的法人代表於偵查期間均無法取得聯繫。

Up to the date of the this report, the Group was not able to locate the books and records of Zhejiang Zhong Chun, Zhejiang Fulian and Zhejiang Xinlian and not able to obtain the latest information of Zhejiang Zhong Chun, Zhejiang Fulian and Zhejiang Xinlian for the purpose of preparing the consolidated financial statements for the years ended 30 April 2022 and 2021, as a result of the event mentioned above in point 1, 2 and 3 (the "Special Event"). The Group has lost control over Zhejiang Zhong Chun, Zhejiang Fulian and Zhejiang Xinlian and accounted for deconsolidation of Zhejiang Zhong Chun, Zhejiang Fulian and Zhejiang Xinlian (the "Deconsolidation") for the year ended 30 April 2021. Therefore, the Group has recorded loss on Deconsolidation of approximately HK\$23.6 million and impairment loss on amount due from deconsolidated subsidiary of approximately HK\$43.9 million in relation to the Deconsolidation.

### Disposal of subsidiaries

The Company has appointed the PRC Legal Adviser to attempt resuming control on the Deconsolidated Subsidiaries, the Company faced serious obstacles. The report of the PRC Legal Adviser indicating the Company that:

- (i) replacement of the seal (公章) of the Deconsolidated Subsidiaries (the "Seal") requires the signatures of the legal representative of the Deconsolidated Subsidiaries, however the legal representative namely Mr. Zhou whom the Company has been unable to contact since 22 July 2021, Mr. Zhou and Ms. Meng were officially arrested by People's Procuratorate of Gongshu District, Hangzhou on 26 August 2021 and the Bureau has published a press release in relation to their arrest on 27 August 2021;
- (ii) change of legal representative requires the Seal; and
- (iii) the Company is not able to regain control of the Deconsolidated Subsidiaries as mentioned in (i) and (ii) above.

由於上述第1、2及3點提及的事件，直至本報告日期，本集團未能就編製截至二零二二年及二零二一年四月三十日止年度之綜合財務報表取得浙江中淳、浙江富連及浙江新聯的賬簿及記錄，亦未取得浙江中淳、浙江富連及浙江新聯的最新資料（「特別事件」）。本集團已失去對浙江中淳、浙江富連及浙江新聯的控制權，並於截至二零二一年四月三十日止年度終止綜合入賬浙江中淳、浙江富連及浙江新聯（「終止綜合入賬」）。因此，本集團已錄得有關終止綜合入賬的虧損約23.6百萬港元及就終止綜合入賬應收終止綜合入賬附屬公司款項的減值虧損約43.9百萬港元。

### 出售附屬公司

本公司已委聘中國法律顧問試圖恢復對終止綜合入賬的附屬公司的控制，本公司面臨著嚴重障礙。中國法律顧問的報告表明，如本公司：

- (i) 更換終止綜合入賬的附屬公司的公章（「公章」）需由其終止綜合入賬的附屬公司的法定代表人簽名，但本公司自二零二一年七月二十二日以來一直無法聯繫法定代表人周先生，周先生和孟女士已於二零二一年八月二十六日被杭州市拱墅區人民檢察院正式逮捕，公安局已於二零二一年八月二十七日就逮捕他們一事發佈新聞稿；
- (ii) 法定代表人的變更需要加蓋公章；及
- (iii) 本公司因上文(i)和(ii)所述無法重新取得終止綜合入賬的附屬公司控制權。

Based on the report from the PRC Legal Adviser, the Board concluded that the resumption of the control of the Deconsolidated Subsidiaries was not possible (the “Resumption”). After then, the Board assessed and evaluated the benefit of the disposal of the Deconsolidated Subsidiaries (the “Disposal”), carried out and completed the Disposal on 29 April 2022. The Company entered into several sale and purchase agreements to dispose of (i) the entire equity interest in Liangzhu Global Limited which held a subsidiary, (ii) the entire equity interest in Sunvot Holdings Limited which held several subsidiaries including two of the Deconsolidated Subsidiaries and (iii) the entire equity interest in Zhejiang Zhong Chun, one of the Deconsolidated Subsidiaries, at cash consideration of HK\$20,000 in aggregate to the purchaser, Mr. Zhao Chengjin, an independent third party. As a result, the Group recognised a loss on the disposal of subsidiaries of approximately HK\$0.2 million and the Deconsolidated Subsidiaries including their shareholder as intermediate holding company were no longer be a member of the Company.

#### Management’s View on the Disclaimer of Opinion

The management of the Company has given careful consideration to the Disclaimer of Opinion and the basis of Disclaimer of Opinion and has had ongoing discussion with the auditor of the Company (the “Auditor”) when preparing the Group’s consolidated financial statements.

Regarding disclaimer of opinion, deconsolidation of subsidiaries, as disclosed in this annual report, to the management’s best knowledge and belief, the management understood that the limitation of scope was mainly due to the Special Event mentioned in above under the heading of Deconsolidated Subsidiaries in PRC.

根據中國法律顧問的報告，董事會得出結論，本公司無法恢復對終止綜合入賬的附屬公司的控制（「恢復」）。此後，董事會評估了出售終止綜合入賬的附屬公司（「出售」）的收益，並已於二零二二年四月二十九日完成出售。本公司訂立若干買賣協議，以向買方周成錦先生（一名獨立第三方）出售(i) Liangzhu Global Limited（持有一間附屬公司）的全部股權，(ii) Sunvot Holdings Limited（持有若干附屬公司，包括兩家終止綜合入賬附屬公司）的全部股權及(iii) 浙江中淳（終止綜合入賬附屬公司之一）的全部股權，現金代價總計為20,000港元。因此，本集團就出售附屬公司確認虧損約0.2百萬港元，且終止綜合入賬附屬公司（包括其作為中間控股公司的股東）不再為本公司的成員公司。

#### 管理層有關不發表意見的意見

於編製本集團綜合財務報表時，本公司管理層已審慎考慮不發表意見及不發表意見的基準，並已與本公司核數師（「核數師」）展開持續討論。

有關本年報披露的終止綜合入賬附屬公司的不發表意見，就管理層所知及所信，管理層瞭解到範圍限制乃主要由於上文終止綜合入賬中國附屬公司中所述的特別事件所致。

In order to address it, the management had used their best endeavours to locate the books and records and information of Zhejiang Zhong Chun, Zhejiang Fulian and Zhejiang Xinlian but in vain. Subsequent to the reporting period for the year ended 30 April 2021, the management concluded that the Group lost the control of Zhejiang Zhong Chun, Zhejiang Fulian and Zhejiang Xinlian (the "Deconsolidated Subsidiaries") which were deconsolidated from the consolidated financial statements of the Group for the year ended 30 April 2021.

Regarding the disclaimer opinion, deconsolidation of subsidiaries, the Directors used their best endeavours to locate the books and records and have appointed the PRC Legal Adviser to assist the Directors to obtain more information of the Deconsolidated Subsidiaries. As a result of the Special Event, a decision of deconsolidation of Deconsolidated Subsidiaries was made for the year ended 30 April 2021. As a result of the failure of Resumption, the Disposal was completed on 29 April 2022.

After discussing with the professional parties of the Company, the management are of the view that (i) the Deconsolidated Subsidiaries have already been disposed on 29 April 2022 and (ii) the Group no longer held any interest in the Deconsolidated Subsidiaries, there will not be disclaimer of opinion in this regard but qualified opinion on the comparability of the corresponding figures only in the consolidated financial statements for the year ending 30 April 2023; and there will no longer be any qualified opinion in this regard for the year ending 30 April 2024.

為處理不發表意見，管理層已盡其最大努力，嘗試查找浙江中淳、浙江富連及浙江新聯的賬冊、記錄及資料，但未能成功。於截至二零二一年四月三十日止年度報告期後，管理層判定，本集團已失去對浙江中淳、浙江富連及浙江新聯（「終止綜合入賬的附屬公司」）的控制權，該等公司已自本集團截至二零二一年四月三十日止年度之綜合財務報表終止綜合入賬。

有關終止綜合入賬附屬公司的不發表意見，董事盡其最大努力查找賬簿及記錄並已委任中國法律顧問協助董事獲得終止綜合入賬附屬公司的更多資料。由於特別事件，截至二零二一年四月三十日止年度已作出對終止綜合入賬附屬公司終止綜合入賬的決定。由於恢復未能作實，出售事項已於二零二二年四月二十九日完成。

經與本公司專業方討論後，管理層認為(i)終止綜合入賬附屬公司已於二零二二年四月二十九日出售，及(ii)本集團不再持有終止綜合入賬附屬公司任何權益，將不會就此發表不發表意見，但僅就截至二零二三年四月三十日止年度綜合財務報表內相應數字的可比性發表保留意見；及截至二零二四年四月三十日止年度，將不再就此發表任何保留意見。

## Management Discussion and Analysis

#### Audit Committee's View and removal of the Disclaimer of Opinion

The Company had tried to provide sufficient supporting document and information to the Auditor. However, up to the reporting date, the books and records of the Deconsolidated Subsidiaries were not available due to the Special Event.

Due to the incomplete books and records of the Deconsolidated Subsidiaries, the Auditor was unable to carry out audit procedures to obtain sufficient appropriate audit evidence to satisfy themselves as well as the disclosures set out in the notes to the consolidated financial statements were free from material misstatement.

The Audit Committee acknowledged the views of the Auditor regarding the disclaimer of opinion. The Audit Committee is of the view that (i) the Company has already completed the Disposal for the year ended 30 April 2022. Upon completion of the Disposal, the Group no longer held any interest in the Deconsolidated Subsidiaries including its shareholder as intermediate holding company, (ii) in view of the deconsolidation of the Deconsolidated Subsidiaries in PRC for the financial year ended 30 April 2021, the limitation of scope was one-off and non-recurring incident and (iii) in view of the Deconsolidated Subsidiaries have already been disposed on 29 April 2022, the audit qualification related to the Deconsolidated Subsidiaries will be on the comparability of the corresponding figures only in the consolidated financial statements for the year ending 30 April 2023 and no such audit qualification will exist in the consolidated financial statements for the year ending 30 April 2024. The auditor of the Company have confirmed that they concur with this view of the Audit Committee and the management.

#### Project during the Year

There was no new significant project for the year ended 30 April 2022.

Pursuant to Rule 18.44 of the Rules Governing the Listing of Securities on the GEM (the “GEM Listing Rules”) of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) GEM Listing Rules, the Board is pleased to present hereby the corporate governance report of the Company for the year ended 30 April 2022 (the “Year”).

The Directors and the management of the Group recognise the importance of sound corporate governance to the long-term success and continuing development of the Group. Therefore, the Board takes the view that good corporate standards and procedures, so as to improve the accountability system and transparency of the Group, protect the interests and create value for Shareholders.

#### CORPORATE GOVERNANCE CODE

During the Year, the Company has complied with the applicable code provisions of the Corporate Governance Code (the “CG Code”), except the followings in Appendix 15 of the GEM Listing Rules save for the deviation from code provision A.2.1 explained below.

- (i) Code provision A.1.8 – The Company did not arrange appropriate insurance cover in respect of legal action against its directors. The insurance was bought and covered for the period of one year with effective from 11 August 2021.
- (ii) Code provision A.2.1 – The roles of chairman and chief executive should be separate and should not be performed by the same individual. Mr. Zhou has been managing the Company’s business and the overall financial and strategic planning since July 2017. Since the Company has appointed Mr. Zhou as chairman and chief executive officer, the roles of the chairman and chief executive officer were not separated and performed by two different individuals. Mr. Zhou was removed by the EGM on 30 September 2021.
- (iii) Code provision A2.7 – The chairman should at least annually hold meetings with the independent non-executive directors without the presence of other directors. No chairman was appointed since Mr. Zhou was removed by the EGM on 30 September. No such meeting could be arranged during the Year.

根據香港聯合交易所有限公司（「聯交所」）GEM證券上市規則（「GEM上市規則」）第18.44條，董事會欣然提呈本公司截至二零二二年四月三十日止年度（「本年度」）的企業管治報告。

本集團董事及管理層肯定健全企業管治對本集團的長遠成功及持續發展極為重要。因此，董事會認為優良企業標準及程序可改善本集團的問責制度及提高透明度，保障股東利益及為股東創造價值。

#### 企業管治守則

於本年度，除GEM上市規則附錄十五所載下列事項外，本公司一直遵守企業管治守則（「企業管治守則」）的適用守則條文，惟下文解釋的與守則條文A.2.1條有所偏離者除外。

- (ii) 守則條文第A.2.1條—主席及行政總裁之角色應有區分，並不應由一人同時兼任。周先生自二零一七年七月起一直管理本公司的業務及整體財務和戰略規劃。由於本公司已委任周先生為主席兼行政總裁，主席及行政總裁之角色並無區分，亦非由兩名不同的人士擔任。周先生於二零二一年九月三十日被股東特別大會罷免。
- (iii) 守則條文第A2.7條—主席應至少每年與獨立非執行董事舉行沒有其他董事出席的會議。由於周先生於九月三十日被股東特別大會罷免，並無委任主席。於本年度期間，並無安排相關會議。

Since 21 October 2021, due to the presence of three independent non-executive Directors which represent half of the Board, the Board considers that there is a balance of power and authority such that no one individual has unfettered power of decision.

### CODE OF CONDUCT REGARDING SECURITIES TRANSACTIONS BY DIRECTORS

The Group has adopted a code of provisions of conduct regarding securities transactions by the Directors the (“Code of Conduct”) on terms no less exacting than the required standards of dealings set out in Rules 5.48 to 5.67 of the GEM Listing Rules. Having made specific enquiries with the Directors except Mr. Zhou Ying and Ms. Meng Ying, all Directors have confirmed that they have complied with the required standards set out in the Code of Conduct during the year ended 30 April 2022.

Relevant employees who are likely to be in possession of inside information of the Company are also subject to compliance with guidelines on no less exacting terms than the Code of Conduct for the Year.

### APPOINTMENT RE-ELECTION OF DIRECTORS

All the directors, including independent non-executive directors, are appointed for terms of three years. All the directors are subject to retirement by rotation and eligible for re-election in accordance with the articles of association of the Company (the "Articles").

Pursuant to Article 108 of the Articles, one-third of the Directors shall retire from office by rotation at each annual general meeting and every Director shall be subject to retirement by rotation at least once every 3 years. However, the retiring Directors shall be eligible for re-election.

Pursuant to Article 112 of the Articles, any Director appointed by the Board to fill a casual vacancy shall hold office only until the first general meeting of the Company after their appointment and be subject to reelection at such meeting.

### RELATIONSHIPS AND ASSOCIATION AMONG THE DIRECTORS

There was no relationships between members of the Board, including financial, business, family or other material/relevant relationships.

### DIRECTORS' CONTINUING PROFESSIONAL DEVELOPMENT PROGRAMME

The Group acknowledges the importance of adequate and ample continuing professional development for the Directors for a sound and effective internal control system and corporate governance. The Company recognised the benefits of having a diverse Board to enhance the quality of its performance. The Board Diversity Policy aimed to set out the approach to achieve diversity on the Board. 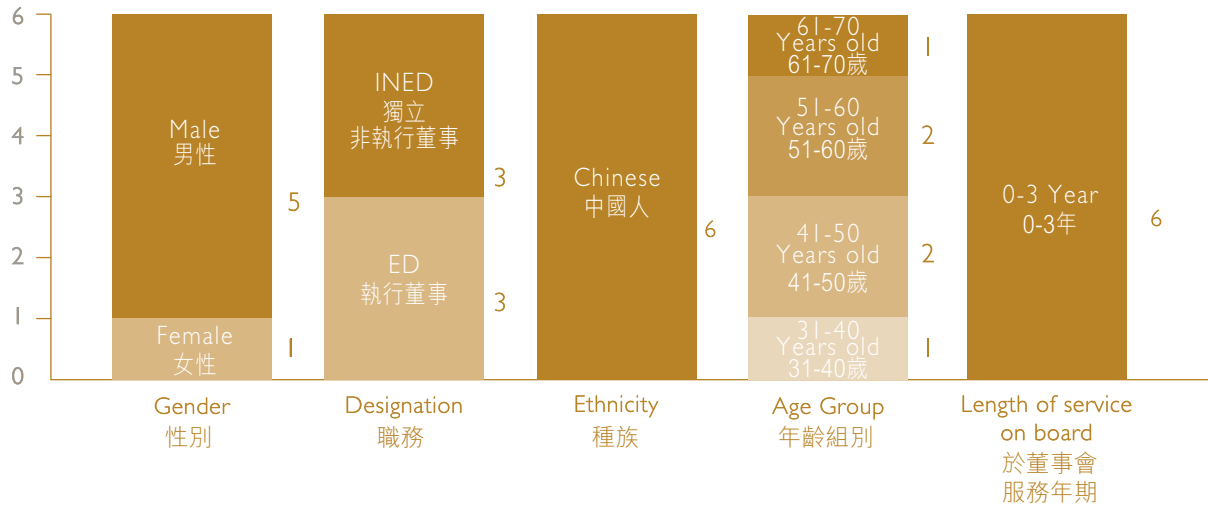

### BOARD AND GENERAL MEETINGS

The CG Code requires regular meeting of the Board be held at least four times a year at approximately quarterly intervals. Such Board meetings involve the active participation, either in person or by telephone conference. Under code provision A.1.3 of the CG Code, notice of at least 14 days should be given of a regular board meeting to all Directors to give all Directors an opportunity to attend. Certain regular Board meetings were convened with less than 14 days' notice to enable the Board members to react timely and make expeditious decision making in respect of transactions which were of significance to the Group's businesses. As a result, the Board meetings were held with a shorter notice period than required with the consent of all the Directors for that time being. The Board will do its best endeavours to meet the requirement of code provision A.1.3 of the CG Code in future. Adequate and appropriate information is circulated in advance of Board meetings to the directors. During the Year, no meeting was held between the Chairman met and the INEDs. The Company utilises telephone conferencing for Directors who are not able to attend in person.

Minutes of Board meetings and Board committee meetings are drafted by the secretary of the meetings and recorded in sufficient details the matters considered and decisions reached, with draft and final versions being circulated to the Directors for their comments and records within reasonable time after the meetings are held. The company secretary of the Company (the "Company Secretary") who kept the original minutes, are open for inspection at any reasonable time on reasonable notice by any Director.

If a Director has conflict of interest in a matter to be considered by the Board which the Board has determined to be material, the matter will be dealt with by a physical Board meeting rather than a written resolution. That Director will abstain from voting on the relevant Board resolution in which he/she or any of his/her associates has a material interest and that he/she shall not be counted in the quorum present at such Board meeting.

During the year ended 30 April 2022, eight board meetings were held. The extraordinary general meeting of the Company was held on 30 September 2021 (the "EGM") and the annual general meeting of the Company was held on 6 January 2022 (the "2021 AGM").

The responsibility of Auditor in respect of the Group's consolidated financial statements are set out in the independent auditor's report forming part of this annual report.

In preparing the consolidated financial statements, the Directors are responsible for assessing the Group's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Directors either intend to liquidate the Group or to cease operations, or have no realistic alternative but to do so. The Directors are aware that the net liabilities, loss and operating cash outflow for the year ended 30 April 2022, and the deconsolidation of the subsidiaries mentioned, which indicate the existence of a material uncertainty which may cast significant doubt on the Group's ability to continue as a going concern as referred to C.I.3 of the CG Code.

In respect of the material uncertainty related to going concern, the Directors have given careful consideration to the future liquidity of the Group and implemented some measures in order to improve the working capital, liquidity and cash flow position of the Group, details are set out in note 2.3 to the consolidated financial statements.

The Auditor draw attention to note 2.3 to the consolidated financial statements which mentions that the Group incurred a loss of approximately HK\$7.4 million during the year ended 30 April 2022 and, as of that date, the Group had net current liabilities and net liabilities of approximately HK\$19.5 million and HK\$19.2 million respectively. These conditions indicate the existence of a material uncertainty which may cast significant doubt on the Group's ability to continue as a going concern. More information is set out in note 2.3 to the consolidated financial statements.

All Directors have entered into service agreements with the Company for a term of three years commencing from their respective date of appointment. All of these service agreements may be terminated earlier by no less than one month written notice served by either party on the other.

No director proposed for re-election at the forthcoming AGM has a service contract which is not determinable by the Group within one year without payment of compensation, other than statutory compensation.

Pursuant to Article 108 of the Articles, at each annual general meeting, one-third of the Directors for the time being (or, if their number is not a multiple of three (3), the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at an annual general meeting at least once every three years. Mr. Choi Pun Lap and Mr. Leung Tsun Ip. will retire from office as Directors at the forthcoming AGM, and being eligible, offer themselves for re-election.

Pursuant to Article 112 of the Articles, any Director appointed by the Board to fill a casual vacancy shall hold office only until the first general meeting of the Company after their appointment and be subject to re-election at such meeting. Mr. Law, Michael Ka Ming will retire from office as Director at the forthcoming AGM, and being eligible, offer himself for re-election.

Each of the executive Directors shall also be entitled to discretionary bonus to be determined by the Board based on, among other things, the performance of the individual Director and the overall financial position of the Group, and is subject to the recommendation of the remuneration committee of the Company.

- The existing executive directors of the Company were re-designated or appointed on 19 July 2021 and 30 September 2021 and all the existing independent non-executive directors of the Company were appointed on 21 October 2021. The current board of directors of the Company (the "Current Board") was formed on 21 October 2021 after the removal of Mr. Zhou Ying ("Mr. Zhou") as executive director, chief executive officer and chairman of the board of the directors of the Company, and Ms. Meng Ying ("Ms. Meng") as executive director and compliance officer of the Company on 30 September 2021.
  - The Company had been unable to contact Mr. Zhou and Ms. Meng since 22 July 2021. Mr. Zhou was also the legal representative of Zhejiang Zhong Chun Wenhua Keji Limited\* (浙江中淳文化科技有限公司) (formerly known as 浙江中紓貿易有限公司), a direct wholly owned subsidiary incorporated in the People's Republic of China (the "PRC"), Zhejiang Fu Lian Zichan Guanli Limited\* (浙江富連資產管理有限公司), an indirect wholly owned subsidiary incorporated in the PRC, and Zhejiang Xin Lian Hengi Tongxun Jishu Limited\* (浙江新聯恒基通訊技術有限公司), an indirect non-wholly owned subsidiary incorporated in the PRC (collectively referred as the "Deconsolidated Subsidiaries").
  - Since Mr. Zhou and Ms. Meng were the senior management and main contact persons of the Deconsolidated Subsidiaries, the Company was experiencing difficulties in reaching the Deconsolidated Subsidiaries and obtaining their financial information for the purpose of preparing the consolidated financial statements of the Group for the year ended 30 April 2021.

- On 27 August 2021, the Company appointed a legal adviser (the "PRC Legal Adviser") to conduct investigation on the status of the Deconsolidated Subsidiaries, Mr. Zhou and Ms. Meng in the PRC. The Company has been reported by the PRC Legal Adviser that the investigation on the status of the Deconsolidated Subsidiaries, Mr. Zhou and Ms. Meng were completed on 13 October 2021. There were indications that Mr. Zhou and Ms. Meng were suspected of illegal absorption of public deposits under the operation of Zhejiang United Small and Medium Enterprises Holdings Group., Ltd\* (浙江聯合中小企業控股集團有限公司), a company incorporated and operated in the PRC of which Mr. Zhou and Ms. Meng were the ultimate shareholders and not a subsidiary within the Group, which were under formal investigation. On 21 July 2021, Mr. Zhou and Ms. Meng were held in custody and on 26 August 2021, Mr. Zhou and Ms. Meng were officially arrested by the PRC authorities.
- The PRC Legal Adviser conducted on-site visit in September 2021 to the registered offices and principal places of business of the Deconsolidated Subsidiaries. It found that the respective registered offices and principal places of business of the Deconsolidated Subsidiaries were either empty or occupied by other parties. The PRC Legal Adviser made enquiry to the relevant government authorities and found that no other business addresses were registered by the Deconsolidated Subsidiaries.
- The PRC Legal Adviser also made enquiry to the officers of the principal banks of the Deconsolidated Subsidiaries, which the officers of the respective principal banks responded that the details and status of the bank accounts of the Deconsolidated Subsidiaries could only be accessed by their legal representatives or their delegate. All the legal representatives of the Deconsolidated Subsidiaries were unable to be contacted during the investigation.

- 於二零二一年八月二十七日，貴公司已委任法律顧問（「中國法律顧問」）對終止綜合入賬的附屬公司、周先生及孟女士於中國的情況展開調查工作。中國法律顧問向貴公司報告其於二零二一年十月十三日已完成對終止綜合入賬的附屬公司、周先生及孟女士的情況調查工作。其表明已對周先生及孟女士在經營浙江聯合中小企業控股集團有限公司（一間於中國註冊成立及經營，以周先生及孟女士為最終股東的公司，並非貴集團內附屬公司）期間涉嫌非法吸收公眾存款一案立案偵查。於二零二一年七月二十一日，周先生及孟女士被羈押，而於二零二一年八月二十六日，周先生及孟女士被中國當局正式逮捕。

- Up to the date of the auditor's report, the Company has not received any official documentation from the Ministry of Public Security of the PRC nor any relevant departments of the PRC government indicating that any of the Company or the companies within the Group was involved in the case that Mr. Zhou and Ms. Meng were being arrested.
- The Current Board has been unable to have access to the books and records of the Deconsolidated Subsidiaries. In the opinion of the Current Board, the consolidated financial statements of the Group for the year ended 30 April 2021, which were prepared on the basis that the deconsolidation of the Deconsolidated Subsidiaries was deemed to be effective on 1 May 2020 (the "Deconsolidation"), presented more fairly the results, state of affairs and cash flows of the Group as a whole in light of the incomplete books and records of the Deconsolidated Subsidiaries available to the Company. Accordingly, the Deconsolidated Subsidiaries were deconsolidated from the consolidated financial statements of the Group from 1 May 2020 onwards.

The de-consolidation of the Deconsolidated Subsidiaries resulted in a loss on de-consolidation of approximately HK\$23,575,000 recognised in consolidated profit or loss for the year ended 30 April 2021, details of which are disclosed in Note 23 to the consolidated financial statements. The de-consolidation of the Deconsolidated Subsidiaries with effect from 1 May 2020 also resulted in the exclusion of the assets, liabilities, revenue, income, expenses, and cash flows of the Deconsolidated Subsidiaries from the consolidated financial statements of the Group for the years ended 30 April 2022 and 2021. In accordance with the requirements of Hong Kong Financial Reporting Standard ("HKFRS") 10 "Consolidated Financial Statements", all subsidiaries controlled by the Company and its subsidiaries are required to be included in the consolidated financial statements of the Group. The facts and circumstances described above do not show that the Group had lost control over the Deconsolidated Subsidiaries with effect from 1 May 2020. Further, as disclosed in Note 24 to the consolidated financial statements, the Deconsolidated Subsidiaries were disposed by the Group on 29 April 2022. Under HKFRS 10, the Company should have consolidated the Deconsolidated Subsidiaries in its consolidated financial statements for the years ended 30 April 2022 and 2021 up until the date of loss of control over these entities. Had the Deconsolidated Subsidiaries been consolidated up until 29 April 2022, many elements in the consolidated financial statements for the years ended 30 April 2022 and 2021 would have been materially affected, and in addition, the loss on the disposal of subsidiaries that occurred on 29 April 2022 and recognised in consolidated profit or loss for the year ended 30 April 2022 would be determined based on the carrying amounts of the assets and liabilities of the Deconsolidated Subsidiaries as at 29 April 2022. However, due to the facts and circumstances as stated above, we have not been able to obtain sufficient appropriate audit evidence to enable us to assess the effects of the matters to which the Deconsolidation relate. Accordingly, the effects on the consolidated financial statements of these matters could not be determined. Any adjustments that would be required may have consequential significant effects on the assets and liabilities of the Group presented in its consolidated statement of financial position as at 30 April 2021 and the revenue, income, expenses and cash flows of the Group presented in its consolidated statement of profit or loss and other comprehensive income and consolidated statement of cash flows for the years ended 30 April 2022 and 2021 and related elements and disclosures thereof in the consolidated financial statements.

### MATERIAL UNCERTAINTY RELATED TO THE GOING CONCERN

We draw attention to note 2 to the consolidated financial statements which states that the Group incurred a loss of approximately HK\$7,364,000 for the year ended 30 April 2022 and as at 30 April 2022, the Group had net current liabilities and net liabilities of approximately HK\$19,520,000 and HK\$19,218,000 respectively. These conditions indicate a material uncertainty exist which may cast significant doubt about the Group's ability to continue as a going concern. The directors consider it is appropriate to prepare the consolidated financial statements on going concern basis, as the current holding company of the Company has confirmed that it will provide financial support to the Group up to the amount of HK\$36,000,000 to enable the Group to meet its financial obligations as they fall due for the future period up to 31 January 2024. Our opinion is not modified in respect of this matter.

### OTHER MATTER

The consolidated financial statements of the Group for the year ended 30 April 2021 were audited by another auditor who expressed a disclaimer of opinion on those statements in its auditor's report dated 30 November 2021.

### RESPONSIBILITIES OF DIRECTORS AND THOSE CHARGED WITH GOVERNANCE FOR THE CONSOLIDATED FINANCIAL STATEMENTS

The directors of the Company are responsible for the preparation of the consolidated financial statements that give a true and fair view in accordance with Hong Kong Financial Reporting Standards issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and the disclosure requirements of the Hong Kong Companies Ordinance, and for such internal control as the directors determine is necessary to enable the preparation of consolidated financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the consolidated financial statements, the directors are responsible for assessing the Group's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the directors either intend to liquidate the Group or to cease operations, or have no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Group's financial reporting process.

貴集團截至二零二一年四月三十日止年度之綜合財務報表已由另一名核數師審核，其於其日期為二零二一年十一月三十日之核數師報告內表示不發表意見。

#### I. GENERAL INFORMATION

Zhejiang United Investment Holdings Group Limited (the “Company”) was incorporated in the Cayman Islands on 20 May 2015 as an exempted company with limited liability and its shares have been listed on the GEM of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) on 2 November 2015. During the years ended 30 April 2022 and 2021, the immediate and ultimate holding companies of the Company were United Financial Holdings Group Limited (“United Financial Holdings”) and Century Investment Holdings Limited (“Century Investment”), respectively. United Financial Holdings was incorporated in Hong Kong and held 50.21% of issued shares of the Company. United Financial Holdings was 100% owned by Century Investment, a company incorporated in the Cayman Islands and is wholly owned by Mr. Zhou Ying (“Mr. Zhou”). On 28 July 2022, Emperor Securities Limited (“Emperor Securities”), a company incorporated in Hong Kong and indirectly wholly-owned subsidiary of Emperor Capital Group Limited, has taken enforcement action (“Enforcement Action”) in accordance with the terms of the facilities agreements entered into between United Financial Holdings as borrower, Mr. Zhou as guarantor and Emperor Securities as lender and a share charge in respect of 792,000,000 shares of the Company (“Charged Shares”) between United Financial Holdings and Emperor Securities. As a result of the Enforcement Action, United Financial Holdings no longer held the Charged Shares and has ceased to be a controlling shareholder of the Company. The directors of the Company consider that the immediate holding company of the Company is Emperor Securities, the intermediate holding company of the Company is Emperor Capital Group Limited, a company incorporated in Bermuda and the shares of which are listed on the Main Board of the Stock Exchange with stock code 717 while the Company’s ultimate holding company is, in the opinion of the directors of the Company, Albert Yeung Capital Holdings Limited, a limited liability company incorporated in the British Virgin Islands.

#### I. 一般資料

浙江聯合投資控股集團有限公司（「本公司」）於二零一五年五月二十日在開曼群島註冊成立為一間獲豁免有限公司，以及其股份已於二零一五年十一月二日在香港聯合交易所有限公司（「聯交所」）GEM上市。截至二零二二年及二零二一年四月三十日止年度，本公司的直接及最終控股公司分別為聯合金融控股集團有限公司（「聯合金融控股」）及Century Investment Holdings Limited（「Century Investment」）。聯合金融控股於香港註冊成立，持有本公司已發行股份的50.21%。聯合金融控股由Century Investment擁有100%權益，Century Investment為於開曼群島註冊成立的公司，由周穎先生（「周先生」）全資擁有。於二零二二年七月二十八日，英皇證券（香港）有限公司（「英皇證券」）（一間於香港註冊成立之公司及為英皇證券集團有限公司之間接全資附屬公司）已根據聯合金融控股（作為借款人）、周先生（作為擔保人）及英皇證券（作為貸款人）訂立之融資協議之條款以及聯合金融控股與英皇證券之間就792,000,000股本公司股份（「押記股份」）所訂立之股份抵押，採取執行行動（「執行行動」）。鑒於採取執行行動，聯合金融控股不再持有押記股份及終止成為本公司之控股股東。本公司董事認為本公司之直接控股公司為英皇證券，本公司之中間控股公司為英皇證券集團有限公司（一間於百慕達註冊成立之公司，其股份於聯交所主板上市，股份代號：717），而本公司董事認為，本公司之最終控股公司為Albert Yeung Capital Holdings Limited（一間於英屬處女群島註冊成立之有限公司）。

### 1. GENERAL INFORMATION (CONTINUED)

The address of the registered office of the Company is Windward 3, Regatta Office Park, PO Box 1350, Grand Cayman KY1-1108, Cayman Islands. The address of the principal place of business of the Company has been changed from Unit 511, 5/F Concordia Plaza, 1 Science Museum Road, Tsim Sha Tsui East, Hong Kong to Unit A6-D, 12th floor, Block A, Hong Kong Industrial Centre, 489-491 Castle Peak Road, Lai Chi Kok, Kowloon, Hong Kong with effect from 23 March 2022. The Company is an investment holding company and its subsidiaries (collectively, the “Group”) are principally engaged in undertaking slope works, foundation works and other general building works in Hong Kong.

The consolidated financial statements are presented in Hong Kong dollar (“HK\$”), which is the functional currency of the Company and its subsidiaries, and all values are rounded to the nearest thousands (“HK\$’000”), except when otherwise indicated.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### 2.1 Statement of compliance

These annual consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”), issued by the Hong Kong Institute of Certified Public Accountants (the “HKICPA”) and the accounting principles generally accepted in Hong Kong. The consolidated financial statements also comply with the applicable disclosure requirements of the Hong Kong Companies Ordinance and the applicable disclosure requirements of the Rules Governing the Listing of Securities on GEM of the Stock Exchange (the “GEM Listing Rules”).

#### 2.2 Basis of preparation

The consolidated financial statements have been prepared on the historical cost basis.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

綜合財務報表以港元（「港元」）呈列，港元為本公司及其附屬公司之功能貨幣，而除另有指明外，所有金額均約整至最接近的千位（「千港元」）。

#### 2.1 合規聲明

此等年度綜合財務報表乃按香港會計師公會（「香港會計師公會」）頒佈的香港財務報告準則（「香港財務報告準則」）以及香港公認會計原則編製。綜合財務報表亦遵從香港公司條例的適用披露規定及聯交所GEM證券上市規則（「GEM上市規則」）的適用披露規定。

#### 2.2 編製基準

## 2.2 Basis of preparation (Continued)

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 Share-based Payment, leasing transactions that are accounted for in accordance with HKFRS 16, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 Inventories or value in use in HKAS 36 Impairment of Assets.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

公平值是指市場參與者之間在計量日進行的有序交易中出售一項資產所收取或轉移一項負債所支付的價格，無論該價格是直接觀察到的結果還是採用其他估值技術作出的估計。在對資產或負債的公平值作出估計時，本集團考慮了市場參與者在計量日為該資產或負債進行定價時將會考慮的那些特徵。在該等綜合財務報表計量及／或披露的公平值均在此基礎上予以確定，惟香港財務報告準則第2號「以股份為基礎的付款」範圍內的以股份支付的交易、根據香港財務報告準則第16號入賬的租賃交易，以及與公平值類似但並非公平值的計量（例如，香港會計準則第2號「存貨」中的可變現淨值或香港會計準則第36號「資產減值」中的使用價值）除外。

此外，就財務報告而言，公平值計量分為第一級、第二級或第三級，此等級別之劃分乃根據公平值計量的輸入數據可觀察程度及輸入數據對公平值計量的整體重要性，詳述如下：

- 第一級輸入數據乃實體於計量日期可以取得的相同資產或負債於活躍市場的報價（未經調整）；
- 第二級輸入數據乃第一級所載報價以外，就資產或負債直接或間接可觀察的輸入數據；及
- 第三級輸入數據乃資產或負債的不可觀察輸入數據。

#### 2.3 Going concern basis

The Group incurred a net loss of approximately HK\$7,364,000 (2021: HK\$93,360,000) and a net operating cash outflow of approximately HK\$7,563,000 (2021: HK\$4,804,000) for the year ended 30 April 2022 and, as of that date, the Group had net current liabilities and net liabilities of approximately HK\$19,520,000 (2021: HK\$12,610,000) and HK\$19,218,000 (2021: HK\$11,854,000) respectively. Those conditions indicate the existence of a material uncertainty which may cast significant doubt on the Group's ability to continue as a going concern.

The directors of the Company ("Directors") adopted the going concern basis in the preparation of consolidated financial statements and implemented the following measures in order to improve the working capital and liquidity and cash flow position of the Group:

(1) Financial support from holding company

The holding company of the Company, Emperor Securities, has confirmed that it will provide financial support to the Group up to the amount of HK\$36,000,000 to enable the Group to meet its financial obligations as they fall due for the future period up to 31 January 2024.

(2) Alternative source of funding

The Group is actively considering to raise new capital by carrying out fund raising activities including but not limited up to rights issue, open offer, placing of new shares and issuance of convertible note.

(3) Various cost control measures

The Directors plan to improve the Group's financial performance by taking steps to reduce discretionary expenses and administrative costs.

#### 2.3 持續經營基準

本集團於截至二零二二年四月三十日止年度錄得虧損淨額約7,364,000港元(二零二一年: 93,360,000港元)及約7,563,000港元(二零二一年: 4,804,000港元)的經營現金流出淨額, 及於該日本集團分別錄得流動負債淨額及負債淨額約19,520,000港元(二零二一年: 12,610,000港元)及19,218,000港元(二零二一年: 11,854,000港元)。該等情況顯示存在重大不確定性, 可能會對本集團持續經營能力產生重大疑問。

於編製綜合財務報表時, 本公司董事(「董事」)採用持續經營基準並為改善本集團營運資金及流動資金及現金流狀況, 實施以下措施:

(1) 控股公司之財務支持

本公司之控股公司英皇證券已確認其將向本集團提供最高金額為36,000,000港元之財務支持, 以使本集團能夠履行其直至二零二四年一月三十一日止未來期間之到期財務責任。

(2) 替代資金來源

本集團正積極考慮通過進行集資活動籌集新資金, 包括但不限於供股、公开发售、配售新股及發行可轉換票據。

(3) 多項成本控制措施

董事計劃透過採取措施減少酌情開支及行政成本改善本集團的財務表現。

## 2.3 Going concern basis (Continued)

In the opinion of the Directors, in light of the various measures/arrangements implemented, the Group will have sufficient working capital for its current requirements and it is reasonable to expect the Group to remain a commercially viable concern. Accordingly, the Directors are satisfied that it is appropriate to prepare the consolidated financial statements on a going concern basis.

Should the Group be unable to continue to operate as a going concern, it may be unable to realise its assets and discharge its liabilities in the normal course of business. Adjustments would have to be made to write down the value of assets to their recoverable amounts, to provide for any future liabilities which might arise and to reclassify non-current assets and liabilities as current assets and liabilities respectively. The effect of these adjustments has not been reflected in the consolidated financial statements.

## 2.4 Deconsolidation of subsidiaries

All the existing executive directors of the Company were re-designated or appointed on 19 July 2021 and 30 September 2021 and all the existing independent non-executive directors of the Company were appointed on 21 October 2021. The current board of directors of the Company (the "Current Board" or the "Board") was formed on 21 October 2021 after removing Mr. Zhou as executive director, chief executive officer and chairman of the board of the directors of the Company, and Ms. Meng Ying ("Ms. Meng") as executive director and compliance officer of the Company on 30 September 2021, and re-designation and resignation of former independent non-executive directors (the "Former Board").

The Former Board has been unable to contact Mr. Zhou and Ms. Meng since 22 July 2021. The Company tried to contact Mr. Zhou and Ms. Meng including residence visits, by email, by telephones and by other telecommunication means but has not been successful.

董事認為，鑑於實施的各項措施／安排，本集團將具備充足營運資金應付其現時需求，且合理預期本集團能維持商業上可行之經營。因此，董事信納按持續經營基準編製綜合財務報表屬適當。

倘本集團無法持續經營，則可能無法於正常業務過程中變現其資產及清償其負債。須作出調整以將資產價值撇減至其可收回金額，為可能產生的任何未來負債做好準備，並將非流動資產及負債分別重新分類為流動資產及負債。該等調整的影響並未於綜合財務報表中反映。

## 2.4 終止綜合入賬附屬公司

本公司全體現有執行董事於二零二一年七月十九日及二零二一年九月三十日調任或委任，本公司全體現有獨立非執行董事已於二零二一年十月二十一日獲委任。本公司本屆董事會（「本屆董事會」或「董事會」）於二零二一年十月二十一日成立，之前已罷免周先生為本公司執行董事、行政總裁及董事會主席的職務及孟瑩女士（「孟女士」）為本公司於二零二一年九月三十日的執行董事兼前合規主任的職務，以及前獨立非執行董事調任及辭任（「前董事會」）。

前董事會自二零二一年七月二十二日起便無法與周先生以及孟女士取得聯繫。本公司曾嘗試通過訪問彼等住址、以郵件、電話等其他電子通訊方式聯繫彼等，但均以失敗告終。

Mr. Zhou is also the legal representative of Zhejiang Zhong Chun Wenhua Keji Limited\* (浙江中淳文化科技有限公司) (Formerly known as 浙江中紓貿易有限公司) (“Zhejiang Zhong Chun”), a direct wholly owned subsidiary incorporated in the People’s Republic of China (the “PRC”), Zhejiang Fu Lian Zichan Guanli Limited\* (浙江富連資產管理有限公司) (“Zhejiang Fu Lian”), an indirect wholly owned subsidiary incorporated in the PRC and Zhejiang Xin Lian Hengi Tongxun Jishu Limited\* (浙江新聯恒基通訊技術有限公司) (“Zhejiang Xin Lian”), an indirect non-wholly owned subsidiary incorporated in the PRC (collectively referred as the “Deconsolidated Subsidiaries”).

Since Mr. Zhou and Ms. Meng are the senior management and main contact persons of the Deconsolidated Subsidiaries, the Company is experiencing difficulties in reaching the Deconsolidated Subsidiaries, for obtaining their latest financial information for the purpose of preparing the consolidated financial statements of the Company for the year ended 30 April 2022 and 2021.

On 27 August 2021, the Company has appointed legal adviser (the “PRC Legal Adviser”) to conduct investigation work on the status of the Deconsolidated Subsidiaries, Mr. Zhou and Ms. Meng in the PRC.

The Company has been reported by the PRC Legal Adviser that the investigation on the status of the Deconsolidation Subsidiaries. Mr. Zhou and Ms. Meng were completed on 13 October 2021 and the key findings are as follows:

由於周先生及孟女士為終止綜合的入賬附屬公司的高級管理層及主要聯繫人士，就編製截至二零二二年及二零二一年四月三十日止年度的財務報表而言，本公司在調查終止綜合入賬的附屬公司及獲取其最新財務資料方面陷入困境。

於二零二一年八月二十七日，本公司已委任法律顧問(「中國法律顧問」)就終止綜合入賬的附屬公司、周先生及孟女士於中國的情況進行調查工作。

中國法律顧問向本公司報告其已於二零二一年十月十三日完成對終止綜合入賬的附屬公司、周先生及孟女士的情況調查工作，主要調查結果如下：

- 1) The PRC Legal Adviser has made enquiry to the branch office of the Hangzhou Public Security Bureau\* (杭州市公安局拱墅區分局) (the "Bureau") and it indicated that Mr. Zhou and Ms. Meng were suspected of illegal absorption of public deposits under the operation of Zhejiang United Small and Medium Enterprises Holdings Group, Ltd\* (浙江聯合中小企業控股集團有限公司 ("Zhejiang United SME"), a company incorporated and operated in the PRC of which by Mr. Zhou and Ms. Meng are the ultimate shareholders and not a subsidiary within the Group), which were under a formal investigation. On 21 July 2021, Mr. Zhou and Ms. Meng were held in custody by the Bureau. On 26 August 2021, Mr. Zhou and Ms. Meng were officially arrested by People's Procuratorate of Gongshu District, Hangzhou in the PRC. The Bureau has published a press release in relation to their arrest on 27 August 2021.
- 2) The PRC Legal Adviser conducted on-site visit in September 2021 to the registered offices and principal places of business of the Deconsolidated Subsidiaries. It found that the respective registered offices and principal places of business of the Deconsolidated Subsidiaries were either empty or occupied by other parties. The PRC Legal Adviser made enquiry to the relevant government authorities and found that no other business addresses were registered by the Deconsolidated Subsidiaries.
- 3) The PRC Legal Adviser also made enquiry to the officers of the principal banks of the Deconsolidated Subsidiaries which the officers of the respective principal banks responded that the details and status of the bank accounts of the Deconsolidated Subsidiaries could only be accessed by their legal representatives or their delegate. All the legal representatives of the Deconsolidated Subsidiaries were unable to be contacted during the investigation.

- 1) 中國法律顧問已諮詢杭州市公安局拱墅區分局(「公安局」)，其表明，已對周先生及孟女士在經營浙江聯合中小企業控股集團有限公司(「浙江聯合中小企業」)(一間於中國註冊成立及經營，以周先生及孟女士為最終股東的公司，並非本集團內附屬公司)期間涉嫌非法吸收公眾存款一案立案偵查。於二零二一年七月二十一日，公安局對周先生及孟女士進行拘留。於二零二一年八月二十六日，周先生及孟女士被中國杭州市拱墅區人民檢察院正式逮捕。公安局已於二零二一年八月二十七日發佈有關該逮捕案情通報。

The Company has appointed the PRC Legal Adviser to attempt resuming control on the Deconsolidated Subsidiaries, the Company faced serious obstacles. The report of the PRC Legal Adviser indicating the Company that:

- (i) replacement of the seal (公章) of the Deconsolidated Subsidiaries (the "Seal") requires the signatures of its legal representative of the Deconsolidated Subsidiaries, however the legal representative namely Mr. Zhou whom the Company has been unable to contact since 22 July 2021, Mr. Zhou and Ms. Meng were officially arrested by People's Procuratorate of Gongshu District, Hangzhou on 26 August 2022 and the Bureau has published a press release in relation to their arrest on 27 August 2021;
- (ii) change of legal representative requires the Seal; and
- (iii) the Company is not able to regain control of the Deconsolidated Subsidiaries as mention above (i) and (ii).

Based on the report from the PRC Legal Adviser, the Board concluded that the resumption of the control of the Deconsolidated Subsidiaries was not able to be done.

- (i) 更換終止綜合入賬的附屬公司的公章(「公章」)需由其終止綜合入賬的附屬公司的法定代表人簽名，但本公司自二零二一年七月二十二日以來一直無法聯繫法定代表人周先生，周先生和孟女士已於二零二一年八月二十六日被杭州市拱墅區人民檢察院正式逮捕，公安局已於二零二一年八月二十七日就逮捕他們一事發佈新聞稿；
- (ii) 法定代表人的變更需要加蓋公章；及
- (iii) 本公司因上述(i)和(ii)項下無法重新取得終止綜合入賬的附屬公司控制權。

根據中國法律顧問的報告，董事會得出結論，本公司無法恢復對終止綜合入賬的附屬公司的控制。

Up to the date of approval of the consolidated financial statements, the Company has not received any official documentation from the Ministry of Public Security of the PRC nor any relevant departments from the PRC government indicating any of the Company or the Deconsolidated Subsidiaries are involved in the case that Mr. Zhou and Ms. Meng were being arrested.

The Company has been unable to access the books and records of the Deconsolidated Subsidiaries for the purpose of preparing the consolidated financial statements for the years ended 30 April 2022 and 2021. The Directors concluded that the Group has lost control over the Deconsolidated Subsidiaries and deconsolidated the Deconsolidated Subsidiaries with effect from 1 May 2020.

The management are of the view that the consolidated financial statements of the Group for the years ended 30 April 2022 and 2021 prepared on the basis that the deconsolidation of the Deconsolidated Subsidiaries was deemed to be effective on 1 May 2020 (the "Deconsolidation") presented more fairly the results, state of affairs and cash flows of the Group as a whole in light of incomplete books and records of the Deconsolidated Subsidiaries.

Further details of the Deconsolidation are set out in note 23 to the consolidated financial statements.

就編製截至二零二二年及二零二一年四月三十日止年度的綜合財務報表而言，本公司未能取得終止綜合入賬的附屬公司的賬簿及記錄。董事斷定本集團已失去對終止綜合入賬的附屬公司的控制權並終止綜合入賬終止綜合入賬的附屬公司，自二零二零年五月一日起生效。

管理層認為，本集團於截至二零二二年及二零二一年四月三十日止年度的綜合財務報表乃根據終止綜合入賬的附屬公司終止綜合入賬被視為於二零二零年五月一日生效的基準（「終止綜合入賬」）編製，可更公平呈列本集團整體業績、事務狀況及現金流量，此乃由於終止綜合入賬的附屬公司之賬簿及記錄並不完整。

#### 2.5 Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent present ownership interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

### 2.6 Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and impairment losses. Cost includes expenditure that is directly attributable to the acquisition of the asset.

Depreciation on other assets is provided to write off the cost less their residual values over their estimated useful lives, using the straight-line method, at the following rates per annum:

Plant and machinery	30%
Motor vehicles	30%
Furniture and fixtures	20%

The assets' residual values, depreciation methods and estimated useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

The gain or loss arising on retirement or disposal is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other costs, such as repairs and maintenance are charged to profit or loss during the financial period in which they are incurred.

#### 2.7 Leases

##### Definition of a lease

A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

For contracts entered into or modified or arising from business combinations on or after the date of initial application, the Group assesses whether a contract is or contains a lease based on the definition under HKFRS 16 at inception, modification date or acquisition date, as appropriate. Such contract will not be reassessed unless the terms and conditions of the contract are subsequently changed.

## Allocation of consideration to components of a contract

For a contract that contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the contract to each lease component on the basis of the relative stand-alone price of the lease component and the aggregate stand-alone price of the non-lease components, including contract for acquisition of ownership interests of a property which includes both leasehold land and non-lease building components, unless such allocation cannot be made reliably.

As a practical expedient, leases with similar characteristics are accounted on a portfolio basis when the Group reasonably expects that the effects on the consolidated financial statements would not differ materially from individual leases within the portfolio.

## Short-term leases

The Group applies the short-term lease recognition exemption to leases of office premises that have a lease term of 12 months or less from the commencement date and do not contain a purchase option. Lease payments on short-term leases are recognised as expense on a straight-line basis.

## Right-of-use assets

The cost of right-of-use asset includes:

- the amount of the initial measurement of the lease liability;
- any initial direct costs incurred by the Group.

Right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities.

Right-of-use assets in which the Group is reasonably certain to obtain ownership of the underlying leased assets at the end of the lease term are depreciated from commencement date to the end of the useful life. Otherwise, right-of-use assets are depreciated on a straight-line basis over the shorter of its estimated useful life and the lease term.

The Group presents right-of-use assets as a separate line item on the consolidated statement of financial position.

##### Lease liabilities

At the commencement date of a lease, the Group recognises and measures the lease liability at the present value of lease payments that are unpaid at that date. In calculating the present value of lease payments, the Group uses the incremental borrowing rate at the lease commencement date if the interest rate implicit in the lease is not readily determinable.

The lease payments include fixed payments (including in-substance fixed payments).

The Group accounts for the remeasurement of lease liabilities by making corresponding adjustments to the relevant right-of-use asset.

### 2.8 Impairment of property, plant and equipment and right-of-use assets

At the end of the reporting period, the Group reviews the carrying amounts of its property, plant and equipment and right-of-use assets to determine whether there is any indication that these assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the relevant asset is estimated in order to determine the extent of the impairment loss (if any).

The recoverable amount of property, plant and equipment and right-of-use assets are estimated individually. When it is not possible to estimate the recoverable amount individually, the Group estimates the recoverable amount of the cash-generating unit (the "CGU") to which the asset belongs.

In addition, the Group assesses whether there is indication that corporate assets may be impaired. If such indication exists, corporate assets are also allocated to individual CGU, when a reasonable and consistent basis of allocation can be identified, or otherwise they are allocated to the smallest group of CGU for which a reasonable and consistent allocation basis can be identified.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset (or a CGU) for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a CGU) is estimated to be less than its carrying amount, the carrying amount of the asset (or a CGU) is reduced to its recoverable amount. For corporate assets or portion of corporate assets which cannot be allocated on a reasonable and consistent basis to a CGU, the Group compares the carrying amount of a group of CGUs, including the carrying amounts of the corporate assets or portion of corporate assets allocated to that group of CGUs, with the recoverable amount of the group of CGUs. In allocating the impairment loss, the impairment loss is allocated first to reduce the carrying amount of the assets on a pro-rata basis based on the carrying amount of each asset in the unit or the group of CGUs. The carrying amount of an asset is not reduced below the highest of its fair value less costs of disposal (if measurable), its value in use (if determinable) and zero. The amount of the impairment loss that would otherwise have been allocated to the asset is allocated pro rata to the other assets of the unit or the group of CGUs. An impairment loss is recognised immediately in profit or loss.

Where an impairment loss subsequently reverses, the carrying amount of the asset (or CGU or a group of CGUs) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or a CGU or a group of CGUs) in prior years. All regular way purchases or sales of financial assets are recognised and derecognised on a settlement date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the market place.

Financial assets and financial liabilities are initially measured at fair value except for trade receivables arising from contracts with customers which are initially measured in accordance with HKFRS 15. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition.

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income and interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts and payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial asset or financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

The Group performs impairment assessment under expected credit loss (“ECL”) model on financial assets (including trade and other receivables, contract assets and bank balances), which are subject to impairment assessment under HKFRS 9. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL (“12m ECL”) represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessment are done based on the Group’s historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions.

The Group always recognises lifetime ECL for trade receivables and contract assets. The ECL on these assets are assessed individually for debtors with significant balances and/or collectively using a provision matrix with appropriate groupings.

For all other instruments, the Group measures the loss allowance equal to 12m ECL, unless when there has been a significant increase in credit risk since initial recognition, in which case the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increases in the likelihood or risk of a default occurring since initial recognition.

(i) Significant increase in credit risk

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the end of the reporting period with the risk of a default occurring on the financial instrument as at the date of initial recognition. - an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

## (ii) Definition of default

The Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full.

Irrespective of the above, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

##### (iii) Credit-impaired financial assets

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- (a) significant financial difficulty of the issuer or the borrower;
- (b) a breach of contract, such as a default or past due event;
- (c) the lender (s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider; or

##### (iv) Write-off policy

The Group writes off a financial asset when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

## (v) Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights.

Generally, the ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

Where ECL is measured on a collective basis or cater for cases where evidence at the individual instrument level may not yet be available, the financial instruments are grouped on the following basis:

- Past-due status;
- Nature, size and industry of debtors; and
- External credit ratings where available.

The grouping is regularly reviewed by management to ensure the constituents of each group continue to share similar credit risk characteristics.

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, and it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate of the amount of the obligation can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

All provisions are reviewed at the end of each reporting period and adjusted to reflect the current best estimate.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future uncertain events not wholly within the control of the Group, are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

Probable inflows of economic benefits to the Group that do not yet meet the recognition criteria of an asset are considered contingent assets.

#### 2.11 Revenue from contracts with customers

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when “control” of the services underlying the particular performance obligation is transferred to the customer.

A performance obligation represents a service that is distinct or a series of distinct services that are substantially the same.

Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation.

- the customer simultaneously receives and consumes the benefits provided by the Group’s performance as the Group performs;
- the Group’s performance creates or enhances an asset that the customer controls as the Group performs; or
- the Group’s performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

A contract asset represents the Group's right to consideration in exchange for services that the Group has transferred to a customer that is not yet unconditional. It is assessed for impairment in accordance with HKFRS 9. In contrast, a receivable represents the Group's unconditional right to consideration, i.e. only the passage of time is required before payment of that consideration is due.

A contract liability represents the Group's obligation to transfer services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

**Construction contracts**

Revenue mainly arises from the provision of performing slope works and foundation works in Hong Kong.

To determine whether to recognise revenue, the Group follows a 5-step process:

1. Identifying the contract with a customer
2. Identifying the performance obligations
3. Determining the transaction price
4. Allocating the transaction price to the performance obligations
5. Recognising revenue when/as performance obligation(s) are satisfied

In all cases, the total transaction price for a contract is allocated amongst the various performance obligations based on their relative stand-alone selling prices. The transaction price for a contract excludes any amounts collected on behalf of third parties.

Revenue from construction contracts are recognised over time as the Group's performance creates and enhances an asset that the customer controls.

The progress towards complete satisfaction of a performance obligation is measured based on output method, which is to recognise revenue on the basis of direct measurements of the value of the services transferred to the customer to date relative to the remaining services promised under the contract, that best depict the Group's performance in transferring control of services.

#### *Variable consideration*

For contracts that contain variable consideration, the Group estimates the amount of consideration to which it will be entitled using either (a) the expected value method or (b) the most likely amount, depending on which method better predicts the amount of consideration to which the Group will be entitled.

The estimated amount of variable consideration is included in the transaction price only to the extent that it is highly probable that such an inclusion will not result in a significant revenue reversal in the future when the uncertainty associated with the variable consideration is subsequently resolved.

At the end of each reporting period, the Group updates the estimated transaction price (including updating its assessment of whether an estimate of variable consideration is constrained) to represent faithfully the circumstances present at the end of the reporting period and the changes in circumstances during the reporting period.

## 2.12 Employee benefits

**Retirement benefits**

Retirement benefits to employees are provided through defined contribution plans.

The Group operates a defined contribution retirement benefit plan under the Mandatory Provident Fund Schemes Ordinance, for all of its employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries.

Contributions are recognised as an expense in profit or loss as employees render services during the year. The Group's obligations under these plans are limited to the fixed percentage contributions payable.

The employees of the Company's subsidiaries which operate in the People's Republic of China (the "PRC") are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute a certain percentage of its payroll costs to the central pension scheme. The contributions are charged to profit or loss as they become payable in accordance with the rules of the central pension scheme.

**Short-term employee benefits**

Employee entitlements to annual leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the end of the reporting period.

Non-accumulating compensated absences such as sick leave and maternity leave are not recognised until the time of leave.

#### 2.13 Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's operations are translated into the presentation currency of the Group (i.e. HK\$) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the period, unless exchange rates fluctuate significantly during that period, in which case the exchange rates at the date of transactions are used. Exchange differences arising, if any, are recognised in other comprehensive expense and accumulated in equity under the heading of exchange reserve.

On the disposal of a foreign operation (that is, a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

All borrowing costs are recognised in profit or loss in the period in which they are incurred.

## 2.15 Equity-settled share-based payment transactions

## Share options granted to employees

Equity-settled share-based payments to employees and others providing similar services are measured at the fair value of the equity instruments at the grant date.

For share options that vest immediately at the date of grant, the fair value of the share options granted is expensed immediately to profit or loss.

When share options are exercised, the amount previously recognised in share-based payment reserve will be transferred to share premium. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share-based payment reserve will be transferred to accumulated losses.

## 2.16 Income taxes

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit/loss before tax because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

The Group identifies operating segments and prepares segment information based on the regular internal financial information reported to the chief operating decision maker (the "CODM") for their decisions about resources allocation to the Group's business components for their review of the performance of those components.

## (a) Revenue recognition for construction contract

The management recognise revenue from construction contract based on output method, which is to recognise revenue on the basis of direct measurement of the value of construction work transferred to the customer to date relative to the remaining construction works promised to be completed under the construction contract. Most construction works take years to complete and the scope of work may change during the construction period. Management estimate the revenue and budgeted costs at the commencement of the construction contracts and regularly assess the progress of construction works as well as the financial impact of scope changes, claims, disputes and liquidation damages. The management's estimate of revenue and the completion status of construction works requires significant judgement and has a significant impact on the amount and timing of revenue recognised. The construction works performed by the Group would be certified by the independent quantity surveyors appointed by the customers periodically. The Group regularly reviews and revises the estimation of contract revenue prepared for each construction contract as the contract progresses based on the internal construction progress reports and the certification issued by the independent quantity surveyors.

## (b) Estimation of impairment of trade and other receivables, contract assets and other financial assets

The Group makes allowances on items subjects to ECL (including trade and other receivables, contract assets and bank balances) based on assumptions about risk of default and expected loss rates. The Group uses judgment in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forward looking estimates at the end of each reporting period as set out in note 2.9. The carrying amounts of trade and other receivables and contract assets at the end of the reporting period is set out in notes 16 and 17 to the consolidated financial statements.

## 26.3 Credit risk

Credit risk refers to the risk that the counterparty to a financial instrument would fail to discharge its obligation under the terms of the financial instrument and cause a financial loss to the Group. The Group's exposure to credit risk mainly arises from granting credit to customers in the ordinary course of its operations and from its investing activities.

The Group's maximum exposure to credit risk is limited to the carrying amounts of the financial assets at the end of each reporting period as detailed in note 26.1 and contract assets at the end of the reporting period.

In respect of trade receivables and contract assets, individual credit evaluations are performed on all customers and counterparties. These evaluations focus on the counterparty's financial position, past history of making payments and take into account information specific to the counterparty as well as pertaining to the economic environment in which the counterparty operates. Monitoring procedures have been implemented to ensure that follow-up action is taken to recover overdue debts. In addition, the Group reviews the recoverable amount of each individual trade and other receivables and contract assets at the end of each reporting period to ensure adequate impairment losses are made for irrecoverable amounts.

As at 30 April 2022, the Group has concentration of credit risk as 32% (2021: 41%), and 99% (2021: 99%) of the total trade receivables were due from the Group's largest customer and five largest customers respectively. The aggregate carrying amounts of trade receivables from these customers amounted to HK\$4,087,000 (2021: HK\$5,510,000), and HK\$12,671,000 (2021: HK\$13,211,000) of the Group's total trade receivables at 30 April 2022.

##### Other receivables and deposits

For other receivables, the directors of the Company make periodic individual assessment on the recoverability of other receivables based on historical settlement records, past experience, and also quantitative and qualitative information that is reasonable and supportive forward-looking information. For the year ended 30 April 2022, the Group assessed the ECL for other receivables and loss allowance of HK\$13,736,000 (2021: HK\$13,715,000) was recognised as at the end of the year.

##### Bank balances and deposits placed in financial institution

The Group's bank balances and deposits placed in financial institution with approved and reputable banks and financial institution. Bankruptcy or insolvency of the banks and financial institution may cause the Group's right with respect to bank balances and deposits placed in financial institution held to be delayed or limited. The directors of the Company monitor the credit rating of these banks and financial institution on an ongoing basis, and consider that the Group's exposure to credit risk as at 30 April 2022 and 2021 were minimal.

##### Trade receivables and contract assets

Expected loss rates are based on actual loss experience over the past 12 months. These rates are adjusted to reflect differences between economic conditions during the period over which the historic data has been collected, current conditions and the Group's view of economic conditions over the expected lives of the receivables.

## 26.4 Liquidity risk

Liquidity risk relates to the risk that the Group will not be able to meet its obligations associated with its financial liabilities that are settled by delivering cash or another financial asset. The Group is exposed to liquidity risk in respect of settlement of trade payables and its financing obligations, and also in respect of its cash flow management. The Group's objective is to maintain an appropriate level of liquid assets and committed lines of funding to meet its liquidity requirements in the short and longer term.

Management monitors the cash flow forecasts of the Group in meeting its liabilities.

Analysed below is the Group's remaining contractual maturities for its non-derivative financial liabilities at the end of the reporting date. When the creditor has a choice of when the liability is settled, the liability is included on the basis of the earliest date on when the Group can be required to pay. Where the settlement of the liability is in instalments, each instalment is allocated to the earliest period in which the Group is committed to pay.

The carrying amounts of the Group's financial assets and liabilities carried at amortised cost are not materially different from their fair values for both years.

### 27. SHARE OPTION SCHEME

The Company has conditionally adopted a share option scheme on 15 October 2015 (the "Scheme"). The terms of the Scheme are in accordance with the provisions of Chapter 23 of the GEM Listing Rules.

The purpose of the Scheme is to attract and retain the best available personnel, to provide additional incentive to eligible participants and to promote the success of the business of the Group. Eligible participants of the share option scheme include employees (full-time and part-time), directors, consultants, advisers, distributors, contractors, suppliers, agents, customers, business partners or service providers of the Group.

The total number of shares issued and to be issued upon exercise of options granted to any participant (including both exercised and outstanding options) under the Scheme, in any 12-month period up to the date of grant shall not exceed 1% of the shares in issue.

An offer for the grant of options must be accepted within seven days inclusive of the day on which such offer was made. The amount payable by the grantee of an option to the Company on acceptance of an offer for the grant of option(s) is HK\$1. An option may be exercised in accordance with the terms of the Scheme at any time during a period as the Board may determine which shall not exceed ten years from the date of grant subject to the provisions of early termination thereof.
