Reference is made to the announcement of National Arts Group Holdings Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) dated 28 March 2022 in relation to the unaudited results announcement for the year ended 31 December 2021 (the “**Unaudited Results Announcement**”) and the announcement of the Company dated 24 May 2022, 20 June 2022, 21 June 2022 and 29 July 2022 in relation to the update on delay in publication of audited final results for the year ended 31 December 2021 and despatch of annual report for the year ended 31 December 2021 (collectively, the Updated Announcements together with the Unaudited Results Announcement, the “**Announcements**”). Unless the context otherwise requires, capitalised terms used herein shall have the same meanings as those defined in the Announcement.

**DELAY IN PUBLICATION OF 2022 INTERIM RESULTS AND DESPATCH OF 2022 INTERIM REPORT**

Pursuant to Rules 18.53, 18.54 and 18.78 of the GEM Listing Rules, the Company is required to: (i) publish the interim results (the “**2022 Interim Results**”) and interim report (the “**2022 Interim Report**”) of the Group for the six months ended 30 June 2022 on a date not later than 45 days after the end of that period of six months, i.e. not later than 14 August 2022; and (ii) dispatch the 2022 Interim Report of the Group for the six months ended 30 June 2022 as soon as reasonable practicable after publishing the 2022 Interim Results.

The Company wishes to inform its shareholders that as the publication of the 2021 Audited Annual Results is still pending, the publication of the 2022 Interim Results and the despatch of the 2022 Interim Report will be delayed. The Board acknowledges that the delay in the publication of the 2022 Interim Results and the despatch of the 2022 Interim Report constitutes non-compliance of Rules 18.53, 18.54 and 18.78 of the GEM Listing Rules, respectively.

## CONTINUED SUSPENSION OF TRADING

Trading in the shares of the Company on The Stock Exchange of Hong Kong Limited have been suspended with effect from 9:00 a.m. on 1 August 2022 and will remain suspended.

The Company will publish further announcement(s) to inform the shareholders of the Company of its progress in particular the expected date for the publication of the 2021 Audited Annual Results, the 2021 Annual Report, the 2022 Interim Results and the 2022 Interim Report as and when appropriate.
