Ms. Ho is a founding partner of Angela Ho & Associates. She has been a practicing lawyer in Hong Kong since 1989, specializing in corporate commercial law and is also admitted as a solicitor in England, the Australian Capital Territory, Queensland, New South Wales, Victoria of Australia and Singapore.

The Board would like to take this opportunity to thank Mr. Tung for his valuable contribution to the Company during his tenure of services and extend a warm welcome to Ms. Ho on her new appointment.
