CHANGE OF AUDITORS

RESIGNATION OF AUDITORS

The board (the “**Board**”) of directors (the “**Directors**”) of the Company hereby announces that BDO Limited (“**BDO**”) resigned as auditors of the Company with effect from 18 January 2023 as BDO and the Company could not reach a consensus on the auditors’ remuneration in respect of the audit of the Group’s consolidated financial statements for the year ended 31 December 2022 (the “**2022 Audit**”).

BDO has confirmed that they have not commenced any audit procedures in respect of the 2022 Audit and has further confirmed that, save as disclosed above, there are no other circumstances in connection with their resignation that need to be brought to the attention of the shareholders of the Company (the “**Shareholders**”).

The Board and the audit committee of the Company (the “**Audit Committee**”) have confirmed that there is no disagreement between BDO and the Company, and there are no other matters in relation to the resignation of BDO that need to be brought to the attention of the Shareholders.

The Board would like to take this opportunity to express its gratitude and appreciation to BDO for their professional and quality services rendered to the Company during the past years.

APPOINTMENT OF AUDITORS

The Board, with the recommendation from the Audit Committee, has resolved to appoint CCTH CPA Limited (“**CCTH**”) as the auditors of the Company with effect from 18 January 2023 to fill the casual vacancy arising from the resignation of BDO and to hold office until the conclusion of the next annual general meeting of the Company.

The Board would like to take this opportunity to express its welcome to CCTH on their appointment as the auditors of the Company.
