This announcement is made by Hong Wei (Asia) Holdings Company Limited (the "Company", together with its subsidiaries, the "Group") pursuant to Rule 17.10 of the Rules (the "GEM Listing Rules") Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") and the Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

# (1) DELAY IN PUBLICATION OF 2023 INTERIM RESULTS AND DESPATCH OF 2023 INTERIM REPORT

Pursuant to Rules 18.53 and 18.78 of the GEM Listing Rules, the Company is required to publish the interim results for the six months ended 30 June 2023 (the "2023 Interim Results") and despatch the interim report for the six months ended 30 June 2023 (the "2023 Interim Report") on a date not later than 45 days after the end of the financial period of the Company (i.e. on or before 14 August 2023).

As the publications of the Annual Results Announcement, the Annual Report, the 2023 First Quarterly Results and 2023 First Quarterly Report are still pending, the Company is unable to publish the 2023 Interim Results and despatch its 2023 Interim Report to the Shareholders within the prescribed time in accordance with the GEM Listing Rules.

As at the date of this announcement, the audit work for the financial year ended 31 December 2022 has already commenced and it is expected that the Annual Results Announcement and the Annual Report will be published by the end of January 2024. #### RESUMPTION GUIDANCE

- (b) demonstrate the Company's compliance with Rule 17.26 of the GEM Listing Rules; and
- (c) inform the market of all material information for the Company's shareholders and investors to appraise its position.

As disclosed in the announcement of the Company dated 21 July 2023, the Company received from the Stock Exchange the following additional Resumption Guidance:

(d) re-comply with Rules 5.05, 5.05A, 5.28, 5.34, and 5.36A of the GEM Listing Rules.

Under Rule 9.14A(1) of the GEM Listing Rules, the Stock Exchange may cancel the listing of any securities that have been suspended from trading for a continuous period of 12 months. In the case of the Company, the 12 month period expires on 2 April 2024. If the Company fails to remedy the issues causing its trading suspension, fulfill the resumption guidance and fully comply with the GEM Listing Rules to the Stock Exchange's satisfaction and resume trading in its shares by 2 April 2024, the Listing Division will recommend the Listing Committee to proceed with the cancellation of the Company's listing. Under Rule 9.15 of the GEM Listing Rules, the Stock Exchange also has the right to impose a shorter specific remedial period, where appropriate.
