DELAY IN PUBLICATION OF THIRD QUARTERLY RESULTS FOR THE NINE MONTHS ENDED 30 SEPTEMBER 2023; DELAY IN DESPATCH OF THIRD QUARTERLY REPORT; AND CONTINUE SUSPENSION OF TRADING

This announcement is made by the board (the “**Board**”) of directors (the “**Directors**”) of Yunhong Guixin Group Holdings Limited (the “**Company**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

Unless otherwise stated, capitalized term used in this announcement shall have the same meaning as those defined in the Announcements.

As the publication of the 2022 Annual Results, the 2022 Annual Report, the First Quarterly Results Announcement, the First Quarterly Report, the 2023 Interim Results Announcement and the 2023 Interim Report are still pending, the Company is unable to publish the 2023 Third Quarterly Results Announcement and despatch the 2023 Third Quarterly Report to the Shareholders within the prescribed time in accordance with the GEM Listing Rules.
