#### (a) Share premium

#### (b) Other reserve

The amount represents the difference between the nominal amount of shares issued by the Company and the aggregate amount of share capital of subsidiaries acquired under common control pursuant to the group reorganisation in preparation of the listing of the Company's shares on GEM of the Stock Exchange on 17 June 2013.

#### (c) Contribution surplus

The amount represents the amounts due to shareholders capitalised before the listing of the Company's shares on GEM of the Stock Exchange.

#### (d) Exchange reserve

The exchange reserve comprises all foreign exchange differences arising from the translation of the financial statements of foreign operations.

#### (e) The PRC statutory reserve

Pursuant to the laws and regulations governing the PRC enterprises, PRC subsidiaries of the Group are required to allocate at least 10% of its after-tax profit but before dividend distribution to the statutory reserve until the reserve has reached 50% of their registered capital. The statutory reserve can only be used, upon approval by the relevant authority, to offset accumulated losses or increase capital.

# 1. GENERAL INFORMATION

The Company was incorporated as an exempted company with limited liability in the Cayman Islands on 31 May 2012. The registered office of the Company is located at Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands. The principal place of business of the Company is located at Office A, 12/F, Tower A, Capital Tower, No. 38 Wai Yip Street, Kowloon Bay, Kowloon, Hong Kong.

The Company had its primary listing on the GEM of the Stock Exchange on 17 June 2013. The Company's principal activity is investment holding and the principal activities of its principal subsidiaries are the provision of environmental cleaning services.

# 2. BASIS OF PREPARATION

The unaudited condensed consolidated financial statements have been prepared in accordance with Hong Kong Accounting Standard 34 "Interim Financial Reporting" issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA") and the applicable disclosures required by the GEM Listing Rules.

The principal accounting policies used in the unaudited condensed consolidated financial statements are consistent with those adopted in the preparation of the Group's annual financial statements for the year ended 30 June 2024.

For the purpose of preparing and presenting the financial information of the unaudited condensed consolidated financial statements, the Group has consistently adopted HKFRSs issued by the HKICPA which are effective for the Group's financial year beginning on 1 July 2024. The adoption of new/revised HKFRSs does not result in changes to the Group's accounting policies and has no material effect on the Group's financial statements. The Group has not early applied the new and revised HKFRSs that have been issued by the HKICPA but are yet to be effective on the accounting period beginning on 1 July 2024.

The Group has not applied the new and revised HKFRSs which have been issued but are not yet effective. The Group is currently in the process of making an assessment of the impact of these new and revised HKFRSs but is not yet in a position to state whether they would have a material impact on the Group's results and financial position.

Hong Kong Profits Tax provision has been provided for at the rate of 8.25% for the first estimated assessable profits of HK\$2,000,000 and the remaining estimated assessable profits are taxed at the rate of 16.5% for the group entity qualified for the two-tiered profits tax rates regime introduced pursuant to the Inland Revenue (Amendment) (No. 7) Bill 2017. For group entities not qualifying for the two-tiered profits tax rates regime, Hong Kong Profits Tax provision has been provided for at the rate of 16.5%.

PRC Enterprise Income Tax ("EIT") is calculated at 25% of the estimated assessable profits of PRC subsidiaries of the Group.

Under the PRC tax law, profits of the Group's subsidiaries in the PRC (the "PRC subsidiaries") derived since 1 January 2008 is subject to withholding income tax at rates of 5% or 10% upon the distribution of such profits to foreign investors or companies incorporated in Hong Kong or for other foreign investors, respectively.

During the six months ended 31 December 2024, the Group acquired items of property, plant and equipment with aggregate cost of approximately HK\$780,000 (six months ended 31 December 2023: approximately HK\$601,000).

At 31 December 2024, the Group's land and buildings are situated in Hong Kong, held under a medium-term leases and measured at the fair values of HK\$37,100,000 (30 June 2024: HK\$42,400,000) which have been arrived at on the basis of valuation by Royson Valuation Advisory Limited, an independent qualified professional valuer not connected with the Group, and determined using the market approach by reference to recent sales price of comparable properties on a price per square foot basis using market data which is publicly available.

At 31 December 2024, the Group had pledged its land and buildings with carrying values of HK\$37,100,000 (30 June 2024: HK\$42,400,000) to secure the bank loans (note 14) and the performance bonds issued (note 16(a)).

# MANAGEMENT DISCUSSION AND ANALYSIS

## **BUSINESS OVERVIEW**

#### **Environmental and Cleaning Services**

The Group is principally engaged in the provision of environmental services in Hong Kong and the PRC, which include the provision of cleaning and related services for (i) public area and office cleaning services which involve cleaning of public areas, carpets, floors, toilets, changing rooms, lifts and escalators and emptying of garbage bins at commercial buildings and their tenants, residential complexes, shopping arcades, hotels and public transport facilities such as airport, ferries, ferry terminal, cargo and logistics centre and depots; (ii) overnight kitchen cleaning services mainly at private club and hotels; (iii) external wall and window cleaning services; (iv) stonefloor maintenance and restoration services; (v) pest control and fumigation services; (vi) waste management and disposal solutions which mainly involve collection, transportation and disposal of household waste, construction waste and trade waste and sales of recyclable waste such as paper, metal and plastic waste collected during our operations; (vii) housekeeping services where we provide housekeeping services to carry out professional daily housekeeping and cleaning services at local boutique hotels, hostels and serviced apartments; (viii) secure and confidential waste destruction for commercial clients; (ix) sanitation solution for yacht; (x) cleaning and waste management solution for renovated apartment; and (xi) airline catering support services.

#### **Money Lending Business**

The Group conducted its money lending business under the money lenders' licences granted by the licensing court in Hong Kong and in the PRC since 2019.

#### **Investments in Financial Assets**

During the period, the Group invested in financial assets classified as the financial assets at fair value through profit or loss which composed of only the shares of companies listed on the Stock Exchange.

#### **BUSINESS REVIEW**

#### **Environmental and Cleaning Services in Hong Kong**

Compared to the revenue of approximately HK\$227.1 million for the six months ended 31 December 2023, the environmental and cleaning services in Hong Kong contributed revenue of approximately HK\$240.4 million for the six months ended 31 December 2024. The increase is mainly attributable to several new services contracts in the residential sector and the commercial sector awarded.

## 管理層討論及分析

## 業務概覽

#### 環境及清潔服務

本集團的主要業務為於香港及中國提供環境服 務,包括提供下列各項清潔及相關服務:(i)公 眾地方及辦公室清潔服務,其涉及清潔公眾 地方、地氈、地板、廁所、更衣室、升降機 及自動梯,以及在商業大廈(及其租戶)、住 宅屋苑、購物商場、酒店及公共運輸設施(如 機場、渡輪、渡輪碼頭、貨物及物流中心及 車廠)等地方掏空垃圾箱;(ii)通宵廚房清潔服 務,有關服務主要提供予私人會所及酒店;(iii) 外牆及玻璃清潔服務; (iv)石材地板保養及翻新 服務;(v)滅蟲及焗霧處理服務;(vi)廢物管理及 處置解決方案,其主要涉及收集、運輸及處置 住戶廢物、建築廢物及商貿廢物及出售在本公 司業務過程中收集所得的可循環再用廢物,例 如:廢紙、金屬及塑膠;(vii)房務服務,我們為 本地精品酒店、賓館及服務式公寓提供房務服 務,每日進行專業的房務及清潔服務; (viii)為 商業客戶提供安全及保密文件銷毀服務;(ix)為 遊艇提供衛生解決方案;(x)為翻新公寓提供清 潔及廢物管理解決方案;及(xi)航空餐飲支持服 務。

#### 放債業務

自二零一九年起,本集團獲牌照法庭授予放債 人牌照,據此於香港及中國開展放債業務。

### 投資金融資產

於期內,本集團投資分類為按公平值計入損益 之金融資產,其僅包括於聯交所上市公司之股 份。

## 業務回顧

#### 香港環境及清潔服務

與截至二零二三年十二月三十一日止六個月的 收益約227,100,000港元相比,香港環境及清 潔服務於截至二零二四年十二月三十一日止六 個月貢獻收益約240,400,000港元。該增加乃 主要由於取得住宅分部及商業分部若干新服務 合約。

#### Results

For the six months ended 31 December 2024, the environmental and cleaning business in Hong Kong achieved a net profit of approximately HK\$2.9 million as compared to the net profit of approximately HK\$3.6 million for the six months ended 31 December 2023. The decrease is mainly due to increasing manpower services costs due to intense labor supply and decline in the prices from some customers upon renewed of services contracts.

#### Environmental and Cleaning Services in Shanghai, the PRC

The Shanghai Operations recorded a decrease in the revenue by approximately HK\$0.2 million to approximately HK\$8.8 million for the six months ended 31 December 2024 (2023: approximately HK\$9.0 million). And the Shanghai Operations recorded a net loss of approximately HK\$30,000 for the six months ended 31 December 2024 (2023: approximately HK\$400,000). The downturn of the financial performance of the Shanghai Operations is mainly due to (i) decline in the prices and services volume from existing customers; and (ii) continuing increasing manpower services costs due to intense labor supply.

#### **Money Lending Business**

The economy in Hong Kong and the PRC have been challenging for all businesses with the prolonged Sino-US trade tensions. Some of our borrowers under the money lending business have been severely affected and are in financial difficulties, and therefore have defaulted on repayment of their loans and interests on schedules. Therefore, the Group already recognized the impairment loss of approximately HK\$49.1 million (the "Impairment Loss") on part of these past due loans and interests receivables from such borrowers. Nevertheless, the Group has been taking actions, including but not limited to legal proceedings against these borrowers, to recover the loan principals, interests and all other related recovery costs incurred.

#### 業績

截至二零二四年十二月三十一日止六個月,香 港環境及清潔業務錄得純利約2,900,000港元, 而截至二零二三年十二月三十一日止六個月則 錄得純利約3,600,000港元。該減少乃主要由於 人力服務成本因勞動力供應緊張而增加以及部 分客戶重續服務合約後價格下降。

#### 中國上海環境及清潔服務

上海業務於截至二零二四年十二月三十一日 止六個月錄得收益減少約200,000港元至約 8,800,000港元(二零二三年:約9,000,000港 元)。此外,上海業務於截至二零二四年十二 月三十一日止六個月錄得淨虧損約30,000港元 (二零二三年:約400,000港元)。上海業務的 財務表現下滑乃主要由於(i)現有客戶的價格及 服務量下降:及(ii)勞工供應緊張導致人力服務 成本持續增加。

#### 放債業務

由於中美貿易關係持續緊張,香港及中國經濟 形勢對於所有企業而言富有挑戰性。放債業務 項下的若干借款人已受到嚴重影響及陷入財務 困難,故延遲按計劃償還貸款及利息。因此, 本集團已就部分應收有關借款人的該等逾期貸 款及利息確認減值虧損約49,100,000港元(「減 值虧損」)。然而,本集團持續採取行動(包括 但不限於針對該等借款人提出法律訴訟)以收 回貸款本金、利息及產生的所有其他相關收回 成本。 The interest income from the money lending business for the six months ended 31 December 2024 amounted to approximately HK\$2.0 million (2023: approximately HK\$1.1 million). The increase in the interest income is mainly due to the increase in the average loans balance and the average loan interest rates granted during the period.

The money lending business recorded a net operating profit of approximately HK\$1.0 million (excluding impairment loss reversal of approximately HK\$88,000) for the six months ended 31 December 2024 (2023: approximately HK\$0.6 million) (excluding impairment loss reversal of approximately HK\$6.8 million). The increase is primarily due to the increase in the interest income during the six months ended 31 December 2024.

# **Properties in Hong Kong**

The market prices and sentiment of the commercial properties in Hong Kong has been gradually declining since 2023. As a result, a revaluation loss of approximately HK\$4.8 million (31 December 2023: approximately HK\$4.0 million) on the Group's commercial properties is recorded based on the independent valuation as at 31 December 2024.

## **Investments in Financial Assets**

The Group's investment strategy is to review the investment portfolio continuously and make appropriate adjustments (by acquisition or disposal) according to the market situation, with an aim to generate reasonable returns. During the six months ended 31 December 2024, the Group recorded net unrealised fair value gain amounting to approximately HK\$52,000 (2023: net unrealised fair value loss of approximately HK\$44,000) from the investments in the financial assets.

截至二零二四年十二月三十一日止六個月, 放債業務的利息收入為約2,000,000港元(二零 二三年:約1,100,000港元)。利息收入增加乃 主要由於期內授出的平均貸款結餘及平均貸款 利率增加。

放債業務於截至二零二四年十二月三十一日 止六個月錄得經營純利約1,000,000港元(不 包括減值虧損撥回約88,000港元)(二零二三 年:約600,000港元)(不包括減值虧損撥回約 6,800,000港元)。該增加乃主要由於截至二零 二四年十二月三十一日止六個月利息收入增 加。

## 香港物業

位於香港的商業物業市場價格及信心自二零 二三年以來已逐步下跌。因此,根據於二零 二四年十二月三十一日的獨立估值,本集團 商業物業錄得重估虧損約4,800,000港元(二零 二三年十二月三十一日:約4,000,000港元)。

# 投資金融資產

本集團的投資策略為持續審閱投資組合並根據 市況作出適當調整(透過收購或出售),旨在產 生合理回報。截至二零二四年十二月三十一日 止六個月,本集團錄得投資金融資產之未變現 公平值收益淨額約52,000港元(二零二三年: 未變現公平值虧損淨額約44,000港元)。 As at 31 December 2024, the Group had investments in financial assets classified as financial assets at fair value through profit or loss of approximately HK\$457,000 (30 June 2024: HK\$405,000) which composed of only the shares of companies listed on the Stock Exchange as set out below:

# **Environmental and Cleaning Services in Hong Kong**

Labor market competition in Hong Kong has intensified with the implementation of the SMW which would to be adjusted upward in May 2025. The Group is also facing higher labor turnover rate in the environmental and cleaning services industry as more labor tend to work in other less laborious industries such as the security guard service industry under the same SMW rate. To offset the increase in labor costs, the Group is striving to transfer most of the increased labor costs to our customers and implement more efficient working flows and stringent cost control procedures. The Group is closely monitoring the labor turnover rate and regularly reviews our remuneration package in order to maintain sufficient labor force and cope with the changing environment. We would continue to enhance the quality of services by providing training to our front line staff.

#### 香港環境及清潔服務

隨著實施法定最低工資(將於二零二五年五月 上調),香港勞動力市場的競爭加劇。本集團 亦正面對環境及清潔服務業的高勞工流失率, 乃由於更多勞工在相同法定最低工資比率下傾 向於其他較輕鬆的行業工作,例如保安護衛服 務業。為抵銷勞工成本的增加,本集團力求將 大部分已增加勞工成本轉嫁予客戶並實施更有 效的工作流程及嚴格的成本控制程序。本集團 密切監控勞工流失率及定期檢討我們的薪酬計 劃,以維持充足的勞動力並應對不斷變化的環 境。我們將繼續通過向前線員工提供培訓提高 服務質量。

The economy in Hong Kong has been challenging and in extreme difficult for all businesses in 2023. Our customers from these sectors have been reducing their service requests and asking for the prices reduction. Both of our service income and profit margin have seen severely affected. To mitigate such downturn effect, we would strengthen our marketing effort in hope to expand our market shares in the commercial and the residential sectors and continue to consolidate our resources to focus on high value customers to bring in additional revenue by crossselling other cleaning and waste management services to our existing customers. We believe this strategy may not only improve our revenue per customer but also increase our profit margin as we could leverage our existing manpower to perform services at location where we already have presence. We would explore other new environmental and cleaning services to expand our service scope to enable customers to use the Group as a one-stop cleaning contractor. We would continue to streamline our operations in order to simplify and improve our operation efficiency. We believe that our success in serving different sectors will further build up the confidence for new clients to select our cleaning services in the coming future.

#### **Environmental and Cleaning Services in the PRC**

The management of the Shanghai Operations has refined its marketing strategies in order to attract more new customers to utilize our cleaning services and implemented more efficient working flows and stringent cost control procedures to reduce all unnecessary expenditures.

#### **Money Lending Business**

With the increasing threat of a downturn of the economy in Hong Kong and the PRC as a result of the above-mentioned negative factors, the Group continues its effort in strengthening its risk management policy and streamlining our existing loan portfolio mix with an aim to reduce our exposure on high risk loans. A cautious and prudent approach is the key direction of our money lending strategies that only borrowers with sound financial abilities would be considered and approved by the Group in the future.

#### **Investments in Financial Assets**

A cautious and prudent approach is continued to be the key direction of our investment strategies that only companies listed on the Stock Exchange with valuable prospects would be considered and invested by the Group in the future.

於二零二三年,香港經濟形勢對於所有企業而 言富有挑戰性及異常艱難。我們來自該等行業 的客戶一直減少其服務需求,並要求減價。我 們的服務收入及利潤率均受到嚴重影響。為減 輕有關衰退影響,我們將增強營銷工作,以期 擴大於商業及住宅領域的市場份額,並繼續整 合資源專注高價值客戶,透過向現有客戶交叉 銷售其他清潔及廢物管理服務,帶來額外收 益。由於我們可以發揮現有人力優勢在我們已 進駐的地點開展服務,故此我們相信,這項策 略不單可提高來自每位客戶的收益,亦可提升 我們的利潤率。我們將探索其他新的環境及清 潔服務,以擴大我們的服務範圍,使客戶將本 集團作為一站式清潔承包商。我們將繼續精簡 我們的業務,以簡化及提升經營效率。我們深 信,我們在服務於各行業方面的成功,將進一 步為新客戶日後選用我們的清潔服務建立信 小。

#### 中國環境及清潔服務

上海業務的管理層已改進其營銷策略,以吸引 更多新客戶使用我們的清潔服務,並實施更有 效的工作流程及嚴格的成本控制程序,以減少 所有不必要的開支。

#### 放債業務

由於上述不利因素導致香港及中國經濟衰退的 威脅越來越大,本集團繼續努力加強其風險管 理政策及精簡現有貸款組合,以降低高風險貸 款的風險。我們的放債策略的主要指示為採取 審慎保守態度,日後本集團僅會考慮及批准具 有良好的財務能力的借款人。

## 投資金融資產

管理層將於實施投資策略時持續採取審慎保守 態度,本集團於日後僅會考慮及投資價值可觀 的聯交所上市公司。

# **FINANCIAL REVIEW**

#### Revenue

For the six months ended 31 December 2024, the Group reported a total revenue of approximately HK\$251.2 million (2023: approximately HK\$237.2 million), representing an increase of approximately 23.4%. The increase is mainly due to the net effect of (i) increase in the contribution of the revenue of approximately HK\$13.4 million from the environmental and cleaning services in Hong Kong as several new services contracts awarded in the residential sector and the commercial sector; and (ii) increase in the interest income of approximately HK\$0.9 million from the money lending business after increase in the average loans balances and the average loan interest rates granted by the Group during the period.

#### Selling, Marketing Expenses and Administrative Expenses

The Group's selling, marketing and administrative expenses increased by approximately HK\$2.5 million to approximately HK\$15.2 million (2023: approximately HK\$12.7 million) for six months ended 31 December 2024. The increase was mainly due to increase in the general office expenses and the exchange loss from the Group's operations in the PRC.

## DIVIDEND

The Board does not recommend the payment of any dividend for the six months ended 31 December 2024.

## LIQUIDITY AND FINANCIAL RESOURCES

During the six months ended 31 December 2024, the Group had financed its operations and capital requirements through operating cash flows.

As at 31 December 2024, the Group had cash and cash equivalents of approximately HK\$107.0 million (30 June 2024: approximately HK\$103.2 million). The increase is mainly attributable to the cash inflows from the operating activities.

As at 31 December 2024, the Group had net current assets of approximately HK\$132.5 million (30 June 2024: approximately HK\$131.0 million) and current ratio of approximately 2.4 times (30 June 2024: approximately 2.3 times) which remain strong and healthy.

## 財務回顧

## 收益

截至二零二四年十二月三十一日止六個月,本 集團錄得總收益約251,200,000港元(二零二三 年:約237,200,000港元),增加約23.4%。該 增加主要由於(i)取得住宅分部及商業分部若干 新服務合約導致香港環境及清潔服務的收益貢 獻增加約13,400,000港元;及(ii)本集團於期內 授出的平均貸款結餘及平均貸款利率增加後, 放債業務帶來的利息收入增加約900,000港元 的淨影響。

#### 銷售、營銷開支及行政開支

截至二零二四年十二月三十一日止六個月,本 集團銷售、營銷及行政開支增加約2,500,000 港元至約15,200,000港元(二零二三年:約 12,700,000港元)。增加主要由於一般辦公費 用及本集團位於中國的業務之匯兑虧損增加。

# 股息

董事會不建議就截至二零二四年十二月三十一 日止六個月派付任何股息。

#### 流動資金及財務資源

截至二零二四年十二月三十一日止六個月,本 集團透過營運現金流量撥付營運及資金需求。

於二零二四年十二月三十一日,本集團現金及 現金等價物約為107,000,000港元(二零二四年 六月三十日:約103,200,000港元)。有關增加 乃主要歸因於經營活動所產生現金流入。

於二零二四年十二月三十一日,本集團流動資 產淨值約為132,500,000港元(二零二四年六月 三十日:約131,000,000港元),流動比率約為 2.4倍(二零二四年六月三十日:約2.3倍),仍 處於強勁及穩健水平。 The Group monitors its capital by reference to the gearing ratio. The Board is of the opinion that the Group is in a strong and healthy financial position and has sufficient resources to support its operations and meet its foreseeable capital expenditures and expansions.

# CHARGES ON THE GROUP'S ASSETS

As at 31 December 2024, the Group had bank deposits of approximately HK\$5.7 million (30 June 2024: approximately HK\$5.9 million) pledged to banks as security for bankers' guarantees on performance bonds issued and banking facilities granted to the Group.

As at 31 December 2024, the Group had properties with carrying values of HK\$37.1 million (30 June 2024: HK\$42.4 million) charged to the bank as security for the bank loans, bankers' guarantees on performance bonds issued and banking facilities granted to the Group.

# FOREIGN EXCHANGE EXPOSURE

During the period, major portion of the Group's operations are located mainly in Hong Kong with most of the Group's transactions, assets and liabilities are denominated in Hong Kong Dollars. The Group is exposed to foreign currency risk due to the exchange rate fluctuation of RMB against HK\$ arising from the our environmental and cleaning services business and money lending business in the PRC. The results of our operations in the PRC are translated from RMB into HK\$ at the exchange rates approximating the rates ruling at the dates of the transactions while their financial items are translated from RMB into HK\$ at the closing rate ruling at the end of the reporting period, the resulted exchange differences are recognised as other comprehensive income and accumulated separately in equity in the translation reserve of the Company and will be reclassified to profit or loss until the disposal of interests in such operations. Fluctuation of RMB against HK\$ is moderate to the Group during the period. The Group will review and monitor its currency exposure from time to time, and when appropriate hedge its currency risk.

# **CONTINGENT LIABILITIES**

Save as disclosed in the note 16 to the unaudited condensed consolidated financial statements, the Group had no other material contingent liabilities as at 31 December 2024 and 30 June 2024.

# **INFORMATION ON EMPLOYEES**

The Group had 1,679 employees as at the end of the period.
