CHANGE OF AUDITORS

This announcement is made by the board of directors (the “**Board**”) of Sun Kong Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.50(4) of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited.

RESIGNATION OF AUDITOR

The Board wishes to announce that Asian Alliance (HK) CPA Limited (“**Asian Alliance**”) has resigned as the auditor of the Company (the “**Auditor**”) with effect from 20 March 2026 as the Company was unable to reach a consensus with Asian Alliance on the auditors’ remuneration in respect of the audit of the Group’s consolidated financial statements for the year ended 31 March 2026 (the “**2026 Audit**”).

The audit committee of the Company (the “**Audit Committee**”) has obtained and reviewed audit fee proposals provided by Asian Alliance and other professional accounting firms regarding the 2026 Audit and considered that the audit fee proposal provided by other professional accounting firms to be more competitive. Upon being informed that the Company, with the recommendation of the Audit Committee, is considering to appoint a new Auditor, Asian Alliance tendered its resignation as Auditor upon the request of Board with effect from 20 March 2026.

Asian Alliance has confirmed to the Board in writing that, save as disclosed above, there are no matters which need to be brought to the attention of the shareholders of the Company (the “**Shareholders**”). The Board and the audit committee (the “**Audit Committee**”) of the Company has confirmed that there is no disagreement with Asian Alliance, and the Company has no other matter save as disclosed above in relation to the resignation of Asian Alliance as Auditors that need to be brought to the attention of the Shareholders.

The Board further confirmed that Asian Alliance has not yet commenced any audit work on the financial statements of the Group for the year ended 31 March 2026. The Board believes that the change of auditor will not have any significant impact on the annual audit and the release of annual results of the Group for the financial year ended 31 March 2026.

The Board would like to express its sincere gratitude to Asian Alliance for its professional and quality services rendered to the Group during its tenure of office.

APPOINTMENT OF AUDITOR

The Board further announces that, with the recommendation from the Audit Committee, McMillan Woods (Hong Kong) CPA Limited (“**McMillan Woods**”) has been appointed as the new auditor of the Company with effect from 20 March 2026 to fill the casual vacancy following the resignation of Asian Alliance and to hold office until the conclusion of the next annual general meeting of the Company.

The Audit Committee has considered a number of factors when recommending McMillan Woods as the new Auditors, including but not limited to (i) their audit proposal (including fee proposal); (ii) their industry knowledge and experience in providing audit services to companies listed on The Stock Exchange of Hong Kong Limited; (iii) their resources and capabilities; (iv) their independence from the Group and objectivity; and (v) Guidelines for Effective Audit Committees – Selection, Appointment and Reappointment of Auditors and Guidance Notes on Change of Auditors issued by the Accounting and Financial Reporting Council.

Based on the above, the Audit Committee has assessed and considered McMillan Woods to be independent, eligible and suitable to act as the Auditor and recommended to the Board for appointing McMillan Woods as the Auditor. Accordingly, the Board and Audit Committee are of the view that the appointment of McMillan Woods as the Auditor would enhance the cost-effectiveness of the Company’s annual audit, which would in turn be in the interest of the Company and its Shareholders as a whole.

The Board would like to take this opportunity to express its warm welcome to McMillan Woods on its appointment as the Auditor.
