#### **RESIGNATION OF JOINT COMPANY SECRETARY, AUTHORIZED REPRESENTATIVE AND PROCESS AGENT IN HONG KONG**

The board (“Board”) of directors (“Directors”) of Hengxin Technology Ltd. (“Company”) announces that Mr. Chu Hon Leung (朱瀚樑) (“Mr. Chu”) has resigned as a/an joint company secretary, authorized representative (for the purpose of Rule 3.05 of the Rules Governing the Listing of Securities (“Listing Rules”) on The Stock Exchange of Hong Kong Limited (“Stock Exchange”)) and authorized representative and process agent (for the purpose of accepting service of process in Hong Kong under Section 333 of the Companies Ordinance, Chapter 32 of the laws of Hong Kong (“Companies Ordinance”)) of the Company with effect from 10 May 2012.

Mr. Chu confirmed that he has no disagreement with the Company and there are no circumstances related to his resignation above which need to be brought to the attention of the Stock Exchange and the shareholders of the Company. Taking this opportunity, the Board would like to express its appreciation and gratitude to Mr. Chu for his contribution and services to the Company in the past.

#### **APPOINTMENT OF NEW JOINT COMPANY SECRETARY, AUTHORIZED REPRESENTATIVE AND PROCESS AGENT IN HONG KONG**

Following the resignation of Mr. Chu, the Board is pleased to announce that Mr. Ngaw Hiu Yue, Hugo (柯曉宇) (“Mr. Ngaw”) has been appointed as the new joint company secretary and authorized representative (for the purpose of Rule 3.05 of the Listing Rules) and authorized representative and process agent (for the purpose of accepting service of process in Hong Kong under Section 333 of the Companies Ordinance) of the Company with effect from 10 May 2012.

## **WAIVER IN RESPECT OF RULE 8.17 OF THE LISTING RULES**

Reference is made to the waiver granted to the Company by the Stock Exchange dated 21 October 2011 (“Waiver”) from strict compliance with Rule 8.17 of the Listing Rules for the period commencing from 25 October 2011 to 23 December 2013 on the condition that, among other things, the Company engages Mr. Chu, who possesses the requisite qualifications under Rule 8.17 of the Listing Rules, as the joint company secretary to assist Ms. Shirley Lim Guat Hua (“Ms. Lim”) (being the other joint company secretary of the Company who is not ordinarily resident in Hong Kong and who does not satisfy the requirements under Rule 8.17 of the Listing Rules) in acquiring the relevant experience as required under Rule 8.17(3) of the Listing Rules. The Waiver will be revoked immediately when Mr. Chu ceases to be the joint company secretary of the Company during the three year period of the Waiver.

The Company has made an application to the Stock Exchange and the Stock Exchange has granted a new waiver to the Company from strict compliance with the requirements under Rule 8.17 of the Listing Rules for a period from 10 May 2012 to 23 December 2013 in relation to Ms. Lim’s eligibility to act as the joint company secretary, on the condition that, among others things, Ms. Lim would be assisted by Mr. Ngaw during the new waiver period. The new waiver will be revoked immediately when Mr. Ngaw ceases to be the joint company secretary of the Company.

Mr. Ngaw is currently a practicing solicitor in Hong Kong and a member of the Law Society of Hong Kong. He is ordinarily resident in Hong Kong. Mr. Ngaw therefore meets the requirements under Rule 8.17 of the Listing Rules in respect of a company secretary.
