#### **RESIGNATION OF AUDITOR**

The Board announces that HLM has changed the status of its practice and resigned as auditors of the Company with effect from 23 January 2013 due to the reorganisation of the firm into HLM CPA. According to the Company's Articles of Association, the Board will convene an extraordinary general meeting as soon as practicable to appoint HLM CPA as new auditors of the Company to fill the vacancy.

The board (the “**Board**”) of directors of Radford Capital Investment Limited 萊福資本投資有限公司 (the “**Company**”, together with its subsidiaries as the “**Group**”) announces that HLM & Co. (“**HLM**”), the auditors of the Company, has changed the status of its practice and resigned as auditors of the Company with effect from 23 January 2013 due to the reorganisation of the firm from a partnership into HLM CPA Limited.

On 21 January 2013, the Company was informed by HLM that the practice of HLM as partnership was reorganised into a limited company named HLM CPA Limited (“**HLM CPA**”) on 23 January 2013. Owing to this reason, HLM has resigned as auditors of the Company with effect from 23 January 2013. According to the Company's Articles of Association, the Board will convene an extraordinary general meeting as soon as practicable to appoint HLM CPA as new auditors of the Company to fill the vacancy.

In its letter of resignation, HLM confirmed that there were no circumstances connected with their resignation that should be brought to the attention of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) or the members or the creditors of the Group. The Board further confirmed that there was no disagreement between the Company and HLM and there were no circumstances connected with HLM’s resignation which should be brought to the attention of the Stock Exchange or the members or the creditors of the Group.
