## **UPDATE ON RECENT DEVELOPMENT OF SUSPENSION OF TRADING**

Reference is made to the announcements of Trony Solar Holdings Company Limited (the “**Company**”) dated 16 November 2012, 8 January 2013 and 28 February 2013 (the “**Announcements**”) in relation to, among other things, (i) the delay in publication of its annual results announcement for the year ended 30 June 2012 (the “**2011/2012 Annual Results**”) and the despatch of its annual report for the year ended 30 June 2012 (the “**2011/2012 Annual Report**”); and (ii) the update on recent development on suspension of trading. Unless the content otherwise requires, capitalised terms used in this announcement shall have the same meaning given to them in the Announcements.

The Board wishes to inform the Shareholders that the forensic review (the “**Forensic Review**”) that is being carried out in respect of the Potential Financial Discrepancies is still on-going as at the date of this announcement.

The Company has been using its endeavour to retrieve and collate the information and documents to facilitate the conduct of the Forensic Review. However, due to a lack of proper handover of documents by some former personnel of the Company who were in-charge of the relevant matters before they left the Company, the Company has encountered difficulties and requires more time to retrieve those relevant information and documents which are required to facilitate the conduct of the Forensic Review. Therefore, given the above and barring any unforeseen circumstances, the Company expects that the Forensic Review will be completed on or around 15 July 2013.

The Board will update the Shareholders and public investors on (i) the expected dates in relation to the publication of the announcement of 2011/2012 Annual Results and despatch of 2011/2012 Annual Report, (ii) the expected dates in relation to the publication of the announcement of 2012/2013 Interim Results and despatch of 2012/2013 Interim Report and (iii) the progress of the Forensic Review, as and when appropriate.

As at the request of the Company, trading in the shares of the Company on the Stock Exchange has been suspended from 9:00 a.m. on 21 June 2012 and will remain suspended until further notice.
