CHANGE OF AUDITORS

The Company wishes to announce that SHINEWING has tendered their resignation as auditors of the Company with immediate effect and accordingly it is proposed that ANDA be appointed as the new auditors of the Company to fill the vacancy arising from the resignation of SHINEWING and to hold office until the conclusion of the next annual general meeting of the Company.

Norstar Founders Group Limited (Provisional Liquidators Appointed) (the “Company”) announces that SHINEWING (HK) CPA Limited (“SHINEWING”) has tendered their resignation as auditors of the Company with immediate effect. SHINEWING confirmed in their resignation letter that there were no circumstances in connection with their resignation which they considered necessary to be brought to the attention of the creditors and shareholders of the Company. The board of directors of the Company (the “Board”) and the provisional liquidators of the Company also confirm that there are no circumstances in respect of the change of auditors which they consider necessary to be brought to the attention of the creditors and shareholders of the Company.

SHINEWING had not carried out any audit work in connection with the financial statements of the Company for the financial year ended 31 March 2012. The Board and the provisional liquidators of the Company proposed to appoint ANDA CPA Limited (“ANDA”) as the new auditors of the Company to fill the vacancy following the resignation of SHINEWING. ANDA will hold office until the conclusion of the next annual general meeting of the Company and will be eligible for re-election at that meeting.

The Company will keep the public informed of any relevant developments by making further announcements as appropriate.

SUSPENSION OF TRADING

At the request of the Company, trading in the shares of the Company on the Stock Exchange has been suspended from 10:00 a.m. on 19 January 2009 and shall remain suspended until further notice.
