FURTHER DELAY IN PUBLICATION OF THE INTERIM RESULTS

As mentioned in the Announcements, the Company is completing and finalising certain information, including but not limited to the investigation on certain PRC subsidiaries of the Company, to be included in the Interim Results and the publication of the announcement of the Interim Results has been delayed. As the Company is still in the process of performing investigation on such PRC subsidiaries of the Company as at the date of this announcement, there will be a further delay in publication of the Interim Results announcement.

The Company will use its best endeavours to complete and finalise the information required for the Interim Results and shall publish the Interim Results announcement to inform Shareholders and public of the information in appraising the financial position of the Group as soon as practicable. The Board targets to publish the Interim Results announcement on or before 30 June 2015.
