The board ("**Board**") of directors (the "**Directors**") of the Company wishes to inform shareholders of the Company that more time is required to finalise the audited financial statements for each of the financial years ended 30 June 2012, 30 June 2013 and 30 June 2014, the publication of (i) the 2011/2012 Annual Results Announcement, 2012/2013 Annual Results Announcement and 2013/2014 Annual Results Announcement and the related annual reports; and (ii) the 2012/2013 Interim Results Announcement, the 2013/2014 Interim Results Announcement, the 2014/2015 Interim Results Announcement and the related interim reports (collectively the "Outstanding Results Announcements and Reports"), will be further delayed.

The delay is mainly due to the additional time required for the Company to arrange and provide the requested information to the auditor of the Company (the "Auditor") to carry out and complete their procedures in respect of the Outstanding Results Announcements and Reports, particularly on (i) the final independent professional reports on the Group's assets valuation and internal control review to be obtained for the Auditor to review; (ii) the audit fieldworks on the Company's major oversea subsidiary; and (iii) audit review procedures in relation to the Group's financial information subsequent to last annual audit reporting year ended 30 June 2014 and up to the date of the approval of the Outstanding Results Announcements and Reports which also cover the financial information of the Group's recent financial year ended 30 June 2015.

The delay in the publication of the Outstanding Results Announcements and Reports was partially caused by the unexpected leaving of certain key accounting personnel of a major subsidiary of the Company in the People Republic of China approaching the Group's the recent financial year ended 30 June 2015 and more-than-expected time in coordination and completion of professional reports and audit fieldworks on the Group's major oversea subsidiary as mentioned in points (i) and (ii) above. The Company has been rendering all other possible efforts, co-operation and assistance to the Auditor during the whole audit process to facilitate the latter's completion of their works on the Outstanding Results Announcements and Reports and the annual results announcement and reports for the year ended 30 June 2015 to finalise the audits in accordance with the timetable as revised below.
