Ms. MOK is a director of KCS Hong Kong Limited. She has over 20 years of professional and in-house experience in the company secretarial field and has been a joint company secretary of the Company since 2011. She is a senior fellow member of the Hong Kong Institute of Chartered Secretaries and the Institute of Chartered Secretaries and Administrators in the United Kingdom.

Mr. ZHU Ying ("Mr. ZHU"), the previous company secretary of the Company, ceases to serve as the company secretary and will continue to serve as the assistant to president, chief risk officer (compliance principal) and audit principal of the Company.
