

The Board wishes to take this opportunity to express its gratitude to Ms. Soon for her contribution to the Company during her tenure of service.

Rules 3.28 and 8.17 Waiver

The Company has made an application to the Stock Exchange and the Stock Exchange has granted a waiver (the "Waiver") to the Company from strict compliance with the requirements under Rules 3.28 and 8.17 of the Listing Rules for a three-year period from 1 March 2018 in relation to Ms. Cheok's eligibility to act as the joint company secretary of the Company, on the condition that, among other matters, Ms. Cheok will be assisted by Ms. So in discharging her duties and responsibilities as a company secretary and in acquiring relevant experience as required under Rule 3.28 of the Listing Rules during the Waiver period. The Waiver will be revoked immediately when Ms. So ceases to be the joint company secretary of the Company.
