FURTHER DELAY IN PUBLICATION OF THE 2018 ANNUAL RESULTS

Additional time is required by the Auditor to perform and complete additional audit procedures in respect of the 2018 Annual Results, including but not limited to finalising the accounting treatment of the accounts receivables, obtaining the updated supporting documents provided by the borrowers and a waiver letter from the lender of the Company's money lending business. Considering the coming Easter holidays, the Company also needs additional time to draft and prepare the 2018 Annual Results announcement according to the Auditor's report. As such, there will be a further delay in publication of the 2018 Annual Results.

As mentioned in the Announcements, the Board reiterated that, after due and careful consideration, it would not be appropriate for the Company to publish the unaudited management accounts of the Group for the year ended 31 December 2018 at this stage where the audit procedures have yet to be completed as it may not accurately reflect the financial performance and position of the Group if significant accounting adjustments on the unaudited management accounts would be required. The Board takes the view that publication of the unaudited management accounts of the Group prior to completion of the audit procedures may be misleading to the Shareholders as well as the potential investors.

The Company will use its best endeavours to publish the 2018 Annual Results as soon as possible. It is expected that the 2018 Annual Results will be published on or before 24 April 2019.

CONTINUED SUSPENSION OF TRADING IN THE SHARES
