WAIVER FROM STRICT COMPLIANCE WITH RULES 3.28 AND 8.17 OF THE LISTING RULES

Reference is made to the announcement of the Company dated 25 October 2019 (the "Announcement") regarding the appointment of Ms. Peng and Ms. Li as Joint Company Secretaries with effect from 25 October 2019. The Stock Exchange has granted a waiver from strict compliance with Rules 3.28 and 8.17 of the Listing Rules (the "Original Waiver") with respect to the appointment of Ms. Peng as a Joint Company Secretary for a period of three years from the date of the said appointment of Ms. Peng (the "Original Waiver Period") on certain conditions. One of the conditions is that Ms. Peng would be assisted by Ms. Li during the Original Waiver Period and the Original Waiver would be revoked immediately if and when Ms. Li ceased to provide assistance to Ms. Peng. For further details of the Original Waiver, please refer to the Announcement.

In view of Ms. Li's resignation and since Ms. Peng does not possess the qualifications of company secretary as required under Rule 3.28 of the Listing Rules, the Company has applied for, and the Stock Exchange has granted, a new waiver from strict compliance with Rules 3.28 and 8.17 of the Listing Rules (the "**New Waiver**") for a period from the date of said appointment of Ms. Wong to 24 October 2022 (the "**New Waiver Period**") on the conditions that (i) Ms. Peng will be assisted by Ms. Wong during the New Waiver Period and the New Waiver will be revoked immediately if there are material breaches of the Listing Rules by the Company; (ii) the Company shall notify the Stock Exchange at the end of the New Waiver Period for the Stock Exchange to re-visit the situation. The Stock Exchange expects that after the end of the New Waiver Period, the Company will be able to demonstrate that Ms. Peng can satisfy Rule 3.28 of the Listing Rules after having the benefit of Ms. Wong's assistance such that a further waiver will not be necessary; and (iii) the Company will disclose details of the New Waiver, including the reasons for and the conditions of the New Waiver, by way of announcement.

REASONS AND GROUNDS FOR SEEKING THE NEW WAIVER

Ms. Wong, the newly appointed Joint Company Secretary, meets the requirements under Rule 3.28 of the Listing Rules. Ms. Wong, as a Joint Company Secretary, will work closely with, and provide assistance to, Ms. Peng in discharging her duties as a Joint Company Secretary.

Although Ms. Peng does not possess the specified qualifications that are usually considered to be acceptable under Rule 3.28 of the Listing Rules, the Company considers that Ms. Peng, by virtue of her professional knowledge and experience in handling its corporate governance matters and with the support to be rendered by Ms. Wong and her working team at Tricor Services Limited, would be capable of discharging her functions as a Joint Company Secretary.

The Company will ensure that Ms. Peng continues to have access to the relevant training and support in relation to the Listing Rules and the duties required of a company secretary of an issuer listed on the Stock Exchange. Ms. Peng and Ms. Wong will take no less than 15 hours of professional training on any latest developments on the applicable Hong Kong laws and regulations in each financial year, in order to strengthen their experience and knowledge in respect of their duties and responsibilities under the Listing Rules.

Both Ms. Peng and Ms. Wong will be advised by the Hong Kong legal adviser of the Company, as and when appropriate and required respectively.
