



# **Chairman's Statement** 主席報告



Li Cheng 李誠 Chairman and Executive Director 主席兼執行董事

On behalf of the board of directors (the "Board") of Yongsheng Advanced Materials Company Limited (the "Company") and its subsidiaries (the "Group" or "Yongsheng Advanced Materials"), I am pleased to present the Group's annual results report for the year ended 31 December 2020 (the "Year under Review").

During the Year under Review, the Group maintained its strategy of diversified development with its textile business and RMAA business running on parallel tracks, which continued to generate revenue for the Group. The Group's RMAA business grew steadily and balanced its business risks despite the rampant outbreak of the novel coronavirus ("COVID-19"). The Group's robust business performance during the Year under Review was also recognized by external institutions. The Company was selected as a constituent stock of the MSCI Hong Kong Micro Cap Index in November 2020, showing great potential for future growth.

本人謹代表永盛新材料有限公司(「本公司」)及其 附屬公司(「本集團」或「永盛新材料」)董事會(「董 事會」,欣然提呈本集團截至二零二零年十二月 三十一日止年度(「回顧年內」)之全年業績報告。

回顧年內,本集團堅持多元發展的戰略,紡織業務 及RMAA事業雙軌並行,為集團持續創造收益。儘管 新型冠狀病毒(「新冠病毒」)肆虐,本集團的RMAA 業務仍穩步增長,平衡了業務風險。回顧年內集團 穩健的業務表現亦贏得了外部機構的認可,本公司 於二零二零年十一月獲納入MSCI香港微型指數成 份股,呈現出巨大的未來發展潛力。

In the first half of 2020, affected by the global spread of the COVID-19 epidemic and the economic downturn in various countries, China's textile industry faced a severe internal and external situation. In the second half of 2020, as COVID-19 was brought under control, China's textile industry continued to promote the resumption of production, supply and demand both improved steadily, and the industry's prosperity rebounded significantly. In 2021, the Group expects that the foundation of China's long-term macroeconomic improvement will not change, domestic macroeconomic policies will focus more on stabilizing growth and the textile industry will adhere to the general keynote of seeking progress while maintaining stability. As a model leader in the industry, the Group is competitive by owning the relevant dyeing technology and environmental protection equipment. Under the severe business environment, the Group will focus on internal optimisation and active research and development to enhance its overall competitiveness, thus maintaining the order size at a satisfactory level. As COVID-19 intensifies industry integration, the Group will take this opportunity to identify acquisition opportunities in upstream and downstream of the industry chain to further expand its industrial presence.

In 2021, the Group will also continue to develop its RMAA project in Hong Kong in a stable manner. As various mandatory inspection requirements for aged buildings (such as the Mandatory Building Inspection Scheme) and the renewal and redevelopment of aged buildings continue to drive the demand for RMAA project, the market size of RMAA project in Hong Kong has been growing steadily and is expected to grow further at a CAGR of 3.5% from 2020 to 2024 to reach approximately HK\$90.1 billion by 2024. In view of the huge demand for upgrading obsolete properties and government urban redevelopment plans in Hong Kong, these are a vast market for RMAA business and capital demand for the project will be high, the Group is expecting the RMAA segment will grow steadily.

#### Chairman's Statement 主席報告

二零二零年上半年,受新冠病毒疫情全球蔓延以及 各國經濟下行影響,中國紡織行業面臨的內外部形 勢嚴峻。二零二零年下半年,隨著新冠病毒得到控 制,中國紡織行業持續推動復工復產,供給和需求 皆穩步改善,行業景氣度明顯回升。二零二一年, 本集團預期,中國宏觀經濟長期向好的基礎不會改 變,國內宏觀經濟政策將更加著重穩增長,紡織行 業將堅持穩中求進的工作總基調。作為業內一家規 範的領導企業,本集團在染色技術及環保設備上具 有優勢,在嚴峻的經營環境下,本集團將著眼內部 優化,積極研發,提升整體競爭力,使訂單量維持 在理想水平。新冠病毒加劇行業整合,本集團將借 此機遇,物色產業鏈上下游收並購機會,進一步擴 大產業佈局。

二零二一年,本集團亦將繼續穩定發展香港RMAA 工程項目。隨著對老化樓宇的各種強制性檢驗要求 (如強制驗樓計劃)及老化樓宇的更新和重新發展 不斷推動對RMAA工程的需求,香港RMAA工程的市 場規模一直穩步增長,預計二零二零年至二零二四 年RMAA工程的市場規模將以3.5%的複合年增長率 進一步增長,到二零二四年達到約901億港元。鑒 於香港陳舊物業升級及政府市區重建計劃需求巨 大,RMAA業務市場廣闊,而且工程對資金的需求 有門坎,本集團預期RMAA分部將穩步增長。

# **Chairman's Statement** 主席報告

Yongsheng Plaza, a building under construction of the Group located at Xiaoshan Economic and Technological Development Zone, Hangzhou City, is undergoing interior decoration and successive investment promotion and pre-sale. With the advent of the commencement of operation of all sections of the rail transportation through Yongsheng Plaza on 30 December 2020 and the 2022 Hangzhou Asian Games, Yongsheng Plaza is expected to become one of the symbolic buildings of Xiaoshan and Hangzhou. The Group will relocate its headquarter to Yongsheng Plaza. With the significant improvement of the surrounding environment and facilities, the rents of the Group's commercial and financial office units in Xiaoshan Economic and Technological Development Zone, Hangzhou City will be significantly increased in the coming year. The management is of the view that the urbanization and development process in the PRC will continue to ascend in the future, and it believes that there will be a positive outlook and development of Hangzhou, which in turn will drive the residential or commercial demand in such region. The investment properties held by the Group will diversify the Group's income sources and bring potential future capital appreciation, which is beneficial to the long-term investment and sustainable development of the Group as a whole.

As an enterprise which highly values social responsibility, the Group is also actively expanding its environmental business while strictly controlling its main dyeing and finishing business to meet environmental standards, so as to diversify its revenue sources and create substantial returns for the shareholders of the Company. In early 2020, the Group established a joint venture with Began Investment Limited ("Began") to actively develop the water market in Southeast Asia by taking advantage of the strong demand for improved municipal infrastructure in Southeast Asia brought by the Belt and Road Initiative. In 2021, the Group will explore the expansion of its business into various areas of environmental protection related industries other than water related industries. In January 2021, the Group partnered with Zhejiang Lingrong Environmental Protection Technology Company Limited\* (浙江靈融 環保科技有限公司) ("Zhejiang Lingrong") to explore the development prospects of solid waste treatment and environmental protection industry in China. In the future, based on the national strategic policy and the Group's strong financial resources, the Group will achieve a "two-pronged approach" in its domestic and overseas environmental protection businesses, specifically speaking, domestically, the Group will actively explore the solid waste treatment industry, green energy development and circular economy development model; overseas, the Group will focus on the municipal infrastructure industry with rigid demand and sound cash flow to develop the water market in Southeast Asian with centering on water supply and wastewater treatment.

本集團位於杭州市蕭山經濟技術開發區的在建樓 宇-永盛大廈正進行室內裝修及陸續招商及預售。 隨著經由永盛大廈的軌道交通於二零二零年十二月 三十日全線貫通和二零二二年杭州亞運會的到來, 預期永盛大廈將成為代表蕭山及杭州的代表建築之 一,本集團的總部也將搬遷至永盛大廈。隨著周邊 環境配套顯著提升,本集團位於杭州市蕭山經濟技 術開發區的商務金融辦公單位於新一年度的租金 將大幅調升。管理層認為,未來中國城市化及發展 進程將繼續深化,杭州市的前景及發展向好,將推 動該地區的住宅或商業需求,本集團持有的投資物 業將多元化本集團的收入來源,並帶來未來資本增 值潛力,有利於本集團整體的長期投資及可持續發 屬。

作為一家重視社會責任的企業,在嚴格控制主營 染整業務達到環保標準的同時,本集團亦積極拓 展環保業務的發展,實現收益來源多元化,以為本 公司股東帶來豐厚回報。二零二零年初,本集團與 Began Investment Limited (「Began」)合作成立合營 公司,緊抓「一帶一路」政策帶來的東南亞地區對改 善市政基礎設施的殷切需求,積極開發東南亞水務 市場;二零二一年,本集團將探索拓展業務至除水 務相關產業以外的環保相關產業的各個領域。於二 零二一年一月,本集團與浙江靈融環保科技有限公 司(「浙江靈融」)合作,探索中國固體廢棄物處理及 環保行業的發展前景。將來,基於國家的戰略方針 及本集團雄厚財力,本集團將實現國內海外環保業 務「兩手抓」:國內業務層面,本集團將積極探索固 體廢棄物處理行業、綠色能源開發及循環經濟發展 模式;海外,本集團將緊抓具備剛性需求且擁有良 好現金流的市政基礎設施行業,以供水及汙水處理 為重點,開發東南亞水務市場。

# **Business Review** 業務回顧

# **MARKET REVIEW**

Looking back to the first half of 2020, the demand for textile in domestic downstream market was suppressed under the impact of the COVID-19 epidemic, and overseas export markets also came to a standstill due to the epidemic. Therefore, global conventional demand in textiles and garment had decreased significantly. However, since the second guarter of 2020, with domestic economic activities gradually resuming in an orderly manner due to China's effective prevention and control on the epidemic, the demand in textile has improved and commodity prices in the textile industry has also recovered rapidly. According to the survey of China National Textile and Apparel Council, since the second guarter of 2020, the climate index of the textile industry rebounded to above 50, above average level over recent years. Demand in the European market and United States market also gradually recovered, which resulted in the exports of the household textile products recovered rapidly in the second half of 2020. In addition, the renovation, maintenance, alteration and addition projects in Hong Kong have not been affected by the epidemic due to its nature of rigid demand. With its own technological advantages, rich product portfolio and diversified development of business segments, the Group can maintain sound operation in any market environment.

#### **BUSINESS PERFORMANCE**

The Group is principally engaged in: (1) dyeing and processing of differentiated polyester filament fabric; (2) provision of renovation, maintenance, alteration and addition services ("**RMAA Service**"); (3) properties investment; and (4) resources recycling and environmental protection project. In 2019, the Group restructured its business by disposing of the business segments of production of differentiated polyester filament yarn ("**PFY**") and trading of PFY in order to enhance technical capacities in dyeing and processing of differentiated polyester filament fabric in an all-round manner, grasp the market trend and move towards the high-added value market for grasping growth opportunities and satisfying customers' demand on products, thereby creating greater value for the shareholders.

# 市場回顧

回顧二零二零年上半年,受新冠病毒疫情影響,國內下游紡織品需求受到壓抑,海外出口市場也受疫情因素停擺,全球紡織服裝常規消費需求呈現斷崖式下跌。但於二零二零年第二季度起,中國有效防控疫情,國內經濟活動逐漸有序恢復,紡織品終端需求改善,紡織行業商品價格亦迅速回升,根據中國紡織工業聯合會調查數據,自二零二零年二季度起紡織行業景氣指數回升到50以上,為近年來的較好水平。歐美市場下半年的需求亦逐漸復甦,家用紡織品出口於二零二零年下半年迅速恢復。而香港的翻新、維護、改建及加建工程屬剛需市場,並未受疫情影響。本集團憑藉自身技術優勢,豐富的產品組合及多元發展業務板塊,在任何景氣環境中皆能穩健經營。

# 業務表現

本集團主要從事:(1)差別化滌綸面料染色及加工; (2)提供翻新、維護、改建及加建工程服務(「RMAA 服務」);(3)物業投資;及(4)可再生資源和環保項目。 本集團於2019年重組業務架構,出售差別化滌綸長 絲(「滌綸長絲」)生產及滌綸長絲貿易業務板塊, 全方位增強差別化滌綸面料染色及加工技術能力, 掌握市場趨勢,往高附加價值市場邁進,確實把握 擴展機遇並滿足客戶產品要求,為股東創造優異回 報。

# **CONTINUING OPERATIONS**

During the Year under Review, the Group recorded a turnover from continuing operations of approximately RMB361.9 million, representing an increase of approximately 18.1%, as compared to approximately RMB306.5 million in 2019. The gross profit was approximately RMB112.4 million, representing an increase of approximately 9.7% as compared to approximately RMB102.5 million in 2019. The gross profit margin decreased to approximately 31.0% from approximately 33.4%, which was mainly due to the significant growth of RMAA Service which has lower gross profit margin (approximately 26% for the year ended 31 December 2020) despite the epidemic, effectively offsetted the slight decline of textile business which has relatively higher gross profit margin (approximately 36% for the ended 31 December 2020) under the COVID-19 epidemic. The profit attributable to shareholders from continuing operations was approximately RMB72.7 million, representing an increase of approximately 42.6% as compared to approximately RMB51.0 million in 2019, and the relevant basic earnings per share from continuing operations was RMB0.099 (2019: RMB0.073).

During the Year under Review, the revenue derived from dyeing and processing of differentiated polyester filament fabric, provision of RMAA Service, property investment and environmental protection accounted for approximately 48.5%, 51.1%, 0.4% and 0.0% of the turnover from continuing operations of the Group, respectively; while the operating profit of such four business segments accounted for approximately 58.7%, 46.8%, -0.3% and -5.2% of the aggregate operating profit of the Group, respectively.

# **DYEING AND PROCESSING**

Hangzhou Huvis Yongsheng Dyeing and Finishing Co. Limited ("**Yongsheng Dyeing**"), a subsidiary of the Company, located in Hangzhou, is principally engaged in polyester filament fabric dyeing and processing and has been certified as a High and New Technology Enterprise by the People's Republic of China ("**PRC**") government and is further recognised as a Provincial Level Research and Development Center.

於回顧年內,本集團錄得持續經營業務營業額約人 民幣361.9百萬元,較二零一九年約人民幣306.5百 萬元增加約18.1%。毛利約為人民幣112.4百萬元, 較二零一九年約人民幣102.5百萬元增加約9.7%, 毛利率由約33.4%下降至31.0%,主要原因為較低 毛利率(截至二零二零年十二月三十一日止年度約 26%)之RMAA服務在疫情下仍錄得顯著增長,有 效抵銷了毛利率相對較高(截至二零二零年十二月 三十一日止年度約36%)之紡織品業務在COVID-19 疫情下的輕微下滑。股東應佔持續經營業務溢利 約人民幣72.7百萬元,較二零一九年約人民幣51.0 百萬元增加約42.6%,相關持續經營業務每股基本 盈利為人民幣0.099元(二零一九年:人民幣0.073 元)。

回顧年內,差別化滌綸面料染色及加工、提供 RMAA服務、物業投資及環保之收益分別佔本集 團持續經營業務營業額約48.5%、51.1%、0.4%及 0.0%;而四個分部經營溢利分別佔本集團的總經營 溢利的約58.7%、46.8%、-0.3%及-5.2%。

# 染色及加工

本集團位於杭州市獲中華人民共和國(「中國」)政 府認證為的「高新技術企業」杭州匯維仕永盛染整有 限公司(「永盛染整」),為主營滌綸面料染色及加工 業務的附屬公司,擁有省級技術研究開發中心的榮 譽。

#### **Business Review** 業務回顧

In the first half of 2020, affected by the epidemic, demand and supply from domestic and foreign market for polyester filament fabric dyeing and processing were both stricken to a certain extent. In the second half of the year, with the successful prevention and control measures taken in China, the outbreak of epidemic was obtained, and therefore the Group's resumption of production and work progressed well, while the supply and domestic orders both gradually recovered. In addition, due to the normalisation of the anti-epidemic and the implementation of the home isolation order, the development of the Stay-at-Home economy in overseas markets has driven the growth of the Group's textile and home furnishing business in the next half year of 2020, offsetting the shortterm negative impact in the first half of the year. Gross profit margins for the year remained solid as compared to last year, despite the industrywide impact of the epidemic. During the Year under Review, segment revenue was approximately RMB175.6 million, representing a decrease of approximately 11.5% as compared to approximately RMB198.5 million in 2019, while gross profit margin decreased by 0.4 percentage points to 36.0%. The Group launched a new variety of dyeing products in 2020, which have met the quality requirements of customers. Going forward, the Group will actively conduct promotion in the market, so as to increase sales and diversify its product portfolio as well as cope with the impact of market changes.

# **PROVISION OF RMAA SERVICE**

The Group is principally engaged in the provision of two categories of RMAA Service in Hong Kong, namely (1) renovation and maintenance works; and (2) alteration and additional works and fitting-out works. The Group has obtained ISO 9001 and ISO 14001 certifications in quality and environment management and has extensive experience in building maintenance, renovation, waterproofing, additions, alterations and building improvement in the sector of RMAA and fitting-out works in Hong Kong. On 30 June 2020, the Urban Renewal Authority of Hong Kong ("URA") announced "Operation Building Bright 2.0" ("OBB 2.0") and "Fire Safety Improvement Works Subsidy Scheme" ("FSW Scheme") to increase efforts to subsidize the rehabilitation of buildings (including buildings aged 40 or above), so as to improve buildings safety and living conditions. During the Year under Review, we obtained 16 new projects which were not affected by COVID-19. The Group recorded the segment revenue of approximately RMB185.1 million, with a gross profit margin of approximately 26.0% and had approximately 44 projects on hand with a total contract sum of over HK\$389 million.

二零二零年上半年,受疫情影響,國內外市場滌綸 面料染色及加工需求與供給皆受到一定程度衝擊, 下半年由於國內防控措施成效顯著,疫情回穩,本 集團復產復工進度良好,供給逐漸恢復正常,國內 訂單逐步恢復。另外,海外市場因抗疫常態化及居 家令的實施而出現宅經濟生態,推動本集團二零二 零年下半年的紡織家居業務增長,抵銷了上半年的 短暫負面影響。在整個行業受疫情衝擊的情況下, 全年毛利率相較去年仍保持穩健態勢。回顧年內分 部收益約為人民幣175.6百萬元,較二零一九年的 約人民幣198.5百萬元同比減少約11.5%,毛利率 減少0.4個百分點至36.0%。本集團於二零二零年推 出新品種染色產品,且已達到客戶質量要求,未來 將積極向市場推廣,增加銷售,使產品組合更多元 化,同時也能應對市場變化所帶來的衝擊。

# 提供RMAA服務

本集團主要在香港提供兩類RMAA服務,包括(1)維 修及保養工程及;(2)改建及加建工程以及裝修工 程。本集團於質量及環境管理方面更分別獲得ISO 9001及ISO 14001認證,對於樓宇維護、翻新、防 水、加建、改建及樓宇改善等方面具備豐富項目經 驗,涉足香港的RMAA及裝修工程領域。香港市區重 建局(「市建局」)二零二零年六月三十日宣佈第二輪 「樓宇更新大行動2.0」(「2.0行動」)及「消防安全改 善工程資助計劃」(「消防資助計劃」),加強樓宇複 修資助計劃,包含樓齡達40年的樓宇,提升樓宇安 全水平,改善居住環境。回顧年內新增工程項目16 個,不受新冠病毒影響。分部收益約為人民幣185.1 百萬元,毛利率約26.0%,在手工程數量約44項,總 額超過港幣389百萬元。 In February 2019, the Group completed the acquisition of 100% issued share capital of Summer Power International Inc. (**"Summer Power**"). Widely Construction & Engineering Limited (**"Widely**") is wholly owned by Summer Power. Pursuant to the relevant agreement in relation to the acquisition, the vendor provided a profit guarantee that the audited consolidated net profit after tax of Widely as shown in the audited consolidated accounts of the Group for the financial year ended 31 March 2019 shall not be less than HK\$23,000,000. As disclosed in the announcement of the Company dated 29 November 2019, such profit guarantee has been fulfilled.

#### **PROPERTIES INVESTMENT**

The property assets held by the Group include:

- Yongsheng Plaza, a building under construction located at (1) Xiaoshan Economic and Technological Development Zone, Hangzhou City, Zhejiang Province, the PRC with an aggregate gross floor area of approximately 64,547.20 square meters with 24 storeys above the ground and 3 storeys under the ground. Due to the outbreak of COVID-19 and unstable weather conditions, the schedule for roofing was affected. During the Year under Review, construction of the main building was completed. The interior decoration will commence soon and is expected to be completed in the first half year of 2021. The Group has been proactively attracting tenants and have successfully entered into several tenancy agreements up to the date of this report. Yongsheng Plaza, positioned as a high-end commercial office building and apartment, is expected to solicit long-term tenancies. With the advent of connection of the rail transportation and the 2022 Asian Games, Yongsheng Plaza is expected to become one of the symbolic buildings in Xiaoshan District or even Hangzhou; and
- (2) eight office units on two floors for commercial uses in a building located at Zhejiang Private Enterprise Development Building\*(浙 江民營企業發展大厦), Xiaoshan Economic and Technological Development Zone, Hangzhou City, Zhejiang Province, the PRC, with an aggregate gross floor area of approximately 2,648.78 square meters. All the office units have been leased out and will bring a stable and sustainable income for the Group, generating a rental income of approximately RMB1.2 million during the Year under Review.

#### Business Review 業務回顧

本集團於二零一九年二月完成收購夏力國際有限公司(「夏力國際」)100%已發行股本。偉利建築工程 有限公司(「偉利」)由夏力國際全資擁有。根據有關 收購的相關協議,賣方提供溢利擔保偉利於本集團 截至二零一九年三月三十一日止財政年度之經審 核綜合賬目所示之經審核綜合除稅後純利應不低 於23,000,000港元。誠如本公司日期為二零一九年 十一月二十九日之公佈所披露,該溢利擔保已獲達 致。

# 物業投資

本集團擁有的物業資產包括:

(1) 位於中國浙江省杭州市蕭山經濟技術開發區市的在建樓宇-永盛大廈。其建築總面積約為 64,547.20平方米,為地上24層、地下3層之建築。除了受到COVID-19影響外,不穩定的天氣狀況也影響封頂完工時程,回顧年內大樓主體已完工,即將開始室內裝修工序,預計二零二一年上半年可完成。本集團一直積極吸引租戶,直至本報告日期已成功訂立若干租賃協議。永盛大廈定位為高檔商業辦公室及公寓,有望引入長期租賃。隨著軌道交通的貫通和亞運會的到來,預期永盛大廈將成為代表蕭山或至杭州的代表建築之一;及

(2) 位於中國浙江省杭州市蕭山經濟技術開發區 浙江民營企業發展大廈的兩層共八個商務金 融辦公單位,總建築面積約為2,648.78平方 米,所有辦公單位均已出租,並將未集團帶來 穩定持續的收入,於回顧年內產生約人民幣 1.2百萬元租金收入。

#### **Business Review** 業務回顧

The property investment is a stable and resilient business of the Group with limited exposure to the epidemic and uncertainties. Xiaoshan District is a key development region with promising prospects in Zhejiang Province. The investment properties of the Group have the potential to increase in value, which is beneficial to the asset structure and sustainable development of the Group in the long run.

# ENVIRONMENT PROTECTION BUSINESS DEVELOPMENT

Driven by the "Belt and Road Initiative". the urbanisation and industrialisation of Southeast Asian countries have been improved. However, water supply and wastewater treatment infrastructure in certain Southeast Asia countries, including Vietnam, Cambodia, Myanmar and Indonesia, are in short supply and relatively backward. Under such situation, numerous potential investment and development opportunities are expected. During the Year, the Group cooperated with Bagan Investment Limited ("Bagan") to form a subsidiary company, which is owned as to 60% and 40% by the Group and Bagan, respectively. The subsidiary company is an investment holding company, the subsidiaries of which are principally engaged in the development, investment, operation and management of hydra-related projects, in particular regarding water supply and wastewater treatment, in China and Southeast Asia. Considering the fact that the outbreak of epidemic dragged down businesses in the Southeast Asia, the Group explored the domestic wastewater treatment market simultaneously and actively seek to build small-scale wastewater treatment project in Binjiang District, Hangzhou to perform the work of community wastewater treatment for purpose of being the demonstration base of the local region.

#### PROSPECTS

In 2021, the domestic new development pattern of "dual circulation" will give space for development and abundant drive force for innovation to the textile industry, and become the core engine for the continuous recovery of the textile industry. The dyeing and processing of differentiated polyester fabrics remain to be the development priority of the Group. As the global vaccination campaign begins, the overseas economy is expected to recover gradually. Thus, it is also expected that global demand for China's textile will remain stable. It is expected that the demand for household textile will maintain and the export of apparel will improve step by step. The Group plans to expand its dying production capacity, increase business volume and focus on developing high value orders with high gross profit at home and abroad, while retain the possibility of increasing its market share by acquisition and merger during the market consolidation period.

物業投資為本集團一項穩定且抗壓性強的業務, 受疫情和不確定因素影響有限,蕭山區為浙江省重 點發展區域,前景向好,本集團的投資物業具增值 潛力,對於本集團的資產結構及可持續發展長遠有 利。

# 環保類業務發展

在「一帶一路」政策推動下,東南亞國家的城市化及 工業化得到加強,然而東南亞部分地區包括越南、 柬埔寨、緬甸、印度尼西亞等國家的水供應及汙水 處理基礎設施短缺相對落後,存在眾多投資發展 機遇。於年內,本集團與Bagan Investment Limited (「Bagan」)成立附屬公司,本集團及Bagan分別擁 有60%及40%的權益,附屬公司為一間投資控股公 司,其附屬公司主要於中國及東南亞從事開發、投 資、營運及管理水務項目,尤其是有關水供應及汙 水處理的項目。疫情拖慢東南亞業務進展,因此, 本集團同步探索國內汙水處理市場,並積極爭取杭 州市濱江區建成小型汙水處理項目,進行小區汙水 處理,目標建成為當地的示範基地。

# 展望

展望二零二一年,國內的「雙循環」新發展格局,將 賦予紡織行業發展空間和豐富的創新原動力,成為 紡織行業持續復甦的核心引擎。差別化滌綸面料染 色及加工仍為本集團發展重點,隨著全球疫苗接種 工作展開,海外經濟預期逐步重啟,因此,亦預期 中國紡織的全球需求仍將保持平穩,預期家用紡織 品的需求維持,而成衣出口將逐步好轉。本集團計 劃擴大染整產能,加大業務體量,著力開發高毛利 的海內外高價值訂單,也不排除在市場整合期間透 過收購兼併來擴大市佔率。

Revenue of the Group in 2020 was approximately RMB361.9 million, representing an increase of approximately 18.08% from approximately RMB306.5 million as compared with last year. The increase in revenue of the Group was mainly due to the increase in the revenue derived from the RMAA Service and property investment.

Gross profit of the Group in 2020 was approximately RMB112.4 million, representing an increase of approximately 9.7% as compared with the same last year. The increase in gross profit of the Group was mainly due to increase in revenue from property investment and RMAA services, resulting an increase in their contribution to the Group's overall revenue, offsetted by the significant decrease of the Group's unit price of dyeing and processing service resulted from the outbreak of COVID-19 and increasing industry competition.

# SELLING AND DISTRIBUTION EXPENSES

The Group's selling and distribution expenses decreased by approximately RMB2.45 million, representing a decrease of approximately 63.21% for the Year under Review. The decrease was mainly due to the decrease in marketing activities and staff costs resulted from the outbreak of COVID-19.

# **ADMINISTRATIVE EXPENSES**

Administrative expenses (including impairment losses on financial and contract assets) is around RMB45.9 million, which is similar as 2019.

# **FINANCE COSTS**

Finance costs increased by approximately 77.61% to RMB1.8 million, primarily due to the increase of bank borrowings during the Year.

#### **PROFIT ATTRIBUTABLE TO SHAREHOLDERS**

The profit attributable to shareholders from the continuing operations in 2019 and 2020 was about RMB51.0 million and RMB72.7 million respectively, with an increase of about 42.55%.

For the year under Review, net cash generated from operating activities was approximately RMB2.0 million, representing a significant decrease as compared with 2019, mainly due to the decrease in operating profit as a result of the disposal of the PFY business in 2019.

Compared with 2019, the cash flow used in investing activities was approximately RMB66.1 million for the year ended 31 December 2020, which was mainly due to Yongsheng Plaza towards completion stage in 2020.

Net cash generated from financing activities was approximately RMB11.8 million for the year ended 31 December 2020, mainly due to the increase of bank borrowings during the Year.

#### Liquidity and financial resources

As at 31 December 2020, the Group's cash and bank balances, including pledged deposits amounted to approximately RMB89.7 million (31 December 2019: approximately RMB148.7 million).

As at 31 December 2020, the total bank borrowings of the Group was approximately RMB168.3 million (31 December 2019: approximately RMB95.5 million).

As at 31 December 2020 and 2019, the Group's key financial ratio reflecting its liquidity and gearing level, were as follows:

# Exposure to fluctuations in exc-hange rates and related hedge

The Group mainly operates in the Mainland China with most of the transactions settled in Renminbi ("**RMB**"), except for the business of provision of RMAA service as it is conducted in Hong Kong with the transaction settled in Hong Kong Dollars (HK\$). The reporting currency of the Group is RMB.

The Group is exposed to minimal foreign currency exchange risk.

The Group's cash and bank deposits are predominantly in RMB. The Company will pay dividends in Hong Kong Dollars if any dividends are declared.

#### **Employee benefits and remuneration policies**

As at 31 December 2020, the Group had a total workforce of 308 employees (31 December 2019: 325 employees). The employees of the Group were remunerated based on their experience, qualifications, the Group's performance and the prevailing market conditions.

During the Year under Review, staff costs (including Directors' remunerations and the salary of the employees) amounted to approximately RMB38.0 million (31 December 2019: RMB89.3 million).

The Group offers its staff competitive remuneration schemes. In addition, discretionary bonuses and share options may be granted to eligible staff based on individual's and the Group's performance.

The Group participated in the social insurance schemes operated by the relevant local government authorities, which include retirement pension, medical insurance, unemployment insurance, industrial injuries insurance and maternity insurance.

The Group emphasizes on team building and the Group's success is dependent on the contribution of all employees.

#### 匯率波動風險及有關對沖

本集團主要於中國大陸經營業務,大部分交易以人 民幣(「**人民幣**」)結算,惟提供RMAA服務業務除外, 乃由於該業務於香港進行,故以港元結算。本集團 的申報貨幣為人民幣。

The annual general meeting ("**AGM**") of the Company were held on 29 May 2020. Our forthcoming AGM will be held on 27 May 2021. Our Directors, chief financial officer and company secretary and other senior executives of the Company will attend the AGM together with our external auditors to answer any questions from the Shareholders. All Directors treasure the opportunity to canvass the views of the Shareholders at the AGM held annually.

#### Board responsibilities and delegation

The Board is collectively responsible for overseeing the management of the business and affairs of the Group. The Board meets regularly to discuss the overall strategies as well as operational and financial performances of the Group. Certain matters are reserved for decisions by the Board, including matters relating to: (i) the formulation of the Group's overall strategy and directions; (ii) any material conflict of interest of substantial Shareholders of the Company or Directors; (iii) approval of the Group's annual results, annual budgets, interim results and other significant operational and financial transactions; (iv) changes to the Company's capital structure; and (v) major appointments to the Board. The Board has delegated the day-to-day management, administration and operation of the Group and implementation and execution of policies and strategies decided by the Board to the executive Directors and management of the Company.

The Board is also responsible for performing corporate governance duties including risk management, internal controls, those under D.3.1 of the Corporate Governance Code and relevant compliance issues relating to the business operation of the Group.

The Board reviews and monitors the training and continuous professional development of directors and senior managers; develops, reviews and monitors the code of conduct and compliance manual applicable to employees and Directors.

The composition of the Board is well balanced with each Director having sound industry knowledge, extensive corporate and strategic planning experience and/or expertise relevant to the business of the Group. #### 董事會責任及授權

董事會共同負責監督本集團業務及事務之管理工 作。董事會定期會面,討論本集團整體策略以及營 運與財務表現。董事會決定的若干事項包括有關(i) 制定本集團整體策略及方向;(ii)本公司主要股東 或董事之任何重大利益衝突;(iii)批准本集團年度業 績、年度預算、中期業績及其他重大營運與財務交 易;(iv)更改本公司之股本結構;及(v)就董事會作出 重大委任之事項。董事會已授權本公司執行董事及 管理層負責管理本集團之日常管理、行政及營運, 並實施及執行董事會決定之政策及策略。

#### Appointment, re-election and removal of Directors

The Company has established the nomination committee under the Board (the "**Nomination Committee**") on 7 November 2013. The Nomination Committee has from time to time identified individuals suitably qualified to become Board members and make recommendations to the Board. The main consideration in selecting candidates for directorships is whether their characters, qualifications and experience are appropriate for the businesses of the Group.

Each of the independent non-executive Directors has entered into a service contract for a term of 3 years which may be terminated by either party giving to the other party at least 3 months' prior written notice. All independent non-executive Directors are subject to rotation and reelection at the AGM in accordance with the Articles of Association.

In accordance with Article 108(a) of the Articles of Association, at each AGM, at least one-third of the Directors for the time being (or, if their number is not a multiple of three (3), the number nearest to but not less than one-third) shall retire from office by rotation provided that every director shall be subject to retirement at an annual general meeting at least once every three years. All such retiring Directors, being eligible, may offer themselves for re-election. Accordingly, Mr. Li Cheng, Mr. Ma Qinghai and Mr. Xu Wensheng will retire from office as Directors, being eligible, and will offer themselves for re-election at the forthcoming AGM.

In accordance with Article 112 of the Articles of Association, any Director appointed to fill a causal vacancy on the Board shall hold office until the next annual general meeting and shall there be eligible for re-election. Accordingly, Mr. He Chengying, being appointed on 1 April 2021 as an addition to the Board, shall retired as a Director by rotation at the AGM and, being eligible, will offer himself for re-election at the forthcoming annual general meeting. Save as Mr. He Chengying, there are no Directors who shall retire from office at the AGM, and being eligible, offer himself/herself for re-election.

## 董事的委任、重選及罷免

根據組織章程細則第108(a)條,於每屆股東週年大 會上,當時最少三分之一董事(或倘人數並非三(3) 的倍數,則為最接近但不少於三分之一的人數)將 輪席退任,惟每位董事須最少每三年於股東週年大 會上退任一次。所有符合資格的有關退任董事可膺 選連任。因此,李誠先生、馬青海先生及徐文勝先 生將於應屆股東週年大會上退任董事職務,並符合 資格且願意膺選連任。

根據組織章程細則第112條,由董事會委任以填補 臨時空缺的任何董事任期僅直至下屆股東週年大 會,並有資格重選。因此,何誠穎先生(於二零二一 年四月一日獲委任加入董事會)應於股東週年大會 上輪值退任,並於應屆股東週年大會上符合資格且 願意膺選連任。除何誠穎先生外,概無董事將於股 東週年大會上退任並符合資格且願意膺選連任。

#### Insurance of the directors and officers

The Company has arranged liability insurance for the Directors and officers of the Group in respect of legal action against them which is in compliance with code provision A.1.8 of the Code.

#### Induction and continuous professional development

Newly appointed Directors will receive guideline and reference materials to enable them to familiarise with the Group's business operations and Board's policies. The Company is committed to arranging and funding suitable training to all Directors for their continuous professional development. Each Director is briefed and updated from time to time to ensure that he is fully aware of his responsibilities under the Listing Rules and applicable legal and regulatory requirements and the governance policies of the Group. All the Directors also understand the importance of continuous professional development and are committed to participating in any suitable training to develop and refresh their knowledge and skills. According to the records provided by the Directors, a summary of training received by the Directors during the Period under Review is set out below:

## **AUDIT COMMITTEE**

The audit committee under the Board (the "Audit Committee") currently consists of three independent non-executive Directors. The primary duties of the Audit Committee are to review the Company's financial information, review and supervise the Company's financial reporting process and internal control procedures, nominate and monitor external auditors and provide advice and comments to the Board. The Audit Committee is established with specific terms of references which deal clearly with the committee's authority and duties and are available on the website of the Stock Exchange and the Company.

The principal duties of the Audit Committee include monitoring the integrity of the financial statements of the Company, reviewing the effectiveness of Company's internal control (including the adequacy of resources, qualifications and experience of staff of the Company's accounting and financial reporting function, and their training programs and budget) and risk management systems as delegated by the Board, and making recommendations to the Board on the appointment and engagement of the external auditor for the audit and non-audit services. The Audit Committee is provided with sufficient resources enabling it to discharge its duties.

There were three meetings held during the Period under Review and the attendance by each committee member is set out below:

During the year ended 31 December 2020, there was no non-audit service provided by the Group's external auditors.

# Directors' and auditors' responsibilities for financial statements

All Directors are responsible for the preparation of the financial statements which give a true and fair view of the state of affairs of the Group. The auditor of the Company acknowledges its reporting responsibilities in the auditor's report on the financial statements of the Company for the year ended 31 December 2020. The statement by the auditors of the Company about their responsibilities for the financial statements is set out in the independent auditor's report contained in this annual report. The Directors are not aware of any material uncertainties relating to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern. Accordingly, the Directors have prepared the financial statements on a going-concern basis.

## NOMINATION COMMITTEE

The nomination committee comprises one executive Director and two independent non-executive Directors. The roles and functions of the Nomination Committee include reviewing the structure, size and composition (including the skills, knowledge and experience) of the Board, identifying individuals suitably qualified to become Board members and assessing the independence of independent nonexecutive Directors. The Nomination Committee is established with specific terms of reference which deal clearly with the committee's authority and duties and are available on the website of each of the Stock Exchange and the Company.

## Corporate Governance Report 企業管治報告

Salary adjustments are made where the Remuneration Committee takes into account performance, contribution and responsibilities of the individual. Apart from basic salary, executive Directors and employees are eligible to receive a discretionary bonus taking into account factors such as market conditions as well as corporate and individual's performance during the year.

## COMPLIANCE AND ENFORCEMENT OF THE NON-COMPETITION UNDERTAKING FROM CONTROLLING SHAREHOLDERS

As disclosed in the prospectus of the Company dated 15 November 2013 (the "**Prospectus**"), Mr. Li Cheng and Ever Thrive Global Limited are the controlling shareholders of the Company (the "**Controlling Shareholders**"). To protect the Group from any potential competition, the Controlling Shareholders has given an irrevocable non-competition undertaking (the "**Non-competition Undertaking**") in favour of the Company on 7 November 2013. Pursuant to the Non-competition Undertaking, each of the Controlling Shareholders has, among other matters, undertaken with the Company that each of the Controlling Shareholders and their respective associates (other than the Group) shall not engage in any business which will or may compete with the business currently and from time to time engaged by the Group. Details of the Non-competition Undertaking have been set out in paragraph headed "Relationship with our controlling shareholders – Non-competition Undertaking" of the Prospectus.

The Company has received the annual declaration from each of the Controlling Shareholders in respect of their respective compliance with the terms of the Non-competition Undertaking during the Period under Review. The independent non-executive Directors, having reviewed the aforementioned annual declarations and made reasonable enquiry, are satisfied that the Controlling Shareholders have complied with the terms of the Non-competition Undertaking during the Period under Review.

## 控股股東對不競爭承諾的遵守及執行

## **COMPANY SECRETARY**

Ms. Yeung Wing Kwan ("**Ms. Yeung**") was appointed as the company secretary of the Company on 31 May 2019.

Ms. Yeung plays an important role in supporting the Board by ensuring efficient and effective information flow within the Board and that the Board's policy and procedures are followed.

The Company Secretary has day-to-day knowledge of the Company's affairs. The Company Secretary reports to the Board through the Chairman and CEO. All Directors may have access to the advice and services of the Company Secretary who regularly updates the Board on governance and regulatory matters and facilitates the induction and professional development of the Directors.

The Company Secretary is also responsible for ensuring the procedures of the Board meetings are observed and providing the Board with opinions on matters in relation to the compliance with the procedures of the Board meetings.

The Company's decision to declare or to pay any dividends in the future, and the amount of such dividends will depend upon, among other things, the current and future operations, financial condition, liquidity position and capital requirements of the Group, as well as dividends received from the Company's subsidiaries and associates, which in turn will depend on the ability of those subsidiaries and associates to pay a dividend. In addition, any final dividends for a financial year will be subject to the approval of the Shareholders. The declaration and payment of dividends by the Company is also subject to any restrictions under the laws of Cayman Islands, the laws of Hong Kong, the Company's Amended and Restated Memorandum and Articles of Association and any applicable laws, rules and regulations.

Whilst this Dividend Policy reflects the Board's current views on the financial and cash-flow position of the Group, the Board will continue to review this Dividend Policy from time to time and the Board may exercise its sole and absolute discretion to update, amend and/or modify this Dividend Policy at any time as it deems fit and necessary. There is no assurance that dividends will be declared or paid in any particular amount for any given period. The Dividend Policy shall in no way constitute a legally binding commitment by the Company that any dividend will be paid in any particular amount and/or in no way obligate the Company to declare a dividend at any time or from time to time.

Such meeting shall be held within two months after the deposit of such requisition. If within 21 days of such deposit, the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) by the Company.

# Procedures for putting forward proposals at general meetings by Shareholders

Shareholders are requested to follow Article 64 of the Articles of Association for including a resolution at an extraordinary general meeting. The requirements and procedures are set out above in the paragraph headed "Convening an extraordinary general meeting by Shareholders". Pursuant to Article 113 of the Articles of Association, no person (other than a retiring Director) shall be eligible for election to the office of Director at any general meeting unless a notice in writing of the intention to propose that person for election as a Director and notice in writing by that person of his willingness to be elected shall have been lodged at the head office or at the registration office no earlier than the day after the dispatch of the notice of the general meeting appointed for such election and end no later than seven days prior to the date of such general meeting and the minimum length of the period during which such notices to the Company may be given will be at least seven days. The procedures for the Shareholders to propose a person for election as a Director is posted on the website of the Company.

## SHARE OPTION SCHEME OF THE COMPANY

The Company adopted a share option scheme (the "**Scheme**") on 7 November 2013 as to attract and retain the best available personnel and to provide additional incentive to the eligible participants under the Scheme. Pursuant to the Scheme, the Board is authorised, at its absolute discretion and subject to the terms of the Scheme, to grant options to subscribe the Shares to any employees (full-time or part-time), Directors, consultants or advisor of the Group, or any substantial shareholder of the Group, or any distributor, contractor, supplier, agent, customer, business partner or service provider of the Group. The Scheme shall be valid and effective for a period of ten years commencing on 7 November 2013, subject to early termination provisions contained in the Scheme.

An offer for the grant of options must be accepted within seven days inclusive of the day on which such offer was made. The amount payable by the grantee of an option to the Company on acceptance of the offer for the grant of an option is HK\$1.00. The subscription price of a Share in respect of any particular option granted under the Scheme shall be a price solely determined by the Board and notified to a participant and shall be at least the highest of: (i) the closing price of the Shares as stated in the Stock Exchange's daily quotations sheet on the date on which an option is offered to a participant; (ii) the average of the closing prices of the Shares as stated in the Stock Exchange's daily quotations sheets for the 5 trading days immediately preceding the date on which an option is offered to a participant; and (iii) the nominal value of a Share on the date on which an option is offered to a participant.

The Company shall be entitled to issue options, provided that the total number of Shares which may be issued upon exercise of all options to be granted under the Scheme and any other share option schemes of the Company must not exceed 10% of the shares in issue on the listing date of the Company (i.e. 27 November 2013).

The Company may at any time refresh such limit, subject to the Shareholders' approval and issue of a circular in compliance with the Listing Rules, provided that the total number of Shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under all the share option schemes of the Company shall not exceed 30% of the Shares in issue from time to time.

The total number of Shares issued and to be issued upon exercise of the options granted to each participant (including both exercised and outstanding options) in any 12-month period must not exceed 1% of the Shares in issue unless approved by the Shareholders in accordance with the requirements of the Listing Rules.

The ESG report aims at improving the stakeholders' confidence and understanding of the Group's environmental and social performance as well as the sustainable development strategies of the Group. The Board of the Company has reviewed and confirmed the ESG report has contained material, complete and balanced contents.

# Environmental, Social and Governance Report

## **ENVIRONMENTAL ASPECT**

## Build a sustainable ecosystem

In response to the national requirement for accelerating the development of "conservation-oriented society", the Group proactively complied with relevant laws and regulations in relation to emissions and pollutants control, and implemented the "Quality and Environmental Management Manual" in association with the management procedure manuals in relation to waste water treatment, gas emission, waste handling and resources management process to monitor the treatment and disposal of waste water, gas emissions and waste disposal. The Group has been accredited with the ISO 14001 environmental management certification since February 2015 and has completed the external audit and renewal related to ISO during the Period under Review.

Application for Global Recycled Standard 4.0 (referred to as GRS 4.0) was first made in 2020. The certificate was successfully obtained in February, which is an international, voluntary and comprehensive product standard that sets out the requirements for third party certification of recycling content, chain of custody, social and environmental practices and chemical restrictions. It currently aims at increasing the use of recycled materials in products and to reduce and eliminate the hazards caused by their production, to lay the foundations for the international marketing of products and to carry out annual audits and renewals of GRS standards.

#### A1. Emission policies

#### Gas emission policy

The Group has formulated the "Gas Emission Management Procedure" in order to effectively and efficiently manage its gas emission and ensure the Group's compliance with the relevant rules and regulations regarding gas emissions in the PRC.

The Group primarily produces the greenhouse gas ("**GHG**") due to energy consumption in the production process. Pursuant to the GHG Protocol (an international standard for measuring emissions from private and public operations) in translating the GHG emission resulted from energy consumption under Scope 2 Guidance of the GHG Protocol (an international standard regarding how corporations measuring emissions from purchased or acquired electricity, steam, heat and cooling), the Group has a total GHG emission of approximately 33,655.95 tonnes of carbon dioxide equivalence during the Period under Review.

## 環境方面

## 締造可持續發展的生態環境

為積極響應國家提出的加快建設「節約型社會」的要求,本集團積極遵守有關排放物及污染物監控之相 關法律法規,本集團已實行與管理程序手冊相關之 「品質環境管理手冊」,有關內容包括廢水處理、廢 氣排放、廢棄物處理及資源管理流程,以及監控廢 水、氣體排放物處理、處置以及廢棄物處置。本集 團已自二零一五年二月取得ISO 14001環境管理體 系認證,並於回顧期內完成了ISO外部審核及ISO轉 換證工作。

2020年初次申請Global Recycled Standard 4.0 (簡 稱全球回收標準4.0),並在二月成功取得證書,該證 書是一項國際、自願和全面的產品標準,規定了回 收內容、產銷監管鏈、社會和環境實踐以及化學品 限制的第三方認證要求,目前就是增加產品中回收 材料的使用,並減少和消除其生產所造成的危害, 為產品在國際銷售打下基礎,並每年對GRS標準進 行審核及換證工作。

## A1. 排放政策

#### 氣體排放政策

為有效及高效管理其氣體排放及確保本集團 符合中國有關氣體排放的相關規則及規例, 本集團已制定「廢氣管理程序」。

本集團的溫室氣體排放主要源於生產過程的 能源消耗。於回顧期間,根據溫室氣體(「**溫室** 氣體」)核算體系(一項計量私營及公營企業排 放物的國際標準)對範圍二項下由於能源消耗 導致的溫室氣體排放進行折算(一項關於企業 如何計量購買式收購電力、蒸汽、加熱及製冷 產生之排放之國際標準),本集團合共產生溫 室氣體排放量約33,655.95噸二氧化碳當量。

In December 2020, Yongsheng Dyeing invested RMB265,000 to complete the remediation and upgrading of major volatile organic compounds (VOCs) and invested RMB2.2 million in real-time online monitoring of VOC management. According to report by Hangzhou Tongbiao Environmental Monitoring Technology Co. Ltd\* (杭州通 標環境監測技術有限公司), all indicators of VOCs have met the requirements of this remediation, and have successfully passed the remediation performance assessment, further standardising the prevention and control of volatile organic pollutants. For water consumption, effort was made to improve water recycling; and for power consumption, air compressors and online transformation are adopted; electronic transformation has been carried out, and the annual energy consumption of water, electricity and steam has dropped by more than 5%, and all pollutants have reached the emission target, achieving better economic and social benefits.

#### Waste water treatment policy

The Group has formulated the "Waste Water Management Procedure" in order to effectively and efficiently manage the treatment and disposal of waste water and comply with the rules and regulations regarding waste water disposal.

The Group adopted measures to separate waste water produced during its production from other uses. Waste water segregation is adopted in the production sites in order to facilitate segregation in treatments for different types of waste water.

The Group's waste water is mainly produced in the dyeing facilities. In order to comply with the local government requirements to ensure waste water was pre-treated (i.e. reducing the Chemical Oxygen Demand ("**COD**") level of the waste water) before entering the municipal drainage system, the Group built a waste water pretreatment facility on the dyeing production site in 2015 with further enhancement in 2018. 2020年12月,永盛染整累計投入人民幣26.5 萬元,完成對主要揮發性有機物(VOCs)進行 的整治提升,投入220萬元對VOC治理實時在 線監控,經杭州通標環境監測技術有限公司 的檢測報告,各項VOCs參數指標均已達到本 次整治要求,順利通過整治績效評估,進一步 規範了揮發性有機物污染的防治工作。對水 耗加大了中水回用投入,對電耗採取空壓機 改造、在線改造;電子改造,全年水、電、汽 能耗值下降5%以上,各項污染物均達目標排 放,取得了較好的經濟效益和社會效益。

#### 廢水處理政策

為有效及高效管理廢水處理及處置,並遵從 有關廢水處置之規則及規例,本集團已制定 「廢水管理程序」。

本集團採取措施對來自其他用途的生產過程 中產生的廢水進行分流。於生產現場採用廢 水分流,以利於對各類廢水分流分冶。

本集團之廢水主要產生於染整裝置。為符合 當地政府規定以確保廢水在進入市政排水系 統前得到預處理(即降低廢水的化學需氧量 (「COD」)水平),本集團已於二零一五年在 染整裝置生產現場建立廢水預處理設施,並 二零一八年得到進一步提升。

During the Period under Review, the Group installed the Distributed Control System ("**DCS**") central control system and ammonia nitrogen automatic monitoring system for wastewater treatment process in its workshops. The DCS central control system is designed to monitor the whole process of wastewater treatment by continuously monitoring sewage inflow, inflow temperature, PH value, operating condition of circulating water pump, discharge amount and other real time indexes on a 24-hour basis. With such system, wastewater treatment was under global monitoring and steady control, ensuring discharged wastewater after treatment met environmental requirements, such as COD under 200mg/ L, PH value within the range of 6 to 9, ammonia-nitrogen below 20mg/L and total nitrogen below 30mg/L.

In May 2018, Yongsheng Dyeing invested approximately RMB0.84 million to upgrade the sewage treatment system, and a set of shallow dissolving air-floating system (淺層氣浮系統) with a processing capacity of 100 tons/hour, replacing the inefficient sewage physicochemical system of the primary settling tank in the original sewage biochemical system. In addition, another set of anaerobic sewage circulation system (污水厭氧循環系統) came into operation and solved occasional blockage in the original anaerobic sewage distributor pipe, which further ensured the stable operation of the sewage treatment system.

In August 2018, Yongsheng Dyeing invested approximately RMB0.14 million to upgrade the sewage online monitoring equipment and installed a detector for total nitrogen to realize realtime monitor on the total nitrogen in the sewage discharged.

In September 2019, Yongsheng Dyeing invested approximately RMB2.24 million to upgrade the waste gas VOC automatic monitoring system.

In December 2020, Yongsheng Dyeing invested approximately RMB0.8 million to upgrade all the sewage pipelines in the plant area to realize "zero liquid discharge". New oil & water separator, 3-pool septic tank and initial rainwater collection pool were built, and 18 rain-sewage joints were dug and repaired and 66 damaged points in pipelines were repaired without excavation, and signs for rain and sewage and flowing direction of about 300 manholes were set, thus the goal of "full collection of sewage, complete diversion of rainwater and sewage, standardized discharge from sewage pipe" was achieved. 於回顧期間,本集團於其車間安裝廢水處理 過程的Distributed control systems (「DCS」) 中控系統和氨氮自動監測系統。DCS中控系 統主要針對整個污水處理過程進行監控,包 括污水進水量、進水溫度、PH值、循環水泵狀 態、排水量等多項實時指標進行24小時持續 監測,使汙水處理在整個過程全程監控穩定 控制,確保外排廢水達到COD 200mg/L以下、 PH值介於6-9之間、氨氮20mg/L以下和總氮 30mg/L以下等環保要求。

2018年5月,永盛染整投入約人民幣84萬元 對污水處理系統進行升級改造,其中投入100 噸/小時的淺層氣浮系統一套,有效取代了 原汙水生化系統中初沉池低效的污水物化系 統,同時增加了一套污水厭氧循環系統,有效 解決了原污水厭氧布水器管道偶爾堵塞的問 題,進一步保證了污水處理系統的可靠運行。

2018年8月,永盛染整投入約人民幣14萬元對 污水在線監控設備進行升級改造,加裝總氮 檢測儀1台,從而對排放污水中的總氮指標也 進行實時監控。

2019年9月,永盛染整投入約人民幣224萬元 對廢氣VOC自動監測系統進行提升。

2020年12月,永盛染整投入約人民幣80萬元 對廠區內所有的污水管道進行「污水零直排」 整治升級,新建隔油池、三格化糞池、初期雨 水收集池,開挖修復雨汙混接點18個,非開挖 點狀修復管道破損點66個,完成約300個窨井 的雨汙標識和流向,達到"污水全收集、雨汙 全分流、污水納管達標排放"的目標。

#### Waste management policy

The Group has formulated the "Waste Management Procedure" in order to effectively and efficiently manage the treatment and disposal of solid waste.

Hazardous waste produced by the Group during its production process mainly includes dyeing sludge and waste oil from stenter. The Group stores such hazardous waste separately by their classification and adds labels on each depositary to specify the type, quantity and deposited time before they were transferred to professional third party for disposal.

In June 2018, Yongsheng Dyeing invested approximately RMB218,000 to purchase a high-pressure diaphragm filter press to upgrade the sludge treatment part of the sewage system, which not only significantly improved the printing and dyeing sludge treatment efficiency, but also made the treated sludge have a very low water content, thus significantly reducing the cost of subsequent sludge disposal.

Non-hazardous waste produced by the Group mainly derived from packaging materials in production and domestic wastes from staff dormitory and office. The Group strives to reduce the packaging materials of the products. The Group maintains optimal design for packaging materials in accordance with environmental protection requirements, for example: to reduce product size, minimise packaging and save storage space. Given the needs to meet customer expectations and logistics requirements, the Group strives to cut down the usage of packaging materials. The main packaging materials for the Group's PFY products include carton boxes, paper cones, foam boards, plastic bags and plastic films, while the packaging materials for dyed fabric products include paper cones and plastic films. Wooden supports are used for product storage and auxiliary transportation and will be disposed of as general industrial waste only when damaged. The new wooden supports are those recyclable old wooden supports. On the other hand, domestic wastes are handled by municipal cleaning service.

#### 廢棄物管理政策

為有效及高效管理固體廢棄物處理及處置, 本集團已制定「廢棄物處理程序」。

本集團生產過程中產生的有害廢棄物主要是 指印染污泥及定型機廢油。該部分有害廢棄 物,本集團會進行分類管理、單獨存放,並於 存放點樹立標籤,標明種類、數量及存放時 間,再交由專業的第三方機構進行處理。

2018年6月,永盛染整投入約人民幣21.8萬元 購入高壓隔膜壓濾機一台,對污水系統的污 泥處理部分進行升級改造,不但印染污泥處 理效率顯著提高,而且處理出來的污泥含水 量極低,明顯降低了污泥後期的處理費用。

本集團的無害廢棄物主要源於生產包裝材料 及員工宿舍及辦公室生活垃圾。本集團致力 減少產品的包裝材料。本集團根據環保規定 對包裝進行優化設計,例如:減少產品尺寸、 最小化包裝及節省存儲空間。鑑於滿足客戶 期望之需要及物流規定之前提下,本集團盡 創少使用包裝材料。本集團滌綸長絲產品 的主要包裝材料包括紙箱、紙筒、泡沫板、塑 料袋及塑料薄膜,而染色面料產品的包裝材 料包括紙筒及塑料薄膜。用於產品儲存、運輸 輔助的木架僅於損壞時才作為一般工業廢棄 物處置。新增的木架為回收的可用的舊木架。 另一方面,生活垃圾由市政清潔服務進行處 理。

As the Group's Yongsheng Plaza project is under construction, we take all reasonable measures to minimize the environmental impact during the construction process.

In terms of waste disposal, we set aside a dedicated temporary space for waste storage at the construction site. Waste is stored by category, with safety precautions and visible signs for waste that may cause secondary pollution. Waste shall not be scattered or mixed during transportation, and will be sent to the units or sites approved by government departments for treatment and disposal.

In terms of construction waste and material dumping, the Group takes the following measures:

- (1) The construction waste shall be dumped by category in a centralized way and cleaned in a timely manner. Closed containers shall be used for temporary domestic waste and water can be sprinkled before removing waste, if appropriate, to avoid dust. Qualified transportation companies will be engaged to remove waste, so as not to dump waste indiscriminately.
- (2) The construction waste in the building structure will be transported through closed special waste channel or closed containers, and is strictly prohibited to be thrown in the air. The construction site is equipped with an enclosed waste collection facility, with construction waste and domestic waste stored separately. The construction waste will be removed in time according to regulations with water sprinkled in advance to reduce the air pollution of dust. Vacuum cleaner shall be used as much as possible and dust-generating equipment, such as wind blower, shall be avoided when cleaning dust and waste before pouring concrete. Protective measures, such as local shielding, covering and water showering, may be adopted when conducting mechanical chiseling.
- (3) The waste on the upper level will be transported to the ground by tower crane, material hoist or pulley, and no arbitrary piling and throwing of waste is allowed. On-site waste shall be transported outward in time, and no overnight waste shall be stored on site. During the construction of earthwork, a dedicated person will sprinkle and sweep the floating soil stored at the site every day to prevent dust when wind is blowing. The lime powder and all kinds of adulterated bulk materials must be stored in the warehouse or tightly covered. Anti-dust measures shall be taken for sand, stone and other bulk construction materials and earthwork, such as surface cure, covering and others.

本集團的永盛大廈項目處施工階段因此也採 取一切合理的措施,希望在施工過程中盡量 減少對環境的影響。

在處理廢物方面,施工現場設專門的廢棄物 臨時儲存場地,廢棄物應分類存放,對有可能 造成二次污染的廢棄物必須單獨儲存、設置 安全防範措施且有醒目標識。廢棄物的運輸 確保不散撒、不混放,送到政府部門批准的單 位或場所進行處理、消納。

在建築垃圾及材料堆放方面,本集團會有以 下方向處理:

- (1) 建築垃圾集中、分類堆放,及時清運;臨 時堆放的生活垃圾採用封閉式容器,清 理前可以適當灑水,確保無揚塵。垃圾 清運委託有資格的運輸單位,做到不亂 卸亂倒。
- (2) 建築結構內的施工垃圾清運採用封閉式 專用垃圾通道或封閉式容器吊運,嚴禁 凌空拋撒。施工現場設密閉式垃圾站, 施工垃圾、生活垃圾分類存放。施工垃 圾清運時提前適量灑水,並按規定及時 清運,減少粉塵對空氣的污染。澆築混 凝土前清理灰塵和垃圾時儘量使用吸塵 器,避免使用吹風器等易產生揚塵的設 備。機械剔鑿作業時可用局部遮擋、掩 蓋、水淋等防護措施。
- (3) 上層的垃圾用塔吊、物料提升機或滑輪向地面運輸,不能任意堆放和拋灑垃圾。現場垃圾應及時向外運輸,現場不存放隔夜垃圾。土方施工時,每天有專人對現場存放的浮土進行灑水、清掃,以防颳風是塵土飛揚。現場的石灰粉及各種摻加用散料必須在庫房內存放或者嚴遮蓋,沙、石等散粒建築材料和土方要採取表面固化、覆蓋等防揚塵措施。

The Group's RMAA services fall under the construction industry which may generate some hazardous waste due to the business nature. Widely Construction endeavors to take all reasonable measures to minimize the impact on the environment during its operations and has been seeking ways less harmful to the environment. The control measures include: (i) spraying water when dusty construction activities (such as demolition, drilling or excavation) are carried out; (ii) transferring waste to other sites for reusing; and (iii) sorting waste for recycling.

本集團的RMAA服務屬於建築行業的業務性 質可能會產生一些有害廢物, 偉利建築致力 採取一切合理措施, 在營運過程中盡量減少 對環境的影響及一直尋求對環境危害較少的 方式。控制措施包括:(()進行多灰塵的施工活動 (如拆卸、鑽探或挖掘)時, 進行灑水;(ii)將廢 物轉移至其他工地進行再利用;及(iii)廢物分 類及回收。

## A3. Environment and natural resources

#### Environmental protection measures

The main types of energy which the Group used in production are electricity and steam; all were supplied by the municipal facilities.

The Group aims at increasing energy efficiency through proper equipment maintenance and replacement of factory equipment. The Group has reduced electricity consumption from production by upgrading and replacing air compression systems. The Group adopted the "coal-to-steam" system which uses steam as driving force of stenter machines. Such system significantly reduces gas emission.

## A3. 環境及天然資源

### 環保措施

本集團生產所用能源主要類型為電力及蒸 汽,均由市政設施供應。

本集團旨在透過適當的設備維護及更換工廠 設備提高能源效益。本集團已經透過升級及 更換空氣壓縮系統減少生產耗電量。本集團 亦通過煤氣技術改造,所有定型機使用蒸汽 定型大大降低了廢氣排放。

During the Period under Review, Yongsheng Dyeing successfully passed the test on the enterprise's electric energy balance conducted by the Government of Xiaoshan District, Hangzhou, Zhejiang Province. The test mainly focused on the following two major parts of the enterprise: i) electricity consumption and power balance test, including power load, daily load rate, main electricity consumption per day, high and low voltage output line threephase current and other parameters; and ii) the actual operating conditions test on on-site electrical equipment to understand whether electrical equipment operates smoothly and whether there is power-saving potential.

Based on the above test data in two aspects and combined with the comprehensive analysis of the current status of equipment operation, the Group proposed a related rectification plan for the production process. Through rectification, Yongsheng Dyeing finally saved energy by over 7%.

In July 2020, Yongsheng Dyeing engaged CCTEG Hangzhou Research Institute (煤科集團杭州環保研究院有限公司) to make a comprehensive electric energy balance test report on the company. By December, a total of RMB3.28 million has been invested to carry out technical renovation of related equipment and lines, and the rectification plan has been basically completed. At present, it is estimated that Yongsheng Dyeing can save 950,000 kwh of electricity and RMB750,000 of electricity charges annually, basically reaching the expected goal of reconstruction and passing the test on the enterprise's electric energy balance conducted by the Government of Xiaoshan District, Hangzhou, Zhejiang Province.

The Group has a circulating cooling water system in place to reduce the consumption of water for cooling down during this Period. Furthermore, Yongsheng Dyeing has installed a water recycling system to recycle dyed water generated from its production and reduce water consumption.

During the Period under Review, Widely Construction advocated to reduce the consumption of fuel, electricity, and improve the resources efficiency by: (i) encouraging its employees to switch off the lights and electronic appliances before they leave the office; (ii) encouraging its employees to set the temperature of the office's air conditioner to 25.5 Degree Celsius; (iii) encouraging its employees to use double-sided printing instead of single-sided printing; and (iv) arranging the surplus materials on the construction sites to be re-used in other construction sites instead of dumping. During the Period under Review, the electricity consumption and total water consumption of Widely Construction were 24,011.00 kwh and 10.00 m<sup>3</sup> respectively.

於回顧期內,永盛染整順利通過了浙江省杭 州市蕭山區政府開展的關於企業電能平衡的 測試,該測試主要圍繞企業的以下兩大部分 進行,i)用電潮流及電量平衡測試、包括用電 負荷、日負荷率、主要電元日用電量、高低壓 輸出路線三相電流等參數;及ii)現場用電設備 實際運行工況測試,了解是否正常運行及是 否有節電潛力。

本集團針對以上兩部分的測試數據並結合對 設備運行現狀的綜合分析,提出了相關的生 產工藝的整改方案,通過整改,永盛染整最終 實現節能7%以上。

2020年7月,永盛染整委託煤科集團杭州環保 研究院有限公司對公司做了全面的電平衡測 試報告,截止12月累計投入人民幣328萬元對 相關設備線路進行技改,基本完成了整改方 案,目前經測算可年節電95萬度,年省電費75 萬元,基本達到改造預期目標,並通過了浙江 省杭州市蕭山區政府開展的關於企業電能平 衡的測試。

本集團設置循環冷卻水系統以減少即期降溫 的用水。此外,永盛染整已安裝水循環系統以 回收染整生產用水及降低水資源消耗量。

在回顧期內, 偉利建築通過下列方法減少燃 料及電力消耗以及提高資源使用效率, (i)鼓勵 員工在離開辦公室之前關掉電燈及電器; (ii) 鼓勵員工將辦公室的空調溫度設置為25.5攝 氏度; (iii)鼓勵員工使用雙面打印而非單面打 印;及(iv)安排建築工地上的剩餘材料在其他 工地上再次使用而非丟棄。於回顧期內, 偉利 建築用電量為24,011.00千瓦時及總耗水量為 10.00立方米。

#### Environmentally friendly products application

During the Period under Review, the Group continued to use environmentally friendly products that were granted with two national invention patents. The "Nylon Ultrafine Fabric Filament and Leather-Feel Velvet Fabric" are manufactured with lower temperature printing and dyeing methods, which significantly reduced energy consumption and emissions, as compared with the manufacturing of regular polyester ultrafine fiber. Meanwhile, the microfiber filaments of "Ultrafine Fabric Filament and Naked Shammy Fabric" require less or no dyestuff in production resulting in less or no sewage being discharged during the production process. These two patented products achieve energy-saving and environmental protection at the same time.

#### 環保產品應用

於回顧期間內,本集團繼續使用獲授兩項國 家發明專利的環保產品。「尼龍超細纖維長絲 及皮感絨織物」乃使用低溫印染方法生產,該 方法較生產常規滌綸超細纖維能大幅減少能 源消耗及排放。同時,「超細纖維長絲及無染 麂皮織物」的超細纖維細絲在生產中需要很少 或不需要染料,進而令生產過程中排放很少 或不排放廢水。該等兩種專利產品同時實現 了節能及環保。

## Care for the employees

#### B1. Employment

The management of the Group believes that "cooperation" and "reciprocity" are the key success elements in a harmonious employment relationship. Hence, the Group strictly complies with labour laws, regulations and industry practices in relation to remuneration and dismissal, recruitment and promotion, working hours, rest periods, equal opportunity, diversity, anti-discrimination and other benefits and welfare. The Group participates in the social insurance schemes estalished by the relevant local PRC government authorities which include: retirement pension, medical insurance, unemployment insurance, industrial injuries insurance and maternity insurance as required by the relevant PRC regulations. Apart from competitive salaries and incentives such as bonus and share options which is based on the evaluation of their contributions to the Group, the Group also provides promotion prospects and training opportunities to staff.

The Group also provides a series of facilities and benefits for its staff and their families. The Group is committed to equipping its staff with all-rounded skills and developing the full potential of its staff. Most of the senior management worked over five years for the Group.

#### Gender equality and diversity

The Group promotes equal opportunity and advocates diversity. All recruitment and promotions are based on meritocracy and all candidates will be considered during the recruitment procedures. Selection of candidates will be based on a diverse range of criteria, including but not limited to gender, age, cultural and educational background, experience, skills and knowledge. Necessary procedures are also exercised to ensure fair and nondiscriminatory recruitment.

As at 31 December 2020, the Group had a total of 308 employees and all of them are full-time employees. During the Period under Review, the Group's overall average employee turnover rate is approximately 52%.

## B1. 僱傭



#### 性別平等及多元化



#### Staff activities

The Group has organised various leisure activities and festival celebrations for its staff. During the Period under Review, the Group organised a series of activities to celebrate festivals like Chinese New Year, Women's Day, etc.. The Group also organised staff travel and other sports activities, in order to encourage work-life balance among its staff. The Group arranged thanks giving gifts to its staff during Chinese New Year, Mid-Autumn Festival, etc.. As a caring company, senior management of the Group regularly visit staff under inferior living conditions and assist them with sincere gratitude.

The Group applied for subsidies of staying in Hangzhou and held the Chinese New Year's Eve activities for its staff that were unable to return home during the Spring Festival due to the epidemic.

#### B2. Health and Safety

#### Emphasis on Production Safety

The Group strictly abides by the local laws and regulations related to employee health and safety, such as the Production Safety Law of People' Republic of China, the Law of the People's Republic of China on the Prevention and Control of Occupational Diseases, and the Measures for the Supervision and Administration of Occupational Health Surveillance. The Group regulates the work regarding production safety and prevention of occupational diseases in a standardised way and strengthens the protection of female employees through a series of internal rules and regulations.

In addition, in accordance with the requirements of systems such as the Safety Production Management System, the Group enhances accident and non-compliance management, supervises production safety, and carefully analyses and reflects on the lessons learned from non-compliance or production accidents to prevent further non-compliance. The principal of "four prohibition" on incomplete cause investigation, incomplete disciplinary action for responsible staff member, incomplete rectification measures and incomplete training for relevant staff member is upheld to improve safety education and implement rectifying measures.

#### 員工活動

本集團已為員工組織豐富的休閒活動及節日 慶典。於回顧期間內,本集團已組織一系列慶 祝春節、婦女節等節日活動。本集團亦組織員 工旅行及其他體育活動,旨在促進員工平衡 工作與生活。本集團在春節及中秋節等期間 為員工準備感恩禮物。作為一間充滿關懷的 公司,本集團高級管理層定期走訪慰問困難 職工,並提供誠摯幫助。

因疫情原因,為春節期間未能回家的員工申 請留杭補貼,舉辦年夜活動。

### B2. 健康與安全

#### 重視安全生產

本集團嚴格遵守當地與員工健康與安全相關 的法律法規,如《中華人民共和國安全生產 法》、《中華人民共和國職業病防治法》、《職業 健康監護管理辦法》等,通過系列的內部規章 制度來規範格式的安全生產與職業病防護工 作,加強女職工的保護。

此外,本集團按照《安全生產管理制度》等制 度規定,加強事故及違章管理,監管安全生產 及,認真分析並反省有關違章或者生產意外 帶來的教訓,杜絕重複現象發生,落實事故原 因未查清不放過,責任人員未處理不放過,整 改措施未落實不放過和有關人員未受到教育 不放過的「四不放過」原則,做好職工安全的 教育及整改措施。

The Group has installed comprehensive fire alarm systems and fire-fighting equipment at each workplace to reduce potential fire risk. All of the Group's new staff has to attend the safety trainings. Apart from the basic safety training, the Group also has focused on implementing the "6S" lean management system in daily works. The Group also requires proper safety training to be conducted before new equipment or techniques being employed or being operated.

#### Emphasis on occupational disease prevention

In accordance with the relevant local laws and regulations, the Group offers health and safety education to employees and provides induction safety training and arranges safety retraining for senior employees.

To promote a safe working environment and protect employees from occupational hazards, the Group has formulated "Management Procedures on Chemical Products" and "Management Procedures on Production Machinery".

The Group posts notices and warning signals at workplaces where occupational hazards may occur in order to raise employees' self-protection awareness.

In 2020, there was no working day lost due to work injury and there were no employee casualties due to work.

#### B3. Development and training

Communications are keys to the success of the Group. Internal management meetings of the Group were held regularly, such as management monthly meetings, periodic meetings for ad-hoc projects, functional meetings and daily team briefings. Also, in order to promote a safe production environment, efficiency and enhance the quality of the Group's products, systematic trainings were provided to staff, such as new staff induction program, fire prevention seminars, work safety seminars, seminars on technical topics, managerial skills, rules and regulations updates, etc.. 本集團已在每個生產車間安裝綜合性火災報 警系統及滅火設備,以降低潛在火災風險。 本集團所有新員工均參加安全培訓。除基礎 安全培訓外,本集團亦集中於日常工作中應用 「6S」精益管理體系。本集團亦要求操作或 運用新設備或技術前進行適當的安全培訓。

#### 重視職業病防護

本集團根據當地的有關法律法規,對員工進 行健康安全教育,實行入職前安全培訓和老 員工安全再培訓。

為促進安全工作環境及保障僱員避免職業性 危害,本集團已制定「化學品管理程序」及「生 產設備管理程序」。

在車間有職業危害的地方進行告知和警示, 提高員工自我防護意識。

於二零二零年,並無因工傷而損失工作日數, 亦無員工因工作關係而死亡的個案。

### B3. 發展及培訓

溝通是本集團成功的關鍵。本集團定期舉行 內部管理會議,如管理月度會議、專案定期會 議、功能會議及日常團隊簡會。此外,為提升 安全生產環境、效率及提高本集團產品質量, 本集團已為員工提供系統培訓,如新員工入 職培訓、防火培訓、工作安全研討會、技術專 題研討會、管理技能、規章制度更新等。

#### B4. Labour standards

#### B4. 勞工準則

The Group strictly complies with the relevant laws and regulations in relation of the prohibition of child and forced labour. The Group strictly prohibited employment of any staff under the age of 16. The human resources department of the Group strictly implements measures to prevent any violations thereof, for example, identity cards, certificates of skills and graduation certificates of each staff member are verified before signing formal employment agreements with the candidates. The Group also has measures in place to reconfirm whether the newly recruited staff meets the recruitment criteria. The Group will pay minimum salary on a monthly basis which is no less than those required by local government in accordance with the government regulations during the probation period. It will determine staff salary in accordance with the skills and technical requirements of the position. 本集團嚴格遵守有關禁止童工及強制勞工之 有關法律及法規。本集團嚴格禁止僱傭任何 16歲以下的員工。本集團人力資源部門與候 選人簽署正式僱傭協議前會嚴格執行如核查 每個員工的身份證、技能證書及畢業證書等 措施,防止任何違規行為。本集團亦採取措施 重新確認新招聘員工是否符合徵聘標準。根 據政府規定,於試用期內,本集團將支付之每 月最低薪金不低於地方政府規定之標準。本 集團將根據職位之技能及技術要求釐定員工 薪金。

## **OPERATING PRACTICES**

#### B5. Supply chain management

#### Corporate certifications, qualifications and awards

The Group promotes the concept of "innovation" with strong research and development capabilities. The Group has obtained certifications in quality and environment management aspects (ISO9001 and ISO14001). In addition, the Group has obtained a series of corporate certifications, qualifications and awards as listed out in the "Certifications and Qualifications" section above in recognition of its effort in promoting "innovation".

#### Procurement reliability and relationships with suppliers

The Group monitors its procurement procedures closely as raw materials directly affect the quality of products. During the Period under Review, the major suppliers of the Group were mainly located in Zhejiang province, Jiangsu province and other regions of the PRC and had over 5 years of relationship with the Group on average. When liaising with new suppliers, the sourcing department of the Group is responsible for evaluating the potential suppliers with reference to the criteria set out in the "Stakeholders Environmental Management Procedures", for example the compliance of relevant statutory requirements, product quality, production stability, compliance with safety and environmental protection rules and regulations and pricing. The Group only engages the suppliers which have passed the evaluation. Subsequent to the engagement of the suppliers, the Group performs regular evaluation of its suppliers in order to monitor product quality.

#### Emergencies management

The Group formulated the "Emergency Management Procedures" and "Fire Prevention Management Procedures" and other production safety management systems to cope with emergencies. In addition, the Group has designated personnel to conduct safety inspections on production facilities and conduct instant follow-up when any exceptional situation was found.

In order to minimise the environmental and social impact due to emergencies, the Company will set up a central team to manage emergencies and designate relevant personnel to formulate evacuation plans, conduct post-incidental repair and investigations in order to avoid the re-occurrence of similar incidents in accordance with the "Ratification and Prevention Measures Management Procedures".

### B5. 供應鏈管理

#### 突發事件管理

本集團已制定「應急準備和回應管理程序」及 「消防管理程序」以及其他生產安全管理制 度,以應對突發事件。此外,本集團已指定人 員對生產設施進行安全檢查,並在發生特殊 情況時及時跟進。

為最大程度減輕突發事件造成的環境及社會 影響,本公司將成立中央小組管理突發事件, 並指定相關人員根據「糾正和預防措施管理程 序」制定疏散計劃、進行事後維修及調查,以 免再次發生類似事件。


#### **Product quality**

The product information department is responsible for managing the patents and projects of the Group. The Group will cooperate with intellectual property service companies to improve the quantity and quality of future patents applications. The Group will continue to develop a sustainable innovation model through internal research and development, industry-university-research cooperation and others research and development efforts.

The Group will also perform periodic customer satisfaction surveys in order to understand customer demand.

#### **B7.** Anti-corruption

The Group emphasises on transparency and responsibility in order to fulfill the corporate motto of "integrity". The Group strives to achieve zero occurrence of incidents that are detrimental to the interests of shareholders, investors, customers and other stakeholders of the Group. The Group had formulated a set of anticorruption policies to ensure compliance with all applicable anticorruption laws and regulations in relation to bribery, extorting, fraud and money laundering. All directors, staff, agents and representatives and any individuals acting on behalf of the Group are prohibited from directly or indirectly offering, giving, soliciting or receiving any form of bribe, kickback or other corruptive payment or anything of value, to or from any person or organisation, including government agencies, individual government officials, private companies and employees of those private companies under any circumstances. During the Period under Review, the Group did not have any non-compliance with laws and regulations in respect of anti-corruption, including but not limited to Prevention of Bribery Ordinance (Chapter 201 of the Laws of Hong Kong) and Criminal Law of the PRC.

Moreover, the Group had formulated a whistle-blowing policy to increase employees' awareness to uphold integrity. The chairman, chief executive officer and the audit committee of the Company will receive report of the whistle-blowing incidents and have the discretion to initiate independent investigations according to the nature of the incidents or refer the incidents to relevant regulatory authorities. The Group communicated with investors and stakeholders periodically by publishing quarterly financial and business updates, organising visits to its factories and arranging focus group meetings with institutional investors and stock commentators. The Group also published announcements in relation to its major development in accordance with the seven "Principles of Responsible Ownership" published by the Securities and Futures Commission ("**SFC**").

In December 2020, the board of directors of the Company and departments, of the Group improve employees' comprehensive understanding of fraud concept, fraud behavior, and methods to prevent and defuse fraud and enhance their awareness through providing various anti-franchluant study materials and off-line trainings.

The Group applied an input method which recognised revenue based on the costs incurred up to the end of the reporting period as a percentage of total estimated costs for each contract. The input method involves the use of management's significant judgement and estimates, including estimates of the progress towards completion, the scope of deliveries and services required, total contract costs, and the remaining costs to completion.

The determination as to estimated credit losses involves management judgement and estimates. Management considers specific factors to decide the ECLs such as the age of the balances, location of customers, existence of disputes, recent historical payment patterns and any other available information concerning the creditworthiness of counterparties. Management uses this information to determine whether a provision for impairment is required.

The assessment was complex, and it involved significant judgements and assumptions such as long-term growth rate and discount rate.

Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these consolidated financial statements.

As part of an audit in accordance with HKSAs, we exercise professional judgement and maintain professional scepticism throughout the audit. We also:

合理確定屬高層次的核證,但不能保證根據香港審計 準則進行的審核在某一重大錯誤陳述存在時總能發 現。重大錯誤陳述可源於欺詐或錯誤,倘個別或整體 在合理預期情況下可影響使用者根據該等合併財務 報表作出的經濟決定時,則被視為重大錯誤陳述。

我們根據香港審計準則進行審核的工作之一,是運用 專業判斷,在整個審核過程中保持專業懷疑態度。我 們亦:

- 識別及評估合併財務報表由於欺詐或錯誤而導 致的重大錯報風險,因應這些風險設計及執行 審核程序,以及獲得充足和適當的審核憑證為 我們的意見提供基礎。由於欺詐可能涉及合謀 串通、偽造、故意遺漏、誤導性陳述或凌駕內部 控制,因此未能發現由此造成的重大錯報風險 比未能發現由於錯誤而導致的重大錯報風險更 高。
- 了解與審核有關的內部控制,以設計恰當的審 核程序,但並非旨在對 貴集團的內部控制的 有效性發表意見。

## 2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRSs") (which include all International Financial Reporting Standards, International Accounting Standards ("IASs") and Interpretations) issued by the International Accounting Standards Board ("IASB") and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for financial assets at fair value through profit or loss, bills receivable at fair value through other comprehensive income, derivative financial assets and investment properties which have been measured at fair value. These financial statements are presented in RMB and all values are rounded to the nearest thousand except when otherwise indicated.

## **Basis of consolidation**

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 December 2020. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

## 2.1 編製基準

## **Basis of consolidation (Continued)**

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the noncontrolling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

The amendments clarify that for an integrated set of activities and assets to be considered a business, it must include, at a minimum, an input and a substantive process that together significantly contribute to the ability to create output. A business can exist without including all of the inputs and processes needed to create outputs. The amendments remove the assessment of whether market participants are capable of acquiring the business and continue to produce outputs. Instead, the focus is on whether acquired inputs and acquired substantive processes together significantly contribute to the ability to create outputs. The amendments have also narrowed the definition of outputs to focus on goods or services provided to customers, investment income or other income from ordinary activities. Furthermore, the amendments provide guidance to assess whether an acquired process is substantive and introduce an optional fair value concentration test to permit a simplified assessment of whether an acquired set of activities and assets is not a business. The Group has applied the amendments prospectively to transactions or other events that occurred on or after 1 January 2020. The amendments did not have any impact on the financial position and performance of the Group.
- (c) Amendments to IFRS 9, IAS 39 and IFRS 7 address issues affecting financial reporting in the period before the replacement of an existing interest rate benchmark with an alternative risk-free rate ("RFR"). The amendments provide temporary reliefs which enable hedge accounting to continue during the period of uncertainty before the introduction of the alternative RFR. In addition, the amendments require companies to provide additional information to investors about their hedging relationships which are directly affected by these uncertainties. The amendments did not have any impact on the financial position and performance of the Group as the Group does not have any interest rate hedging relationships.
- (d) Amendments to IAS 1 and IAS 8 provide a new definition of material. The new definition states that information is material if omitting, misstating or obscuring it could reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements. The amendments clarify that materiality will depend on the nature or magnitude of information, or both. The amendments did not have any significant impact on the financial position and performance of the Group.

Further information about those IFRSs that are expected to be applicable to the Group is described below.

Amendments to IFRS 3 are intended to replace a reference to the previous Framework for the Preparation and Presentation of Financial Statements with a reference to the Conceptual Framework for Financial Reporting issued in March 2018 without significantly changing its requirements. The amendments also add to IFRS 3 an exception to its recognition principle for an entity to refer to the Conceptual Framework to determine what constitutes an asset or a liability. The exception specifies that, for liabilities and contingent liabilities that would be within the scope of IAS 37 or IFRIC 21 Levies if they were incurred separately rather than assumed in a business combination, an entity applying IFRS 3 should refer to IAS 37 or IFRIC 21 Levies respectively instead of the Conceptual Framework. Furthermore, the amendments clarify that contingent assets do not qualify for recognition at the acquisition date. The Group expects to adopt the amendments prospectively from 1 January 2022. Since the amendments apply prospectively to business combinations for which the acquisition date is on or after the date of first application, the Group will not be affected by these amendments on the date of transition.

有關預期將適用於本集團的國際財務報告準 則的進一步資料載述如下。

Amendments to IFRS 9, IAS 39, IFRS 7, IFRS 4 and IFRS 16 address issues not dealt with in the previous amendments which affect financial reporting when an existing interest rate benchmark is replaced with an alternative RFR. The Phase 2 amendments provide a practical expedient to allow the effective interest rate to be updated without adjusting the carrying amount when accounting for changes in the basis for determining the contractual cash flows of financial assets and liabilities, if the change is a direct consequence of the interest rate benchmark reform and the new basis for determining the contractual cash flows is economically equivalent to the previous basis immediately preceding the change. In addition, the amendments permit changes required by the interest rate benchmark reform to be made to hedge designations and hedge documentation without the hedging relationship being discontinued. Any gains or losses that could arise on transition are dealt with through the normal requirements of IFRS 9 to measure and recognise hedge ineffectiveness. The amendments also provide a temporary relief to entities from having to meet the separately identifiable requirement when an RFR is designated as a risk component. The relief allows an entity, upon designation of the hedge, to assume that the separately identifiable requirement is met, provided the entity reasonably expects the RFR risk component to become separately identifiable within the next 24 months. Furthermore, the amendments require an entity to disclose additional information to enable users of financial statements to understand the effect of interest rate benchmark reform on an entity's financial instruments and risk management strategy. The amendments are effective for annual periods beginning on or after 1 January 2021 and shall be applied retrospectively, but entities are not required to restate the comparative information. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to IFRS 10 and IAS 28 address an inconsistency between the requirements in IFRS 10 and in IAS 28 in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss when the sale or contribution of assets between an investor and its associate or joint venture constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to IFRS 10 and IAS 28 was removed by the IASB in December 2015 and a new mandatory effective date will be determined after the completion of a broader review of accounting for associates and joint ventures. However, the amendments are available for adoption now.

Amendments to IFRS 16 provides a practical expedient for lessees to elect not to apply lease modification accounting for rent concessions arising as a direct consequence of the COVID-19 Pandemic. The practical expedient applies only to rent concessions occurring as a direct consequence of the pandemic and only if (i) the change in lease payments results in revised consideration for the lease that is substantially the same as or less than, the consideration for the lease immediately preceding the change; (ii) any reduction in lease payments affects only payments originally due on or before 30 June 2021; and (iii) there is no substantive change to other terms and conditions of the lease. The amendment is effective for annual periods beginning on or after 1 June 2020 with earlier application permitted and shall be applied retrospectively. The amendments did not have any significant impact on the financial position and performance of the Group.

Amendments to IAS 1 clarify the requirements for classifying liabilities as current or non-current. The amendments specify that if an entity's right to defer settlement of a liability is subject to the entity complying with specified conditions, the entity has a right to defer settlement of the liability at the end of the reporting period if it complies with those conditions at that date. Classification of a liability is unaffected by the likelihood that the entity will exercise its right to defer settlement of the liability. The amendments also clarify the situations that are considered a settlement of a liability. The amendments are effective for annual periods beginning on or after 1 January 2023 and shall be applied retrospectively. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to IAS 16 prohibit an entity from deducting from the cost of an item of property, plant and equipment any proceeds from selling items produced while bringing that asset to the location and condition necessary for it to be capable of operating in the manner intended by management. Instead, an entity recognises the proceeds from selling any such items, and the cost of those items, in profit or loss. The amendments are effective for annual periods beginning on or after 1 January 2022 and shall be applied retrospectively only to items of property, plant and equipment made available for use on or after the beginning of the earliest period presented in the financial statements in which the entity first applies the amendments. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to IAS 37 clarify that for the purpose of assessing whether a contract is onerous under IAS 37, the cost of fulfilling the contract comprises the costs that relate directly to the contract. Costs that relate directly to a contract include both the incremental costs of fulfilling that contract (e.g., direct labour and materials) and an allocation of other costs that relate directly to fulfilling that contract (e.g., an allocation of the depreciation charge for an item of property, plant and equipment used in fulfilling the contract as well as contract management and supervision costs). General and administrative costs do not relate directly to a contract and are excluded unless they are explicitly chargeable to the counterparty under the contract. The amendments are effective for annual periods beginning on or after 1 January 2022 and shall be applied to contracts for which an entity has not yet fulfilled all its obligations at the beginning of the annual reporting period in which it first applies the amendments. Earlier application is permitted. Any cumulative effect of initially applying the amendments shall be recognised as an adjustment to the opening equity at the date of initial application without restating the comparative information. The amendments are not expected to have any significant impact on the Group's financial statements.

- IFRS 9 Financial Instruments: clarifies the fees that an entity includes when assessing whether the terms of a new or modified financial liability are substantially different from the terms of the original financial liability. These fees include only those paid or received between the borrower and the lender, including fees paid or received by either the borrower or lender on the other's behalf. An entity applies the amendment to financial liabilities that are modified or exchanged on or after the beginning of the annual reporting period in which the entity first applies the amendment. The amendment is effective for annual periods beginning on or after 1 January 2022, Earlier application is permitted. The amendment is not expected to have a significant impact on the Group's financial statements.
- IFRS 16 Leases: removes the illustration of payments from the lessor relating to leasehold improvements in Illustrative Example 13 accompanying IFRS 16. This removes potential confusion regarding the treatment of lease incentives when applying IFRS 16.

# 2.4 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Business combinations and goodwill**

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

# 業務合併及商譽

業務合併使用收購法入賬。所轉讓的代價按 收購日期的公平值計量,即本集團所轉讓資 產的收購日期公平值、本集團對所收購公司 前擁有人承擔的負債及本集團為換取所收購 公司控制權而發行的股本權益的總和。就每 項業務合併而言,本集團可選擇按公平值或 分佔所收購公司的可識別淨資產比例,計量 屬現時擁有人權益並賦予其持有人權利在清 盤時按比例分佔淨資產於所收購公司的非控 股權益。所有其他非控股權益部分按公平值 計量。收購相關成本於產生時支銷。

當所收購的一組活動及資產包括一項資源投 入及一項實質過程,而兩者對創造產出的能 力有重大貢獻,本集團認為其已收購一項業 務。

當本集團收購一項業務時,其根據合約條款、 經濟環境及於收購日期的相關情況評估金融 資產及所承擔的負債,以作出適當分類及指 定。此包括區分所收購公司主合約的嵌入式 衍生工具。

倘分階段進行業務合併,則先前持有的股本 權益按其收購日期的公平值重新計量,而所 產生的任何收益或虧損於損益確認。

收購方將轉讓的任何或然代價於收購日期按 公平值確認。倘或然代價歸類為資產或負債, 則按公平值計量,並於損益確認公平值變動。 倘或然代價歸類為權益,則毋須重新計量,且 往後結算於權益內入賬。

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable net assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 December. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cashgenerating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

商譽初步按成本計量,即已轉讓代價、已確 認非控股權益數額及本集團先前持有的被收 購方股權的公平值總額,超逾所收購可識別 資產淨值及所承擔負債的差額。倘該項代價 及其他項目之和低於所收購資產淨值的公平 值,於重估後其差額於損益內確認為議價購 買收益。

於初步確認後, 商譽按成本減任何累計減值 虧損計量。商譽須每年作減值測試, 倘有事 件發生或情況改變顯示賬面值有可能減值, 則會更頻密地進行檢討。本集團於十二月 三十一日進行其商譽年度減值測試。為進行 減值測試, 因業務合併而購入的商譽自收購 日起被分配至預期可從合併產生之協同效益 中獲益的本集團各個現金產生單位或現金產 生單位組別, 而無論本集團其他資產或負債 是否已分配至該等單位或單位組別。

減值乃通過評估與商譽有關之現金產生單位 (現金產生單位組別)的可收回金額釐定。當 現金產生單位(現金產生單位組別)的可收回 金額低於賬面金額時,便確認減值虧損。已就 商譽確認的減值虧損不得於其後期間撥回。

倘商譽已被分配至現金產生單位(或現金產生 單位組別),而該單位內部分業務被出售,與 出售業務相關的商譽於釐定出售收益或虧損 時列入業務的賬面值。在此等情況下出售的 商譽根據已出售業務的相對價值及所保留現 金產生單位的部分計量。

### Fair value measurement

The Group measures its investment properties and financial assets at fair value through profit or loss at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

本集團於各報告期末計量其投資物業及按公 平值計入損益的金融資產。公平值為市場參 與者之間於計量日期於井然有序交易中出售 資產收取或轉讓負債時支付的價格。公平值 計量以假設出售資產或轉讓負債的交易於資 產或負債的主要市場中進行為基礎,或倘並 無主要市場,則於資產或負債的最有利市場 進行。主要或最有利市場必須為可讓本集團 參與的市場。資產或負債的公平值以市場參 與者對資產或負債定價時使用的假設計量, 並假設市場參與者以其最佳經濟利益行事。

An asset's recoverable amount is the higher of the asset's or cashgenerating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is charged to the statement of profit or loss and other comprehensive income in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to profit or loss in the period in which it arises.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in the statement of profit or loss and other comprehensive income in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Construction in progress represents a building under construction, which is stated at cost less any impairment losses, and is not depreciated. Cost comprises the direct costs of construction and capitalised borrowing costs on related borrowed funds during the period of construction. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

## **Investment properties**

Investment properties are interests in land and buildings held to earn rental income and/or for capital appreciation, rather than for use in the production or supply of goods or services or for administrative purposes; or for sale in the ordinary course of business. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at fair value, which reflects market conditions at the end of the reporting period.

Gains or losses arising from changes in the fair values of investment properties are included in the statement of profit or loss in the year in which they arise.

Any gains or losses on the retirement or disposal of an investment property are recognised in the statement of profit or loss and other comprehensive income in the year of the retirement or disposal.

For a transfer from investment properties to owner-occupied properties or inventories, the deemed cost of a property for subsequent accounting is its fair value at the date of change in use. If a property occupied by the Group as an owner-occupied property becomes an investment property, the Group accounts for such property in accordance with the policy stated under "Property, plant and equipment and depreciation" for owned property and/or accounts for such property in accordance with the policy stated under "Right-of-use assets" for property held as a right-of-use asset up to the date of change in use, and any difference at that date between the carrying amount and the fair value of the property is accounted for as a revaluation in accordance with IAS16. For a transfer from inventories to investment properties, any difference between the fair value of the property at that date and its previous carrying amount is recognised in the statement of profit or loss.

## 投資物業

投資物業乃為賺取租金收入及/或資本增 值,而非用以生產或提供貨物或服務或作行 政用途又或於日常業務中出售而持有的土地 及樓宇的權益。該等物業初次以成本(包括交 易成本)計量。於初次確認後,投資物業乃按 反映各報告期末的市場狀況之公平值列賬。

投資物業公平值變動所帶來的盈虧於產生的 年度計入損益表。

因投資物業報廢或出售而產生的任何收益或 虧損乃於報廢或出售年度的損益及其他全面 收入內確認。

#### Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

Intangible assets with indefinite useful lives are tested for impairment annually either individually or at the cash-generating unit level. Such intangible assets are not amortised. The useful life of an intangible asset with an indefinite life is reviewed annually to determine whether the indefinite life assessment continues to be supportable. If not, the change in the useful life assessment from indefinite to finite is accounted for on a prospective basis.

#### Technical know-how

Acquired technical know-how of manufacturing processes is shown at historical cost. Acquired technical know-how are capitalised on the basis of the costs incurred to acquire the knowhow and are amortised over their estimated useful lives of 10 years.

#### Computer software

Acquired computer software is shown at historical cost and is capitalised on the basis of the costs incurred to acquire the specific software. These costs are amortised over their estimated useful lives of 10 years.

#### Sewage pipe usage right

Acquired sewage pipe usage right is shown at historical cost and is capitalised on the basis of the cost incurred to acquire the usage right. The costs are amortised over the contractual lives of 20 years.

# 無形資產(商譽除外)

個別收購的無形資產於初步確認時按成本計 量。業務合併中所收購無形資產的成本乃該 資產於收購日期的公平值。無形資產的可使 用年期被評估為有限或無限。具有限可使用 年期的無形資產其後在可使用的經濟年期內 作攤銷,並在有跡象顯示無形資產可能已減 值時進行減值評估。具有限可使用年期的無 形資產的攤銷期間及攤銷方法至少於各財務 年度結束時作檢討。

具無限可使用年期的無形資產每年會個別或 在現金產生單位級別作減值測試。該等無形 資產並不予以攤銷。使用年限不確定的無形 資產的可使用年期於每年作評估,以釐定無 限可使用年期的評估是否繼續可靠。倘不再 可靠,則可使用年期的評估自此由按無限年 期更改為有限年期。

#### 技術知識

所獲得有關製造過程的技術知識按歷史成本 值列示。所獲得的技術知識按獲得有關知識 所產生的成本撥充資本,並於10年估計可使 用年期內攤銷。

#### 計算機軟件

所獲得的計算機軟件按歷史成本值列示,並 按獲得指定軟件所產生的成本撥充資本。該 等成本於10年估計可使用年期內攤銷。

#### 污水渠使用權

所獲得的污水渠使用權按歷史成本值列示, 並按獲得有關使用權所產生的成本撥充資 本。有關成本於20年合約年期內攤銷。

#### Contract backlog

Contract backlog acquired as part of business combinations was valued of fair value based on present value technique. Contract backlog was amortised over the period up to the completion of each of the contracts.

#### Brand

Brand acquired as part of business combinations was valued at fair value based on the relief from the royalty method. Brand was considered as the main attributes to the revenue and future growth of the Group's RMAA Service in Hong Kong, and thus are recognised as intangible assets with indefinite useful lines and tested for impairment annually.

#### Research and development costs

All research costs are charged to the statement of profit or loss as incurred.

Expenditure incurred on projects to develop new products is capitalised and deferred only when the Group can demonstrate the technical feasibility of completing the intangible asset so that it will be available for use or sale, its intention to complete and its ability to use or sell the asset, how the asset will generate future economic benefits, the availability of resources to complete the project and the ability to measure reliably the expenditure during the development. Product development expenditure which does not meet these criteria is expensed when incurred.

## 未完工合約

作為業務合併一部分所獲得的未完工合約根 據現值技術按公平值進行估值。未完工合約 在每個合同完工之前的期間內攤銷。

## 品牌

作為業務合併一部分所獲得的品牌乃基於減 免特許權使用費的方法,按公平值進行估值。 品牌被視為本集團在香港的RMAA服務的收 入及未來增長的主要來源,因此被確認為具 有無限使用年期的無形資產,並每年進行減 值測試。

### 研發成本

所有研究費用於產生時在損益表扣除。

開發新產品項目產生的開支僅當以下各項得 到證明時方可資本化並遞延:本集團在技術 可行性上可完成無形資產以使其能供使用或 出售;有完成該資產的意圖,並有能力使用或 出售該資產;該資產能產生未來經濟利益;具 有可用資源完成項目以及於開發階段的開支 能夠可靠地計量。不符合該等準則的產品開 發開支均於產生時支銷。

#### Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

#### Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

#### (a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

#### 本集團作為承租人

#### (b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset. The Group's lease liabilities are included in interest-bearing bank and other borrowings.

#### (b) 租賃負債

租賃負債於租賃開始日期按於租賃期內 作出之租賃付款現值確認。租賃付款包 括固定付款(包括實質固定付款)減任何 應收租賃優惠、取決於某一指數或比率 之可變租賃付款及預期根據剩餘價值擔 保將支付之金額。租賃付款亦包括本集 團合理確定行使購買選擇權之行使價, 倘租賃期反映了本集團行使終止選擇 權,則須就終止租賃支付罰款。並非取 決於某一指數或比率之可變租賃付款於 發生觸發付款之事件或狀況期間確認為 開支。

計算租賃付款的現值時,因為租賃隱含 的利率不能可靠釐定,本集團使用於租 賃開始日期的增量借款利率。於租賃開 始日期後,租賃負債金額為反映利 增加而增加,並因作出的租賃付款而減 少。此外,倘出現修訂、租賃期出現變 動、租賃付款出現變動(例如指數或利 率出現變動導致未來租賃付款出現變 動)或購買相關資產的選擇權的評估出 現變動,則重新計量租賃負債的賬面 值。本集團租賃負債包括計息銀行及其 他借款。

(c) Short-term leases

The Group applies the short-term lease recognition exemption to its short-term leases of machinery and equipment (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option).

Lease payments on short-term leases are recognised as an expense on a straight-line basis over the lease term.

#### Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in revenue in the statement of profit or loss and other comprehensive income due to its operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

Leases that transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee, are accounted for as finance leases.

(c) 短期租賃

本集團將短期租賃確認豁免應用於其機 器及設備短期租賃(即租賃期為自開始 日期起計12個月或以下且不包含購買選 擇權的租賃)。

短期租賃的租賃付款於租期內按直線法確認 為開支。

#### 本集團作為出租人

當本集團作為出租人時,其租賃於租賃開始 (或倘有租賃修訂)時各自分類為經營租賃或 融資租賃。

所有本集團並未轉讓資產所有權所附帶的絕 大部分風險及回報的租賃歸類為經營租賃。 當合約包含租賃及非租賃部分時,本集團按 相關一次性售價基準於合約中將代價分配至 各部分。租金收入於租期內按直線法列賬並 由於其營運性質計入損益及其他全面收入表 之收入。於磋商及安排經營租賃時產生的初 始直接成本乃計入租賃資產的賬面值,並於 租期內按相同方法確認為租金收入。或然租 金乃於所賺取的期間內確認為收益。

當相關資產的絕大部分風險及回報擁有權轉 讓至承租人時,該租賃入賬作為融資租賃。

## Investments and other financial assets

#### Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income, and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under IFRS 15 in accordance with the policies set out for "Revenue recognition" below.

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

#### 初步確認及計量

金融資產於初步確認時分類,其後按攤銷成 本、按公平值計入其他全面收入及按公平值 計入損益計量。

金融資產於初步確認時的分類視乎金融資產 的合約現金流特徵及本集團管理金融資產的 業務模式而定。除不含重大融資部分或本集 團已採用實際權宜方法不予調整重大融資部 分的影響之貿易應收款項外,本集團初步按 公平值加上(就並非按公平值計入損益的金融 資產而言)交易成本計量金融資產。根據下文 「收益確認」所載的政策,不含重大融資部分 或本集團已採用實際權宜方法之貿易應收款 項按根據國際財務報告準則第15號釐定的交 易價計量。

為使金融資產按攤銷成本或按公平值計入其 他全面收入進行分類及計量,需就未償還本 金產生純粹支付本金及利息(「純粹支付本金 及利息」)現金流量。現金流量並非純粹支付 本金及利息的金融資產,不論其業務模式如 何,均按公平值計入損益進行分類及計量。

本集團管理金融資產的業務模式指其如何管 理其金融資產以產生現金流量。業務模式確 定現金流量是否來自收集合約現金流量、出 售金融資產,或兩者兼有。持有金融資產的目 的乃為收集現金合約流量的業務模式按攤銷 成本分類及計量金融資產,而持有金融資產 的目的乃為收集合約現金流量及出售金融資 產而持有兩者的業務模式按公平值計入其他 業務模式持有的金融資產。並非按上述 分類及計量金融資產。

#### Initial recognition and measurement (Continued)

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

#### Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

#### Financial assets at amortised cost (debt instruments)

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in the statement of profit or loss when the asset is derecognised, modified or impaired.

# Financial assets at fair value through other comprehensive income (debt instruments)

For debt investments at fair value through other comprehensive income, interest income, foreign exchange revaluation and impairment losses or reversals are recognised in the statement of profit or loss and computed in the same manner as for financial assets measured at amortised cost. The remaining fair value changes are recognised in other comprehensive income. Upon derecognition, the cumulative fair value change recognised in other comprehensive income is recycled to the statement of profit or loss.

金融資產的所有常規購買及出售於交易日(即 本集團承諾購買或出售該資產之日)確認。常 規購買或出售指需要在一般由法規或市場慣 例確立的期間內移交資產的金融資產購買或 出售。

#### 後續計量

金融資產的後續計量視乎其下列分類而定:

按攤銷成本計量的金融資產(債務工具)

按攤銷成本計量的金融資產其後使用實際利 率法計量,並可能受減值影響。當資產終止確 認、修訂或減值時,收益及虧損於損益表中確 認。

Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss includes assets management debt investment are carried in the statement of financial position at fair value with net changes in fair value recognised in the statement of profit or loss.

## **Derecognition of financial assets**

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- he rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

#### Impairment of financial assets

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

#### General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

倘本集團已轉讓從資產收取現金流量的權利 或訂立過手安排,則評估有否保留資產所有 權的風險和回報及保留程度。倘本集團並無 轉讓或保留資產的絕大部分風險及回報,亦 無轉讓資產控制權,本集團以本集團持續參 與程度為限繼續確認所轉讓資產。在該情況 下,本集團亦確認相關負債。已轉讓資產及相 關負債根據反映本集團所保留權利及責任的 基準計量。

預期信貸虧損分兩個階段確認。就首次確認 以來信貸風險並無大幅增加的信貸敞口而 言,會為未來12個月(12個月預期信貸虧損) 可能發生的違約事件所產生的信貸虧損計 提預期信貸虧損撥備。就首次確認以來信貸 風險大幅增加的信貸敞口而言,須就預期於 敞口的餘下年期產生的信貸虧損計提減值撥 備,不論違約的時間(全期預期信貸虧損)。

#### General approach (Continued)

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Debt investments at fair value through other comprehensive income and financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables and contract assets which apply the simplified approach as detailed below.

本集團於各報告日期評估金融工具的信貸風 險自初始確認後是否已顯著增加。在進行有 關評估時,本集團會就金融工具於報告日期 發生違約的風險與金融工具於首次確認當日 發生違約的風險進行比較及會考慮合理且可 靠並毋須付出不必要的成本或努力即可獲得 的資料,包括過往及前膽性的資料。

本集團認為,倘合約已逾期還款90天,則金融 資產違約。然而,在若干情況下,倘內部或外 部資料反映,在計及本集團持有的任何信貸 提升措施前,本集團不大可能悉數收到未償 還合約款項,則本集團亦可認為金融資產違 約。倘無法合理預期收回合約現金流量,則撇 銷金融資產。

按公平值計入其他全面收入及金融資產按攤 銷成本進行的債務投資在一般方法下或會發 生減值,且除應用簡化方法的貿易應收款項 及合約資產外,其就計量預期信貸虧損分類 為以下步驟,如下文所述。

- Stage 1 Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs
- Stage 2 Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs
- Stage 3 Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

#### Simplified approach

For trade receivables and contract assets that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

### 簡化法

對於並未包含重大融資成分的貿易應收款項 及合約資產,或當本集團應用不調整重大融 資成分影響的實際權宜方法時,本集團應用 簡化法計算預期信貸虧損。根據簡化法,本集 團並無追蹤信貸風險的變化,反而於各報告 日期根據全期預期信貸虧損確認虧損撥備。 本集團已根據其過往信貸虧損經驗,建立撥 備矩陣,並就債務人及經濟環境的特定前瞻 性因素作出調整。

## **Financial liabilities**

#### Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, payables, or as derivatives designated as hedging instruments in an effective hedge, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include trade and other payables, lease liabilities and interest-bearing bank and other borrowings.

#### Subsequent measurement

The subsequent measurement of financial liabilities depends on their classification as follows:

#### Financial liabilities at amortised cost (loans and borrowings)

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of profit or loss.

# 金融負債

#### 初步確認及計量

金融負債於初步確認時歸類為按公平值計入 損益的金融負債、貸款及借款、應付款項或指 定為實質對沖工具的衍生工具(如適用)。

所有金融負債初步按公平值確認及倘為貸款 及借款以及應付款項,則應扣除直接應佔交 易成本。

本集團之金融負債包括貿易及其他應付款 項、租賃負債以及計息銀行及其他借款。

## 其後計量

金融負債之其後計量取決於其下列分類:

#### 按攤銷成本列賬的金融負債(貸款及借款)

初步確認後,計息貸款及借款隨後使用實際 利率法按攤銷成本計量,惟倘折現影響並不 重大,則按成本列賬。收益及虧損於終止確認 負債時透過實際利率攤銷過程於損益表中確 認。

計算攤銷成本時已計及任何收購折讓或溢 價,及屬實際利率不可或缺部分的費用或成 本。實際利率攤銷則計入損益表的融資成本。

#### **Derecognition of financial liabilities**

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

#### Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

#### **Properties under development**

Properties under development are intended to be held for sale after completion.

Properties under development are stated at the lower of cost comprising land costs, construction costs, borrowing costs, and other costs directly attributable to such properties incurred during the development period and net realisable value.

Properties under development are classified as current assets unless they will not be realised in the normal operating cycle. On completion, the properties are transferred to completed properties held for sale.

金融負債於負債責任解除、取消或屆滿時終 止確認。

倘現有金融負債被另一項由同一貸款人提供 而絕大部分條款不同的負債所取代,或現有 負債的條款遭大幅修訂,則有關取代或修訂 以終止確認原有負債及確認新負債的方式處 理,而相關賬面值的差額於損益表中確認。

## 抵銷金融工具

倘現時有可執行的法定權利抵銷已確認金額 且有意按淨額基準結算,或同時變現資產及 結算負債,則金融資產與金融負債可抵銷且 淨額於財務狀況表呈報。

## 發展中物業

發展中物業乃擬於完工後持作銷售。

發展中物業乃按成本(包括土地成本、建築成 本、借貸成本及該物業在發展期間直接應佔 的其他成本)及可變現淨值兩者的較低者列 賬。

發展中物業列為流動資產,除非其不會在正 常經營周期內變現。完成時,該物業轉撥至持 作出售的已竣工物業。

## Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined by the weighted average method. Cost of finished goods comprises direct materials, direct labour and an appropriate proportion of overheads. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

## **Cash and cash equivalents**

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amount of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

# 存貨

存貨按成本與可變現淨值的較低者列賬。成 本使用加權平均法釐定,就製成品而言包括 直接材料、直接勞工及適當部分的生產開支。 可變現淨值乃按估計售價減完成及出售所產 生的任何估計成本計算。

# 現金及現金等值物

就合併現金流量表而言,現金及現金等值物 由手頭現金及活期存款組成,及可隨時轉換 成已知金額現金、價值變動風險不大且獲取 時一般具有不超過三個月短暫有效期的短期 高流通投資,再扣除須於要求時償還且為本 集團現金管理所包含的銀行透支。

就合併財務狀況表而言,現金及現金等值物 由所持不限用途的手頭現金及銀行存款(包括 定期存款)以及性質與現金類似的資產組成。

### **Provisions**

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in profit or loss.

### **Income tax**

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amount for financial reporting purposes.

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of deductible temporary differences associated with investments in subsidiaries and the joint venture, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amount of deferred tax liabilities or assets are expected to be settled or recovered.

## **Government grants**

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

Where the grant relates to an asset, the fair value is credited to a deferred income account and is released to the statement of profit or loss over the expected useful life of the relevant asset by equal annual instalments or deducted from the carrying amount of the asset and released to the statement of profit or loss by way of a reduced depreciation charge.

## **Revenue recognition**

#### Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in IFRS 15.

#### Revenue from contracts with customers (Continued)

(a) Sale of industrial products

Revenue from the sale of industrial products is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the industrial products.

(b) Processing services

Revenue from the provision of processing services is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the processed products.

(c) Construction services

Revenue from the provision of construction services is recognised over time, using an input method to measure progress towards complete satisfaction of the service, because the Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced. The input method recognises revenue based on the proportion of the actual costs incurred relative to the estimated total costs for satisfaction of the construction services.

#### Revenue from other sources

Rental income is recognised on a time proportion basis over the lease terms. Variable lease payments that do not depend on an index or a rate are recognised as income in the accounting period in which they are incurred.

### Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Dividend income is recognised when the shareholders' right to receive payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

## **Contract assets**

A contract asset is the right to consideration in exchange for goods or services transferred to the customer. If the Group performs by transferring goods or services to a customer before the customer pays consideration or before payment is due, a contract asset is recognised for the earned consideration that is conditional. Contract assets are subject to impairment assessment, details of which are included in the accounting policies for impairment of financial assets.

## **Contract liabilities**

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

## **Contract costs**

Other than the costs which are capitalised as inventories, property, plant and equipment and intangible assets, costs incurred to fulfil a contract with a customer are capitalised as an asset if all of the following criteria are met:

- (a) The costs relate directly to a contract or to an anticipated contract that the entity can specifically identify.
- (b) The costs generate or enhance resources of the entity that will be used in satisfying (or in continuing to satisfy) performance obligations in the future.
- (c) The costs are expected to be recovered.

The capitalised contract costs are amortised and charged to the statement of profit or loss on a systematic basis that is consistent with the transfer to the customer of the goods or services to which the asset relates. Other contract costs are expensed as incurred.

## Share-based payments

The Company operates a share option scheme for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Employees (including directors) of the Group receive remuneration in the form of share-based payments, whereby employees render services as consideration for equity instruments ("equity-settled transactions").

# 合約成本

The cost of equity-settled transactions is recognised in employee benefit expense, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to the statement of profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

The dilutive effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

## Other employee benefits

### Pension scheme

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for its employees of the Group's subsidiaries which operate in the Hong Kong. Contributions are made based on a percentage of the employees' basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

## **Borrowing costs**

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

## **Dividends**

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the financial statements.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

## 退休金計劃

These financial statements are presented in Renminbi. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a nonmonetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

# 外幣

## **Foreign currencies (Continued)**

The functional currencies of certain overseas subsidiaries are currencies other than the RMB. As at the end of the reporting period, the assets and liabilities of these entities are translated into RMB at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into RMB at the weighted average exchange rates for the year.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in the statement of profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amount of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

For the purpose of the consolidated statement of cash flows, the cash flows of overseas subsidiaries are translated into Renminbi at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of overseas subsidiaries which arise throughout the year are translated into Renminbi at the weighted average exchange rates for the year.

# 3. SIGNIFICANT ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amount of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amount of the assets or liabilities affected in the future.

## **Judgements**

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

### Revenue recognition for construction contracts

For the year ended 31 December 2020, the Group recognised revenue from construction contracting and the related businesses amounting to RMB185,115,000 (2019: RMB107,570,000). The Group has recognised revenue from the provision of construction services over time, using an input method to measure the progress towards complete satisfaction of the service, because the Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced. The input method recognises revenue based on the proportion of the actual costs incurred relative to the estimated total costs for satisfaction of the construction services. This involves the use of management judgements and estimation uncertainty, including estimating the progress towards completion of the services, scope of deliveries and services required, total contract costs incurred and forecasts in relation to costs to complete and profit margin.

## 建築合約的收益確認

於截至二零二零年十二月三十一日止年度, 本集團確認來自建築承包及相關業務的收益 人民幣185,115,000元 (二零一九年:人民幣 107,570,000元)。本集團已按時間確認來自 提供建設服務的收益,即使用輸入法計量完 全達致服務的進度,此乃由於本集團履約創 建及強化一項資產,該資產於創建及強化時 由客戶控制。相對達致建設服務的估計總成 收益。此乃涉及使用管理層之判斷及估計不 確定性,包括估計服務完成之進度、所提供服 務的範圍及所需服務、所產生之合約總成本 及預計直至完工所需的成本及利潤率。

## **Estimation uncertainty**

## Measurement of progress towards complete satisfaction of performance obligation

The Group recognises contract revenue and relevant direct costs according to management's estimation of the progress and outcome of a project. Estimated revenue is determined in accordance with the terms set out in the relevant contracts or, in the case of variation orders, based on contract terms or other forms of agreements. Estimated direct costs, which mainly comprise direct labour cost, subcontracting charges and costs of materials, are variable and estimated by the directors of the Company according to the amount of direct labour, subcontracting charges and costs of materials incurred from time to time based on quotations provided by the major subcontractors/suppliers/ vendors involved and the experience of the directors of the Company. Notwithstanding that the directors of the Company frequently review and revise the estimates of both the estimated revenue and direct costs as the contracts progress, changes in estimates or the actual outcome will affect the carrying amounts of contract assets/contract liabilities with the corresponding adjustments to future revenue and/or direct costs.

## Provision for expected credit losses on trade receivables and contract assets

The Group uses a provision matrix to calculate ECLs for trade receivables and contract assets. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns by geographical region.

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. For instance, if forecast economic conditions are expected to deteriorate over the next year which can lead to an increased number of defaults in the manufacturing sector, the historical default rates are adjusted. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

# 估計不明朗因素

### 計量履約責任的完成進度

本集團根據管理層對項目進度及結果的估算 確認合約收益及相關直接成本。估計收益乃 按照相關合約所載的條款釐定,或如為工程 變更訂單,則按照合約條款或其他形式的協 議釐定。估計直接成本(主要包括直接勞工成 本、分包費用及物料成本)變化不定,由本公 司董事按照主要分包商/供應商/商戶所提 供報價而不時產生的直接勞工金額、分包費 用及物料成本及其自身經驗作出估計。儘管 本公司董事隨著合約進度頻繁審閱及修訂估 計收益及估計直接成本,估計變動或實際結 果將影響合約資產/合約負債的賬面值以及 未來收益及/或直接成本的相應調整。

### 貿易應收款項及合約資產預期信貸虧損撥備

本集團使用撥備矩陣計算貿易應收款項及合約資產之預期信貸虧損。撥備率乃基於按地 區劃分將具相似虧損模式之各個客戶分部進 行分組之逾期天數計算。

撥備率最初基於本集團的歷史觀察違約率。 本集團將調整矩陣,以結合前瞻性資料調整 過往信貸虧損經驗。例如,如果預期經濟狀況 將在未來一年內惡化,這可能導致製造業違 約數量增加,歷史違約率將被調整。於各報告 日期,已更新歷史觀察違約率及分析前瞻性 估計之變動。

## **Estimation uncertainty (Continued)**

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future. The information about the ECLs on the Group's trade receivables and contract assets is disclosed in note 21 and note 23 to the financial statements, respectively.

### Provision for expected credit losses on loan receivables

The Group calculate ECLs for loan receivables by considering the probability of default and the loss given default. The probability of default based on average cumulative issuer-weighted global default rates and the loss given default based on average debt recovery rates issued by Moody's Investors Service. The Group uses judgement in making these assumptions and selecting inputs to the ECLs calculations, based on the credit rating of the debtor which is accessed by the Group using Moody's Rating Methodology.

### Impairment of goodwill

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the value in use of the cash-generating units to which the goodwill is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating units and also to choose a suitable discount rate in order to calculate the present value of those cash flows. The carrying amount of goodwill at 31 December 2020 was RMB99,514,000 (2019: RMB105,923,000). Further details are given in note 17 to the consolidated financial statements.

# 估計不明朗因素(續)

歷史觀察違約率、預測經濟狀況及預期信貸 虧損相關性之評估屬重大估計。預期信貸虧 損之金額對環境及預測經濟狀況之變動敏 感。本集團的過往信貸虧損經驗及經濟狀況 預測亦未必能反映客戶日後的實際違約可 能。有關本集團貿易應收款項及合約資產預 期信貸虧損之資料分別於財務報表附註21及 附註23披露。

## 應收貸款預期信貸虧損撥備

本集團透過考慮違約可能性及違約虧損率計 算應收貸款預期信貸虧損。違約可能性基於 平均累計發行人加權全球違約率,而違約虧 損率基於穆迪投資者服務發佈的平均債務收 回率。本集團於作出該等假設及選擇計算預 期信貸虧損的輸入數據時使用判斷,有關判 斷基於本集團運用穆迪評級方法獲取的債務 人信貸評級。

## 商譽減值

本集團每年最少進行一次評估以釐定有否商 譽減值。此須就獲分配商譽的現金產生單位 的使用價值而作出評估。本集團須評估現金 產生單位的預期未來現金流量,以估計使用 價值,並選擇合適的貼現率計算該等現金流 量的現值。於二零二零年十二月三十一日,商 譽賬面值為人民幣99,514,000元(二零一九 年:人民幣105,923,000元)。進一步詳情載列 於合併財務報表附註17。

# Impairment of intangible assets with indefinite useful lives

The Group determines whether intangible assets with indefinite useful lives are impaired at least on an annual basis. This requires an estimation of the recoverable amount of the intangible assets with indefinite useful lives. Estimating the recoverable amount requires the Group to make an estimate of the expected future cash flows from intangible assets with indefinite useful lives and also to choose a suitable discount rate in order to calculate the present value of those cash flows. The carrying amount of intangible assets with indefinite useful lives at 31 December 2020 was RMB54,817,000 (2019: RMB58,347,000). Further details are given in note 18 to the consolidated financial statements.

## Estimate of fair value of investment properties

Investment properties under construction carried at fair value based on the appraised market value provided by independent professional valuers. Such valuation was based on certain assumptions, which are subject to uncertainty and might differ from actual results. In making the estimation, the Group considers information from current rental prices in an active market for similar properties and uses assumptions that are mainly based on market conditions existing at the end of the year.

The principal assumptions for the Group's estimation of the fair value of the completed investment properties include those related to estimated rental values with reference to the current market rents for similar properties in the same location and condition, and discount rates that reflect current market assessments of the uncertainty in the amount and timing of the cash flows.

At 31 December 2020, the carrying amount of investment properties was RMB755,323,000 (31 December 2019: RMB654,698,000). Further details, including the key assumptions used for fair value measurement and a sensitivity analysis, are given in note 15 to the consolidated financial statements.

- Processing: Dyeing and processing of differentiated polyester filament fabric
   Properties Investment, development and sale of properties investment:
- RMAA Service: Provision of construction services in building construction, building maintenance and improvement works, renovation and decoration works
- Environmental water project operation:
- Consultancy services and sale of machineries
   related to environmental protection, including operation and maintenance services (new in 2020)

Management monitors the results of the Group's operating segments separately for the purpose of making decisions about resource allocation and performance assessment. Segment performance is evaluated based on profit before tax without allocation of interest income/costs and other expenses which are not incurred directly for operating segments.

Segment assets exclude corporate cash and deferred tax assets as these assets are managed on a group basis.

Segment liabilities exclude corporate accruals, payroll payable, deferred tax liabilities and income tax payable as these liabilities are managed on a group basis.

Intersegment sales and transfers are transacted with reference to the selling prices used for sales made to third parties at the then prevailing market prices.

All of the Group's subsidiaries incorporated in Hong Kong are subject to profits tax at a rate of 16.5% (2019:16.5%) on the estimated assessable profits arising in Hong Kong during the year, except for one subsidiary of the Group which is a qualifying entity under the two-tiered profits tax rates regime. The first HK\$2,000,000 (2019: HK\$2,000,000) of assessable profits of this subsidiary are taxed at 8.25% (2019: 8.25%) and the remaining assessable profits are taxed at 16.5% (2019: 16.5%).

A subsidiary of the Group incorporated in Malaysia is subject to profits tax at a rate of 24%.No provision for taxation in Malaysia has been made, as the subsidiary did not generate any assessable profits arising in Malaysia for the year ended 31 December 2020.

A subsidiary of the Group incorporated in Cambodia is subject to profits tax at a rate of 20%. No provision for taxation in Cambodia has been made, as the subsidiary did not generate any assessable profits arising in Cambodia for the year ended 31 December 2020.

A subsidiary of the Group incorporated in Myanmar is subject to profits tax at a rate 25%. No provision for taxation in Myanmar has been made, as the subsidiary did not generate any assessable profits arising in Myanmar for the year ended 31 December 2020.

All of the Group's subsidiaries registered in the PRC having operations only in Mainland China are subject to the PRC enterprise income tax on the taxable income as reported in their PRC statutory accounts adjusted in accordance with relevant PRC income tax laws. The PRC Enterprise Income Tax Law introduced a wide range of changes which include, but are not limited to, the unification of the income tax rates for domestic-invested and foreign-invested enterprises at 25%.

Pursuant to the relevant laws and regulations in the PRC and with the approval from the tax authorities in charge, one of the Group's subsidiaries, Yongsheng Dyeing, qualified as a High and New Technology Enterprise, is entitled to the preferential enterprise income tax rate of 15% for three years from 2018 to 2020.

本集團所有於中國註冊並僅於中國內地營運 的附屬公司須就其於中國法定賬目(根據相關 中國所得稅法作出調整)內呈報的應課稅收入 繳納中國企業所得稅。中國企業所得稅法引 入一系列改革,包括但不限於將境內投資及 外資企業的所得稅率統一為25%。

根據中國相關法律及法規以及經負責稅務機 關批准,本集團其中一間附屬公司永盛染整 合資格成為高新技術企業,有權於二零一八 年至二零二零年三年間享有15%的優惠企業 所得稅率。

Pursuant to the PRC Enterprise Income Tax Law, a 10% withholding tax is levied on the dividends declared to foreign investors from the foreign investment enterprises established in the PRC. The requirement is effective from 1 January 2008 and applies to earnings after 31 December 2007. A lower withholding tax rate may be applied if there is a tax treaty between the PRC and the jurisdiction of the foreign investors. The Group is therefore liable to 5% withholding taxes on dividends distributed by those subsidiaries established in the PRC in respect of their earnings generated from 1 January 2008. The aggregate amount of temporary differences associated with investments in subsidiaries in Mainland China for which deferred tax liabilities have not been recognised totalled approximately RMB96,720,000 at 31 December 2020 (2019: RMB96,720,000). In the opinion of the directors, it is not probable that these subsidiaries will distribute such earnings in the foreseeable future.

# **11. DISCONTINUED OPERATIONS**

On 18 October 2019, the Company announced the decision to dispose of the entire interests in the subsidiaries engaged in the development and manufacture of polyester filament yarns and the research of high polymer advanced materials. The Group has decided to cease its polyester filament yarn business because it plans to focus its resources on its dyeing services segment and strengthen its liquidity for future investment opportunities. The disposal of the three companies had been completed in November 2019 and the liquidation of one company had been completed in August 2019 with Hangzhou Huvis Yongsheng Chemical Fiber Company Limited ("Hangzhou Fiber"), Nantong Yongsheng Fiber Advanced Materials Company Limited ("Nantong Fiber"), Jiangsu Yongsheng High Polymer Advanced Materials ("Yongsheng High Polymer") and Research Institute Company Limited being classified as discontinued operations.

The Group's investment properties consist of two commercial properties in Hangzhou, the PRC. The Group's investment properties were revalued on 31 December 2020 based on valuations performed by Avista Valuation Advisory Limited ("Avista"), an independent professionally qualified valuer, at RMB755,323,000. Selection criteria include market knowledge, reputation, independence and whether professional standards are maintained. The Group's finance manager and the chief financial officer have discussions with the valuer on the valuation assumptions and valuation results when the valuation is performed for financial reporting.

The completed investment properties are leased to third parties under operating leases, further summary details of which are included in note 16 to the financial statements.

For completed commercial properties, fair values are generally derived using the term and reversionary method. This method is based on the tenancy agreements as at the respective valuation dates. The rental income derived within the tenancy agreements is discounted by adopting term yields and the potential reversionary income is discounted by adopting appropriate reversionary yields for the period beyond the rental period in the tenancy agreements. Potential reversionary income and the reversionary yields are derived from analysis of prevailing market rents and the valuer's interpretation of prevailing investor requirements or expectations. The prevailing market rents adopted in the valuation were determined with refer to recent lettings, within the subject properties and other comparable properties.

A significant increase (decrease) in the market rent per month would result in a significant increase (decrease) in the fair value of the investment properties. A significant increase (decrease) in the term yield and the reversionary yield in isolation would result in a significant decrease (increase) in the fair value of the investment properties.

Fair values of the investment properties under development are generally derived using the residual method. This valuation method is essentially a means of valuing the construction with reference to its development potential by deducting development costs and developer's profit and risk from the estimated capital value of the proposed development assuming completed as at the date of valuation.

A significant increase (decrease) in the market rent per month would result in a significant increase (decrease) in the fair value of the investment properties. A significant increase (decrease) in the reversionary yield, budgeted construction costs to be incurred per month and developer's profit in isolation would result in a significant decrease (increase) in the fair value of the investment properties.

# **34. SHARE OPTION SCHEME**

The Company operates a share option scheme (the "Scheme") for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Eligible participants of the Scheme include the Company's directors and other employees of the Group. The Scheme became effective on 7 November 2013.

The maximum number of unexercised share options currently permitted to be granted under the Scheme is an amount equivalent, upon their exercise, to 30% of the shares of the Company in issue at any time. The maximum number of shares issuable under share options to each eligible participant in the Scheme is limited to 10% of the shares of the Company in issue on 27 November 2013, the day since which the Company's shares have been listed on the Stock Exchange of Hong Kong Limited.

Share options granted to a director, chief executive, are subject to approval in advance by the independent non-executive directors. In addition, any share options granted to a substantial shareholder or an independent non-executive director of the Company, or to any of their associates, in excess of 0.1% of the shares of the Company in issue at any time or with an aggregate value (based on the price of the Company's shares at the date of grant) in excess of HK\$5 million, within any 12-month period, are subject to shareholders' approval in advance in a general meeting.

The offer of a grant of share options may be accepted within 7 days from the date of offer, upon payment of a nominal consideration of HK\$1 in total by the grantee. The exercise period of the share options granted is determinable by the directors, and commences after a vesting period of not shorter than 12 months and ends on a date which is not later than 10 years from the date of offer of the share options.

The exercise price of share options is determined at the highest of (i) the Stock Exchange closing price of the Company's shares on the date of offer of the share options; (ii) the average Stock Exchange closing price of the Company's shares for the five trading days immediately preceding the date of offer; and (iii) the par value of shares.

Share options do not confer rights on the holders to dividends or to vote at shareholders' meetings.

On 6 January 2015, 15,000,000 share options were granted to 39 employees with vesting dates falling from 2 April 2016 to 5 January 2025 and an exercise price of HK\$1.48 per share. The expiration date of the options granted falls within 10 years after the grant date.

On 30 December 2015, 16,300,000 share options were granted to 45 employees with vesting dates falling from 1 April 2017 to 30 December 2025 and an exercise price of HK\$1.52 per share. The expiration date of the options granted falls within 10 years after the grant date.

Subject to certain restrictions set out in the Company Law of the PRC, part of the statutory surplus reserve may be converted to increase share capital, provided that the remaining balance after the capitalisation is not less than 25% of the registered capital.

The foreign currency translation reserve comprises all foreign exchange differences arising from the translation of the financial statements of operations with a functional currency other than RMB.

Other reserve represents (i) the gains/(losses) arising from transactions with non-controlling interests, (ii) the difference between the fair value of capital contribution received from the non-controlling interests and the proportionate of the carrying amount of the net assets of the respective subsidiaries attributable to owners of the company being deemed disposed of.

On 22 February 2019, the Group acquired a 100% of the equity interest in Summer Power International Inc. and its subsidiary, Widely Construction & Engineering Ltd (collectively referred to as the "Summer Power Group") from an independent third party at a total consideration of RMB176,274,200, which was satisfied by HK\$6,000,000(equivalent to RMB5,134,200) in cash and a consideration of RMB171,140,000, which was determined by reference to a total of 80,000,000 shares of the company issued for this acquisition and the closing price of the Company's shares at the date of completion. The Summer Power Group is principally engaged in providing RMAA Service. The acquisition was made as part of the Group's strategy to expand the construction business.

The valuation is reviewed and approved by the CFO.

The Group's principal financial instruments comprise cash and short-term deposits. The main purpose of these financial instruments is to raise finance for the Group's operations. The Group has various other financial assets and liabilities, such as trade and other receivables and trade and other payables, which arise directly from its operations.

The Group is exposed to foreign currency risk, interest rate risk, credit risk and liquidity risk. The Group's senior management oversees the management of these risks. The board of directors reviews and agrees policies for managing each of these risks, which are summarised below.

#### **Foreign currency risk**

The Group has transactional currency exposures. Such exposures arise from sales or purchases by operating units in currencies other than the units' functional currencies. Approximately 6% (2019: 7%) of the Group's sales were denominated in currencies other than the functional currencies of the operating units making the sale, whilst approximately nil (2019: 4%) of costs were denominated in currencies.

The Group is also exposed to cash flow interest rate risk relates to loan receivables and bank balances carried at prevailing market rates. However, such exposure is minimal to the Group as these loan receivables and bank balances are almost short-term in nature.

#### **Credit risk**

The Group trades mainly with recognised and creditworthy third parties. It is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. In addition, receivable balances are monitored on an ongoing basis. For transactions that are not denominated in the functional currency of the relevant operating unit, the Group does not offer credit terms without the specific approval of senior management.

The credit risk of the Group's other financial assets, which comprise cash and cash equivalents, loan receivables, financial assets at fair value through profit or loss, bills receivable, other receivables and amounts due from related parties, arises from default of the counterparty, with a maximum exposure equal to the carrying amount of these instruments.

The Group expects that there is no significant credit risk associated with loan receivables since the Group reviews the recoverable amount of each individual debtor at the end of each reporting period to ensure the adequate impairment losses are made for irrecoverable amounts.

Since the Group trades only with recognised and creditworthy third parties, there is no requirement for collateral. Concentrations of credit risk are managed by analysis by customer/counterparty and geographical region. There are no significant concentrations of credit risk within the Group as the customer bases of the Group's trade receivables are widely dispersed in different regions.

Further quantitative data in respect of the Group's exposure to credit risk arising from trade receivables, loan receivables and contract assets are disclosed in note 21, 22 and note 23, respectively, to the consolidated financial statements.

#### **Capital management**

The primary objectives of the Group's capital management are to safeguard the Group's ability to continue as a going concern and to maintain a strong credit rating and healthy capital ratios in order to support its business and maximise shareholders' value.

The Group manages its capital structure and makes adjustments to it in light of changes in economic conditions and the risk characteristics of the underlying assets. To maintain or adjust the capital structure, the Group may adjust the dividend payment to shareholders, return capital to shareholders or issue new shares. The Group is not subject to any externally imposed capital requirements. No changes were made in the objectives, policies or processes for managing capital during the years ended 31 December 2020 and 31 December 2019.

The Group regards total shareholders' equity as it's capital and monitors capital using a gearing ratio, which is total debt to total shareholders' equity. Total debt includes interesting bank borrowings. Total shareholders' equity comprises all components of equity attributable to owners of the parent. The Group's policy is to maintain the gearing ratio at a reasonable level.
