The Company has identified McM (HK) CPA Limited ("McM") as the new auditor of the Group to fill the vacancy occasioned by the resignation of Cheng & Cheng. The Company is arranging for the engagement of McM as the new auditor of the Company and will make further announcement in this regard as and when appropriate.
