## **CHANGE OF AUDITOR**

This announcement is made by the board (the “**Board**”) of directors (the “**Directors**”) of Wah Wo Holdings Group Limited (the “**Company**”) pursuant to Rule 13.51(4) of the Rules Governing the Listing of Securities of The Stock Exchange of Hong Kong Limited.

### **RESIGNATION OF AUDITOR**

The Board announces that Ernst & Young (“**EY**”) has resigned as the auditor of the Company with effect from 17 November 2021 as the Company could not reach a consensus with EY on the audit fee in respect of the audit of the Company’s consolidated financial statements for the year ending 31 March 2022.

EY has confirmed in its letter of resignation dated 17 November 2021 that there are no circumstances connected with its resignation that need to be brought to the attention of the shareholders of the Company. The Board and the audit committee of the Company (the “**Audit Committee**”) have also confirmed that there is no disagreements or unresolved matters between EY and the Company (save for the said audit fee), and that there are no other matters in respect of the change of auditor which should be brought to the attention of the shareholders of the Company.

The Board would like to take this opportunity to express its gratitude and appreciation to EY for its professional and quality services rendered to the Company during the past years.

### **APPOINTMENT OF AUDITOR**

The Board further announces that, with the recommendation from the Audit Committee, RSM Hong Kong (“**RSM**”), has been appointed as the auditor of the Company with effect from 17 November 2021 to fill the casual vacancy following the resignation of EY and to hold office until the conclusion of the next annual general meeting of the Company.

The Board believes that the change of auditor will not have any significant impact on the annual audit for the year ending 31 March 2022.

The Board would like to take this opportunity to express its warm welcome to RSM on its appointment as the auditor of the Company.
