The Board and audit committee of the Company ("Audit Committee") also confirmed that, save for the audit fee for the year ending 31 December 2021 as aforesaid, there is no disagreement between KPMG and the Company, and there are no other matters in respect of the change of auditors that need to be brought to the attention of the holders of the securities of the Company.

The Audit Committee has assessed and considered that Elite Partners is eligible and suitable to act as auditors of the Group. The Board, with the recommendation of the Audit Committee, has resolved to appoint Elite Partners as the new auditors of the Group to fill the vacancy arising from the Resignation and hold office with effect from 21 December 2021 and until the conclusion of the next annual general meeting of the Company.

The Board would like to take this opportunity to express a sincere appreciation to KPMG for its professional services and support in the past years and its warm welcome to Elite Partners on its appointment as the auditors of the Company.
