### QUARTERLY ANNOUNCEMENT

This announcement is made by China Putian Food Holding Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rules 13.09(2) and 13.49(3) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcements of the Company dated 30 March 2022, 27 April 2022, 27 May 2022 and 21 June 2022, in respect of (i) the delay in the publication of audited annual results and annual report; (ii) profit warning; (iii) postponement of the board meeting; (iv) suspension of trading; and (v) the announcement of the Company dated 24 June 2022 in respect of the resumption guidance (“**Initial Resumption Guidance**”) (collectively, the “**Announcements**”). Capitalised terms used herein, unless otherwise defined, shall have the same meanings as those defined in the Announcements.

### BUSINESS OPERATIONS

The Group has well established white and black hogs in the Shiti and Xianglixiang farms in Putian, Fujian, for many years. The capacity utilisation rate of farms in Hebei is also increasing gradually. For the sales business, the Group continued to focus more on the retail business as compared to wholesale business by exploring more retail sales channels. The market penetration rate of “Putian Black Pearl” and the high-end brand of the Group, were further improved in Fujian and Beijing with effective promotion measures.

As at the date of this announcement, the business operations of the Group are continuing as usual in all material respects. The Board will continue to assess and monitor the impact of the suspension of trading (if any) on the operations and financial performance of the Company.

## **RESUMPTION GUIDANCE IMPOSED BY THE STOCK EXCHANGE**

As disclosed in the Company's announcement dated 21 June 2022, the Company received the Resumption Guidance from the Stock Exchange on 17 June 2022 setting out the following guidance for the resumption of trading in the Shares:

- (i) publish all outstanding financial results required under the Listing Rules and address any audit modifications;
- (ii) demonstrate the Company's compliance with Rule 13.24 of the Listing Rules; and
- (iii) inform the market of all material information for the Company's shareholders and investors to appraise the Company's position.

The Stock Exchange may modify or supplement the Resumption Guidance if the Company's situation changes.

## **PROGRESS ON THE FULFILMENT OF THE RESUMPTION GUIDANCE**

Pursuant to Rule 13.24A of the Listing Rules, the Board wishes to update the shareholders and potential investors of the Company that, as at the date of this announcement, the latest development on the progress of the Company's efforts to fulfil the Resumption Guidance are as follows:

### **The 2021 Audit and the publication of the 2021 Audited Annual Results**

As stated in the Announcements, the reasons for delay in publication of the 2021 Annual Results are that, among others, the Company is in the process of negotiating with Vandí Investments Limited, a wholly-owned subsidiary of CCB International (Holdings) Limited on the extension of maturity date of the 5% secured Convertible Bond in the aggregate principal amount of HK\$150 million and the 6% secured non-convertible Note in the aggregate principle amount of HK\$110 million, which may constitute inside information and the result of which may affect the 2021 Annual Results, and (ii) the audit process mainly relating to a possible substantial impairment loss on non-current assets of the Group's cash generating units under a fair value assessment and addressing certain outstanding evidence concerning the Company's ability to continue as a going concern in order to finalise the 2021 Annual Results.

The Board hereby provides an update to the Shareholders and potential investors of the Company that, having considered the latest development and progress of the negotiating process with Vandí Investments Limited and the audit process, additional time is required for the completion of the said negotiation with Vandí Investments Limited and the said audit process in order to finalise the 2021 Annual Results. Hence, it is expected that, subject to any unforeseeable circumstances and assuming that the audit procedure will be completed on or before 29 July 2022, the 2021 Annual Results will be published on or before 29 July 2022.

Due to the delay in the publication of the 2021 Annual Results, it is expected that, subject to any unforeseeable circumstances, the annual report of the Group for the year ended 31 December 2021 will be despatched on or before 19 August 2022. As a result of the further delay in publication of the 2021 Annual Results and despatch of the annual report of the Group for the year ended 31 December 2021, it is expected that the convening of the annual general meeting of the Company will be postponed accordingly.

The Board acknowledges that any delay in publishing the announcement in relation to the 2021 Annual Results will constitute non-compliance with Rule 13.49(1) of the Listing Rules.

Rule 13.49(3) of the Listing Rules provides that where an issuer is unable to issue its preliminary results in accordance with Rules 13.49(1) and (2) of the Listing Rules, it must announce its results based on the financial results that have yet to be agreed with the auditors (so far as the information is available).

After due and careful consideration, the Board is of the view that it may not be appropriate for the Company to publish the unaudited management accounts of the Group for the year ended 31 December 2021 at this stage as they may not accurately reflect the financial performance and position of the Group, and their publication may be misleading and/or confusing to the Shareholders and potential investors of the Company.

## **POSTPONEMENT OF THE BOARD MEETING**

Due to the aforesaid delay in the publication of the 2021 Annual Results, the Board Meeting will be further postponed to another date to be fixed and announced by the Board.

## **CONTINUATION OF TRADING SUSPENSION**

At the request of the Company, trading in the shares of the Company on the Stock Exchange has been suspended since 1 April 2022 and will continue to remain suspended until further notice. Further announcement will be made by the Company in this respect as and when appropriate.

The Company will publish further announcement(s) to inform the shareholders of the Company of its progress in complying with the Resumption Guidance, any significant developments in respect of the publication of the 2021 Audited Annual Results and the expected dates for the publication of the 2020 Audited Annual Results as and when appropriate, as well as quarterly updates on its development pursuant to Rule 13.24A of the Listing Rules.

**Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.**
