PROGRESS OF POTENTIAL RESTRUCTURING AND
CONTINUED SUSPENSION OF TRADING**

This announcement is made by Lerthai Group Limited (In Liquidation) (the “**Company**”) pursuant to Rules 13.09 and 13.24A of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

References are made to the Company’s announcements dated 8 March 2021, 17 March 2021, 20 April 2021, 20 July 2021, 20 October 2021, 28 October 2021, 21 January 2022, 27 January 2022, 20 April 2022 and 30 May 2022 (“**Announcements**”). Terms used herein shall have the same meanings as defined in the Announcements unless otherwise stated.

DELAY IN PUBLICATION OF OUTSTANDING FINANCIAL RESULT

Owing to the limited financial information available to the Liquidators to date, the publication of Company’s annual results namely the 2020 annual report, 2021 interim report and 2021 annual report will be further delayed. The expected date of publication will be announced as and when appropriate.

PROGRESS OF POTENTIAL RESTRUCTURING

The Liquidators were approached by some potential investors who have shown interest in the restructuring of the Company. However, none of these potential investors have expressed further interests to enter into any restructuring framework. As at the date of this announcement, no definitive agreement has been entered into in this regard.

CONTINUED SUSPENSION OF TRADING IN THE SHARES

Trading in the shares of the Company on the Stock Exchange, which has been suspended with effect from 9:00 a.m. on 21 January 2021, remains suspended and will continue to be so until further notice.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.
