The Board further announces that, in accordance with the articles of association of the Company and with the recommendation of the audit committee of the Company, the Board has resolved to appoint Linksfield CPA Limited ("Linksfield") as the new auditor of the Company with effect from 19 January 2023 to fill the casual vacancy arising from the resignation of Moore Stephens. Linksfield will hold office until the conclusion of the next annual general meeting of the Company.
