The Audit Committee has considered a number of factors in assessing the Appointment in accordance with their duties stated in the terms of reference of the Audit Committee, including but not limited to (i) the caliber of BDO including its experience in handling audit work for companies listed on the Stock Exchange, its familiarity with the requirements under the Listing Rules and the International Financial Reporting Standards; (ii) the audit plan of BDO; (iii) its independence and objectivity; (iv) its reputation in the market; (v) its resources and capability; and (vi) the guidelines issued by the Accounting and Financial Reporting Council.

The Audit Committee has noted that BDO has extensive audit experience for other sizable listed companies in Hong Kong and has engaged in other reporting accountant works for many listed companies. BDO is of high reputation in the market and has a large global network with extensive internal expert support on various industries. The Audit Committee has also assessed the engagement team for the audit of the Group and considered there is sufficient and appropriate resources. Based on the above, the Audit Committee is satisfied that BDO is independent, competent and capable (including manpower, expertise, time and other resources) to perform a high-quality audit.

In view of the relatively lower audit fee chargeable by BDO and the abovementioned qualities, the Board, with the recommendation from the Audit Committee, considered that the Appointment would enhance the cost-effective of the Company's audit fee and is in the interest of the Company and its Shareholders as a whole.
