As set out in the Company's announcement dated 31 October 2023, the Company delayed the publication of the 2023 Annual Results because the Auditor, pending the receipt of the outstanding financial documents, among others, the finalised Investigation Report and the management accounts of Happy Group for the six months ended 30 June 2023, could not be able to ascertain the information required to be contained in the 2023 Annual Results. As a result, the Company has been working closely with the Auditor to facilitate the completion of the remaining audit procedures to publish the 2023 Annual Results as soon as practicable.

The Company and the Auditor had obtained a preliminary draft of the Investigation Report prepared by the Independent Investigator in late September and early October 2023, respectively, and a second draft of the Investigation Report was provided to the Company in early November 2023. As additional time is required by the Independent Investigator to finalise the Investigation Report, which, amongst others, is essential for the Auditor to proceed with its remaining audit work for finalising the 2023 Annual Results, the Company, having discussed with the Auditor, expects that the publication date of the 2023 Annual Results will be further delayed to a date falling on or before 31 December 2023.

POSTPONEMENT OF ADJOURNED BOARD MEETING

Due to the above-said further delay in the publication of the 2023 Annual Results, the Board hereby informs the Shareholders that the date of the adjourned Board Meeting for the purposes of, among others, approving the 2023 Annual Results for publication and considering the recommendation for the payment of a final dividend (if any), will be further postponed to on or before 29 December 2023.
