FURTHER DELAY IN PUBLICATION OF THE 2023 ANNUAL RESULTS

As set out in the Announcements, the Delay was mainly attributable to the (i) outstanding external audit confirmation letters; and (ii) first-year and late engagement of the Auditor. Since the Delay, the Company has been working closely with the Auditor to facilitate the completion of the remaining audit procedures to publish the 2023 Annual Results as soon as practicable. As disclosed in the Announcements, the 2023 Annual Results was originally scheduled to be published on or before 15 December 2023. However, pursuant to an email message provided to the audit committee of the Company by the Auditor on 17 December 2023, the Auditor has requested for a further day to (i) finalize their internal review and approval procedures; and (ii) undergo the internal sign-off approval process. The Auditor expects the 2023 Annual Results will be ready for publication on 18 December 2023. As of the date of this announcement, based on the information currently available to the Company, the 2023 Annual Results is expected to be published on or before the trading session of 19 December 2023 (the "**Further Delay**").

Save for the abovementioned reasons, the Auditor confirmed that there were no other circumstances which lead to any subsequent delay and there are no other disagreements or unresolved matters between the Company in relation to the Further Delay and the audit work for the 2023 Audit Results.
