Hence, the Company wishes to inform its shareholders that the publication of the 2022/23 Audited Annual Results will be further delayed and expected to be published on 19 April 2024.

It is also expected that the despatch of the annual report of the Group for the year ended 31 March 2023 (the "**2022/23 Annual Report**") will be published shortly after the publication of the 2022/23 Audited Annual Results.

As the 2022/23 Audited Annual Results have not been finalised and may have an impact on the 2023/24 Unaudited Interim Results. It is also expected that the despatch of the interim report of the Group for the six months ended 30 September 2023 (the "**2023/24 Interim Report**") will be published shortly after the publication of the 2023/24 Unaudited Interim Results.

#### POSTPONEMENT OF BOARD MEETING

In light of the delay in the publication of the 2022/23 Audited Annual Results, the Board meeting is scheduled to be held on Friday, 19 April 2024 for the purposes of, inter alia, considering and approving the 2022/23 Audited Annual Results and the 2023/24 Unaudited Interim Results.

#### POSTPONEMENT OF ANNUAL GENERAL MEETING

Due to the delay in the despatch of the 2022/23 Annual Report, it is expected that the annual general meeting of the Company will be postponed to the end of June 2024 accordingly.

#### LISTING RULES IMPLICATION

Pursuant to Rules 13.48(1) of the Listing Rules, the Company is required to send the 2023/24 Interim Report to its Shareholders not later than three months after the end of that period of six months.
