As at the date of the AGM, the total number of issued shares of the Company was 660,373,297 shares, which was the total number of shares entitling the holders to attend and vote on the resolutions at the AGM. The numbers of shares represented by the total voting rights present at the AGM were 605,280,376 shares.

There were no shares of the Company entitling the holders to attend and abstain from voting in favour at the AGM as set out in rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") and no shareholders of the Company were required to abstain from voting at the AGM under the Listing Rules.
3. There were no restrictions on any shareholder of the Company to cast votes on any of the proposed resolutions at the AGM.
4. No parties have stated their intention in the circular and the supplemental circular of the Company dated 30th April 2025 and 2nd May 2025 respectively to vote against or to abstain from voting on any resolution at the AGM.
5. Computershare Hong Kong Investor Services Limited, the Company's branch share registrar in Hong Kong, acted as scrutineer for the poll at the AGM.
