If the Company does not receive the signed and properly completed Reply Form or receive a response indicating an objection from you within 30 days from the date hereof and until you inform the Hong Kong Branch Share Registrar by reasonable prior notice in writing or sending a notice by email to husoke704-ecom@vistra.com, you will be deemed to have consented to receiving Website Version and a notification letter of the publication of the Corporate Communication on the Company’s website will be sent to you in the future.
