- (3) TEAM FABULOUS LIMITED is owned and managed by THE CORE TRUST COMPANY LIMITED, the Trustee for IMMVIRA BIOSCIENCE TRUST, the ESOP Trust set up by the Company to facilitate the administration of certain share awards issued under the Share Incentive Plan. Therefore, THE CORE TRUST COMPANY LIMITED is deemed to be interested in the Shares held by TEAM FABULOUS LIMITED under the SFO. Therefore, each of Beijing Huagai, Huagai Healthcare and Huagai Capital is deemed to be interested in the Shares held by Huagai Investment under the SFO.
- (5) HH IMV is wholly owned by HH IMV Holdings, L.P., the sole limited partner of which is Hillhouse Fund IV, L.P., which is managed and controlled by Hillhouse Investment Management, Ltd. Therefore, each of HH IMV Holdings, L.P., Hillhouse Fund IV, L.P. and Hillhouse Investment Management, Ltd. is deemed to be interested in the Shares held by HH IMV under the SFO.
- (6) Triwise Capital are managed by Shenzhen Qianhai, which is ultimately controlled by Dr. Tang Dajie. Therefore, each of Shenzhen Qianhai and Dr. Tang Dajie is deemed to be interested in the Shares held by Triwise Capital under the SFO.
