- (5) Tencent is deemed to be interested in (i) the 111,774,870 Shares held by Linzhi Tencent; (ii) the 80,207,820 Shares held by Shenzhen Litong. Each of Linzhi Tencent and Shenzhen Litong is a subsidiary of Tencent.
- (6) Beijing HongShan Huanxin Management Consulting Center LP (北京紅杉環信管理諮詢中心(有限合伙)) (“**HongShan Huanxin**”), HongShan Jiachen (Xiamen) Equity Investment LP (紅杉嘉辰(廈門)股權投資合夥企業(有限合伙)) (“**HongShan Jiachen**”) and Xiamen Junheng Zhiyuan Capital LP (廈門峻恒致遠投資合夥企業(有限合伙)) (“**HongShan Junheng**”) are limited partnerships established under the laws of the PRC. The general partner of HongShan Huanxin is HongShan Kunde Investment Management Center (Limited Partnership) (北京紅杉坤德投資管理中心(有限合伙)), who is ultimately controlled by Zhou Kui. With HongShan Jiachen, its general partner is Shenzhen HongShan Antai Equity Investment Partnership (Limited Partnership) (深圳紅杉安泰股權投資合夥企業(有限合伙)), whose general partner is Shenzhen HongShan Huanyu Investment Consulting Company Limited (深圳市紅杉恒宇投資諮詢有限公司), it is also ultimately controlled by Zhou Kui. For HongShan Junheng, its general partner is Shanghai Zheyong Investment Center (Limited Partnership) (上海喆酉投資中心(有限合伙)), whose general partner is HongShan Capital Investment Management (Tianjin) Company Limited (紅杉資本股權投資管理(天津)有限公司), it is also ultimately controlled by Zhou Kui.
- (7) The general partner of Starquest Capital is New Starquest Consulting (Shenzhen) Partnership (Limited Partnership) (新星界諮詢顧問(深圳)合夥企業(有限合伙)) whose general partner is Starquest Private Equity Investment Fund Management (Shenzhen) Co., Ltd. (星界私募股權投資基金管理(深圳)有限公司).
