Zhuhai Jierong is a limited partnership established in the PRC. The general partner of Zhuhai Jierong is Mr. Ren who holds approximately 12.68% of its partnership interest, and none of the limited partners of Zhuhai Jierong holds more than one-third of the partnership interest of Zhuhai Jierong.

Zhuhai Jiehua is limited partnership established in the PRC. The general partner of Zhuhai Jiehua is Mr. Ren who holds approximately 18.28% of its partnership interest, and none of the limited partners of Zhuhai Jiehua holds more than one-third of the partnership interest of Zhuhai Jiehua.

By virtue of the SFO, Mr. Ren is deemed to be interested in the Unlisted Shares held by each of Zhuhai Jierong and Zhuhai Jiehua.

- (5) These Unlisted Shares are held by Zhuhai Zhichen. Zhuhai Zhichen is owned as to approximately 1.67% by Mr. Ren and 66.67% by Ms. Xu, the spouse of Mr. Ren. None of the other shareholders of Zhuhai Zhichen holds more than 30% equity interest in Zhuhai Zhichen. By virtue of the SFO, Ms. Xu is deemed to be interested in the Unlisted Shares held by Zhuhai Zhichen. Furthermore, Mr. Ren is deemed to be interested in the same number of Unlisted Shares in which Ms. Xu is interested.
- (6) Ms. Xu is the spouse of Mr. Ren. Under the SFO, each of them is deemed to be interested in the same number of Shares in which his/her spouse is interested.
- (7) These Unlisted Shares are held as to 22,857,140 by Guangdong Gaorui and 14,000,000 by Guangzhou Yingqi.

Guangdong Gaorui is a limited partnership established in the PRC. The general partner of Guangdong Gaorui is Guangdong Gaorui Private Equity Funds Management Co., Ltd. (廣東高瑞私募基金管理有限公司) (“Gaorui PE”) which holds approximately 0.05% of its partnership interest. Gaorui PE is ultimately controlled by Ou Zhanying (歐湛穎). None of the other limited partners holds more than one-third of the partnership interest of Guangdong Gaorui. To the best knowledge and belief of our Directors, Guangdong Gaorui, its general partner, its limited partners and their respective ultimate beneficial owners are Independent Third Parties.

Guangzhou Yingqi is a limited partnership established in the PRC. The general partner of Guangzhou Yingqi is Ou Zhanying (歐湛穎) who holds approximately 71.43% of its partnership interest. Mr. Leong Ka Hou (梁嘉豪) holds the remaining approximately 28.57% of the partnership interest in Guangzhou Yingqi as a limited partner. To the best knowledge and belief of our Directors, Guangzhou Yingqi, its general partner, its limited partner and their respective ultimate beneficial owners are Independent Third Parties.

By virtue of the SFO, Ou Zhanying is deemed to be interested in the Unlisted Shares held by each of Guangdong Gaorui and Guangzhou Yingqi.
