As of the Latest Practicable Date, (i) Biggering Holdings directly held 371,799,937 A Shares and was collectively wholly owned by the Wu Family; and (ii) Happy Union directly held 19,811,263 A Shares and was owned as to 75.82% by the Wu Family and 24.18% by Ms. Mok Yuet Ngor, Candy, an Independent Third Party. Therefore, by virtue of SFO, the Wu Family is deemed to be interested in the Shares held by both Biggering Holdings and Happy Union, which is 391,611,200 A Shares in total.

- (2) As of the Latest Practicable Date, WUS Holdings directly held 216,711,023 A Shares and was wholly owned by WUS TW. Therefore, by virtue of SFO, WUS TW is deemed to be interested in the Shares held by WUS Holdings.
