Remarks:

(1) The Company was listed on GEM on 25th November, 1999. The Company became the holding company of the other companies comprising the Group on 11th November, 1999. The Group's unaudited consolidated results for the nine months ended 31st March, 2000 have been prepared on the basis of merger accounting as if the Company had been the holding company of the other companies comprising the Group throughout the nine months ended 31st March, 2000.

(2) The calculation of basic earnings per share for the nine months ended 31st March, 2001 was based on the unaudited consolidated profit attributable to shareholders of approximately HK\$46,515,000 for the nine months ended 31st March, 2001 and on the 250,000,000 shares in issue during the nine months ended 31st March, 2001.

The calculation of basic earnings per share for the nine months ended 31st March, 2000 was based on the unaudited consolidated profit attributable to shareholders of approximately HK\$19,408,000 for the nine months ended 31st March, 2000 and on the weighted average number of approximately 209,909,000 shares in issue during the nine months ended 31st March, 2000.

(3) Diluted earnings per share for the nine months ended 31st December, 2000 and 2001 was not presented because there were no dilutive potential ordinary shares in existence during the periods.
