### **CLARIFICATION ANNOUNCEMENT**

Goldigit Atom-tech Holdings Limited (the “Company”) refers to its prospectus issued on 29th June, 2001 (the “**Prospectus**”).

The Company notes that the Chinese name of Core Pacific-Yamaichi International (H.K.) Limited, as one of the joint-lead managers of the placing of 425,000,000 shares of the Company (subject to over-allotment), should be “京華山一國際(香港)有限公司” and not “京華山一企業國際(香港)有限公司” as set out on the cover page and the first page of the Chinese version of the Prospectus. The Company regrets the mis-statement.

The Prospectus sets out the correct English name of Core Pacific-Yamaichi International (H.K.) Limited and, in addition, all other pages of the Prospectus bear the correct Chinese name of Core Pacific-Yamaichi International (H.K.) Limited.

The expected timetable as set out in the Prospectus and the announcement of the Company dated 29th June, 2001 remains unchanged. The Stock Exchange has advised the Company and the Sponsor that it reserves rights to take appropriate action in relation to the mis-statement.
