1. Basis of preparation of results

The Company was listed on GEM on 9 July, 2001. The Company became the holding company of the other companies comprising the Group on 9 February, 2001. The Groups's unaudited consolidated results for the nine months ended 30 September, 2001 have been prepared on the basis of merger accounting as if the Company had been the holding company of the other companies comprising the Group throughout the period from 1 January 2000 to 30 September, 2001.

2. Earnings per share

The calculation of the basic earnings per share for the nine months ended 30 September, 2001 is based on the unaudited consolidated net profit attributable to shareholders of approximately HK\$57,899,000 (2000: HK\$279,000) and the weighted average number of 1,468,211,648 (2000: 1,359,860,000) ordinary shares outstanding assuming 1,359,860,000 shares had been in issue since 1 January, 2000.

Diluted earnings per share is not presented for the nine months ended 30 September, 2001 and 2000 as there were no potential dilutive securities in existence during the nine months ended 30 September, 2001 and 2000.
