The Group is principally engaged in the sales and marketing of the products applying the Propulsive Agent technology originally invented and developed by Harbin Institute of Technology which has been solely owned by the Group since 3rd June, 2000. The Propulsive Agent is a chemical solvent agent produced by the Group and applied to paddy pesticides which possess automatic diffusion and propulsion on water surface. It is a type of Chemical Delivery System. The Propulsive Agent technology is based on the chemical theory of super-molecule. At present, the Propulsive Agent technology is applied on two kinds of paddy pesticides which have already been launched in the market, namely Sha Shi Ba and Dao Ying Wen Jing. The Propulsive Agent technology utilises molecular diffusion to disperse chemical ingredients of the pesticides over water surface.
