However, on 8 January 2007, Deloitte sent to the Directors another letter stating that the statement "The Company was informed by, Deloitte that they will not issue the confirmation letter unless there is a matter needed to be brought to the attention of the Shareholders" was not a true statement as they had never informed the Company to this effect. Deloitte went on to state in the letter that in fact they are bound by the Code of Ethics for Professional Accountants Section 441 (the "Code") issued by Hong Kong Institute of Certified Public Accountants to issue a termination letter on a change of auditors and would in due course issue a termination letter to be mentioned pursuant to the Code. Deloitte went on to state in the letter "We also note that we have the right under article 170 of the Companies Law of the PRC to make a statement at the Shareholders meeting. We reserve our right in this regard and if we wish to make such a statement we will let you know within a reasonable time prior to the meeting". Up to the moment the Company makes this announcement, the Company has not received any confirmation/termination letter from Deloitte. The Company confirms that it will issue an announcement upon receiving a confirmation/termination letter from Deloitte.
