CHARACTERISTICS OF THE GROWTH ENTERPRISE MARKET

1. INTRODUCTION

The purpose of this circular is to provide you with information regarding the resolutions to be proposed at the Annual General Meeting. These include (i) the ordinary resolutions proposing election of Directors who are due to retire at the Annual General Meeting, (ii) the ordinary resolutions granting the Board of Directors ("Board") general mandates to issue and repurchase shares of the Company ("Shares"), and (iii) the special resolution amending the articles of association of the Company ("Articles of Association"); and to give you Notice of Annual General Meeting at which the ordinary resolutions and the special resolution as set out in the Notice of Annual General Meeting will be proposed.

LETTER FROM THE CHAIRMAN

2. PROPOSED ELECTION OF DIRECTORS

In accordance with Article 116 of the Articles of Association, Mr. Li Tzar Kuoi, Victor, Mr. Kam Hing Lam and Mr. Ip Tak Chuen, Edmond will retire by rotation at the 2007 Annual General Meeting of the Company and, being eligible, have offered themselves for re-election. Details of the above Directors that are required to be disclosed under the GEM Listing Rules are set out in **Appendix I** to this circular.

Any shareholder who wishes to nominate a person to stand for election as a Director of the Company at the Annual General Meeting must lodge with the Company Secretary of the Company at 7th Floor, Cheung Kong Center, 2 Queen's Road Central, Hong Kong within the period from Monday, 2nd April, 2007 to Tuesday, 10th April, 2007, both days inclusive, (i) his written nomination of the candidate, (ii) written confirmation from such nominated candidate of his willingness to be elected as Director and (iii) the biographical details of such nominated candidate as required under Rule 17.50(2) of the GEM Listing Rules for publication by the Company.

3. PROPOSED GENERAL MANDATE TO ISSUE NEW SHARES

A general mandate is proposed to be unconditionally given to the Board to issue and dispose of additional Shares (in addition to ordinary Shares issued under the share option scheme adopted by the Company on 26th June, 2002) not exceeding 20% of the issued share capital of the Company at the date of the resolution until the next Annual General Meeting. The relevant resolution is set out as Ordinary Resolution No. 4(1) in the Notice of Annual General Meeting dated 30th March, 2007 ("Ordinary Resolution No. (1)").

Concerning Ordinary Resolution No. (1), the Directors wish to state that they have no immediate plans to issue any new Shares. Approval is being sought from the shareholders as a general mandate for the purposes of the GEM Listing Rules.

4. PROPOSED GENERAL MANDATE TO REPURCHASE SHARES OF THE COMPANY

At the last annual general meeting of the Company held on 11th May, 2006, a general mandate was given to the Board to exercise the power of the Company to repurchase Shares of HK\$0.10 each. Such mandate will lapse at the conclusion of the forthcoming Annual General Meeting. It is therefore proposed to seek your approval of the Ordinary Resolution No. 4(2) as set out in the Notice of Annual General Meeting ("Ordinary Resolution No. (2)") to give a fresh general mandate to the Board to exercise the power of the Company to repurchase Share(s).

An explanatory statement, as required by the relevant rules set out in the GEM Listing Rules to regulate the repurchase by companies with primary listings on the Stock Exchange of their own securities on the Stock Exchange, to provide requisite information to you for your consideration of the proposal to authorize the Board to exercise the power of the Company to repurchase Share(s) up to a maximum of 10% of the issued share capital of the Company at the date of Ordinary Resolution No. (2) ("Repurchase Proposal") is set out in **Appendix II** to this circular.

5. PROPOSED AMENDMENT TO THE ARTICLES OF ASSOCIATION

In view of a Code Provision of the Code on Corporate Governance Practices requiring that all directors appointed to fill a casual vacancy should be subject to election by shareholders at the first general meeting after their appointment, the Board proposes to the shareholders of the Company for approval of an amendment to the Articles of Association to be in line with such provision. The full text of the amendment to be made to the Articles of Association is contained in the Notice of Annual General Meeting set out in **Appendix III** to this circular.

6. ANNUAL GENERAL MEETING

A notice convening the Annual General Meeting to be held at the Ballroom, 1st Floor, Harbour Plaza Hong Kong, 20 Tak Fung Street, Hung Hom, Kowloon, Hong Kong on Thursday, 10th May, 2007 at 10:30 a.m. is set out in **Appendix III** to this circular.

Your right to demand a poll on the resolutions to be proposed at the Annual General Meeting is set out in **Appendix IV** to this circular. The Chairman of the Annual General Meeting will exercise his power under Article 80 of the Articles of Association to put each of the resolutions to be proposed at the Annual General Meeting to the vote by way of a poll.

Proxy form for use at the Annual General Meeting is enclosed with this circular. The proxy form can also be downloaded from the GEM website at www.hkgem.com and from the Company's website at www.ck-lifesciences.com. Whether or not you are able to attend the Annual General Meeting in person, please complete, sign and return the enclosed proxy form in accordance with the instructions printed thereon to the Company's principal place of business at 7th Floor, Cheung Kong Center, 2 Queen's Road Central, Hong Kong as soon as possible and in any event not less than 48 hours before the time appointed for the holding of the Annual General Meeting or any adjournment thereof or, in the case of a poll taken subsequently to the date of the Annual General Meeting or adjourned meeting, not less than 48 hours before the time appointed for taking the poll. Completion and return of the proxy form will not preclude you from attending and voting at the Annual General Meeting or any adjournment thereof should you so wish.

Pursuant to Rule 17.47(5) of the GEM Listing Rules, if voting at a general meeting is taken on a poll, the Company is required to announce the results of the poll in accordance with that Rule. An announcement on the outcome of the Annual General Meeting will be made by the Company in respect of the ordinary resolutions and the special resolution taken by poll after conclusion of the Annual General Meeting.

The following are the particulars of the three Directors (as required by the GEM Listing Rules) proposed to be elected at the Annual General Meeting to be held on 10th May, 2007.

1. **LI Tzar Kuoi, Victor**, aged 42, Chairman. Mr. Victor Li joined the Group in April 2002. He is the Chairman of the Remuneration Committee of the Company. He is the Managing Director and Deputy Chairman of Cheung Kong (Holdings) Limited (“Cheung Kong Holdings”). He is also the Chairman of Cheung Kong Infrastructure Holdings Limited, Deputy Chairman of Hutchison Whampoa Limited, an Executive Director of Hongkong Electric Holdings Limited, Co-Chairman of Husky Energy Inc. and a Director of The Hongkong and Shanghai Banking Corporation Limited. All the companies mentioned above except The Hongkong and Shanghai Banking Corporation Limited are listed companies. Mr. Victor Li serves as a member of the Standing Committee of the 10th National Committee of the Chinese People’s Political Consultative Conference of the People’s Republic of China. He is also a member of the Executive Committee of the Commission on Strategic Development of the Hong Kong Special Administrative Region. Mr. Victor Li holds a Bachelor of Science degree in Civil Engineering and a Master of Science degree in Structural Engineering.

Mr. Victor Li is son of Mr. Li Ka-shing, a substantial shareholder of the Company within the meaning of Part XV of the Securities and Futures Ordinance (“SFO”), and nephew of Mr. Kam Hing Lam, President and Chief Executive Officer of the Company. Mr. Victor Li is also a Director of each of (i) Triluck Assets Limited, the management shareholder of the Company, and (ii) Trueway International Limited, (iii) Li Ka Shing Foundation Limited, (iv) Gold Rainbow Int’l Limited, (v) Gotak Limited and (vi) Cheung Kong Holdings, all being substantial shareholders of the Company within the meaning of Part XV of the SFO. Mr. Victor Li also holds directorships in certain companies controlled by certain substantial shareholders of the Company. Li Ka-Shing Unity Trustee Corporation Limited (“TDT1”) as trustee of The Li Ka-Shing Unity Discretionary Trust (“DT1”), Li Ka-Shing Unity Trustcorp Limited (“TDT2”) as trustee of another discretionary trust (“DT2”), and Li Ka-Shing Unity Trustee Company Limited as trustee of The Li Ka-Shing Unity Trust in which each of TDT1 and TDT2 hold units, are substantial shareholders of the Company within the meaning of Part XV of the SFO. The discretionary beneficiaries of each of DT1 and DT2 include Mr. Li Tzar Kuoi, Victor, his wife and children. Save as disclosed above, Mr. Victor Li does not have any relationship with any other Directors, senior management, management shareholders, substantial shareholders or controlling shareholders of the Company.

Mr. Victor Li has a personal interest of 2,250,000 Shares and other interest of 4,258,634,570 Shares within the meaning of Part XV of the SFO. There is no service contract entered into between Mr. Victor Li and the Company. The Director’s fee of Mr. Victor Li as an Executive Director and Chairman of the Company is HK\$70,000 per annum. The emoluments of Directors are determined by reference to the Company’s performance and profitability, as well as remuneration benchmark in the industry and the prevailing market conditions.

Mr. Victor Li previously held directorship in Star River Investment Limited (“Star River”) (*ceased to act as director on 4th June, 2005*), a company owned as to 50% by Cheung Kong Holdings with its place of incorporation in Hong Kong and active in acquiring property for development. Star River commenced creditors’ voluntary winding up on 28th September, 2004 since it could not continue its business by reason of its liabilities. The amount involved in the winding up was HK\$17,259,710.34 and Star River was dissolved on 4th June, 2005.

Save as disclosed above, there are no other matters concerning Mr. Victor Li that need to be brought to the attention of the shareholders of the Company nor any information to be disclosed pursuant to the requirements of Rule 17.50(2) of the GEM Listing Rules.

2. **KAM Hing Lam**, aged 60, President and Chief Executive Officer. Mr. Kam has been with the Group since its establishment in December 1999. Mr. Kam is also a Deputy Managing Director of Cheung Kong Holdings, the Group Managing Director of Cheung Kong Infrastructure Holdings Limited, an Executive Director of Hutchison Whampoa Limited and Hongkong Electric Holdings Limited, and a Non-executive Director of Spark Infrastructure Group. All the companies mentioned above are listed companies. He is a member of the Beijing Committee of the Chinese People’s Political Consultative Conference of the People’s Republic of China. He holds a Bachelor of Science degree in Engineering and a Master’s degree in Business Administration.

Mr. Kam is the brother-in-law of Mr. Li Ka-shing, a substantial shareholder of the Company within the meaning of Part XV of the SFO, and uncle of Mr. Li Tzar Kuoi, Victor, the Chairman of the Company. He is also a Director of each of (i) Gold Rainbow Int’l Limited, (ii) Gotak Limited and (iii) Cheung Kong Holdings, all being substantial shareholders of the Company within the meaning of Part XV of the SFO. Mr. Kam also holds directorships in certain companies controlled by Cheung Kong Holdings. Save as disclosed above, Mr. Kam does not have any relationship with any other Directors, senior management, management shareholders, substantial shareholders or controlling shareholders of the Company. Mr. Kam has a family interest of 6,225,000 Shares within the meaning of Part XV of the SFO. There is no service contract entered into between Mr. Kam and the Company. The Director’s fee of Mr. Kam as an Executive Director of the Company is HK\$70,000 per annum. The emoluments of Directors are determined by reference to the Company’s performance and profitability, as well as remuneration benchmark in the industry and the prevailing market conditions.

Mr. Kam previously held directorships in CrossCity Motorway Pty Ltd, CrossCity Motorway Nominees No. 1 Pty Ltd, CrossCity Motorway Nominees No. 2 Pty Ltd, CrossCity Motorway Holdings Pty Ltd and CrossCity Motorway Finance Pty Ltd (collectively the “CrossCity companies”) (*all resigned on 22nd December, 2006*), all incorporated in Australia. The principal business of the CrossCity companies is the design, construction and operation of the Cross City Tunnel in Sydney, Australia. A voluntary administrator and a receiver and manager were appointed in respect of the CrossCity companies on 27th December, 2006 as they are insolvent.

Save as disclosed above, there are no other matters concerning Mr. Kam that need to be brought to the attention of the shareholders of the Company nor any information to be disclosed pursuant to the requirements of Rule 17.50(2) of the GEM Listing Rules.

3. **IP Tak Chuen, Edmond**, aged 54, Senior Vice President and Chief Investment Officer. Mr. Ip joined the Cheung Kong Group in 1993 and the Group in December 1999. He is also a Deputy Managing Director of Cheung Kong Holdings, Executive Director and Deputy Chairman of Cheung Kong Infrastructure Holdings Limited, a Director of Critical Path, Inc. (*de-listed on 17th November, 2005*), and a Non-executive Director of TOM Group Limited, CATIC International Holdings Limited, Excel Technology International Holdings Limited, The Ming An (Holdings) Company Limited and Shougang Concord International Enterprises Company Limited. Mr. Ip previously held directorships as a Director of priceline.com Incorporated (*retired on 1st June, 2005*) and a Non-executive Director of Hanny Holdings Limited (*retired on 1st September, 2005*). All the companies mentioned above except Critical Path, Inc. are listed companies. Mr. Ip is currently also a Director of ARA Asset Management (Singapore) Limited, the manager of Fortune Real Estate Investment Trust which is listed in Singapore and ARA Trust Management (Suntec) Limited, the manager of Suntec Real Estate Investment Trust which is listed in Singapore. He holds a Bachelor of Arts degree in Economics and a Master of Science degree in Business Administration.

Mr. Ip is also a Director of each of (i) Triluck Assets Limited, the management shareholder of the Company, and (ii) Trueway International Limited, (iii) Gold Rainbow Int'l Limited, (iv) Gotak Limited and (v) Cheung Kong Holdings, all being substantial shareholders of the Company within the meaning of Part XV of the SFO. Mr. Ip also holds directorships in certain companies controlled by certain substantial shareholders of the Company. Save as disclosed above, Mr. Ip does not have any relationship with any other Directors, senior management, management shareholders, substantial shareholders or controlling shareholders of the Company. Mr. Ip has a personal interest of 2,250,000 Shares within the meaning of Part XV of the SFO. There is no service contract entered into between Mr. Ip and the Company. The Director's fee of Mr. Ip as an Executive Director of the Company is HK\$70,000 per annum. The emoluments of Directors are determined by reference to the Company's performance and profitability, as well as remuneration benchmark in the industry and the prevailing market conditions.

Mr. Ip previously held directorships in CrossCity companies (*all resigned on 22nd December, 2006*), all incorporated in Australia. The principal business of the CrossCity companies is the design, construction and operation of the Cross City Tunnel in Sydney, Australia. A voluntary administrator and a receiver and manager were appointed in respect of the CrossCity companies on 27th December, 2006 as they are insolvent.

Save as disclosed above, there are no other matters concerning Mr. Ip that need to be brought to the attention of the shareholders of the Company nor any information to be disclosed pursuant to the requirements of Rule 17.50(2) of the GEM Listing Rules.

This explanatory statement contains all the information required pursuant to Rule 13.08 of the GEM Listing Rules.

1. SHARE CAPITAL

As at 24th March, 2007 (the latest practicable date prior to the printing of this circular) (“Latest Practicable Date”), the issued share capital of the Company comprised 9,611,072,400 Shares of HK\$0.10 each.

Subject to the passing of Ordinary Resolution No. (1) and on the basis that no further Shares are issued prior to the Annual General Meeting to be held on 10th May, 2007, the Company would be allowed under the Repurchase Proposal to repurchase a maximum of 961,107,240 Shares, representing 10% of the issued share capital of the Company.

2. REASONS FOR REPURCHASE

The Directors believe that the Repurchase Proposal is in the best interests of the Company and its shareholders.

Such purchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net assets and/or earnings per Share and will only be made when the Directors believe that such a purchase will benefit the Company and its shareholders.

3. FUNDING OF REPURCHASE

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its Memorandum and Articles of Association and the applicable laws and regulations of the Cayman Islands. The Company may not purchase securities on the GEM for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange from time to time.

In the event that the Repurchase Proposal was to be carried out in full at any time during the proposed repurchase period, there might be a material adverse impact on the working capital or gearing position of the Company as compared with the position disclosed in the audited consolidated financial statements contained in the annual report for the year ended 31st December, 2006. However, the Directors do not propose to exercise the Repurchase Proposal to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

5. UNDERTAKING

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the power of the Company to make repurchases pursuant to Ordinary Resolution No. (2) and in accordance with the GEM Listing Rules and the applicable laws of the Cayman Islands.

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, their associates, have any present intention to sell any Shares to the Company under the Repurchase Proposal if such is approved by the shareholders.

No other connected persons (as defined in the GEM Listing Rules) have notified the Company that they have a present intention to sell Shares to the Company, or have undertaken not to do so, in the event that the Repurchase Proposal is approved by the shareholders.

6. HONG KONG CODE ON TAKEOVERS AND MERGERS

If on exercise of the power to repurchase Shares pursuant to the Repurchase Proposal, a shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of Rule 32 of the Hong Kong Code on Takeovers and Mergers ("Takeovers Code").

As a result, a shareholder or group of shareholders acting in concert, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rules 26 and 32 of the Takeovers Code.

As at the Latest Practicable Date, an indirect wholly-owned subsidiary of Cheung Kong Holdings held 4,258,634,570 Shares, representing approximately 44.30% of the issued share capital of the Company and for the purpose of the SFO, each of (i) Mr. Li Ka-shing, (ii) Li Ka-Shing Unity Trustee Company Limited as trustee of The Li Ka-Shing Unity Trust, (iii) TDT1 as trustee of DT1, and (iv) TDT2 as trustee of DT2 ((ii), (iii) and (iv) together the “Trust Companies”) is taken to be interested in the same 4,258,634,570 Shares. In accordance with the provisions of the SFO, Mr. Li Tzar Kuoi, Victor, as a Director of the Company, is deemed to be interested in 4,260,884,570 Shares comprising the same block of 4,258,634,570 Shares held by the said indirect wholly-owned subsidiary of Cheung Kong Holdings and 2,250,000 Shares held personally. For the purpose of the Takeovers Code, Mr. Li Tzar Kuoi, Victor is a concert party to Mr. Li Ka-shing. Mr. Li Ka-shing together with his concert parties are taken to have an interest in a total of 4,260,884,570 Shares, representing approximately 44.33% of the issued share capital of the Company.

In the event that the Directors exercise in full the power to repurchase Shares which is proposed to be granted pursuant to Ordinary Resolution No. (2), then (if the present shareholdings otherwise remained the same) the deemed interest of each of Cheung Kong Holdings and the Trust Companies in the Company would be increased to approximately 49.23% of the issued share capital of the Company and similarly, the deemed interests of Mr. Li Ka-shing and Mr. Li Tzar Kuoi, Victor in the Company would be increased to approximately 49.26% of the issued share capital of the Company. In the opinion of the Directors, such increase may give rise to an obligation to make a mandatory offer under Rules 26 and 32 of the Takeovers Code. The Directors have no present intention to exercise the Repurchase Proposal to such an extent that would result in takeover obligation or the public holding of Shares would be reduced below 20% of the issued share capital of the Company.
